- New Rd. may be cut to get to Fairview Cemetary from Cfd. Now, in bad weather, you mus go to Wstfld by county road 2½ mi., then out Broad St. 1½ mi. to the cemetary. There are 3 rds which, by short extensions, could reach the cemetary in 2 mi. One, Orchard St. might be extended from the turn near the Torbusch farm. The 2nd, could be cut thru the Ludlow & Ham propty. The 3rd cut thru Geo. Brown's farm, out Spgfld.Ave.

- 210/21/99 - Street being opened up which will connect Spgfld Ave. with Brookside Pl., thru what was Eichenberg Farm, now part of Fairview Manor
- 21/31/07 - Sheriff's sale fro Hoboken B & L Co. vs. Elise Winckler et al. defendants., property area of Willow St. and Washington Pl. (now Tulip St.) Lots 26 & 27, map of Fairview Manor
- 1/29/96 - E.C. Winckler of South Ave., has purchased the Sengstak propty. on Spgfld & Willow Aves., of 19 acres, including 75 bldg. sites. Tract will be called Fairview Manor. It starts at Spgfld. & West End Pl., & extends west to the Winckler farm. Southern boundary is the farms of Williams & Torbusch. Beside Willow St., 2 other streets, Lafayette Pl., & Wshgtn Pl., have been laid out in the area.

9/7/16 - Woodruff farm on Faitoute Ave. See \$ Dimicke card. (error for Dienicker?)

9/3/25 - Old mansion on Damski farm on Faitoute Rd., near Cfd.-Knlwth line burned 8/30. No water nearby.

9/18/30 - Prohibition raid on Deneicke farmhouse, Faitoute Ave. just over Knlwth line. (See Prohibition card.)

1/18/34 - 14-room dwelling on Faitoute Ave., near Kenilworth line, burned down Mon. 1/15. It had been known as the old Woodruff farm house. (See Woodruff card.)
