Catholic Young Men's Lyceum Begin a Bowling Tourney.

The Dangerous Slingshots.

As the occasional pleasant days come and go, the busy little sparrows begin to get ready for their season's work, and they congregate on the trees in great numbers seeking proper localities in which to erect new homes. The small boys, and many who are not so small, are after them with their slingshots, that is, a bit of rubber attached to a forked stick or wire, and of sufficient power to propel buckshot or small pebble with sufficient force to kill a sparrow twenty-five or thirty feet away. The trouble is the boys do not always confine themselves to feathered game. It frequently occurs that they turn their catapult batteries on each other, which is a very dangerous pastime indeed. Even when shooting the birds they are not at all careful which way they aim their shots, and broken windows are often the result, and of course "nobody" did it. Somebody's eyes might be saved if the police were to put a stop to the use of these dangerous toys.

Result of the Bank Failure.

Trenton, March 11.—Chancellor McGill granted today an order requiring ex-Congressman J. Nelson Pidcock of Hunterdon County to show cause why he should not be adjudged guilty of contempt of court. The order is returnable before the Chancellor at Trenton March 19, and was granted on the application of William Y. Johnson the receiver of the Somerset County Bank, which was wrecked by Pidcock's failure two years ago. Receiver Johnson recovered judgments against Pidcock aggregating about \$55,000 and an injunction was issued by the Chancellor restraining Pidcock from transferring or disposing of any property held by him. Since that injunction was granted, Receiver Johnson alleges that Pidcock assigned to his two sons for the nominal consideration of \$1 a judgment for \$1,100.15 which he had obtained against the executors of John Vermilye. This, it is claimed, is a violation of the injunction.

Acorns That Grow Big.

Rev. Dr. E. M. Rodman has appointed the following committee to form an Acorn Society: Mrs. S. A. Cruikshank, Mrs. Thos. Mumford, Mrs. Marion S. Ackerman, Mrs. D. T. VanBuren, Mrs. Joseph W. Reinhardt, Mrs. N. Pendleton Rogers and Miss Dryden. The object of the society is the reduction and final extinction of the debt on the church property, and it is expected that every family in the parish will have a representative in the society.

Driver Townley of Alert Hose cart yesterday afternoon constructed a small bridge from a window in the flat in which his family resides to a window in Alert Hose house, which is only a few feet distant. By this means he can go quickly and safely from his home to the hose cart. Heretofore he has taken the risk of jumping from one window to another.

Leading Citizens Discuss Plans and Prospects.

WHAT TO DO WITH THE TRAMPS.

Funds Low, But Work Progressing Steadily—Planning to Incorporate the Association, to Perfect and Make Permanent Its Work.

The meeting of the Citizens Organized Aid Association in the parlors of the Crescent Avenue Church last evening was well attended, and much interest was evidenced.

It was stated, as announced in last night's Daily Free, that the Plainfield Relief Association had rented the house on West Second street next to their present quarters, and the Aid decided to rent two of their new rooms, where headquarters would be established from April 1.

H. B. Newhall, Dr. W. H. Murray, Miss E. B. Leonard, Mrs. H. B. Opyke, D. P. Hall and S. E. Huntington were appointed a committee to revise the constitution and see what could be done towards incorporating the society.

A communication was received from Councilman S. A. Ginn stating that a committee from the Council had been appointed to confer with the committee from the society in regard to the proposed poor farm.

Reports of various committees were read, and showed a steady progress, though the funds of the treasury were low. A private donation of \$50 was received, and gratefully acknowledged.

The Employment Committee called attention to the fact that they had enrolled a number of deserving women, who were anxious to secure work.

A portion of the evening was occupied in discussing the tramp question, but no conclusions were reached as to what should be done with them.

Consolidating the Parishes.

By the approach of Spring we are reminded that it will soon be necessary to make arrangements for the Sunday-school Summer excursion. It has been customary for the Sunday-school of Grace Church, as well as of St. Stephen's, to unite with the Baptist or Presbyterian Sunday-schools, or rather to pay them outright a sum of money for the use of a certain number of cars attached to their train. Lewis G. Timpeon, who has long had charge of this matter for Grace Sunday-school, offers a suggestion which he desires to bring to the attention of the schools belonging to the parishes represented by this paper, namely: That the four parishes unite in making the excursion, hiring their own train, and not being dependent on others in this matter. He has considered the subject carefully, and he believes that instead of being obliged to make expenditure on this account, each Sunday-school would, through the sale of tickets, if not have a balance to its credit from the venture, at least would be able to send its scholars free; that the receipts would balance expenses. Would it not be well to have a meeting of the superintendents to consider the question?

OVER THE VETO.

A Partisan Legislature Refuses to Listen to Gov. Wertz's Arguments.

Trenton, March 11.—The Republican Senators held a long caucus tonight and decided that the Senate would be ready for final adjournment Friday, March 23. They also decided to pass over the Governor's veto the Voorhees bill abolishing lay Judges of the county courts and providing for the election of the county law Judges by the people.

This was done immediately after the caucus adjourned. The vote to pass the bill over the veto was 14 to 4, the minority votes being cast by Democrats. The bill will go to the Senate on Wednesday, and must lie over a day there before being acted upon. There will be no session of either House tomorrow, which will be given up the State House investigation.

Later the Elective Judiciary bill was taken up and passed by partisan votes. Senator Daly spoke against it and Senator Voorhees for it. The former after reading an editorial from the Jersey City Evening Journal (Rep.) condemning the bill said he did this for the edification of the Republican party, and while he did not suppose he could influence the party to vote against the bill, he said it was not a Democratic funeral.

Mr. Daly also read from the Newark Times (Rep.) a similar article against the bill. He submitted that a majority of the people of the State were opposed to the measure, and that if passed it would be a step backward. But he supposed it must go, and the judicial ermines for the first time must be dragged in the political mire.

LEVI HETFIELD'S WILL.

Filed for Probate in Union County.

EVERYTHING STAYS IN THE FAMILY

Plainfield Property Specifically Bequeathed to His Sons and Daughters, and Two of Them Chosen Executors.

The will of Levi Hetfield was filed for probate in Elizabeth yesterday.

After providing for the payment of his debts and the erection of a monument over his grave, the testator bequeaths:

To his daughter Anna D. Serrell the land, brick stores and right of way at 202-204 West Front street, valued at \$18,000 and mortgaged for \$5,000.

Also to Anna D. Serrell his gold watch and chain and gold eye glasses.

To the executors, in trust for his son Walter L. Hetfield, and to said Walter's heirs after his death, the land, brick building and right of way at 140-142 Park avenue, valued at \$6,000, mortgaged for \$2,000.

Also to the executors in trust for Walter L., the four brick dwellings, land and right of way, on West Third street between Madison and Arlington avenues, valued at \$6,000.

To Walter L. Hetfield the use of testator's diamond stud, one-half his set of carpenter's tools, tool chest, and gold-headed cane.

To John M. Hetfield the row of eight frame dwellings on Arlington avenue, between Third and Fourth streets, valued at \$10,000.

Also to John M. Hetfield his diamond ring, gold-band bracelet, one-half set carpenter's tools.

To his daughter Aretta H. Manning the homestead, Madison avenue and West Fourth street, valued at \$8,000. Also \$2,000 cash, and \$500 special legacy for her kind and careful attention to him and his brother Squire Hetfield.

Also to her, the piano, carpets, rugs, pictures and other household goods.

The balance of the estate is to be divided among the four sons and daughters, Walter L.'s share being held in trust by the executors. Two notes endorsed for Walter and held by the City National Bank, for \$1,000 and \$475, are to be paid out of his share.

John M. Hetfield and Aretta H. Manning are made executors.

Wm. C. Boone and J. A. Hubbard are witnesses.

Today's Election.

The election that is being held today in North Plainfield is one of the most peculiar that has ever taken place in that community. The call for the Republican primary was published only four hours previous to its assembling. The Press named most of the successful candidates at the same time that it published the primary call one week ago last Friday. The Democratic call was published that same day, and was called for the following evening, (twenty-eight hours later), when a few met and nominated a ticket. The persons there nominated refusing to run, left the field to the Republicans without any opposition. And yet both parties are nearly equally divided in the number of voters, in that municipality.

LET PARKHURST ALONE

Such Is the Decision of the Presbytery.

Resolutions of Censure on Account of Recent Utterances Laid Upon the Table—Animated Discussion Over the Church of Sea and Land.

New York, March 12.—According to programme the resolutions reflecting upon the conduct of Dr. Charles H. Parkhurst in the matter of his criticism of the New York presbytery's action with regard to the sale of the church of Sea and Land as outlined in these despatches, were offered at the monthly meeting of that body in the lecture room of the First Presbyterian church. Dr. Parkhurst was absent, having left the city for a two weeks' rest, but his friends were there in force. Dr. Chambers, having the resolutions in charge, secured the floor at the opening of the session. He had a long statement based upon the records of presbytery and giving in detail the facts in regard to the proposed sale of the property and the terms of the occupancy, pending the sale, by the Madison Square church, of which Dr. Parkhurst is pastor. He prefaced this statement with a whereas setting forth the fact of an interview with Dr. Parkhurst in which the proposed sale was characterized by the eminent reformer as a "cold blooded violation of a solemn contract which is as true as the everlasting gospel. It was an act which, had it been committed in Wall street, would have furnished the clerical members of the presbytery with what they would have considered juicy material for homiletical exploitation." Following this preamble were the extracts from the presbytery records showing that the decision to sell the "Sea and Land" church antedated the arrangement with Dr. Parkhurst's church by nearly a year and a half, that the occupancy of the church by Dr. Parkhurst's session was for one year only, that the session of the Madison Square church had stipulated in writing that "we would not wish to be obligated ourselves or our presbytery to do anything beyond the 'same year,' that subsequent action in regard to the sale of the church was made subject to the agreement with the Madison Square church, and that part of the proceeds of the sale was to be used in planting a mission in the neighborhood of the church, which would be available as a field for work carried on in the Sea and Land building by Dr. Parkhurst's session.

Animated Discussion. Dr. John Hall opposed the resolution in the interests of peace and harmony. He objected to references in the preamble to Dr. Parkhurst and the Madison Square church. He asked to have the names stricken out. "Authorize the officers of the presbytery," he said, "to print and circulate the statement as far as you wish, but omit all personal references to a brother whom we love and respect. Let the statement rest on the facts, and let the newspaper interviews with this brother alone. The public will be able to compare these statements of facts authorized by us with the newspaper references and adjudications upon them as they see fit." Dr. Mullaly, whose objections to the recent vote of approval of Dr. Parkhurst's reform methods created such a stir in the presbytery several weeks ago, was on his feet in an instant. "To my mind," he cried, "the preamble is the most important. It is a question of a member of presbytery arraigning his presbytery before the public instead of before the session and charging it with crime, with a misappropriation of funds, with a violation of confidence, an abuse of trust, and a church rises to object because the member who does this is named. Are we to be the prey of a man who makes his living by sensational writing? An individual has arraigned the presbytery, and an individual shall be named. If I had my way I would bring him before the bar of this court and make him answer." Dr. Francis Brown, Dr. Duffield, Dr. Buchanan and other pastors opposed the resolution, which had been altered by Dr. Chambers to meet Dr. Harris' suggestion. Dr. Buchanan of the Thirteenth Street church thought it was unnecessary and undignified for the presbytery to exonerate itself from alleged criticisms spoken to an unknown reporter on mere rumor by publishing a statement. Dr. Arbury of the Park Presbyterian church agreed with Dr. Buchanan and his motion to lay the resolutions as amended on the table was carried by a vote of 57 to 36. Many of the conservative members of presbytery voted with the liberals on this motion.

CUBAN REVOLUTION

Spain Deems the Situation Serious and Sends \$1,000,000. Madrid, March 12.—A credit of \$1,000,000, to be used in suppressing the Cuban insurrection, has been cabled to Captain General Calleja in Havana. The preparations to ship more troops to Cuba are pressed forward with great rapidity. In addition to the three transports which have already sailed, half a dozen or more troopships have been made ready to leave Cadiz and Santander as soon as the infantry shall be got aboard. The total number now under orders for the Cuban campaign is 12,000. Not a few of the soldiers are veterans of the previous campaign. They and the other experienced men have been distributed among the regiments so that every company of new recruits may have a backbone of tried campaigners. Despite the terrors of the Cuban climate for the European Spaniard, there are numerous volunteers from all parts of the country. The popular excitement is beyond anything warranted by the sanguine reports given out by the government. It is almost as great as when the Kabyles attacked Melilla. While military men here profess to believe that the insurrection is not very serious, the officers of Cuban experience, most notably Martinez de Campos, fear that the present outbreak is the beginning of a long period of unrest on the island. They think the armies will be forced to remain some time in the disturbed districts. The expense and loss of life in the trying climate, they predict, will be sources of constant regret and inconvenience to the mother country. To this view undoubtedly is due Campos's eagerness to have any thorough reforms introduced in the administration of Cuban affairs. He has reiterated in private conversation with members of the government the plea for reform which he made in the senate last week and the ministers have decided to take in hand most of the measures suggested by him.

WORTH IS DEAD.

End of the Man Who Ruled the World of Fashion. Paris, March 12.—Charles Frederick Worth, the world-famed dressmaker, of Paris, and the man who ruled the world of fashion, died yesterday. The famous dressmaker was, singularly enough, a native of England, but the only queen in all Europe who never ordered a toilette from him is the one in whose dominions he was born. He began life as a printer, but an instinctive dislike to soiling his hands, as well as his inborn gifts, led him to exchange his apprenticeship for a position in the extensive dry goods house of Swan & Edgar, in London.

There he developed and perfected his appreciations for the productions of the French milliners and dressmakers, superintending the unpacking of every case of pattern garments that arrived, and speedily becoming an authority in all matters connected with stylishness of cut and tastefulness of trimming. Worth made dresses not only for the royal ladies of Europe, but for the queens of society both in Europe and the United States, and for the queens of the footlights as well. His first royal customer was Donna Maria da Gloria, queen of Portugal. For years thereafter there was scarcely a princess married in Europe—outside of the imperial family of Germany, whose principles forbid them from ever ordering anything to be made in Paris—that did not have a group of Worth toilets included in her trousseau.

Jameson's Unlucky Journey. Providence, R. I., March 12.—Mrs. Thos. Jameson, of Johnston, sent her husband to Quebec two weeks ago to transact business in her name. Jameson received \$755 for her, and started for home, and, as he failed to reach here, it was supposed that he had deserted his wife. It now transpires that Jameson, who was once an able seaman on H. M. S. Pandora, was arrested in Quebec by an officer of a court-martial in England, he having deserted the Pandora at Barbados. He will probably be sentenced to serve his entire term of enlistment, and in addition a long term of imprisonment. At the time of the queen's jubilee Jameson failed to secure a pardon.

Plan to Pension Employees. Peru, Ind., March 12.—President Ashley of the Wabash railway has evolved a new plan for pensioning and providing insurance for the employees of that system. The company is to set aside a certain sum of money each year to be invested as an insurance fund, the men to be paid according to length of service and good record. Five years from now, in 1900, would give those entitled \$1,000 at death. For each five years' service thereafter \$1,000 additional would be paid until the limit as provided is reached. His plan also provides for a pension under which employees who become disabled or grow old in the service, will receive stated amounts.

What China Agrees To Do. London, March 12.—The Times correspondent in Peking says: "China, through the United States Ministers Denby and Dun, has agreed that the points to be discussed at the peace conference with Japan shall include: the independence of Corea; the cession of territory; the payment of such an indemnity as the envoys may determine."

Fatal Fire in a Shaft House. Winnipeg, Man., March 12.—The Sultana mine shaft house at Rat Portage took fire in the drying room yesterday. Two miners are dead and eight others were almost suffocated to death. The fire is supposed to have been started by a pipe in the pocket of a coat hanging on the wall.

Rebellion of Sooloos. Madrid, March 12.—The captain general of the Philippine Islands has made an urgent application for troops to quell a rebellion of the Sooloos. A battalion of marines held ready at Ferrol to embark for Cuba has been ordered to Manila.

Clean Sweep for Republicans. Augusta, Me., March 12.—Yesterday's election resulted in a clean sweep for the republicans who re-elected Mayor Millikin by an increased majority.

LAW AND LANGUAGE

Judge Righter Seems To Be Master of Both.

Louisiana's Law on Prize Fighting Declared To Be a Piece of Legislative Fraud and Mendacity—Pugilism a Legitimate Business and Domestic Industry in That State.

New Orleans, March 12.—Yesterday Judge Righter handed down the following decision in the case of the state vs. the Olympic club: "I am called upon to interpret and enforce act No. 25 of the statutes of 1890. The title of the act reads: 'An act defining the crime of prize fighting and to provide for the punishment thereof in and out of the state of Louisiana.' 'The act embraces two sections and a proviso, neither of the sections defining the crime of prize fighting nor does the proviso tell what a glove contest is. The former (not defined) is forbidden and punished, the latter are under conditions permitted and by implication encouraged. 'Having under instructions from the supreme court excluded all expert testimony as to the distinction between these differently designated methods of pugilism, and referring only to the facts proved in one case and in the other, I find that a prize fight is a glove contest without gloves, and that a glove contest is a prize fight with gloves. In each case, there is a duel with fists and there is a prize. In each case there is the same danger to limb and life, the same maiming and shedding of blood; the same brutality. 'I conclude therefore, that the act entitled 'An act defining the crime of prize fighting and to provide for the punishment thereof in and out of the state of Louisiana,' is a piece of legislative fraud and mendacity. It neither defines the crime of prize fighting nor does it provide any penalty for the same which cannot be evaded by the mockery of covering with gloves the hands of the gladiators. That a glove contest is brutal and dangerous as a prize fight was clearly settled in the case of Lavigne vs. Andy Bowen. On the whole, I find that a prize fight in Louisiana is a glove contest and that a glove contest is a prize fight. It logically follows, that there being no prohibition of glove contests in this state, the same being legalized and encouraged under certain conditions, which the prize fighter willingly accepts, prize fighting is now what it never was before the enactment of statute No. 25 of 1890, a legitimate business and domestic industry, under the special protection of the law, while before the passage of that statute it would constitute the crime of assault and battery and in some cases of manslaughter. 'Judgment for the Olympic club.'

JERSEY POLITICAL SCANDALS.

Plan To Continue the Investigations Begun at Trenton. Trenton, N. J., March 12.—The state house investigation committee will resume the examination of witnesses in the senate chamber to-day. Sensational developments are expected but the members of the committee are close-mouthed and refuse to reveal their nature. Eugene J. Murphy, the former book-keeper of John Mullin & Co., the Jersey City furniture dealers, will probably be put on the stand again. He was closeted with Counselor Corbin several hours. He was the witness who last Friday showed from the books of Mullin & Co., that desks, chairs, etc., sent to private houses were paid for by the state and that the state paid exorbitant prices for nearly everything bought from the firm. While it is true that great pressure is being brought by certain politicians to have the committee end its labors summarily it is also a fact that there is a great demand that the committee shall continue its work and "cleanse the stables" thoroughly before quitting. The committee have practically decided after getting through at the state house to investigate complaints of corruption in Hudson, Middlesex and other counties. There is work enough, however, right in the capitol to keep the committee busy several weeks.

Strange and Fatal Epidemic. Ashland, Ky., March 12.—Latest reports from Floyd county brought by local traveling salesmen just returned are not at all encouraging for the early suppression of the strange malady that is raging in the Mud river country. It has become so violent that even the physicians of the surrounding towns refuse to visit the victims. In all, the death roll has exceeded fifty already and the disease is on the increase. The disease instead of being smallpox resembles cholera except that it chokes the victim to death, beginning in the stomach and rising to the throat. In almost every case it has been fatal, the victims seldom living three days after the attack.

Want Their Old Wages. Jamestown, N. Y., March 12.—Nearly 400 girls employed in the drawing and spinning rooms at the Broadhead Worsted mills will go on strike to-day unless their wages are increased to what they were before the cut of last fall. The other employes of the factory are in sympathy with them and a general strike of the 1,000 employes may result.

THE NOISE OF BATTLE

Swords Drawn Among the Southern Railroads.

The Seaboard Air Line Hits Back at the Boycotters—Good Exercise for the Combatants and Fun for the Public Who Pay the Freight. Deep Cuts in Rates.

Baltimore, March 12.—President R. Curzon Hoffman, of the Seaboard Air Line, has returned here after an absence of a week. In talking about the boycott which the Southern Railway & Steamship Association had instituted against the Seaboard, and the cut in passenger rates which his line has made in retaliation, Mr. Hoffman said: "We have made our move, and we are now waiting for the other fellows to do something. Our cut has not been met as yet. At least there has been no public announcement. We are prepared to make a determined fight for what we know to be our rights.

"The hearing of the injunction which we obtained against the Western & Atlantic and Nashville, Chattanooga & St. Louis, restraining them from joining in the fight against us, which was set for last Saturday, was postponed at the instance of the counsel of the defense. We were ready and anxious to go ahead with the case. Judge Lumpkin, before whom the case will be tried, has not set a date for the hearing, but will probably decide upon an early hearing. Meantime the injunction stands and the defendant roads are exchanging business with the Seaboard as usual."

Asked if his line would join the Southern Passenger Association, which was formed last week, to take the place of the old association, which was run in connection with the Southern Railway & Steamship Association, Mr. Hoffman replied that the Seaboard did not contemplate joining any association at the present time. The Seaboard was not represented at the meeting at which the association was formed although it was invited to send a representative.

A rumor is current that the Southern Railway Company has secretly cut both passenger and freight rates, but the report was denied at the local office of the company. A cut in freight rates by the Seaboard Air Line would cause no surprise in shipping circles.

Secret Rate-Cutting.

It was reported that open proof of widespread demoralization in Baltimore and Ohio and Pennsylvania passenger rates had been obtained, and as a result a searching investigation is to be instituted. The allegations are that both roads have been manipulating rates for some time in various forms. Mileage books, it is alleged, have been sold by the passenger department of the Pennsylvania system directly to ticket scalpers at reduced rates. The Baltimore & Ohio is accused of secretly cutting the rate between Chicago and Columbus. As a result of the discoveries an expert has been appointed to go to Pittsburgh, which is the headquarters of the western lines of the Pennsylvania, and examine the books of the latter system with a view to learning how many of the mileage books have been issued. It is also charged that not one half the roads are maintaining the agreement relative to paying commissions.

Coal Rates.

Philadelphia, March 12.—Anthracite coal operators and dealers in this city received from the Lehigh Valley Railroad company official notification of the withdrawal of the old joint rate from the mines to points on the Reading company's system and with which was enclosed the new tariff sheet giving the rate to South Bethlehem and East Penn Junction, the points of connection with the Reading. The change is not to take effect until March 29, although the withdrawal of the old joint rate on the part of the Reading has gone into effect. The naming of the later date by the Lehigh Valley is stated to be due to the desire of that company not to inflict any hardship upon dealers who have ordered Lehigh Valley coal in advance and also because the action is in compliance with the provisions of the interstate commerce law.

Dinners \$140 Each.

New Haven, Conn., March 12.—The Yale special train from New York to this city Sunday nights has been discontinued. For years the Yale men living in New York and vicinity have been trying to get the New York road to put on such a train, and six weeks ago Henry S. Borden, a New York broker, whose son is a Yale man, induced the railroad people to try the experiment. He guaranteed the road against loss for six trips. Only one of the trips has paid, and as nearly as can be ascertained, the Sunday dinners which student Borden has enjoyed with his father, have cost Borden senior about \$140 each.

New Railroad.

Baltimore, March 12.—The preliminary arrangements for the construction of the Baltimore & Cumberland railroad have been completed and work will begin as soon as the weather will permit. Although having a separate charter, the line will really be an eastern extension of the West Virginia Central & Pittsburgh, which guarantees both principal and interest on the bonds issued for the purpose of construction. The line is projected from Cumberland to Hagerstown, but will ultimately be extended to Baltimore.

Senator George's Shoes.

Jackson, Miss., March 12.—In an interview Gov. J. M. Stone announced himself a candidate for the seat in the United States senate now occupied by Senator George.

SUFFERING IN ST. JOHNS.

Stories of Distitution from All the Neighboring Districts. St. Johns, N. F., March 12.—The goods for the relief of the suffering poor of this city, which were brought here by the steamer Grand Lake from Boston a few days ago, have all been landed and stored free of cost and were being distributed yesterday. The opinion of the committee in charge of the distribution is that the quality of the goods was never excelled in this city. The amounts for distribution in outports are being carried to their destination by the railroad company free of cost. The number of destitute families in St. Johns is increasing daily and the reports from outports are to the effect that the people in many localities are in utter destitution. A dispatch from a small settlement on the southwest coast, signed by the parish priest, was received here stating that forty families were starving there and there was nothing to give them. The dispatch also asked that assistance be sent them immediately. This same condition exists in nearly all the neighboring districts. There are about two thousand eight hundred families in this city and its suburbs in distress and they are being assisted by the relief committee as much as possible. At a meeting of the clerical relief committee resolutions of thanks to the good people of Boston and of New England were unanimously adopted for their haste in replying to the appeal for assistance from this place with such a magnificent donation of food which was so badly needed.

CHURCH SCANDAL.

An Illinois Priest Appeals to the Civil Courts.

Chicago, March 12.—A novel suit for \$50,000 damages has been brought in the circuit court here against Archbishop Feehan by Rev. Francis Noonan, formerly priest of the parish of Wilmington, Ill., now without a charge. The bill states that when the priest came to the Chicago diocese, six years ago, he was officially received by the archbishop, who assigned him to the Wilmington church, where he remained three years, the time necessary to become a child of the diocese when the bishop does not formally adopt the priest. The suit rests largely on this question of adoption into the diocese fold. Father Noonan suing to recover his regular pay and damages for the loss of his parish position. The further charge is made that Rev. Thomas O'Garra, the present pastor of the Wilmington church, coveted the position of the plaintiff, and obtained the same by circulating false reports to the effect that two young women who lived with Father Noonan at the Wilmington parish house were not, as represented by the plaintiff, his nieces. A scandal resulted and when Father O'Garra was appointed to the parish it is alleged he threw Father Noonan out of the house. Suit for libel will also be brought against Father O'Garra.

NATIONAL FINANCES.

Receipts Improving But Not Yet Equal to Expenses.

Washington, March 12.—The treasury condition for the first third of March shows the receipts to have aggregated \$9,325,000, and the expenditures over receipts \$2,029,000. An element of uncertainty not heretofore entering into treasury calculations, has now to be considered. It is the large sums of money appropriated by congress in the deficiency appropriation bills and sundry civil appropriation bills. Many of these items are made immediately available and the payment of \$15,000 on the "civil and miscellaneous" accounts shows that some of them have begun to reach the cashier's desk. The custom receipts show a continued and sustained improvement, being for the fiscal year up to date \$106,877,000 or nearly a million more than for the same time last year. Internal revenue receipts are \$5,000,000 in excess of this time last year, but improvement in both sources of receipts must be shown for the last third of the fiscal year or government revenues for the entire fiscal year will fall considerably below the estimates.

Executive Courtesy.

Indianapolis, March 12.—A bitter quarrel occurred between Lieut.-Gov. Nye and Gov. Matthews shortly before noon. This is the last day of the legislative session and the lieutenant-governor took advantage of his constitutional right to pass on bills on the last day. Gov. Matthews heard of this and started out to hunt for Nye. He found him in the speaker's room and demanded that he permit the passage of the prize fighting bills. Those present say that Nye told the governor to go to hell. "I am running this senate," said Nye, "and not a single bill shall be passed while I'm in the chair." The governor left in a rage and blows were narrowly averted.

Binghamton's Bank Affair.

Albany, March 12.—Superintendent Preston, of the state banking department, held a conference with Attorney-General Hancock yesterday regarding the prosecution of the persons connected with the defalcation in the Chenango Valley Savings bank of Binghamton. The attorney-general has decided to take charge of the proceedings in person and will act independently of the district attorney in the matter. He will send a representative to Binghamton at once to confer with Bank Examiner Backus and obtain necessary data.

Hayward Sentenced To Be Hanged.

Minneapolis, March 12.—Harry T. Hayward, convicted of the murder of Catherine Ging, was sentenced by Judge Seagrave Smith, after a motion for an arrest of sentence had been denied, to be hanged on a day fixed by the governor of the state after the expiration of three months' confinement in the Hennepin county jail. Hayward listened calmly to the sentence and showed no feeling afterwards.

Ithaca Is Dry.

Ithaca, N. Y., March 12.—This city, the seat of Cornell university, has gone dry. At 7 o'clock last night all liquor licenses expired and there is now in office a no-license board of excise. The liquor sellers all made application for a renewal of their licenses, which were all refused by the board. The drug stores were given licenses, however.

BRITISH LION GROWLS

Another Acute Stage in the Behring Sea Matter.

Bitter Complaints Because the United States Have Not Paid That \$425,000 to Canadian Sealers—Newspaper Comment on the Fifty-third Congress.

Ottawa, Ont., March 12.—Another acute stage in the Behring sea difficulty is engaging the attention of the British, United States and Canadian governments. Since the refusal of the American congress to vote the compensation agreed upon, the Canadian government has been urging the home authorities that the indisposition of the United States to carry out the understanding, justifies the refusal of Great Britain to assent to the enforcement of the restrictions upon sealing during 1895. So far no answer has been received to these representations. About this time last year a similar difficulty arose when through the delay of the great powers interested it began to look as if the award would not be enforced in the approaching season. At that time Senator Morgan, chairman of the senate committee on foreign affairs, made a bold declaration that in his opinion no damages would ever be paid by the United States. Though the government of the republic is still declaring its desire that the lump sum of \$425,000 agreed upon should be paid over, the action of congress is a plain intimation that Senator Morgan's views hold good with those who hold the strings of the national purse. Whether Canada is to be compelled to live up to her portion of the award while the United States refuses to be bound by the part which applies to it, is the question which is bothering the diplomats of the nations concerned.

Toronto, Ont., March 12.—The Mall and Empire, (government organ) in an editorial, under the caption "An Unhonored Legislature" says: "No body has a good word to say for the late unlamented fifty-third congress. On all hands it appears to be agreed that the United States was never cursed with its like before. It was this boorish, dishonorable congress that repudiated the just claim of our sealers. By doing so it placed its own country in a mortifying position in the eyes of the world; a position which the government of the United States keenly feels. To-day the government is as much ashamed of that congress as the people are indignant with it. It broke the national word, formally passed by representatives of the country in a treaty which provided for the settlement of the Behring sea question by arbitration. The executive is in no sense responsible for the non-payment of the \$425,000 due to our sealers. On the contrary both President Cleveland and Secretary Gresham pressed on congress the expediency and justice of paying this amount at once. When congress refused to do so Secretary Gresham expressed his regret to Great Britain. The whole disgrace rests on congress. It is with the executive, through its outside agents, that foreign countries have to deal. If it were as mean as the late legislature, Great Britain would no doubt withdraw from the Behring sea arrangement at once. But the president and secretary of state are most worthy men, anxious for upholding the honor of their country. They may be seconded by a worthy congress in the fifty-fourth."

Libel in Massachusetts.

Boston, March 12.—The committee on Judiciary of the legislature gave a hearing on the petition of Charles H. Taylor, Jr., secretary of the general committee of Massachusetts publishers, for an amendment to the law relative to libel, and providing that a person aggrieved by a publication in a newspaper shall make a demand for a retraction, and if that is made the publisher may in case of suit introduce evidence of the retraction, and that the alleged libel was published in good faith and without actual malice. The proposed amendment also provides that in all civil suits for libel, unless the plaintiff prove actual malice, or a failure to retract after written demand, he shall recover as damages only such pecuniary loss as he shall specially allege and prove. Evidence may also be introduced of settlements of other suits for the same cause of action.

Cleveland's Luck.

Cape Henry, Va., March 12.—Unpropitious weather put an end to the president's duck shooting, after a few hours sport yesterday. In that short time, however, Mr. Cleveland had fairly good luck. Storm signals are hoisted here indicating a northeaster which will prevent the president from shooting to-day in which event it is probable that the Violet will be put about on the return trip to Washington.

Miners Resume Work.

Pittsburg, March 12.—Eight thousand river coal miners in this city will start to work to-day, the operators having granted the 69 cents per ton demanded by the men. The operators claim, however, that the advance is not permanent and that it would not have been granted but for the reason of the favorable condition of the river for shipping coal.

Silence Regarding Roseberry.

London, March 12.—The Daily News, Lord Roseberry's organ, is silent as to the renewal of the tory rumors of the premier's resignation. It will remark, however, that "Lord Roseberry will occupy shortly his official residence in Downing street while extensive alterations are making in his own house."

Noted Forger Arrested.

Newark, N. J., March 12.—Alphonse Voullaire, alias Albert St. Claire, a forger of some fame, has been arrested here in the act of passing a worthless check for \$15 on Theodore Hilbert, a saloon keeper.

Morocco Factory Burned.

Lynn, Mass., March 12.—Kelly & Green's morocco factory was burned last night. Loss about \$48,000.

A WOMAN ATHLETE.

Mrs. Antonio began her work on the Trap-ze When Only 5 Years Old. "I have been in training since I was five, and that's twenty years ago," Mrs. Antonio tells her questioners. So long, indeed, the training and so gradual the practice of the feats that this Romanian trapezist never gave herself a shock or a thrill like she now gives Londoners twice a day at the Royal Aquarium. One thing she does is this: Having gaily mounted to the giddy height of the roof, Mrs. Antonio falls backward into her net seventy feet beneath. She starts on her descent with a weight of ten stone and with each yard down her weight doubles. The blow with which she strikes the net causes her to rebound nine or ten feet—according as the weather is dry or damp—into air. That blow must be on her back. If she fell on her arms or feet they would be broken like matches, and if on her neck the figure that has fallen so far through space would stir no more. Loud is the whirl of the air in her ears during that flight downward. It strikes cold against her eyes, too, but her eyes must be able to see the net beneath her as she makes her double somersault in air, so that she may arrange her attitude before she strikes the net. She does not breathe as she descends. But she thinks and sees. Then there is the crash of the fall, the rebound, the bow to the applauding crowd, the smile, the hand waving kiss, and for half a day more Adeline Antonio has the assurance of life and limbs.

Not so sensational, but more deliberately beautiful, is her descent of the rope. With arms cast free, with no tying or fastening, with no haste or effort, she comes gliding perpendicularly down, floating and swaying. Where does the rope hold her? By a mere twist round waist or ankle. There is no sign of strain. The turning on the high trapeze, with a mere grip of the knees and both hands incessantly striking the tambourine, is perhaps less distinctive, but it is a marvelous feat of both grace and strength. Ten times or fifty times, without the help of a finger, the vigorous figure wheels itself under and over this bar so quickly that the mere spectator is giddy. But she herself is giddy never; she does not know what blood to the head means and she remains white in face where red and purple would be expected, just as her arms are shapely when you might suppose that by development of muscle they must appear malformed.

HAWTHORNE'S EARLY YEARS.

As Solitary as a Hermit Until He Was Married.

The little town of Salem in Massachusetts is memorable chiefly because of the pitiful witchcraft trials held there two hundred years ago. One of the judges most active in the task of convicting the poor creatures then accused of evil practices was John Hawthorne. In Salem, their lives, first and last, six generations of this family (spelling its name sometimes Hathorne and sometimes Hawthorne); and in Salem Judge Hawthorne's grandson's grandson was born in 1804 on the Fourth of July—a fitting birthday for an author so intensely American as Nathaniel Hawthorne. Four years after the boy's birth, his father, a sea captain, died at Surinam; and his mother never recovered from the blow of her husband's death, withdrawing herself wholly from society, and living for forty years the life of a recluse, even to the extent of taking her meals apart from her children. When Nathaniel Hawthorne was eight or nine years old his mother took up her residence on the banks of Sebago Lake in Maine, where the family owned a large tract of land. Here the boy ran wild, fishing and swimming, shooting and skating—and, on rainy days reading. This life in the woods increased the liking for solitude which he inherited from his mother, and which in after years he was never able to wholly overcome. In time he went back to Salem to prepare for college. In 1821, being then seventeen, he entered Bowdoin, having long before for a classmate, and making a close friend of Franklin Pierce, who was in the class before him. He was graduated in 1825, and he then went back to Salem. The family was fairly well to do, and it was not needful for Nathaniel to hurry in choosing a profession. He had already decided that he wished to be an author, but authorship offered little chance of a livelihood. There was not then a single prosperous magazine in the United States. Yet the Sketch Book and the Spr, the pioneers of American literature, had been published not five years before; and the success of Irving and of Cooper, and the prompt appreciation with which their early writings were received both in America and in England, was encouraging to other native authors. So the year after he left college, Hawthorne wrote a tale and published it at his own expense; but it made no impression on the public, and very few copies were sold. The tale appeared without its author's name, and its failure seems to have increased Hawthorne's love of solitude. For ten years and more he lived to his mother's almost as alone as if he were a hermit in a cave. For months together he scarcely met any one outside of his own family, seldom going out save at twilight or to take the nearest way to the desolate seashore. Once a year, or thereabouts (so he told a friend a long while after), he used to make an excursion of a few weeks, "in which I enjoyed as much of life as other people do in the whole year round." Unnatural as this existence was, Hawthorne kept his health, and seldom lost his cheerfulness. He read endlessly and he wrote unceasingly. These were his "practice years" of authorship and in them he became a master of the craft of writing.—St. Nicholas.

Bradford, Pa., March 12.—Associate Judge C. M. Stearns, of Potter county, who has been recently suffering from the grip, attempted to commit suicide yesterday by cutting his throat. He was overpowered and disarmed before he could succeed.

Steamers in Collision.

London, March 12.—Two unknown steamers were in collision last night off Beachy Head. One is believed to be sinking.

TRIP OF PAUL JONES.

HE STARTED AROUND THE WORLD WITHOUT A CENT.

Returns With \$5,000. Various Expeditions He Resorted to in His Endeavor to Win a Hat Made a Year ago. Taken for a Spy.

Paul Jones, genius and globe trotter, landed in New York the other day, having completed a circuit of the world from Boston.

It will be remembered that this Paul Jones, as he calls himself, made a sensation last February by the odd means he took to get money enough to start on his journey. He was in New York for several days shortly after his release from several Massachusetts jails. He was not a particular success in New York, but outside he did very well, and made money rapidly. In his journey around the world he has succeeded in adding to his pile rather than lowering it, and as he turns up in Boston with \$5,000 in hand, he will have another \$5,000, the aggregate of the wagers made on the success of his exploit.

Now that he has practically won the identity of Jones is disclosed. His name is E. C. Pfeiffer and he is a well known Harvard man. He was at one time captain of the Harvard crew and was a member of the class of '89. He rowed in the freshman crew against the Columbia freshmen and the next year pulled No. 4 in the "Varsity" against Yale. He was captain in his senior year. He is an athlete, stands six feet high and describes himself as "a sure winner."

Here is his own story of his trip around the world and of the way he came to make it, as he told it to "me the other day."

"When I left Harvard I joined the Boston Athletic club. I was sitting in the club one evening with a group of men when the expense connected with a trip around the world became the topic. Two Americans had just made the trip and their expenses had amounted to \$8,000 apiece. I expressed the opinion that a man ought to be able to start on such a trip with nothing and make money.

"One of the party asked me if I could do as much. I said I thought I could. Then several wagers were made that I couldn't do it. In all \$5,000 was staked, and the agreement was that I was to be put into a room, my clothes taken from me, and in one year I was to travel around the world and make, including my expenses, \$5,000. One day in February, 1890, I was put into a room. There was nothing in the room. My clothes were taken from me.

"Several newspaper men heard of this and came to the room. They knocked for admittance. I said they could come in, but I must charge them a cent apiece. They paid their cents. A committee was in the room to see that the start was fair and according to agreement.

"I paid one of my visitors a cent to buy me a paper.

"With the paper I made as much of a suit of clothes as possible. At any rate it enabled me to talk more freely. Other persons kept coming and the men who had paid a cent to come in paid me ten cents to get their original cents back. They thought there might be luck in them. In this way I got a dollar or so, and sent out and bought some manilla paper. With this I made a suit of clothes. I stuck it together with gum, for which I paid a cent.

"Then I went to a clothier, told him about my plans, and asked him if he had a proposition to make. He offered to let me have a suit of clothes if I would exhibit myself in his shop for a day. I accepted. The newspapers wrote me up and I soon found that I could make money by exhibiting myself.

"I was hired by proprietors of various kinds of business to work for them. Some paid me \$25 a day for three days. I have got as much as \$200 a week. I traveled over a great part of the United States. I exhibited my paper suit everywhere. I rode on bicycles and was paid for it by the manufacturers. I sailed for Liverpool on the Umbria and sold some of my photographs on board.

"I was introduced to the representative of an English banking syndicate, who took a liking to me and hired me as interpreter for a trip through Germany. We went to Hamburg, spending one week, thence to Berlin for three days, thence to Leipzig, and finally to Innsbruck, where we remained one day. Here we parted and I dropped into Switzerland."

"Only a short time was spent in Switzerland and the round the world tramp was soon in Naples. Here he went on ship-board and plunged into the Mediterranean. One Thanksgiving day he was puffing down the Suez canal, and ate his dinner in full view of a crowd of fleet footed Arabs that ran along by the side of the boat.

"In Japan he had an experience that for a time ruined his prospects. He reached that country during the New Year's festivities, which last week, and as a traveler has to use a passport was hampered by the failure to get the signature of the necessary officials. He supplied by American nerve the Japanese signature, but at Kyoto was held under suspicion as a spy against the government. As good fortune would have it, he encountered at the right instant a Japanese, now an official, who had been educated in Boston, and he straightway released him from his predicament.

"Of his trip, as almost completed, Jones says: "On my trip I have found men of all nationalities who have seen printed in their native tongue some account of my undertaking. I have found that my attempt to become an outcast, a wanderer on the face of the earth, in an endeavor to escape from the banishments of modern civilization has been a failure, for everywhere, in varied languages and with an infinitude of accent, I heard the children sing 'Ta-ra-ra, boom-de-aye,' and the old folks in all hours of the day and night exercising their voices with the strains of 'After the Ball.'"

THE NEW MILLINERY.

Hats to Transcend All Their Predecessors for Screen Purposes This Season.

Straw hats which will not be needed for weeks to come have already appeared in the shops in all sorts of fantastic shapes, large and small, high and low crowns, and mostly made up with a rim of one color and a crown of another. There is a new straw called satin, which is very glossy and pliable, like baby ribbon, and is used for rosettes as well as plaits. Some of the straws are shot with different colors, like the Leghorn hats with ostrich feathers and lace are to be worn again.

Many of the hats are immense in size, and assume a sort of square shape, and flowers, feathers, lace, velvet, and glittering ornaments are used in their trimming. Roses are the favorite flower in Paris, and more foliage is used this season than ever. Several close rosebuds, massed together in an upstanding bunch, rising from a bunch of bright green leaves, is a favorite arrangement. Rims of hats are covered with frillings of silk, chiffon and braid, and crowns are made of tiny straw wings.

Great width is given to hats and bonnets by widespread bows directly in front, and wings of chiffon wired into shape and covered with sequins are to be used more than ever.

Large airy black lace hats are a feature of the new millinery. One startling combination has a black lace rim and a crown of gold and black from which roses in varying dahlia tints spread out among the hoops of wide dahlia satin ribbon which extend out at either side in front, and are further softened by black lace edging. The backs of the hats are trimmed broad, like the front, and large rosettes of lace and velvet are seen on one hat, with a cascade of roses falling at the back.

Boat shaped hats are here again, but they are transformed by a frill of lace, which is wired and made to extend over the brim, and masses of flowers are arranged just above the ears.

A lace in white and cream, which resembles Brussels applique, is a specialty in millinery, and every shade of red, from the palest to the darkest ruby, is to be worn, while violets will continue in favor. Bonnets are made entirely of loops of jet prettily mingled and brightened by flowers placed directly in front.

With broad bows at the back of our hats, broad bows in front, such upstanding aligrettes on the crown, the new hat will transcend any of its predecessors for all screen purposes.

Shirt waists continue to multiply in variety and besides the regulation Chamberly waist with the stiff turn over collar, there are dainty ones of dotted Swiss, striped with a color and made with the soft draped band at the neck, which can be replaced by one of satin ribbon.

Passed Him Off as McClellan.
