

EXPECT SWIFT JUSTICE

Summing Up in Trial of Heron, Charged with Murder of Metuchen Preacher.

VERDICT LIKELY TONIGHT.

But Two Days Consumed in Disposition of Case Against Prisoner—The Lawyers Are Now Summing Up.

Before night is its generally expected Archibald Heron, of Metuchen, will be found "guilty in the first degree" in the Middlesex county court, at New Brunswick, where he is on trial for his life for killing Rev. B. B. Prickett, a retired Methodist minister at Metuchen some few days ago. All morning the witnesses for the defense were examined, mostly saintly experts. Mrs. Heron, the wife of the prisoner, at first refused to go to court to testify in her husband's behalf but later consented to do so. An automobile was sent to Metuchen for her but on the way she fainted. When revived, Mrs. Heron absolutely declined to go to court. The lawyers in the case are summing up this afternoon.

Dr. William E. Ramsay, of Perth Amboy, testifying for the defense, yesterday, swore that Heron is an alcoholic paranoiac, and that, in his opinion, the man has been insane for the past two and a half years. Justice James J. Bergen, who is presiding at the trial, would not permit the physician to give this testimony until he had qualified by telling of the examination which he had made of the murderer.

Dr. Ramsay said that he had spent an hour and a half with the prisoner, and had examined him physically, and had also questioned him. Heron had told the doctor that he had been mesmerized by the Rev. Dr. James G. Mason, the Rev. Mr. Prickett, George Bennett and other members of the Masonic order in Metuchen. These men, he had declared, were forcing women into the Masonic order, and had taken his wife from him and forced her to join the order. Women who refused to join the order, the murderer had said, were taken to the Presbyterian church and abused. He claimed that he had heard them cry out at the meetings.

Heron had told the doctor that once he had been ordered to go to Newark to investigate a Masonic order there and that he had written down to find out about the doings. He said that he had told the Rev. Mr. Prickett all these things, but that didn't stop the persecution.

Says He Was Mesmerized.
On the day that he shot Mr. Prickett, he claims that he met the Rev. Dr. James G. Mason on the street and that the doctor made a lot of passages with his arms in the air, which had mesmerized him and had impelled him to shoot Mr. Prickett. Dr. Ramsay was on the stand at adjournment for the day and he was cross-examined this morning. His testimony was listened to by Dr. Britton D. Evans, of the Morris Plains Asylum, and Dr. Frank M. Donohue, of New Brunswick, who are to be called in rebuttal by the State. The State's doctor took notes of Dr. Ramsay's evidence freely.

The State did not produce any unexpected evidence, simply following the actions of Heron for months, showing that he had told many people that he intended to kill Mr. Prickett, when recorder of Metuchen, had sent him to jail for thirty days for being disorderly, and the prisoner had been talking of that sentence for the past two years and threatening to get even. Charles N. Prickett, the grandson of the murdered minister, was the only eyewitness to the murder. He saw Heron shoot and saw his grandfather fall.

The defense did not attempt to deny the shooting. Judge C. T. Cowenhoven, counsel for the prisoner, in opening for the defense yesterday afternoon, said: "We do not deny that Heron fired the fatal shot. If this man Heron, in cold blood, deliberately took the life of that man, the law will fix the penalty, and justly. Heron may have fired the shot, but we deny that at that time he was Archibald Heron himself. We shall show that he has not been endowed with all the powers of reason. On that day he was morally and legally irresponsible—unable to discriminate between right and wrong. He had no knowledge or conception of the result of his act. The fact that he brooded over what he thought to be unfair treatment and that society was against him, preyed upon his mind, and he knew not what he did. Banish all prejudice and feeling, and do unto this man as you would have him do unto you."

Thomas Horn and Patrick Gafney, who had known Heron for some time, said that they had often heard him complain of his treatment, but

GANNUZZI FINED \$20; WILL APPEAL HIS CASE

Fined \$20 by Recorder Dolliver at the session of North Plainfield police court, last night, John Jannuzzi, the Italian whose fruit store on Somerset street was raided as a "speak-easy" and disorderly house by Chief Marshal Weiss, Sunday afternoon, will apply through his counsel, Francis J. Blatz, for a writ of certiorari to take his case to the Supreme Court at Trenton. Jannuzzi pleaded not guilty at his hearing last night and George Monck, a witness, testified that there was no disorderly disturbance in the place, no swearing or bad language and that the men did not seem to be drunk. The borough judge, following out North Plainfield's stern policy toward "speak easies," imposed the maximum fine, which Jannuzzi paid.

The writ of certiorari will be secured on a recent decision at Atlantic City that penalties for disorderly houses must be by indictment and that a prisoner cannot be tried under a city ordinance. The five men arrested by Chief Marshal Weiss in the raid Sunday were fined \$2 apiece at a hearing yesterday morning.

"Tuck" now runs with the Westfield hose wagon, paired with a sorrel, and the action of the pair has been highly praised. The horse is the better of the pair of greys, but the other horse, "Nip," broke his ankle and had to be shot several months ago. "Newt" and "Sam" were purchased by the borough shortly after "Nip's" death, and the sale of "Tuck" was in accordance with a motion passed at the last borough Council meeting.

MARTINE IS IN HARNESS

Farmer-Orator to Whoop it Up for Bryan and Kern in Jersey and Elsewhere.

HE WON'T ACCEPT AN OFFICE.

Our Jim Never Would Be An Appointee and Now Refuses to Become a Candidate Before Voters.

From all parts of the State, to say nothing of foreign parts, James E. Martine is receiving invitations to speak at Bryan rallies. In this Presidential campaign, Mr. Martine says he will confine himself to the Eastern States, having been convinced, he says, that the West is plentifully supplied with stump speakers of the best kind. "I will be kept busy, much to my delight," said Mr. Martine today, "from now on until Mr. Bryan's election takes place. On Saturday night, August 8, I will address a party organization in Newark. On the following Wednesday I speak at Lake Grinnell, Sussex county, where a farmers' reunion will be held. I will be right at home with those people for I am a farmer myself. A little later I will tell the good people of Hunterdon county the virtues of Mr. Bryan, having been invited to speak at the farmers' reunion at Flemington. My services are at the disposal of the State and National committees and I assure you that I will do all in my power to help the Triumphal Democracy which will see a realization of its efforts on Nov. 3.

"All this talk about my accepting a position under Mr. Bryan is pure rot," continued Mr. Martine. "I have repeatedly said during the forty-five years that I have fought in the ranks that I would never accept an appointive position. If the people want me for office, they will say so. As yet they have not been of that view although in this Congressional district they came mighty near saying so three years ago."

WELCOME HOME FOR FATHER J. J. ZIMMER.

Rev. Father J. J. Zimmer, of Raritan, is expected to arrive home from a trip of several months abroad, Thursday night, and plans have been completed to tender him a big reception. PRESBYTERIANS WIN CUP

Have Most Points, Though Crescent Ave. Players May Win Tournaments.

FINALS IN S. S. A. L. TENNIS.

First Presbyterian Tennis Players Will Get At Least 18 Points While Crescent Avenue Church Can't Exceed 16 1/2.

While Albert D. Beers is picked as the winner of the Sunday School Athletic League tennis tournament in singles, and he and his team mate, Monroe H. Long, of the Park Club, are considered probable winners in the doubles, the First Presbyterians will be awarded the league cup for winning most of the matches in the two tournaments. Eight Presbyterian players entered in the singles and three teams from that church in the doubles and now, with both tournaments in the last rounds, the Presbyterians have a total of fourteen points, with a certainty of four more, having runners-up in both tournaments. The Crescent Avenue church, represented by Beers and the Beers-Long team, still in the play, had six players in the singles and three teams in the doubles, and has a point score of 10 1/2, which cannot exceed 16 1/2 points. This gives the trophy to the Presbyterians, for no other Sunday-school is within striking distance. The winners in the singles and each member of the winning team is the doubles will each receive silver medals, and the runners-up in each tournament will receive bronze medals.

The singles tournament will probably be concluded this afternoon, when Arthur Dunning has a match arranged with Beers. Dunning trimmed R. D. Rice in straight sets at the Park Club yesterday afternoon, the scores being 6-3, 6-3. In the doubles F. O. Dunning and Chauncey Murphy have reached the final round, and will play the winner of the match between A. and W. Dunning and Beers and Long still unplayed in the semi-finals. The tournament will be finished this week. An unfortunate feature of the tournament this season has been the number of defaults made necessary by the inability of the teams or players in matches to get together within the prescribed number of days. In one case, a misunderstanding and the delayed transmission of a telephone message made it necessary to split a point. This was in the match between Slocum and Daniels and Powlson and Miller, where each team was awarded half a point.

Points are awarded in each tournament to the team or player winning a match. One point is awarded for each match, except in the semi-finals, when no points are awarded. The winner of each tournament makes three points for his church and the runner-up, two points. The scores to date, singles and doubles added together, to determine the cup standings, are as follows: First Presbyterians, 14; Crescent Avenue, 10 1/2; Congregationalists, 5; Seventh-Day Baptists, 4; First Baptists, 3 1/2.

FAIR ACRES CLUB PLANS RACE MEET FOR AUG. 6

The Fair Acres Riding and Driving Association met in the Iroquois Hotel parlors last night and arranged for a matinee race meet at the Driving Park on Saturday, August 6. The card will include one running event and four trotting and pacing, valuable prizes being offered for each.

In the others, three heats will constitute a race and prizes will be given as the horses stand in the summary at the end of the final heat. The committee has received assurance from all the prominent horse owners in this section that they will have entries.

It was decided at the meeting to charge an admission fee of twenty-five cents in order to meet the cost of prizes and other expenses. The payment will entitle all comers to a program and a seat in the grand stand.

BEER PUTS OUT A FIRE

Hen. Lewis' Pail of Soda, Judiciously Applied, Kills a Threatening Blaze.

SAVED MARTHA ROGERS' HOME.

Chief Doane's Men and a Bunch of Apparatus Reach the Scene After the Trick Had Been Accomplished.

The Prohibitionists who assert that beer has no other mission on earth beside furnishing cases for the police court, will have to go way back and sit down after an occurrence that took place on Madison avenue this afternoon. If it hadn't been for a big can of the German Joy, Martha Rogers' home in the rear of the old Alert horse company house might have been in ruins by this time, as it was applied so judiciously that it killed an incipient fire that was getting real sassy. Water was applied a little later but the beer deserves all the credit for stopping the flames in their hungry search for more fuel.

Thomas Bowzer, the East Front street barber, was standing in the alley adjoining Mrs. Rogers' home when he noticed smoke pouring out of the windows. He noted that no one was inside so broke open a door to locate the trouble and found a small blaze in a pile of rags near the wall. The flames were also creeping up some loose wall paper. Bowzer immediately jumped back to escape the dense smoke and yelled "fire" with all the strength of his lungs.

It was at this point that the beer appeared on the scene. Henry Lewis had purchased it only a few minutes before and was on the way through the alley to find a cool spot wherein to enjoy it. The exact quantity is uncertain but Hen says he paid fifteen cents for what was in the can. At any rate, when he heard Bowzer's cry of distress it occurred to him that the Widow Rogers' home was of more importance than his thirst; so he decided on the instant to hand up the amber liquid.

"Here Tom, take this," he shouted, and the beer was held out. Bowzer didn't stop to see what it was but let 'er go. Swash—it went squarely into the bundle of burning rags and the way the blaze sputtered showed his aim had been true. There was a small quantity left after the first ker-souse and the remainder was slapped against the flames making a tour of discovery up the wall.

There is little more of importance to tell about the fire. Somebody else heard Bowzer's call for assistance and turned in an alarm from box 12 but when Chief Doane, six pieces of apparatus and twenty men arrived on the scene they found that fifteen cents' worth of saloon soda had accomplished what they turned out for. As a matter of precaution, some water was thrown in the house and about nine bales of rags were pitched out doors by the firemen.

Chief Doane conducted an investigation but was unable to learn what started the blaze. Mrs. Rogers had been away from home all morning and her daughter was visiting somewhere in the neighborhood. The damage was trifling.

It was stated after the excitement had died down that the owner of the place had given Hen Lewis thirty cents for a double size can of beer and stands ready to repeat the dose for the next thirty days.

DROGS HIM THROUGH STREET.

Says Newark Man Is Her Husband.

Who Left Her Eight Years Ago.
Mrs. Annie Katz, of No. 66 St. Mark's place, Brooklyn, created much excitement at Broad and Market streets, Newark, last night, when she dragged a man she says is her husband through the street and handed him over to a policeman. The woman insisted that her prisoner be locked up on a charge of desertion. The man said he was Hyman Katz, a tailor, having a wife and children at No. 541 Bergen street, Newark.

Katz denied that the woman was his wife, and he was paroled until this morning. The Brooklyn woman said that eight years have elapsed since she last saw Katz. She added that only recently she learned her alleged recreant spouse was living in Newark. For several days the woman haunted the tailor shops in that city, and was on her way home after a day's fruitless search when she accidentally met the object of her eight years' search.

Mraving Boomed By Rector.

A boom has been started by Dean Gessner for Dr. Victor Mraving for Mayor of Elizabeth. The physician, who for six years was a Republican Alderman there, has been in the field for some months as a candidate for the Republican nomination for Mayor, and seemed to be in the lead among the aspirants.

BOWERS AND ROGERS HELD FOR GRAND JURY

Martin Rogers, the second participant in the affray at Third and Church streets on July 18, was arraigned before Judge Runyon this morning. He waived examination on a charge of assault and was held in \$100 bail for the Grand Jury. The amount was furnished.

Contrary to expectation, no hearing of the case was held today as Ira Bowers, Sr., who appeared in court yesterday morning and claimed to be ignorant of why he should be arrested, changed his attitude within a few hours. He presented himself before Judge Runyon yesterday afternoon and offered a plea of not guilty to atrocious assault. The bail of \$500 imposed earlier in the day was made permanent and the entire matter will now be heard by the county authorities.

Rogers was discharged from the hospital yesterday afternoon. He is still suffering from three knife wounds inflicted by Bowers but will be able to return to work within a few days.

BOHAN YOUTH HELD FOR TRIAL TOMORROW

Elmer Bohan, the eighteen-year-old young man who broke into H. C. Corsa's home and stole \$20 and then confessed other thefts, was given a preliminary hearing in the city court this morning. At the request of his counsel, George W. V. Moy, the matter was adjourned until tomorrow and the defendant was released in \$50 bail. The amount was furnished by his father.

The police have followed up their investigations commenced directly after Bohan's arrest and have learned that he has been guilty of wrongdoing for the past three years. Beside the robberies at the homes of Mr. Corsa, James R. Knowlton and James Moran, which he has admitted, he consistently pilfered desks at the Plainfield High School and the clothing of members of the Y. M. C. A. left in the gymnasium lockers. He had long been under suspicion at the school but nothing was said in public for fear that a mistake might be made. Chief Kiely and Detective Sergeant Flynn have four other robberies to which they believe he committed but he has not acknowledged them as yet.

The parents of young Bohan are highly respected and enjoy the full confidence of all who know them. The father is bookkeeper for A. M. Griffin.

FOOLISH JOKE INJURES TWO OWL CLUB MEMBERS

As a result of a so-called practical joke played by a number of Plainfield young women, two members of the Owl Club, the local organization enjoying cottage life at Lake Hopewong, are laid up with badly inflamed eyes. The trouble seemed very serious yesterday and the victims had to be treated by Dr. Derry, of Dover.

The club gave a house party and dinner over Sunday to about thirty friends from Plainfield and North Plainfield. During the afternoon, while the guests were inspecting the cottage, several of the young women watched their opportunity and sprinkled red pepper on the pillows, and in the beds belonging to the Owls' outfit. None of them suspected anything was wrong when they retired at night but in a very few seconds the pepper got in its work and all were more or less affected by it. There was very little sleep for any of them afterwards as those who recovered quickly spent their time planning revenge on the perpetrators of the trick.

All but the two members mentioned had gotten rid of the pepper by yesterday and they will probably suffer for several days yet. The physician who treated declared that the affair might have resulted seriously.

Gives Her Pet Dog a Formal Burial.

Bob Roy, an Irish setter, which belonged to Miss Mabel Olmstead, of Morristown, died on Saturday at Spring Lake, where Miss Olmstead has a summer cottage. The dog's body arrived at Morristown yesterday in a sealed coffin and was buried in the dog cemetery on the Olmstead place. Miss Olmstead accompanied the body to the grave and sprinkled earth on the box as it was lowered. There are a number of other graves in the cemetery of Miss Olmstead's dead pets. She was for years at the head of the local Society for the Prevention of Cruelty to Animals.

A LIVELY TILT IN COURT

Chief Kiely and Lawyer Moy Argue Over Right to Confer with a Prisoner.

JUDGE RUNYON HAS TO DECIDE.

Police Head Declares Legal Light Tried to "Bull-doze" Him While Latter Declares He Acted Politely.

The customary quietude that attends the dispensation of justice at police headquarters was given a black-hand jolt this morning through a lively tilt between Chief Kiely and Lawyer George M. V. Moy. A difference of opinion between the two men as to whether or not the legal light had a right to interview a client, held a prisoner, led to a heated argument that was finally brought to Judge Runyon for settlement. His Honor granted Mr. Moy the privilege he asked.

The first round of the affair took place before court convened and there were only one or two witnesses. According to Chief Kiely, the lawyer came into his office and announced in a commanding way that he wanted to have a private talk with Elmer Bohan, the young man arrested for robbing the home of Henry Corsa. He was informed that the privilege could not be granted whereat, the chief says, Mr. Moy began "bull-dozing" him. A cross-fire of talk followed and the lawyer stated that he would ask no favors from the police head but would make application to the court.

When Judge Runyon took his place on the bench, Mr. Moy stepped forward and announced that he had a statement to make. He then told of the occurrence with Chief Kiely, concluding with the request that his right in the matter be established. The chief also related his side of the affair and added that the lawyer had tried to "bulldoze" him.

"Hump," exclaimed the latter, surveying the police official's figure and contrasting it with his own; "doesn't it seem rather preposterous for a man of my physique to come in and try to 'bulldoze' you?" The chief then went on to say that Mr. Moy was seeking advertisement by his appeal to the court and there was several minutes of rapid-fire conversation. Both men kept their tempers but the suppressed excitement was plain to the large crowd of spectators. In the end the lawyer was allowed to hold a conversation with Bohan before he was arraigned.

Mr. Moy was interviewed later in the day and stated that he did not propose to let the matter drop. "I have no desire to undermine the prerogatives of the chief of police," he said, "but I intend to have it made plain whether or not a lawyer has a right to go to headquarters and interview a client locked up. I understand that the same occurrence has happened before and it is time that something is done. I am seeking no advertisement as was implied but will have the proper authorities define the law."

"What about the statement that you 'bulldozed' the chief?" he was asked.

"I did nothing of the sort. When I first saw the chief I greeted him with a polite 'good morning,' and then stated that I wanted to talk to Elmer Bohan. He asked why I wanted to talk to him. I replied that I had been engaged as his counsel and wished to become enlightened on several matters before his case was called. He then asked what I wanted to talk to him and when I refused to say, I was informed that my request would not be granted. Soon afterward, in the course of the conversation, the chief implied that as a special favor I would be allowed to speak with the prisoner but I informed him that I was seeking no favors and would make application before Judge Runyon. As I went into the court room a little later, the chief followed me and said, 'you can see the man now.' This inconsistency is very queer. The fact that I was told one minute that I could not speak to Bohan and the next that I could is a very strange proceeding. I reiterated that I was seeking no favors and would let the court decide what I could do."

FROM BRIDGE INTO RIVER.

Four Occupants of Surrey Narrowly Escape Death.

Stamford, Conn., July 28.—Rotted by long usage, a truss timber gave away on the bridge over Rippowam river on Cold Spring road here yesterday morning and the horse and surrey of Louis D. Hopkins, a wealthy New Yorker, with business offices at 312 Madison avenue, went through it into the swollen river twelve or fifteen feet below.

In the surrey were Mrs. Tredwell G. Hopkins, her two-year-old son, William Burrell, the coachman, and John Clary, an employe of Mr. Hopkins. All were badly bruised, but not seriously hurt.

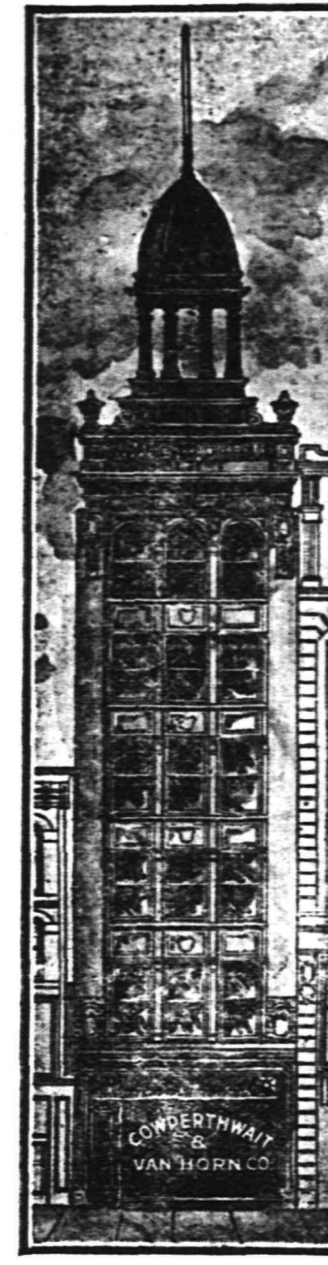

He denied making it, and declared that he swore at the chickens in German so that she might not be shocked at his language.

Mrs. Grinshaw said that she did not understand German, but that Kreuger's threat was made in choice English.

NAN PATTERSON IN FLIGHT ONCE MORE.

Leaves Pittsburg When Prominent Man's Wife Complains of Her to the Police.

Pittsburg, Pa., July 28.—Fearing that she was to be sent back to New York, Nan Patterson, the chorus girl who was tried three times for the murder of Caesar Young, several years ago, and who has since been making this city her home, has left here for parts unknown, following a conference with the police authorities.

In speaking of the matter yesterday afternoon, Acting Captain of Detectives Roche said:

"When Nan Patterson was brought in before me, she thought that she was to be sent back to New York, as she is only out on probation there during good behavior. She was very retired and quiet, and when I told her she would have to go she agreed to do so.

"The wife of a prominent man called up on the telephone, stating that the young woman had enticed her husband, and Nan Patterson promised to leave the city at once."

PRIEST ANSWERS DAVIS AS TO BISHOPS' LAW

Father J. C. MacErlain, who established the Sacred Heart parish, in Jersey City, and was active in the fight for the enactment and enforcement of the amended excise law, discussed yesterday the declaration of "Bob" Davis, the Democratic boss of Hudson county, that he would attack the law and would advocate an amendment that would permit the saloons to do business on certain hours on Sunday.

"No one regrets it more than the friends of Mr. Davis to find him assuring such an untenable attitude on the question of law and order in Jersey City," he said.

"Has not Mr. Davis made it the issue for the next shrewdly campaign?" was asked, and Father MacErlain, after a momentary pause, exclaimed, with warmth: "Mr. Davis may be the guardian of Bryanism, but he is certainly not the guardian of the morality of Jersey City. If he has undertaken to attack and nullify the Bishops' law he has assumed a gigantic contract, a job that will land him where the last administration landed. For the sake of the present administration we regret exceedingly that Mr. Davis has come out of the West to array himself against the moral element. We are not politicians, but we are the guardians of the morals of the people, and, standing in the watch towers, will sound the alarm like faithful sentinels. We are for that which is right, and right will prevail; we shall not fail.

"If this be Bryanism or Davisism to encourage the violation of a law that every lover of good order admires and is ready to defend, we do not want Davisism or Bryanism. It is only a few months ago, so recent as to be within the recollection of everybody, that ex-Judge McCarthy attacked the Bishops' law from the bench before ascending to which he had taken the oath of office and sworn that he would uphold that law and do justice between man and man according to the principles of the law. On that occasion we defended the Bishops' law, and that was the beginning of the end of the last administration.

"We hope that this is not the beginning of the end of this administration, for so far we have great respect for many of the men who at present govern our city, but from not one of them shall we for a moment brook any interference with the Bishops' law as it stands at the present time."

POLITICAL NOTES.

United States Senator Briggs is in Cincinnati to attend the notification ceremonies incident to officiating advising William H. Taft of his nomination for president, which are scheduled for today. Senator Briggs is the New Jersey member of the committee on notification. He will return home Thursday.

The Cranford Taft and Sherman Republican Club has been formed with 100 members on the charter roll. The executive committee has been empowered to procure permanent headquarters for the club and the club has decided to raise a Taft and Sherman banner over North or Union avenue opposite the station in Cranford.

The Taft and Sherman Republican Club, of Cranford, has pledged its support to Assemblyman Carlton B. Pierce and decided to recommend to the county his renomination and election to represent Union county in the Assembly. The club has decided to join the Union County League of Republican Clubs and delegated Secretary Austin to attend the meeting of the league at Elizabeth next Friday evening.

Former United States Senator Jas. Smith, Jr., who as a delegate-at-large from New Jersey to the Democratic National convention refused to vote for the nomination of William J. Bryan, announced yesterday that he would support the Democratic candidates. Mr. Smith said: "I will do all in my power for the success of the ticket endorsed by the Democratic convention at Denver. I believe that Mr. Bryan has an excellent chance of being elected, and New Jersey will work for his election."

Ex-Mayor Joseph P. Riordan, who was removed from office last November at Harrison, decided yesterday to become a candidate for election at the coming campaign in Harrison. Both times that he was made mayor he was nominated by the Democrats and endorsed by the Republicans. Councilman John J. Daly was elected to succeed Riordan to fill out the unexpired term.

Black Hands in State Prison.

Michael Filosetto, John Cery and Antonio Natelli, the Italians recently sentenced at New Brunswick to twelve years for sending Black Hand letters to the Rev. Augustino Dasso, of Franklin Park Station, were taken to State prison yesterday. Their counsel, H. B. Cook, has taken out a writ of error, and he held that this acted as a stay and that the Sheriff had no right to remove the prisoners, but the court overruled him, as it did a few years ago in the writ of error taken for Frank Cordova, the unfrocked minister.

FORT GIVES PRAISE TO GENERAL COLLINS

Governor Fort has sent the following letter to General Collins: "Brigadier-General Dennis F. Collins, Commanding Second Brigade, N. G. N. J., Sea Girt.

"My Dear General Collins—With today your service in camp will have ended. It has been a delight to have you and your staff here. The review last Saturday of your brigade was a most satisfactory one, and it was my first opportunity of seeing a brigade review. I greatly enjoyed it and appreciated the pleasure of having my first review with you.

"The battery, troop and both regiments of your brigade in camp have been a credit to you and to the State. The discipline and bearing of the men evidenced close watchfulness on the part of their commanding officer. The one thing especially gratifying to me was the spirit exhibited by the men in their work, and this only comes from a feeling of satisfaction on the part of the men with their superior officers.

"The two weeks in camp have impressed me greatly with the efficiency and usefulness of the National Guard, and that efficiency and usefulness, of necessity, are in a large measure due to the commanding officers.

"I congratulate you upon the appearance of your brigade, the splendid manner in which they have maintained discipline during their tour of duty in camp and their general soldierly bearing. Anything that I can do to promote the efficiency of the brigade or aid you in this matter personally, I shall esteem it a pleasure to be called upon to perform.

QUESTIONS PROPOUNDED ON INDUSTRIAL PROGRESS.

The New Jersey Commission on Industrial Education recently appointed by Governor Fort, and which started work only about two months ago, at its headquarters in Newark, has already got under way important work that promises to be of great value.

The commissioners are George R. Howe, of Newark, president; George G. Tennant, of Jersey City, treasurer; together with William A. Bembridge, of Roselle Park; John W. Ferguson, of Paterson, and Ferdinand W. Roebbing, Jr., of Trenton. Albert A. Snowden is the secretary.

The purpose of the commission is to make investigations that will lay the foundations for conditions under which the young people of New Jersey entering industrial pursuits will have a satisfactory training to fit them for the highest efficiency and success in life. Data is being collected showing the wages earned by those thrown into industrial occupations without any preliminary training and the wages of those fully equipped by proper industrial training.

Blank question sheets have been sent out to 2,400 of the leading manufacturers of New Jersey, some of these circulars coming to Elizabeth firms. They contain a series of twenty-one questions bearing on the subject of the efficiency of the workers. Other letters if inquiry have been sent to labor leaders and to labor organizations, in order to secure the point of view of employer as well as those of manufacturers.

The commission is preparing data to make clear the increased earning capacity brought about by industrial training. As the result of its investigations, the commission aims to suggest, not an elaborate scheme, but the next steps to be taken in the evolution of some comprehensive plans, such as has been carried out with striking success and benefit in many European States during the last fifty or a hundred years, especially by Germany and France.

REARDON KNOWN ON COAST.

Jerome's Detective Ran Police System at Long Branch.

Edward J. Reardon, county detective, whose resignation has been asked for by District Attorney Jerome, of New York, is well known in Long Branch among the summer cottagers. Until last fall he had a well-organized police force patrolling the beach front night and day, and maintained an office there, with telephone connection, all the year round.

Reardon's men acted independently of the local police, and incurred their enmity by their methods. Finally the authorities compelled Reardon to close up. Reardon's resignation was asked by Jerome because it was said he had a tendency to use his stick and revolver too freely.

Runaway Fatal to Woman.

Mrs. Rose Barunstein, 38 years old, of 663 Park avenue, Brooklyn, who was injured in a runaway in Linden Sunday night, died from her injuries in the General Hospital, Elizabeth. While Mr. and Mrs. Barunstein were out driving their horse was frightened by an automobile. The woman jumped, striking her head against a stone. Her skull was fractured.

HOTEL MAN SHOTS HIMSELF IN THE HEAD.

Frank Brubaker, proprietor of Sunset Lodge at Lakewood, shot himself through the head at Point Pleasant Sunday afternoon and died shortly after he was brought to St. James' Hospital at Lakewood. It is presumed that financial difficulties and the consequent worry had unsettled Brubaker's mind.

Since the close of the hotel season in Lakewood, Brubaker has been acting as freight agent for the Central Railroad at Keyport, N. J. Sunday he left Keyport for Point Pleasant, presumably intending to drive across from Point Pleasant to his home at Lakewood.

Instead, after leaving the Point Pleasant depot, he wandered off from Arnold avenue into a bit of woods, sat down under a tree and sent a bullet crashing through his brain. The deed was seen by a young woman, Miss Clark, who ran screaming for help. Dr. Edwin H. Middleton was near and he placed Brubaker in an automobile and hurried him to the hospital at Lakewood.

Brubaker was 52 years old and leaves a wife and two children, one a babe in arms and the other half-grown. He was formerly in well-to-do circumstances, but is known to have worried lately over his financial difficulties.

MGR. FOX INDORSED.

Judge Lanning Also Condemns Public Marriages.

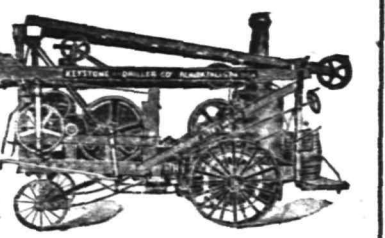
United States Judge William M. Lanning, president of the Inter-church Federation of Trenton, embracing all of the Protestant churches of Trenton, yesterday indorsed the position taken by Monsignor John H. Fox, vicar-general of the Catholic diocese of Trenton, who Sunday preached a scathing sermon against a public marriage arranged as a drawing card at a summer park owned by prominent society men.

Judge Lanning declared yesterday that while the Protestants do not regard marriage as a sacrament of the church, as do the Catholics, he held that common decency should forbid such public ceremonies as proposed by the park management. Judge Lanning was one of the New Jersey commissioners to the uniform divorce congress, held a few years ago, and he has made an extended study of marriage and divorce.

AMENDMENTS PROPOSED TO THE CONSTITUTION OF THE STATE OF NEW JERSEY BY THE LEGISLATURE OF 1908.

SENATE CONCURRENT RESOLUTION NO. 6.

STATE OF NEW JERSEY.

Be It Resolved (the House of Assembly concurring). That the following amendments to the Constitution of the State be and the same shall be agreed to by a majority of the members elected to the Senate and the House of Assembly, to be published in their journals, with the yeas and nays thereon, and referred to the Legislature next to be chosen, and published for three months prior to the first Tuesday after the first Monday of November next, at least one newspaper of each county to be designated by the President of the Senate, the Speaker of the House of Assembly and the Secretary of State, payment for such publication to be made by the Treasurer on the warrant of the Comptroller.

SECTION I.

First—Strike out Paragraph 10 of Section VII of Article IV, and insert in place thereof the following:

2. Elections for members of the Senate and General Assembly shall be held every two years on the first Tuesday after the first Monday in November, beginning on the first Monday of November, and every second year thereafter; and the two Houses shall meet separately on the second Tuesday of January of each year, at which time of meeting the legislative year shall commence.

SECTION II.

1. The Senate shall be composed of one Senator from each county in the State, elected by the legal voters of the counties respectively, for four years, to be chosen on the first Tuesday of January, and in place thereof.

ASSEMBLY CONCURRENT RESOLUTION, NO. 4.

STATE OF NEW JERSEY.

Be It Resolved (the Senate concurring). That the following amendment to the Constitution of the State be and the same shall be agreed to by a majority of the members elected to the Senate and the House of Assembly, to be published in their journals, with the yeas and nays thereon, and referred to the Legislature next to be chosen, and published for three months prior to the first Tuesday after the first Monday of November next, at least one newspaper of each county to be designated by the President of the Senate, the Speaker of the House of Assembly and the Secretary of State, payment for such publication to be made by the Treasurer on the warrant of the Comptroller.

SECTION I.

Second—Change Paragraph 10 of Section V so to read as follows:

The Governor or person administering the government, and four citizens of the State appointed by the Governor, shall constitute the Board of Pardons. The members of said Board or any three of them, of whom the Governor shall be one, may remit fines and forfeitures, and may grant and pardon, after conviction, in all cases except impeachment. The four members, appointed separately for five years, and receive for their services a compensation which shall not be diminished during the term of their appointment.

SECTION II.

The judicial power shall be vested in a Supreme Court, County Courts and such other Courts as may be established by law, which inferior Courts the Legislature may alter or abolish as the public good shall require.

Fourth—Strike out all of Section II, IV, V, VI and VII of Article VI, and insert in place thereof the following:

Any Judge of any of the Courts of the State may be removed for disability continuing for one year, or for refusal to perform the duties of his office, by a vote of two-thirds of all the members of the Senate and of two-thirds of the members of the House of Assembly, sitting separately, after a hearing before both Houses in joint session.

1. The Supreme Court shall be organized in three divisions, namely: the Appeals Division, the Law Division, and the Chancery Division. The Appeals Division shall consist of a Presiding Justice of the Appeals Division, who shall be styled the Chief Justice, and a Presiding Justice of the Chancery Division, who shall be styled the Chief Justice of the Chancery Division, and eighteen Associate Justices, which number may be increased by law.

2. The Appeals Division shall consist of the Chief Justice, and six other Justices of the Supreme Court to be assigned by the Governor, and the Law Division shall consist of the Chief Justice of the Law Division, and six other Justices of the Supreme Court to be assigned by the Governor, and the Chancery Division shall consist of the Chief Justice of the Chancery Division, and six other Justices of the Supreme Court to be assigned by the Governor.

3. 4. Four Justices shall be necessary to constitute a quorum on the Appeals Division, but the Supreme Court may provide by rule for the making of interlocutory orders by a lesser number of Justices, such orders to be subject to revision by the Appeals Division.

5. On the hearing of a cause in the Appeals Division, no Justice who has given a judicial opinion in the cause in favor of or against the judgment, order, or decree, shall be eligible to sit at the hearing to review such judgment, order or decree, but the reasons for such opinion shall be assigned to the Court in writing.

6. A majority of all the members of the Supreme Court, to be prescribed by the Constitution, shall constitute a quorum for the assignment of Justices, and for the appointment of officers, and for the amendment of rules.

7. The Supreme Court shall appoint one or more reporters, not exceeding three, who shall be styled the Reporter of the Supreme Court, and shall by rule define his or their duties and powers. The reporters shall hold office for five years, but may, however, be removed at the discretion of the Court.

8. The Appeals Division shall have and exercise the appellate jurisdiction heretofore possessed by the Court of Errors and Appeals, and such jurisdiction on writ of error, and the jurisdiction heretofore possessed by the Ordinary on appeal, and such further appellate jurisdiction as may be conferred upon it by the Legislature.

9. SECTION VI. The County Courts shall have and exercise such jurisdiction within the county such original common law jurisdiction concurrent with the Supreme Court, and such other jurisdiction heretofore exercised by the Courts of Common Pleas, Orphan's Courts, Courts of Oyer and Terminer, Quarter Sessions, or other Courts thereof, shall be exercised by the County Courts pursuant to rules prescribed by the Supreme Court of the County Courts. All other jurisdiction of the County Courts shall be exercised by the County Courts, Judge or magistrate until the Legislature shall otherwise provide.

SECTION VII. This amendment to the Constitution shall not cause the abatement of any suit or proceeding then pending when it takes effect. TRUE DETECTIVE STORIES

FROM THE ARCHIVES OF THE PINKERTONS

Meanwhile Mr. Pinkerton discovered that the story told him by Proctor was entirely untrue. So far from having been an honest man before the robbery, it came to light that he was already at that time a hardened criminal, having committed burglaries both in the United States and Canada, and having been sentenced under another name to a term in the Massachusetts state prison. While in prison he had contrived to make keys that would unlock his own cell and those of three other prisoners, and the four had thus made their escape. One of them was the notorious Charles Burdard, who was at that time serving a term of 20 years for the robbery of the Boyiston bank of Boston. Proctor had also offered the privilege of escape to Scott and Dunlap, the Northampton bank robbers, who were confined in the same prison, but they had distrusted his plan, and refused to avail themselves of it.

It was now necessary for the detectives to devise a new plan. Robert Pinkerton knew that some three years earlier Donahue had been concerned in the robbery of a bank at Winnipeg, and also in the robbery of a hardware store at Quebec. His brother, William Pinkerton, he also knew, had a personal acquaintance with Donahue, from having arrested him a number of years before. He therefore sent for William Pinkerton to come to New York from Chicago, and on his arrival requested him that he go to Fort Erie, get an interview with

Donahue, and tell him of Proctor's treachery in betraying Collins and himself; impress upon him that Proctor was a dangerous man to have dealings with; and try to induce him to lend his aid in delivering Proctor and Collins over the line, just as Robert Pinkerton had sought to have Proctor do in the case of Donahue and Collins. Donahue was known as a "stanch" man—that is, one who is true to his friends—and it was thought probable that he would refuse to take part in any such scheme. But in that event William Pinkerton was to threaten him with arrest for the old robberies at Winnipeg and Quebec.

This plan was carried out by William Pinkerton with greater success than had been expected. At first Donahue stoutly refused to betray a comrade, but the danger threatening himself was made to appear so great that finally, seeing no other way out of his difficulties, he consented to do what was asked of him in regard to Proctor. Against Collins, however, he declined to give any aid. By working on Proctor's natural fear of arrest, he easily persuaded him that the immediate departure of all three of them—himself, Proctor and Collins—for Europe was advisable. It was arranged that they should not sail from Quebec or Halifax, since the steamers from those points were likely to be watched by detectives, but that they should leave Fort Erie stealthily by night, make their way separately to Montreal, and meet there.

This plan was carried out, and within a few days the three were in Montreal, all apparently of one mind in their desire to escape the country, though in reality Proctor was the only one of the three who thought himself in danger. Donahue had taken Collins into his confidence, and Collins was quite of Donahue's opinion that they were doing the proper thing in saving themselves by surrendering to a man who had shown himself willing to betray them.

It had been agreed between William Pinkerton and Donahue that at Montreal tickets should be purchased to Europe by way of Portland, Me., and that the party should leave Montreal at a certain time by the Grand Trunk road. The line of this road runs for a number of miles through northern

Vermont, and it was customary for the train the men were to take to wait over for an hour at Island Pond, a little place just across the Canadian line. Here, as it was arranged, Robert Pinkerton was to be waiting, ready to take Proctor into custody, and also (though in this part of the arrangement Donahue, of course, was not consulted) Donahue and Collins, should they be so imprudent as to stay on the train until it crossed the line. To the forwarding of this latter end, indeed, a special stratagem was resorted to. Conceiving that Donahue and Collins, in order the more completely to allay Proctor's suspicion, might remain with him until the last station was reached on the Canadian side, the detectives arranged that on this particular night the train should not stop at that station, but push on at full speed to the American side.

On a certain Tuesday night Donahue, Collins and Proctor took the 10:15 p. m. train at Montreal for Portland. No sooner had they left the station than a Pinkerton representative, who had "shadowed" them aboard, telegraphed the fact to Robert Pinkerton at Island Pond. Proctor went early to his berth in the sleeper. In another berth, not far distant, never closing his eyes through the night, but lying there fully dressed, with weapons ready, was a Pinkerton detective, whose instructions were to accompany the three robbers as long as they were together, and to stay with Proctor to the last.

GAMBLING CADDIES RAIDED.

Police Fire at Them on the Montclair Golf Links.

Policemen in an automobile raided crap-playing caddies employed on the golf links of the Montclair Golf Club in Verona late Sunday afternoon, and the men and women who were playing golf at the time witnessed the exciting chase, in which a number of shots were fired by the pursuing policemen. In the Silver Lake raid the pot was saved by a man who jumped out of the window and got away from the officers with the cash. At the golf links the officers confiscated the stakes, \$1.80.

had not heard him threaten anyone. Gafney said that Herron was all right when sober, but a "little off" when drunk. When he left the witness stand, he clapped his hat on his head and went over to Herron and shook hands with him.

Henry Williams, a negro, who had worked with Herron, said that the man had a sunstroke on Staten Island and a couple of years ago and had not been right mentally since.

Edwin Smith said that he had heard Herron talk about his alleged wrongs, but that he hadn't paid much attention to him.

Mrs. Herron, the wife of the murderer, was in court yesterday morning, having been subpoenaed by the defense. She saw her husband for the first time since the crime when he was led into court. She did not offer to say a word to him and did not meet his glance. She was very nervous during the State's case and when Herron was asked to stand up so that the county physician could demonstrate the position of Herron and the Rev. Mr. Prickett at the time of the shooting, she swooned away and had to be helped out of the court room. She was called as a witness yesterday afternoon, but did not respond, having been taken to her home.

The trial of Herron promises a new record for murder cases in New Jersey. The murder was committed July 15; Herron was indicted July 20; his trial commenced July 27; the jury held in twenty-five minutes; the State rested the first day; the defense will finish the second day and the case may go to the jury tomorrow afternoon.

WIFE-DESERTER ARRESTED.

Eloped With Young Girl; Accused of Theft by Father.

Prosecutor Koester has been notified by the police of Philadelphia of the arrest there of Victor Heyny, wanted in Hackensack for deserting his wife and an infant child and robbing his father of \$105. It is said he eloped with a seventeen-year-old girl named Rankin, of Jersey City. He declared his purpose to elope to Judson Rankin, the girl's brother, who said:

"A bully scheme. I am to be married to Eva Galloway, of Hoboken, and we will all four go together."

The quartet went to the office of Justice of the Peace O'Keefe, in Hoboken. Rankin and Miss Galloway were married there. Then the four fled to Philadelphia, where the two men were captured in a furnished room house yesterday. The young women, they said, had gone to Atlantic City for a day's outing. No attempt was made to bring the young women back. Heyny's father will prosecute him for the theft of the money.

Dean Gessner to Be Fort's Guest.

The Very Rev. Dean Gessner, rector of St. Patrick's parish, Elizabeth, who, as a witness before the State excise probers at Elizabeth last week, described the city government as "rotten," has been invited by Governor Fort to visit him at his cottage at Sea Girt. The dean will accept the invitation, and says he will lay before the Governor some interesting information as to the rebellion of the authorities in Elizabeth.

WHAT'S BEING DONE FOR BABIES OF THE POOR

That Plainfielders are taking great personal pride in the support of the King's Daughters' Baby Camp on the Watchung Mountains is proved by the fact that thus far this summer \$65.50 has been received for the fund annually raised by The Daily Press to help maintain the camp for babies and sick children of the city and borough. Yesterday afternoon a delegation of nine babies and the poor, tired mother of one of them was taken to the King's Daughters' Camp for a week's stay. Arrangements had already been made to keep eleven little children at the camp for another week, so there are now twenty-one in the "family."

The King's Daughters' Camp is situated on Johnston's Drive, a few minutes' walk from the end of the Somerset street trolley line and its work is entirely with the local poor. Although Plainfield is not a large city, there is considerable suffering each summer among the poor, especially the babies. The camp opened for the season July 19 and up to yesterday more than 500 have been benefited by week stays on the mountain. The "family" of babies, which is in charge of officers of the Organized Aid Society and Mrs. Bird, as matron, numbers between 30 and 35 a week.

Consistent work among Plainfield's poor is done the year round by the Organized Aid Society, of which Miss Margaret Holly is in charge. Miss Holly, with Miss Olive DeLany, the nurse, and Dr. L. S. Pockock, visit the homes during the summer and take to the mountain the most needy of the babies. If accommodations can be secured.

The babies have a good time at the mountain home. They spend the days in the sand-pit, in swings, hammocks, or being wheeled about the grounds. They eat good, healthful food as often as they are hungry and it takes ten quarts of milk a day to keep them happy. Another item is bread, and they consume seven loaves of that daily, not to mention considerable other food—all of which costs money. Their recreation taken by day, they sleep in the dormitory where twenty-four beds have been set up.

If "charity begins at home," a home charity should be especially supported. It is going to cost more than \$65.50 to run that camp during the summer, and to restore to health and strengthen for the winter months the babies of Plainfield's poor.

"A MEN'S CHURCH IS AS BAD AS A CLUB"

Claiming that the "men's church," in which husbands and fathers are allowed to smoke and loll in shirt sleeves, is too attractive, a score of wives have protested to the Rev. Sydney Goodman, pastor of the new idea congregation in Atlantic City, that their husbands would rather go to church than stay home. The protest took the form of a letter read before the male congregation by the rector Sunday night, but he refused to give out the names of the irate wives who made the protest.

"Church is all right for men but our husbands are staying out as late Sunday night to attend your service, as they do on lodge nights," said the letter. "We insist that some of the attractions be cut out or else the services be cut down so that they can get home in decent time."

So pleasant have been the weekly Sunday night meetings of the Men's Church that the men have insisted on the services being strung out longer and longer, with the fine program of music and singing interspersed with moving pictures, soft drinks and cigars, which latter have become an important part of the services. As a result of the protest, the meetings will be opened earlier next Sunday night, and will be halted at an hour which will allow of the men getting home before 10 o'clock.

Eight Eat Fried Rattlesnake.

Eight persons ate fried rattlesnake Sunday night at a Newton hotel. Those in the party were Mr. and Mrs. William Erb, Thomas Erb, Frank B. Allen, of Bernardsville; Mrs. C. J. White and the Misses Charlotte, Caroline and Augusta White, of Harrison. All say that the rattlesnake was palatable. The snake was killed early in the day by Mr. Allen as he was inspecting a farm near Lake Owassa.

Zastera Trial Delayed.

Alleging that he had been unable to get several material witnesses to court at Freehold to give testimony in the trial of Frank Zastera, indicted for killing William B. Sheppard, his wife and their servant, Jennie Bendy, at Marlboro on May 16 last, ex-Judge William P. Hoffman, of Jersey City, counsel for the prisoner, asked that the case be postponed until September 21 next. The motion was granted.

DOGS CAPTURE BURGLAR.

He Had Broken Into "Frat" House of Stevens Institute.

William Bastain, who claims to come from Portland, Oregon, was chased and captured early yesterday on the Castle Point grounds at Hoboken by two powerful mastiffs owned by Colonel Edwin A. Stevens. It was an exciting few minutes while the chase was in progress and Bastain was more than glad when William Robinson, manager of Colonel Stevens' stables, called off the dogs and took him into custody until the arrival of the police.

Robinson was reading when he suddenly heard the sound of crashing glass coming from the new "Frat" house on the northern edge of the Stevens Institute campus. He got on the job immediately and as he was crossing from the stables to the fraternity house Bastain leaped from a first-story window and started on a run across the campus toward Sixth street.

The big mastiffs were unleashed by Robinson in a jiffy, and with deep-voice bays took up the chase. Before Bastain had left the campus they were upon him. Both dogs have been well trained by Robinson and they did not bite Bastain, but simply held him until Robinson caught up with him. He was held by Recorder McGovern to await the action of the Grand Jury in \$1,000 on a charge of breaking and entering.

ROOSEVELT COMMENDED.

St. Patrick's Alliance Favors Scheme for Big Navy.

Paterson, July 28.—Delegates to the thirty-first annual convention of the National Council, St. Patrick's Alliance of America, which began at Paterson yesterday morning, were welcomed by Mayor McBride and Thomas A. Butler, of Roselle, national president, and other speakers made brief addresses. The annual report of the national council was read by William H. Smith, of Newark. Delegates were present from State councils to the number of about 250. Following a dinner tendered the delegates by the members of local district, No. 9, the afternoon session was begun. Reports were read, among them one by National Treasurer P. J. Hoxey, of Newark. James A. Grant, representative of the State council, and John Scanlon, representing Branch No. 4, of Newark, were among those present.

After the reports of committees were received by the chair, the report of the committee on resolutions recommended the adoption of a resolution favoring President Roosevelt's scheme for an increased navy. This resolution was applauded.

Bad Effects of Spices.

Although the use of spices for the purpose of heightening the flavor of food is almost universal, it is generally recognized that their influence on digestion is detrimental. Some experiments recently carried out tend to prove that, while spices stimulate the motor functions of the stomach, they progressively impair the secretory functions, and in the long run inhibit the production of hydrochloric acid. On the whole, therefore, the ingestion of spices hinders rather than accelerates digestion, though an exception may be made in respect of persons in whom slowness of digestion is due to a deficiency of muscular activity on the part of the stomach, and also possibly of the victims of hyperacidity.

Asbury Cottages Burned.

Fire yesterday afternoon practically destroyed two cottages in the west section at Asbury Park. It started in the dwelling at No. 602 Asbury avenue, owned by Benjamin Hacker, almost totally destroying it. The adjoining cottage, owned by H. S. Wilson and occupied for the summer by Henry Michaels, of New York city, was badly damaged. The loss will exceed \$6,000.

Scalds Wife With Soup.

Charged with throwing a kettle of steaming soup over his wife, John Slackley is a prisoner at police headquarters in Trenton. Mrs. Slackley is in a hospital, and is scalded so badly the physicians believe she will die. The wife says her husband became angry because she said the soup was bad.

Fire at T. A. Sullivan's Home.

A still alarm was received at Fire Headquarters at 10:30 this morning for a blaze at the home of T. A. Sullivan on Park avenue near Eighth street. It was between the walls on the second floor and was put out after about \$15 damage had been occasioned. The origin is unknown.
