THE END OF THE LEGGETT.—On Saturday morning, Thomas B. Leggett, Comptroller of the City and County of Rahway, was arrested by Sheriff Eliza and Daniel W. Lewis, acting Treasurer of the same city, for a violation of the law against conspiracy and similar crimes committed by them as officials, found against them by the late Grand Jury. The court-room was crowded. After the usual preliminaries, Prosecutor Fay moved for sentence, and the court requested explained some of the offenses in the indictments to which Leggett had pleaded not guilty. Mr. Lindbergh addressed the court in a plea for mitigation. After consultation with his associates, Judge Van Syckel addressed Leggett, stating plainly the enormity of the offenses of which he stood convicted. He then sentenced him to two years imprisonment on the indictment on which he was tried, and to one year each on five other indictments. On ten other indictments a sentence of \$250 fine each was imposed, and on a number of other indictments a fine of \$1 each, making a total of seven years imprisonment at hard labor and a fine of \$2,500, besides the costs of prosecution.
