





. Teachers and the Rahway Board of Education have come to what we believe to be an equitable and re-

_alistic wage settlement. Obviously, both sides cannot get everything they desire, because successful negodarions require compromise. It would appear both teachers and the board had enough sense to give in a little. The most gratifying part of the settlement was its two-year nature. The terms of the contract provide for a 61/2 per cent salary increase which includes The average teacher will receive \$070 increments. more salary in 1971-72 than he or she did in 1970-71. In addition, a cost-of-living prvision was agreed upon for 1972-73 to be based upon such a reliable source of salary statistical data as the Bureau of Labor Statistics, United States Department of Labor, for the Northern New Jersey, Metropolitan Area. Several years ago we recommended this approach in a hard-hitting editorial which some people did not like. Several teacher representatives thought it was unfair to them, and that the paper was speaking too strongly for management which in the case of teacherboard negotiations is the board. We did not feel that was the case at that time, and

we know that this new contract will do several things forthrightly and courageall of which are to the great betterment of teachers and heir school system. With this two-year provision, endless wage negotiations will not be the case. leachers and the board will be able to enjoy probably well more than a year's vacation from negotiations and turn their attentions to other and more important educational matters, such as course content and student With reliable statistical guides to inflation levels,

as we suggested two years ago, both teachers and the board can have down-to-earth yardsticks to compare their positions to and not come together in "give me everything" or a "we have nothing extra to dispense"

For all the parties concerned, we are very pleased to see an amiable solution reached that is based on reasonable evidence from a reliable source.

Guard Against Another Central Ave. Any motorist who has attempted to navigate through the traffic mess that develops in Clark during rush hours at the "circle" where the Garden State Parkway. Central Avenue, Valley Road and Brant Avenue collide will agree that no municipality should get into such a To have the traffic enter township streets from the

parkway is bad enough for any municipality. To have local streets which carry a great amount of traffic go through the area compounds the problem. The difficulties all motorists experience in the area, especially the Central Avenue section, are multiplied by the hodge-podge of businesses which have been permitted to locate in the area. Stores which draw a great number of shoppers and drive-in eateries have congested the area beyond all reason. Property in the section undoubtedly is much desired because of the great amount of traffic but there is no excuse for the heavy concentration in one section of businesses which depend on large volume to exist.

When the area at Valley Road and Walnut Avenue is developed (as it most certainly will be in the future) the township officals should guard against saturation. A hotel and an office building at the intersection would enhance the area. One has only to look at the 1 Walnut Avenue property as it exists to realize there would be an improvement. There seems to be no doubt that the old factory building on the opposite side of Walnut Avenue will be replaced sometime in the years ahead. The town-

Acts 4:19,20 Four hundred and forty one years ago, this week, several men dared to stand before the emperor of the Holy Roman Empire and present a confession of faith with seemed to contradict the accepted tenants of Christianity.

Were these men at the Diet of Augsburg right or wrong, and what does their conscience-motivated protest mean for us in our time? Our affirmation of faith, along with theirs, sees the plain truth of scripture brought forth again after a period of submersion in tradition and speculation. We

see the normative character of God's Word judging every act and thought of man, both in church and state. -How disconcerting this principle is? God's Word does not let us bless every wind of religious fad and national policy that blows our way. God stands as judge when we would use Him to give credance to our blinded interpretations of daily events: to wars of national ionor, to hatred among men, to misuse of resources and potential, to continuation of outmoded patterns. lowever, the Eternal One who is concerned with righteousness and justice among men calls us to new nterpretations and understanding of His will in each eneration of men. This can be hard to understand for those who always expect things to remain the same. He is the same, but the conditions of history and our attempts to respond with solutions to problems are subject to constant evaluation. The prophets questioned the religious-and-political-motivations of their con-

temporaries because they were subject to a higher authority and could not condone mistakes simply because they were popular. John and Peter questioned the authorities of Jerusalem when they proclamed the Lordship of Jesus because they knew God had sent a new day and a new way. We also are confronted by the challenge of God's Word.

Will we stay with the acceptable and attempt to make His will fit our interpretations, or will we be subject to a higher authority and be willing to suffer the displeasure of our contemporaries because our ideas seem controversial, radical or threatening? God's concern for the welfare of men is steadfast but not always easy to discern because it does not coincide with the self-interest expressed in our views of how things should be done. God's mastery over all of life will-continue.-Some-
