

Residents along Prerpost **Fransport** of New Jersey's to reduce the number

The once-a-day line began operation Tuesday after months of no service due to the strike against TNJ. **Prior to the strike**, buses went from the Rahway business center, to Inman Avenue and then into Colonia. Since the strike, service terminates in downtown Rahway, with the exception of the one bus taking the prestrike route which began service two days ago Route 132 was the subject of a similar tussle with residents last August when service was reduced from 13 to seven runs daily. The company is claiming the line loses money, and says it will substantiate its claim before members of

the Public Utilities Commis-Residents say the line is patronized, and that without service many people will be forced to walk long distances. Duke Road residents for instance, are more than two miles from an alternate bus route.

The service that began Tuesday is supposed to have one bus leaving Potters -Grossing in Golonia for Eli-zabeth at 7:39 a.m. and another coming from Newark to leave Broad and Jersey Streets, Elizabeth, at 5:07 p.m. The route will be in operation Monday through Friday, it was stated.

A study written by Dr.

Jan Chaiken, a former Rahway resident, and Dr. Bernard Cohen of the New York City-Rand Institute states that New York City police officers who perform either effectively or ineffectively can be accurately identified during their first months of the force.


The study received wide oublicity in New York newspapers. Findings of the study. "Police Background Characteristics and Performance." were developed from personnel files of nearly 2. 000-policemon-appointed-to the force in 1957. Their performance records were collected 11 years later. Two key criteria used by

Dr. Chaiken and Dr. Cohen in for-ecasting a policeman sjob performance are his Police Academy grades and the evaluation made of him by his superiors when he is a probationary patrolman. Dr. Chaiken resided in Rahway from 1945 until he was graduated from college. He is the son of Mr. and Mrs. Joseph Chaiken of Scotch Plains, formerly of 2406 St. George Avenue, Rahway. Dr. Chalken attended Franklin School and Rahway High School. He was graduated from high school in

1956 at the top of his class. Dr. Chaiken received a Westinghouse Scholarship to attend Carnegie Institute of Technology (now Carnegie-Mellon University) in Pittsburgh, Pa., where he was awarded a bachelor of science degree in physics in 1960. He then was awarded a National Science Foundation-to-attend-Massachusetts Institute of Technology, Cam-

bridge, Mass. He was given a doctor of philosophy_degree in mathematics in 1966. Dr. Chaiken was an assistant professor of mathematics at Cornell University and a research associate at-MIT, prior to joining the New York City-Rand Institute in 1968. At the Rand Institute he has conducted research on allocating police and fire units to match the needs for emergency vehicles to respond to calls from the public. He also worked on the study of po-


