ROMAN COOKS AND GOVERNMENT

In Juvenal's time the salary of a

good cook was ten times higher than

that of a senator, a man of learning

and ability, who, according to

Lucian, was deemed well paid with

200 sesterces a year. The salary of

Dionysius, a dancer, was 200,000.

The house and the establishments of

the two players in pantomime

at the time of the emperor Augustus

were the richest of the rich. There

were three Roman named Apicius,

each celebrated for devotion to gas-

tronomy. The second, who flourished

under Tiberius, was the most fam-

ous and he had the credit of hav-

ing thrown both dissipation and in-

dustry in the gratification of his

appetite; so much so that his name

has passed into a synonym for an

accomplished epicure. After spend-

ing about 100,000 on great and small

luxuries, he died, and his estate was

balanced his books, and finding that

he had not much more than 200,000

left, he made it his business to live

upon such a pittance. Lamprey's

version is that he made a mistake in

counting up his books, and having

found himself short, he was driven

to the desperate expedient of

selling his books, and finding that
