THE COMMON COUNCIL OVERRULING THE LEGISLATURE

We have always supposed the Common Council of our city was a body composed of limited powers. With that definite view of our law-makers, we respectfully suggest to them that their powers are fixed and defined by what are generally known as the statutes of New Jersey. Those statutes were so framed to be executed by a body of men generally called the Legislature. Of course we admit the inferior legislative capacity of those men as compared with our local rulers. Yet under the constitution of our State they enjoy, we humbly conceive, the executive right to define the extent of those rulers' powers. In our innocence we had arrived at the conclusion that the Legislature could enlarge or curtail those powers at its pleasure. We are clear it has been extending this right at each session, and we never heard its power in this respect questioned by any judge or lawyer.

Well, it now seems we were all wrong. The Legislature in the session of 1881 passed a law mandating that every city should receive in payment of all taxes levied for one year the bonds issued by it in anticipation of the law until the last meeting of Council. At that meeting it appears our democratic authorities concluded the law was unwise. They did not question the existence of it. They did not deny that therefore their official duty demanded it proper to obey it. They did not even think necessary to ask their professional advisers if they had a right to say they would no longer obey it. They simply resolved they would not, except, to use the language of the resolution, "for those taxes the law of 1879, and that this resolution take effect immediately."

From the report it appears the reasons which governed the Democratic majority in adopting the resolution were that the bonds "would not be taken by the county for taxes due from the city." Well, suppose it wouldn't? What of it? The law doesn't require the county to take them, but does require the city to do so. The language is as follows: "The city government shall pay the interest on the bonds of the city for one year after the same shall become due and payable, said taxes may be paid in any of the municipal bonds of said city, which may have been issued in anticipation of taxes." "Such bonds shall be received by said city in lieu of money payments for said taxes at the par or face value, with the interest accrued thereon." Can any one doubt what that means? During all the time the city government has been taking them the county never dreamed of receiving them in payment of county taxes. We should like to know if, during all this time, the city doubted the act required it to take them? If it did, what did it take them for? If it did not, what happened since to change the situation? In either event, why should it take them in payment of taxes back of 1879 and not for the others that are one year overdue?

It seems our new Judge Hyer happened to be present. So he has called on for a proposition. He said there was a law making these bonds legal tenders in payment of taxes, but though it was passed in the interest of parties who had such bonds. One would suppose that when parties interested in the passage of a law requested its passage our council could do within its province to say the law is not law. Now if there is such a law why does not our council obey it? Has there not yet been enough money spent in unsuccessful litigation on the part of the city to cry halt for a little while at least? It seems plain to us that a deliberate defiance of a law ought to be preceded by legal advice. Clearly to get that first would be much more prudent than to include in an unwisely and afterward when exceeding in cost to sell the City Attorney he has not defended the city for a course of conduct which he had never approved. Had he been consulted beforehand his counsel might have been a goal-defeat of litigation that is likely to cease by reason of the passage of this resolution.
