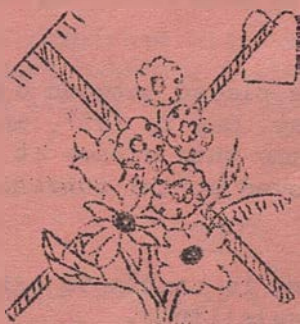

RULES FOR ARTISTIC ARRANGEMENT CLASSES

1. All spaces allocated by exhibits committee, except open classes 4, 5 and 16. Mail entries for these classes to Mrs. Walker Hinton, 33 Gallowae, Westfield, N.J., before April 26, 1957.
2. Only one entry in each class may be made by an exhibitor.
3. Exhibits must be placed between 8 a.m. and 10 a.m., Thursday, May 9, 1957, and remain in place until the show closes at 9 p.m., and then be removed at the convenience of the hostess.
4. When an exhibitor is unable to exhibit, she must provide a substitute.
5. Exhibitor will be notified of date she may visit home where arrangement will be placed. Be prepared to make notes of color, style, size, etc.
6. An arrangement implies the artistic use of fresh cut plant material, a container and a base, if used.
7. A composition is an arrangement with one or more accessories, such as lid of container, figurine, books or additional plant material or dried material.
8. Any exhibitor assigned a mantel may use her own discretion as to whether one or two arrangements best fill the class requirements.

RULES FOR ARTISTIC ARRANGEMENT CLASSES

(Cont.)

9. Plant materials used should be listed on small index card to be attached to entry card.
10. Plants on the State Conservation List may not be used unless grown by exhibitor and stated on card to accompany entry on which all plant material used is listed.
11. While the committee will exercise every precaution to safeguard exhibits, containers, accessories, etc. it cannot assume responsibility for injury or loss.

AWARDS

This show is to be judged as a Standard Accredited Show, with one Blue Ribbon for first award, one Red Ribbon for second award, one Yellow Ribbon for third award, and a White Ribbon for honorable mention, at the discretion of the judges.

A Tri-color may be awarded.

The decision of the judges will be final.

2. "Five O'Clock" - Arrangement or composition featuring pink flowers. 4 Entries.
3. "Perhaps" - Novice class, open to members who have not won a Blue Ribbon. 6 Entries
4. "Endearing" - Open class. Arrangement not to exceed 8 inches in any dimension, staged on Victorian Whatnot. 5 Entries.
5. "Most Precious" - Open class. Miniature arrangement not to exceed 3 inches in any dimension. Staged on Victorian Whatnot. 10 Entries.
6. "Escapade" - For Men Only. Arrangement or composition using any material; must include some living plant material. 6 Entries.

7. "Joli Bouquet" - Arrangement or composition in the French manner. 6 Entries.
8. "Repartee" - Suitable arrangement or composition, must include yellow. 4 Entries.
9. "Apropos" - Arrangement or composition suitable to location. 5 Entries.
10. "Night and Day" - Arrangement or composition of foliage using flowers as accent. 5 Entries.
11. "Tweed" - Arrangement or composition featuring textural contrasts. 4 Entries.

17. "Heavensent" - Arrangement or composition for a little girl's bedroom. Open to girls age 5 to 8. 6 Entries.
18. "Ballerina" - Arrangement or composition for a young girl's bedroom. Open to girls aged 9 to 12. 6 Entries.
19. "Enchanting Menace" - Composition of vegetables and/or fruits to resemble an animal. Entries Unlimited.
Division A - Open to boys and girls aged 5 to 8

RULES FOR HORTICULTURAL CLASSES

1. Mail entries before May 5 to Mrs. Charles L. Warnecke, 102 Jefferson Ave., Westfield. Exhibitors are URGED to submit advance entries. Entry cards will then be ready with the entry clerk the day of the show.
2. Open to all amateur gardeners of this area.
3. All entries shall be grown by exhibitor, must be labeled, and preference will be given to new varieties.
4. Exhibitors are to take their specimens to the second floor of the YMCA, 220 Clark St., Westfield.
5. All entries must be in place between 8 a.m. and 10 a.m. and removed by 9:15 p.m. Specimens not removed by this time will be donated to the YMCA. Members only may make entries the night before from 8:30 to 9:00 p.m.
6. Exhibitors are limited to one entry in each class, but may enter each subdivision of a class.
7. All house plants must have been in possession of exhibitor for at least three months prior to the show, except for Junior entries. Junior entries should have been in the possession of the exhibitor for at least one month prior to the show.
8. Definition for this show: collection--not less than 3 nor more than 10 varieties.

RULES FOR HORTICULTURAL CLASSES

(Cont.)

9. Any wild flower or other material on the State Conservation list, but grown in exhibitor's garden, must be accompanied by a typed card so stating.
10. Containers for all horticultural specimens except house plants will be furnished by the committee. Containers for house plants will be supplied by the exhibitor.
11. The committee reserves the right to subdivide any class where the number of entries so warrants or to combine classes, if necessary.
12. The Rake and Hoe Garden Club of Westfield will exercise due care but assume no responsibility for damage or loss of property.
13. Only members of committees allowed on the floor before judging.

AWARDS

Ribbons may be awarded for first, second, third and honorable mention in each class.

A Sweepstakes Ribbon will be awarded to the exhibitor winning the most blue ribbons.

A Tri-color may be awarded.

All awards will be made at the discretion of the judges and the judges' decisions will be final.
