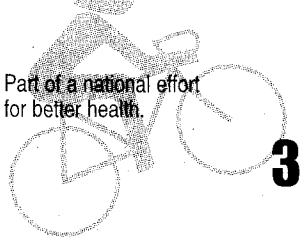

Victim on beach identified

Investigators have brought in a forensic anthropologist to determine the cause of death of a Cape Coral woman whose body was discovered Friday at Lighthouse Park on Sanibel, according to a prepared statement from the Lee County Sheriff's Office.

After a week-long investigation into an endangered missing adult, detectives received a tip that led members of the LCSO Crime Scene Unit to an area near the boardwalk at Lighthouse Point Beach. They located the decomposed body of Stacie Lee Davis, 28, of 1808 Southwest 15th Place, Cape Coral, Friday afternoon, May 12 about 800 feet from

the parking lot.

Around 9:30 p.m. that same day, detectives arrested David John Baugher, 30, of 13102 Regent Circle, Fort Myers, based on information obtained during the investigation.

An autopsy was performed on Davis' body Friday, but cause of death could not be determined due to advanced decomposition, officials stated.

A forensic anthropologist arrived Monday to assist with the investiga-

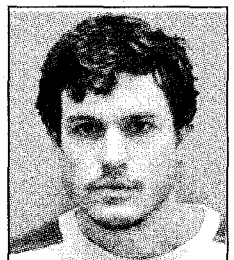
tion, according to sheriff spokes-
woman Illeana LiMarzi.

Officials declined to address the time frame of death or the possibility that Davis' body was dumped at Lighthouse Park after she was killed elsewhere.

"We're conducting a thorough investigation and the body has been turned over to the medical examiner's office who is also conducting a thorough investigation," Lee County Sheriff's Deputy Angelo Vaughn said.

Baugher and Davis were "acquaintances," according to LiMarzi, who declined to elaborate on the nature of their relationship.

Now charged with one count of second degree murder, Baugher had

no previous crimes or record with Lee County, according to a records search.

The discovery of Davis' body marks the first murder in more than 20 years on

the island, according to Sanibel Police Chief Bill Tomlinson.

"This was not a stranger crime," he said. "And the residents here should not feel unsafe."

SFWMD director visits city council

Finger pointing, buck passing, excuse making and skirting the issue were all a large part of the first half of Sanibel City Council's meeting Tuesday, May 16, as they were visited yet again by representatives of the South Florida Water Management District (SFWMD) and the U.S. Army Corps of Engineers.

The visit from SFWMD Executive Director Carol Wehele was in response to a letter from Mayor Carla Johnston, calling for an

Emergency Deviation Plan for the management of Lake Okeechobee for the upcoming rainy season.

Johnston's letter stated SFWMD and the Army Corps should have a plan in place before the heavier rains come and fill Lake Okeechobee to unsafe levels, prompting the same kind of massive water releases into the Caloosahatchee River that have been done the past two years.

Council considers legal defense fund

With a legal battle brewing between the City of Sanibel and the agencies in charge of managing Lake Okeechobee, lawyer's fees are growing. City council is considering reviving a legal defense fund by which private citizens and businesses can make donations to help defray those costs.

The matter was discussed during the council's Tuesday, May 16 meeting.

Councilman Jim Jennings, who has previously voiced his opposition to pursuing a lawsuit, said he would be opposed to such a fund.

"Because at this time I won't be supporting any type of litigation, I won't be supporting this at this time," Jennings said.

City Attorney Ken Cuyler advised that the wording he used in preparing the resolution which would

Hurricane passes now available for residents

With the start of hurricane season on June 1, the Sanibel Emergency Management program is now issuing Residential Hurricane Hangtags only to residential property owners and residents. The hangtag is valid for one year only.

The Hurricane Hangtag expedites the re-entry process for residents following an evacuation at a time when access could be limited due to any ongoing response and recovery efforts on Sanibel and Captiva Islands.

The Hurricane Hangtag Program has been updated this year to exclude the wallet passes and to limit the hangtags to two (2) per household for safety and security purposes. The hangtags are mobile and can be used for different vehicles as they are recorded in the Sanibel Police Dept. Hangtag Database under the name of the person who applied for them.

Hangtags for 2006 are available at the Sanibel Police Department. Any one of the following docu

Summer reading at the Sanibel Library

The end of the school year is just weeks away, but the Sanibel Library wants to keep children learning throughout the summer with their weekly Summer Reading Program.

According to Children's Librarian Barb Dunkle, the youngsters will be divided into two age groups, with different activities and programs especially designed for each group.

Younger children, ages five years through the third grade will participate in "Paws, Claws, Scales & Tales."

Dunkle said the reason for the program is simple.

"The purpose of the Summer Reading Program is to keep kids reading through the summer," she said.

In this program, kids can earn points for reading throughout each week, and are encouraged to read for a minimum of 20 minutes each day, five days a week.

Dunkle said the reading doesn't have to be from a book, either. Practically anything with print; cereal boxes, DVD cases, newspapers and any other readable material qualifies. Points are awarded based on the length and complexity of what is read.

The program will begin Saturday, June 3 with a "kick-off party" from 10 a.m. to noon. The weekly activities will then be held each Tuesday at 3 p.m., beginning June 13. On that day participants will be treated to a magic show by John Robert.

The following Tuesday, June 20, will feature a visit from the Lee County Sheriff's Department K-9 unit, and Tuesday, June 27 will be the "4th Annual Mini-parade Float Contest" in which the kids can decorate their own floats for the competition.

The program will take a break for the holiday Tuesday, July 4, but will resume July 11 with a visit from local veterinarian, Dr. Suzanne Presley.

Throughout the Summer Reading Program, the older group of students, fourth grade and up will be preparing a stage play under the guidance of Kelly Legarreta, Children's Education Director and Marketing Director for the Schoolhouse Theater on Sanibel. They will then perform their play for the younger group on Tuesday, July 18. The summer program wraps up for the younger children July 25, when John Storm's World of Reptiles stops at the library.

An organizational meeting will be held for the older, theater group this Friday, May 19 from 2:30 to 3 p.m. Again, this is for students in grades four and up. Participants are asked to bring their summer schedule for family vacations or times away from the island and a calendar. Dunkle said there is a need for actors, actresses, and behind-the-scenes helpers.

The regular weekly schedule for the older group will be each Monday at 3 p.m., starting June 5.

Many believe the huge influx of fresh lake water, which also carries excessive amounts of nitrogen, phosphorous and other chemicals, is responsible for our local water's dirty appearance, the formation of foamy "scum balls," higher incidents of red tide and massive fish kills. The dirty water is thought to be the cause of the demise of seagrass beds in the estuary, which serve as breeding grounds for a wide variety of fish and other aquatic life.

Johnston's letter stated the entities who manage Lake Okeechobee need to gradually lower the lake level to prepare for the wet weather to come and should seek alternate places and methods to store the excess water rather than send it rushing down the Caloosahatchee.

"It is commonplace for households, businesses, state and local governments to have Hurricane Emergency Plans. Why don't the Army Corps of Engineers and the South Florida Water Management District have one? Hope for a dry 2006 is not a plan," the letter read.

Wehele said the schedule for water releases from the lake are set up and managed by the federal government and her agency has no power in that matter.

"The regulation schedule the Corps operates the lake under is all, 100 percent federal," she said. "We're authorized that way in federal statute."

Wehele said SFWMD is seeking public and private land on which to store excess water so it doesn't have to come down the Caloosahatchee to the Gulf Of Mexico and to the east coast via the St. Lucie River. She said SFWMD does not have "condemnation authority" and cannot take private land for public use through eminent domain. They must have the cooperation of the landowners to use it for water storage.

"This is a willing participant program," she said.

She said her department provides weekly reports to the Corps of Engineers regarding environmental issues for the lake and related waterways.

Councilman Steve Brown said the safety of those in the Okeechobee area is a primary concern for everyone involved, but the preservation of our local environment is also crucial. He was critical of the release schedule used for the past two years, saying the Caloosahatchee received an unfair share of the water, making an unbalanced "shared adversity" among the west, east and south sides of the lake.

"We were told early on it was shared adversity, which everyone can buy into. Shared adversity, it sounds good, doesn't it? Everyone is equally affected," Brown said. "What happened last year was criminal, with the amount of fish and wildlife that went out ... dead fish on the beach, the effect on wildlife in 'Ding' Darling, it was absolutely criminal. If a corporation or private resident had done that, they'd be in court today. My appeal is going to be, can we get guarantees that you're not going to flood the Caloosahatchee like you did a year ago?"

Brown strongly restated his position to fight for Sanibel's environment, up to and including supporting the city in lawsuits.

"You're killing us. You're killing our seagrasses. You're killing our environment and your killing our wildlife," he said. "I'm going to fight like crazy for this and I know the Army Corps of Engineers are big guys and the govern-

ment's a big organization and the district, too, but it's not fair. It's not shared adversity."

Wehele said again the release schedule is managed by the Corps of Engineers. One problem arises from the agencies diverse missions. The Corps of Engineers officials say their duty is flood control and they have no responsibility for water quality. SFWMD says they are concerned with the quality of the water, but have no say so on the timing and volume of the releases.

Pete Milam of the Army Corps of Engineers said a priority for the Corps is to reinforce the Herbert Hoover Dike around Lake Okeechobee, allowing the lake to safely hold more water.

Andrew Gellar, Lake Okeechobee Basin Operations Manager for the Corps, gave a history of the dike, testing the patience of Johnston and the council, who were looking for answers to the immediate problem, not a history lesson.

"If you could talk about 2006 and what you might do," Johnston said. "I just want to know what you're going to do in 2006. I don't want to know what you're behind schedule on."

An option the council said they would like to see used is to release more lake water to the south, onto the Everglades Agriculture Area (EAA). Gellar said areas are available to the south, but that could not be done because of lawsuits filed by property owners in that region that demand water released there be treated. He said treatment is not the Corps' job, answered by moans from the council and the audience.

"It's not a federal responsibility to treat the water. The state is responsible to treat the water," Gellar said.

Johnston again gave a impassioned plea for a solid plan to manage the lake, citing not only environmental, but economic concerns as well.

"This is about our economy. This is about tourism, which is as big, in a fact a larger component of Florida's economy than is agriculture," she said. "This is about real estate. The real estate values in this part of the state are considerable and you are destroying it. It cannot happen again and that's why we care about 2006."

City Attorney Ken Cuyler asked if there were plans to lower the lake to any specific level in preparation for the rains.

Gellar continued to speak about prior years, much to Johnston's dismay.

"You've been asked to talk about 2006 and you've ignored my request for that," she admonished Gellar, who still continued talking about 2004 and 2005.

"Could you please answer the attorney's question pertaining to 2006?" Johnston asked again.

Milam interjected that it looks like the lake levels, water storage areas and other related water bodies are in a better state of readiness than in the past two years.

"We're starting out 2006 in better condition than we were in 2004 and 2005," he said. "The Kissimmee River basin is below regulation schedule. The lake is at its optimal level, which we did not have in 2004 and 2005. So we're starting out this year in better storage condition than we were in those prior years."

Wehele offered to come back to the council as often as needed to report on the progress of the lake management issue.

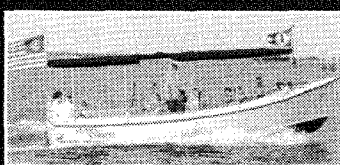
The city has retained outside legal counsel and is considering filing litigation to halt or alter the lake releases. A decision is still pending on exactly what course to follow.

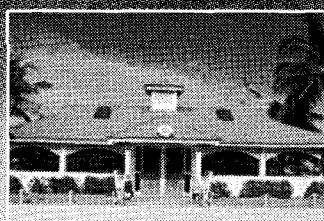

State activates hotline to pursue price-gouging from wildfires

Florida Agriculture and Consumer Services Commissioner Charles H. Bronson has ordered the activation of the Department's price-gouging hotline to assist consumers who may face problems resulting from the wildfires. The price-gouging law was activated after Governor Jeb Bush issued an emergency declaration due to the wildfires and the ongoing wildfire threat statewide.

The price-gouging law takes effect during any declared state of emergency and the Florida Department of Agriculture and Consumer Services receives and investigates complaints. Under Florida law, it is illegal to charge exorbitant or excessive prices for essential items -- including gasoline, shelter, food, water, ice, batteries, generators or lumber -- during a declared emer-

gency, unless the price increases can be attributed to additional costs incurred by the retailer.

"People have been forced to evacuate as a result of these wildfires and may need temporary shelter and gasoline," Bronson said. "The hotline is activated during any declared emergency and I urge people who think they may have been victimized to contact our Department."

Individuals or businesses found to have been involved in price-gouging activities face fines of up to \$1,000 per violation, or up to a maximum of \$25,000 a day.

Florida Flame will not play in 2006-07

Ownership looking for alternate venue before returning to D-League

The Florida Flame has decided not to field an NBA Development League team for the 2006-07 season due to difficulties in arena scheduling.

Managing partner Gary Fluharty said the Flame ownership group is examining alternate venues with hopes of a return in 2007-08.

"We believe Fort Myers is an excellent market for an NBA D-League team,"

Fluharty said. "We need a venue in which we can play a significant percentage of our games on weekends, when families like to be entertained,

so we can be as successful from a business perspective as we have been from a basketball perspective."

The Flame has played the last two seasons at Germain Arena in Estero. Head coach and former NBA All-Star Jeff Malone led the team to the 2006 D-League postseason before being eliminated in the semi-final round by the eventual champion Albuquerque Thunderbirds.

In addition to point guard Andre Barrett signing with the Toronto Raptors, the Flame had five NBA-assigned players on its roster this season.

authorize the fund said nothing about whether the money was to be used only in case of litigation. The council has not decided to sue, but Cuyler said legal fees are mounting and will continue to do so even if no suit is filed.

"It doesn't require litigation to expend the funds. We're going to have hundreds of thousands of dollars in legal fees over the course of this, even if you do not litigate," Cuyler told the council.

The resolution, if passed, would instruct the city's finance director to set up the special fund for environmental defense. A concern was raised over the possibility of donors being confused about what their contributions would be used for.

"I didn't want to get into a situation where we had some set of funds and were banking on litigation and council decided

that was not in the city's best interest. I assume we could ferret out and return the money," Cuyler said. "But I didn't write it that way mainly because it's not a situation where we're not going to spend money if we don't litigate or we are going to spend money if we do litigate."

The council voted 3-1 at their last meeting to continue studying the possibility of filing suit to halt or diminish the harmful lake releases. Jennings was the lone "no" vote and Councilman Tom Rothman was absent from that May 2 meeting.

Councilman Steve Brown said Tuesday that since council had voted to continue their current path, they should also support establishing the fund.

It was decided Cuyler would rewrite the resolution and present it again at council's meeting June 20.

ments will be sufficient for obtaining them:

- A valid Florida driver's license with a **physical** Sanibel or Captiva address (not a P.O. Box number) may still be used for re-entry, however, a Hurricane Hangtag will expedite return. Persons having a P.O. Box number on their driver's license will need to produce a document with a **physical** island address.
- A copy of your tax bill.
- A deed, mortgage document or rental agreement.
- A Sanibel or Captiva utility bill with your name and local address.

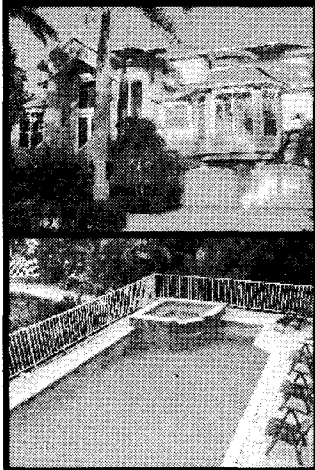
- A valid and current county voter registration card showing your Sanibel or Captiva address.

Please remember: residents with a Florida driver's license which reflects a **physical** Sanibel or Captiva address do not need a Hurricane Hangtag, their license will serve as a re-entry pass, however, the hangtag will expedite the process.

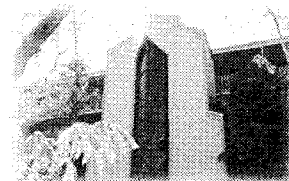

Criticizing the critic

To the Editor:

Unlike two-star rebel Maj. Gen. Battiste who awaited other General Officers to make similar claims against our Secretary of Defense and then retired before doing it himself for obvious reasons, it took me as a retired Brigadier General of the Army five minutes to decide to speak openly about that careless and improper criticism of our Constitution's ultimate civilian control over the military as reported in the May 13 "Wall Street Journal" by Greg Jaffee.

I speak as a retired civilian artillery man with combat experience in WWII and Korea, and battalion com-

mand of the 37th Army Battalion supporting the 23rd Infantry Regiment, and the UN French Battalion attached to the 2nd Infantry Division. My education included ROTC at Princeton University and a University of Virginia law degree in 1942. My lifetime law practice was interrupted by seven years of active Army service. My military career ended in 1976 as Assistant Division Commander of the 50th Armored of the New Jersey National Guard.

After 35 years of ownership here, I am now a full-time resident of Sanibel Island.

Although I have never met Donald Rumsfeld, associations have caused

me to follow his career service to the U.S.

If he is a bit arrogant and dismissive of others, as noted, including the press on occasion, his full schedule and burdensome activities justify those seeming indiscretions and we are fortunate to have a representative of such merit.

By Maj. Gen. Battiste's criticism of the president's secretary of defense, he has slighted the president and violated his oath to obey the president's orders.

Sec. Rumsfeld has made many important and significant changes that have increased greatly our military punch and mobility. Some of those worthy actions have been faulted by those reluctant to

change, as sacrificing an army of huge size on the ground. Many technological improvements have greatly reduced the charges of inadequate security and troop size continuing after Saddam Hussein's defeat and no one could have guessed the type of manpower required to protect against a continuing war of terror fought primarily today by insurgents.

To me it is obvious that Battiste's narrow military life experience, (father and son both lifetime military men) has promoted a lack of comfort with change, and his outspokenness reflects a failure to profit from the firing of Gen. Douglas MacArthur by President Truman. Should this pensioner of our federal government be allowed to sit back comfortably now, free of criticism, making harsh comment of his former commander-in-chief's doings, which he would not have dared do without resigning a few days ago? No!

Today we have too many general officers, and as one of them, I say that our personal discipline (whether military or self-imposed) should not be forgotten so long as we continue to be honored as flag officers in this great country of ours.





SBA loan approvals for hurricane rebuilding surpass \$9 billion

96 percent of applications processed

WASHINGTON - With processing completed on more than 96 percent of applications for rebuilding loans after Hurricanes Katrina, Rita and Wilma devastated the Gulf Coast and Florida, the U.S. Small Business Administration has approved over \$9 billion in financing to the small businesses, homeowners and renters who were victims of the largest disaster in U.S. history.

The record loan volume over the last eight months is more than double what was provided in the agency's previous record disaster response, the Northridge earthquake in 1994, in which \$4 billion in loans were made over a 12-month period.

"We've pledged to stay on the job until

it's completed, and that's what we're doing," said SBA Administrator Hector V. Barreto. "This has been an agency-wide effort with thousands of SBA personnel working tirelessly, urgently and with compassion to help the victims of these devastating storms, and I'm proud to say that very soon we will complete processing on virtually all of the applications submitted to us.

"The challenges and obstacles for small businesses continue to be significant in the affected areas," Barreto noted. "Not only do they have to rebuild their facilities and communications networks, but they also have to recover records, find and hire employees, reestablish a client base, and acquire inventory. Still, in New Orleans, as many as half of the residents haven't returned, and there are literally

tens of thousands of people who have been approved for loans but haven't decided whether to accept them or not.

"We continue to urge everyone whose loan application has been approved and is ready to start the rebuilding process to call our Customer Service Center at 1-800-659-2955 or e-mail us at disastercustomerservice@sba.gov and arrange for a loan closing. We want to get this money into the hands of the people in the disaster areas as fast as we possibly can."

The application deadline for loans to repair physical damage has passed, but small businesses that suffered financial losses after the hurricanes may still apply for SBA economic injury disaster loans. For small business owners in Louisiana, Alabama and Mississippi affected by Hurricane Katrina, the deadline is May

29; Florida business owners have until June 14 to apply. Small business owners in Louisiana and Texas affected by Hurricane Rita have until June 26 to apply. July 24 is the deadline for Florida businesses that suffered losses after Hurricane Wilma.

Through May 7, the SBA has approved 140,131 disaster loans to homeowners, renters and businesses in the disaster areas, with an approval rate of 42.8 percent. The total includes 120,123 disaster loans for homeowners and renters for \$7.14 billion, and 20,008 loans to businesses for \$1.94 billion. More than \$1.07 billion in loan funds have been disbursed to borrowers.

It was not long before Pres joined CROW (Clinic for the Rehabilitation of Wildlife) and the Conservation Foundation. He began reading the local paper and became fully immersed in all of the "goings on" of the island. He found his favorite spot for kayaking, riding his bike, walking on the beach and (he would say, most importantly) buying his favorite banana split.

Over the next ten years, we exchanged one house for another (one with easy access to the Gulf), began looking at boats and made plans for our move to our house on Sanibel. We walked the beach and talked about living here. We sat and watched the sunsets and dreamed of what was to be.

Finally, we were ready to make the move. We moved our belongs to Sanibel. Pres became a resident of Florida. It seemed that we were finally going to live our dream.

And then, on August 13, 2005, the very day that Hurricane Charley hit, everything changed for us. Pres ended up in the emergency room that morning. After many tests, and weeks later, we learned that he had a brain tumor, a very aggressive form of brain cancer. Despite his characteristic determination to fight the cancer and his refusal to believe that he would not survive, six months later, he lost his battle.

He would want me to write about how much he loved Sanibel, all of the wonderful people who live and visit here and what a special place it was to him. And most of all, he would say how very "luck" he was to have had the time he spent here.

I know that Pres would have supported the Periwinkle Partnership and the replanting of Periwinkle. He said, the first time he saw Sanibel after Hurricane Charley, "Don't worry, it will be back even better than before." I cannot think of a better way to honor and remember him than to have a native plant garden and bench where others can come, sit and enjoy his beloved Sanibel.

I am looking forward to the day when our two very young granddaughters can

Police chief updates city council prior to budget preparation

Following one of the busiest weeks in the history of the Sanibel Police Department, Chief Bill Tomlinson gave a brief report to city council at their meeting Tuesday, May 16.

The department was challenged by the discovery of a dead body and two major drug arrests all on the same day, but reportedly took it all in stride. Tomlinson's update came at the request of Councilman Steve Brown, who had high praise for the entire department.

"I was very impressed with what a busy

evening our police department had, but that's getting to be more and more. Not the murder part," Brown said, suggesting that more funds might be allocated for the police in next year's budget.

Tomlinson said as he prepares his budget needs for the upcoming fiscal year, he will study and examine crime trends on the island.

"I don't have any conclusive report for you at this time, but during the budget process, after I do the analysis of the trends and types of things that are happening on Sanibel, I'll give you an honest assessment of any needs, if there are any," he said.

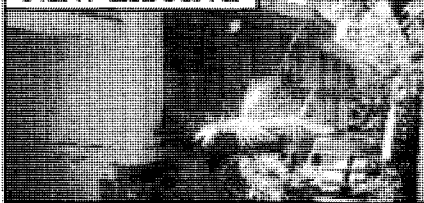
