FORT IN WHIRLWIND TOUR.

Gubernatorial Candidate to Make Auto Trip Through County October 28th.

WITH THE COUNTY LEADERS.

To Talk to Factory Hands—Brass Band to Whoop It Up Along the Line—County Chairman Smith Plans Program.

John Franklin Fort, Republican candidate for Governor, will make a whirlwind tour of Union county on October 29. With County Chairman Frank Smith and a delegation of county leaders he will visit nearly every city and town, making a brief speech in each place. The trip will be made by automobile. There will be two big touring cars in the party. The first will be occupied by the gubernatorial candidate, and County Chairman Smith. A brass band has been hired for the occasion, and will play selections along the route from the automobile chartered for its use.

The itinerary includes visits to the factories in Elizabeth, Garwood, Westfield, Plainfield, Springfield and Summit. Other towns will also be visited, even the small hamlets of Mountainside and New Orange being included.

The program has been left to County Chairman Smith, who has about completed arrangements. A big demonstration is promised in Elizabeth and Plainfield. The employees of the Singer Sewing Machine Company, and the Pond Tool Works will turn out in full force to greet "the Governor."

More Honors for Dr. Savitz.

County Superintendent of Schools, Dr. John J. Savitz, of Westfield, was on Wednesday night, elected president of the School Principals' organization, composed of the heads of schools outside the cities of Elizabeth, Plainfield, Rahway and Summit. David Davis, of Roselle Park, was elected secretary and treasurer. The meeting at which the organization was effected was held at the residence of Superintendent Johnston of Cranford.

Dr. Savitz is now at work on a course which will be recommended for approval to the State Board, and then adopted by the local board.

SLING SHOT FLEW BACK PUT OUT BOY'S LEFT EYE.

Young Preston Swaney Meets With Serious Mishap While at Play.

While playing with a slug-shot Tuesday afternoon, Preston Swaney, the nine year old son of Clark R. Swaney of Highland Avenue, lost the sight of his left eye. An operation was performed last night but the sight could not be saved. Young Swaney was playing near his home with the slug-shot. He held the wooden fork in front of his face and with his teeth held the leather sling with the rubber bands stretched taut. The catch slipped from his hand, flew back and one of the prongs struck him in the left eye making a cross cut. It did not pain him at all at first but later on Dr. Shindler was called. He advised that the injured boy be taken at once to the Muhlenberg Hospital in Plainfield as the only hope for saving the sight would be in an operation by a specialist. This was done and the operation was performed. It proved unsuccessful however and the doctors state that he will never have the use of that eye again. The eye-ball may possibly be saved so that in time the boy may be able to distinguish light from dark.

VANDERBILT RAYMOND, FUGITIVE, CAPTURED BY LOCAL POLICE.

Youth Indicted for Burglary Last January, Caught in Barn With "Pals."

Vanderbilt Raymond, of Plainfield, who was indicted for burglary last January by Judge Toney, and who has been a fugitive from justice ever since, was arrested in Scotch Plains early Tuesday morning by Detective Galician.

Galician after receiving a tip that Raymond was in hiding in a barn in Scotch Plains hustled to the place. He expected to find Raymond alone, but instead he found three other youths and two girls. All six were arrested and brought to Westfield.

When they appeared before Judge Toney later on the boys gave the names of Frank McNair, Oliver Pool and James Kolderling. The girls were Jessie Vull and Mary Howard, of Plainfield. The three youths were fined \$2 apiece and costs on a charge of vagrancy and the girls were committed to appear before Judge Abner in Elizabeth.

It was discovered later that Pool was the only one of the boys that lives in Plainfield. The other three come from Scotch Plains. The two girls live in Plainfield and are well known to the police there.

WOMEN START YEAR'S WORK

Interesting Exercise Marked Opening Meeting of Local Club in Presbyterian Chapel.

DR. HARWIN CRAIG HEARD.

Browning, the Theme of Informal Talk—Mrs. Eunice Talks on Year's Work—300 in Attendance.

Interesting exercises, featured by an informal talk on Browning, by Dr. Harwin Craig, of Princeton, marked the opening meeting of the Woman's Club, held in the chapel of the Presbyterian Church, Monday afternoon. The president, Mrs. T. D. Bunce, presided, and every seat in the hall was taken when the meeting was called to order. There were about 300 present, including the active and associate members, and their friends, the pastors of the churches and a few invited guests. Prayer was offered by Rev. Sidney Cross, rector of St. Paul's Episcopal Church. The chapel was tastefully decorated with autumn leaves and ferns.

In her opening address Mrs. Bunce very clearly outlined the character and scope of the work to be undertaken during the year. She said: "Members of the Woman's Club and our guests:

"It is a great pleasure to welcome you to the opening meeting of the thirteenth season of the Woman's Club of Westfield. The summer, time of rest and change of scene, is over. We gather together on this beautiful, crisp, invigorating autumn day, ready for the duties and privileges of our club year."

"Your Programme Committee has prepared for you, with great care, an outline of study that promises to be extremely interesting and profitable. It rests with each one of us to make much or little of it."

"The greater part of the meetings of the year will be given to the study of some of the most important poems and dramas of Robert Browning. It has been the aim of the committee to present this subject in such a manner that those of us who have longed to love the wonderful writings of the great poet, past and present, may find their acquaintance with him deepened and their appreciation of his work increased. It has been the committee's special care to so arrange the year's work that those of us who have read or studied that little of Robert Browning may find the way especially attractive and inspiring."

"Several afternoons are devoted to other subjects of interest to us as residents of Westfield. But it is not alone on our programme that we rely to round out a full year's work. We believe that we have working near our hands and hearts, in our town and state, we are women working together to improve and uplift by our influence and example, every opportunity for good in our little town that we love. Our schools, our library, our streets, our environment as it affects our children, are all objects of our solicitude. No social or denominational line is drawn here. A motto, given to one federation meeting, was an apt one for us: 'Let all be for each, each for all.' Club members, we beseech this year, your regular attendance, a spirit of goodwill and helpfulness, an open mind for our program of study, may the year 1907 and 1908 be the best yet in our history."

In order to refresh the minds of the members with the business of the annual meeting last spring, the report of this meeting was read by the secretary, Mrs. E. D. Floyd. Other routine business was carried over until the next regular meeting, October 28th. The announcement by the president that the new plan of adding twenty-five associate members to the club had met with an unqualified success, the entire list having already been made up, was greeted with enthusiastic applause.

In connection with the theme, the rendition of Browning's "In a Gondola," by Miss Elizabeth Beebe, assisted by Mrs. Frank Smith, who has planned, was one of the most attractive numbers of the program. Miss Beebe showed a true appreciation of the subtleties of Browning's verse in her reading of the poem, and Mrs. Smith's playing and singing indicated that even Browning is capable of dramatic interpretation. The music which, by the way, was composed by Mrs. Smith, was well adapted to the lines.

Dr. Craig's discourse was, in the nature of an informal talk on Browning, in which he emphasized some of the most important phases of the poet's work, and gave interesting glimpses of his home life. In commenting upon the latter, Dr. Craig said the influence of Elizabeth Barrett had deeply affected the character and work of Browning. In more than one instance his poems had been written with an eye to pleasing her, and she was the best judge of his productions.

As a poet, the speaker said that Browning bore a closer relation to Chaucer in his outlook upon the world than any other poet. Walter Savage Landor had, he said, defined Browning in a little dedicatory poem of fourteen lines. The seeming obscurity of Browning's work, Dr. Craig said, was due to his peculiar method of treatment. Browning was interested in men and women, and his office in poetry was to analyze

PROPERTY OWNERS REIMBURSE TOWN FOR SHOVELING SNOW.

Citizens Who Had Their Sidewalks Kept Clean Last Winter Will Pay a Tax and Interest.

Property owners, who last year had snow and ice removed from their sidewalks at the expense of the town, are to reimburse the township treasury by paying an additional tax assessment. This program was put through at an adjourned meeting of the town council held in the town rooms Monday night when a resolution was passed instructing the tax collector to cause certain sums of money to be collected with interest at 10% the same being cost of removal of snow and ice as provided by ordinance. This to be included in the tax bills of the respective property owners.

The only other item of interest that was placed before the council was a petition from Philip B. Winter and others for an eight inch vitrified sewer with appurtenances for North Avenue from the main sewer at St. Paul's street, out to town line or as near thereto as possible. A hearing will be held on the petition at a meeting of the council on the night of November 14th.

EDWARD T. PERINE NOW HEAD OF AUDIT COMPANY.

Local Man Succeeds August Belmont at President of Big New York Concern.

Edward T. Perine of this place, has been elected president of the Audit Company of New York. August Belmont, the retiring president and who lately tendered his resignation to that office, is one of the directors of the company.

The Audit Company is the largest auditing and accounting concern in America, and the election of Mr. Perine as its president is recognition of his high rank as an accountant. He is one of the best accountants in the world.

Mr. Perine and City Judge Ramsey of Plainfield were schoolmates at Plainfield High School. Soon after leaving school, Mr. Perine's family moved to Jersey City and as he has shown a great liking and aptitude for mathematics while at school, he took a position in a bank. He made rapid progress and soon had a big reputation as an accountant. He advanced higher and higher in his chosen profession and several years ago he was known throughout the country as an expert.

Mr. Perine moved to Westfield from Plainfield about two years ago. He has a beautiful home on Dudley Avenue which was built by Mr. O. D. Orth, and from whom he purchased it. Mr. Perine is a director of the Peoples National Bank and is very prominent in local society.

DEMOCRATS ORGANIZE.

Town Local Club with W. E. Tuttle, Jr. as President—Committees Appointed.

The Democrats of Westfield met last night at the office of Tuttle Bros., and formed a permanent organization to be known as The Westfield Democratic Club. William E. Tuttle Jr. was elected president, and John M. C. Marsh and W. O. Bachman were appointed a committee to make arrangements for the campaign. The club has rented a room in the Pearsall building, where it will establish headquarters. Meetings will be held every Thursday night.

All the wards were represented at the organization meeting last night, there being twenty-five present. The political situation was fully discussed.

Form New Social Organization.

A club of several young men has been formed here known as The Club. They have hired a room in the Westfield Club House and will meet there once a week. The officers for the coming year are as follows: Alfred Mayor, President; William Duff, Vice President; Walter Smith, Secretary; and William Heinicke, Treasurer.

LOCAL REPUBLICANS CHEER FORT AS HE DEFINES ISSUES OF THE CAMPAIGN.

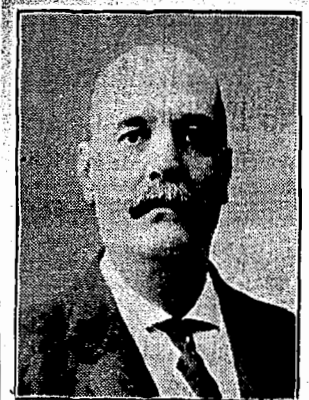
Head of G. O. P. Ticket Makes Clear His Stand on Excise Question, and Will Work for More Adequate Corporation Laws.

BARBER, PIERCE AND PARROT SPEAK.

Important Questions Discussed Frankly by Candidates, at Mass Meeting in Westfield Club Hall, Wednesday Night. Big Crowd Present.

For the first time in memory a Republican candidate for Governor has been heard in Westfield. That candidate is John Franklin Fort, and the address which he made to the Republican voters of this place, in the Westfield Club Hall, Wednesday night, will be long remembered as a honest, clear-cut statement of principles. Mr. Fort made his appeal directly to the mind and conscience of the American citizen.

He frankly stated that the corporation laws of our State were not adequate to meet the needs of the times, and declared that if elected he would ask the Legislature to pass a law which would do away with the evil of over-capitalization which is today menace to the commonwealth. He pledged his support to the Bishops Bill and declared that he would veto any measure that aimed to accomplish the opposite.

He said that it was a matter of regret to him that the Governor had not more power in the matter of removing officials from office when the exigencies of the situation demanded. He would, he said, work for the passage of a law that would vest in him that power, and, "I think," he declared, "if there is misconduct in office, the people will know on whom to lay the blame."

Alfred N. Barber, the Republican leader of the House; Surrogate Geo. T. Parrot, and Carlton D. Pierce, of Cranford, the Assembly nominee, also spoke. Each emphasized the importance of continuing the Republican party in power, and made it clear to their auditors just where they stood on the important issues before the people.

The hall was well filled with people, among them women. Flags and bunting adorned the pillars and the stage. Two large pictures of McKinley and Roosevelt were hung over the proscenium arch. A brass band of twelve pieces helped to make things lively before the speech-making began and after the conclusion.

know as Judge, but whom we shall soon know as Governor Fort. "Governor" Fort received a hearty reception when he stepped upon the platform.

He said that there was not another State in the Union in exactly the same position as the State of New Jersey. It is bounded on one side by the Delaware River and on the other side by the Hudson. Almost all of the enormous commerce of the Western States passes through New Jersey on its way to other countries. This State is also famous for its good roads, and its magnificent homes, the like of which few other States can boast. How could we preserve this present prosperous condition of affairs? By good government and good laws; and, he said, that if the people of New Jersey saw fit to elect him to the Governorship of this State he would to all in his power to preserve the high standard of excellence.

Mr. Fort went on to say that in all the twelve years of Republican rule in this State there had not been the slightest suggestion of misappropriation, and that in this respect, not a statute on the books was subject to criticism. He said that there were two questions, however, upon which he wanted his position clearly understood. These were the famous New Jersey Corporation Act and the Bishops Bill. He declared that he wanted to see, and would do his utmost to have this Corporation Act amended. It should be modified in this way. A commissioner ought to be appointed to look into the character of the stocks issued and to have control of the values of stocks. As it is now a corporation can capitalize for twice the value of its holdings and yet dispose of the stock at par. Every other State has such a commissioner and he said that if he were elected he would ask the Legislature for the appointment of a commissioner of corporations so that a man can feel that if he purchases a certificate of stock issued under New Jersey laws he will know that he has something really worth its face value. Overcapitalization is the one great evil of the New Jersey Corporation Act and only in this way can it be amended, he said.

In regard to the so-called Bishops Bill, Mr. Fort said that the Republican party had clearly defined its stand for its support in the platform at the convention. He said that he did not need to deceive any body as to his position on the bill. He believed in it absolutely and heartily, and that if elected he would do his utmost to sustain it and veto any bill to repeal it.

Mr. Fort said further that there was not enough responsibility attached to officers of the government at the present time. Divided responsibility is bad in government matters. Many officers draw their salary and do nothing. They are useless both to the government and to the people. In his mind the Governor should be held accountable. He stated that there was not a single law upon the statutes giving the Governor any power to investigate any institution or corporation or remove anyone from office. Mr. Fort declared that were he elected to rule as Governor of this State he would work for the enactment of a law giving him the power to remove negligent or incompetent officials.

He made reference to the Perkins and Duffield acts as examples of commendable Republican measures and told of the amendments resulting therefrom to the people of the State. The mention of Assemblyman Perkins' name started a volley of hand clapping, and Judge Fort's tribute to "our fellow townsman" called for more applause. Mr. Fort's speech ended with a broad smile.

Alfred N. Barber, the Republican leader of the Assembly, was the next speaker of the evening. He talked at length on the investigations made by the Hahn Committee and the garbled reports circulated by the Democrats before the first meeting for campaign purposes. He also spoke of the criticisms made by the Democratic brethren upon the increased expenditure since the Republican party has been in power. The Democrats, he said, were careful to point out the expense in different departments, and entirely overlook the profits. He also mentioned the long and prosperous period of the Democratic rule in New Jersey, until corrupt officials got in power, who used their offices as a cloak for personal gain instead of financial benefit to the State. He said by the continued abuse of public trust, the people of New Jersey were aroused and took the leadership from the Democrats and placed it in the hands of the Republicans where it had remained for the last twelve years.

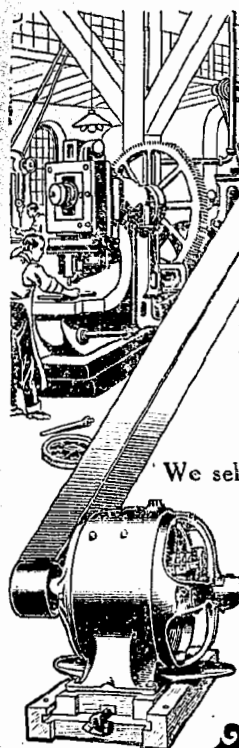

the human soul. Browning was not primarily a philosopher or a preacher, although there were philosophy and moral lessons in his poems. He was a delineator of the subtleties of human character as exhibited in the working of the soul. Hence his poems were lacking in dramatic action.

Browning was a deep student by nature. Early in life he had mastered the classics and he knew history as a school boy knows his primer. His familiarity with historic characters, and his free use of them in his work, and particularly in his *Sordello*, which abounds in allusions to obscure personages of the middle ages, rendered his work more difficult to understand. Scholarship was essential to a just appreciation of the poet.

Frequently Browning was obscure in his conversation. Being by nature of a simple and modest character, he always took for granted that his devotees were as well informed as himself, and in his speech he was often not clear to those who were not very familiar with his habits of mind.

In his second lecture Dr. Craig will make a more formal presentation of Browning—his life and work.

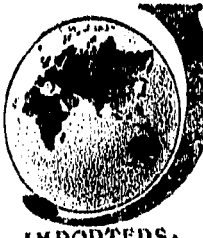

CHECKER COLUMN.

"Old Fourteenth."

Repeating the moves given last week: 11-15, 23-10, 8-11, 22-17, 4-8, 17-18, 15-18, 24-20, 11-15, 28-24, 8-11, 26-23, 9-14, 30-26, we stated that 30-26 was a loss for white, and asked that our checker experts show us the continuation of the game by which black wins.

The following have replied to our request, viz.: L. M. Whitaker, J. H. Kimball, Theodore A. Ball, J. H. Cash, W. H. Baker, and J. C. Brill, of Newark.

The win for black, after white moves 30-26, is made thus: 22-0, 6-9, 15-6, 2-9, 20-22, 13-31, 20-15, 0-32, 28-1, 19-16, 19-10, 23-10, 14-17, 21-14, 10-17, 25-21, 18-25, 29-22, 15-19, B wins.

Variation 1.
Instead of 30-26, make the move 32-28, thus: 32-28, 9-8, 20-22, 0-13, 31-20, 5-9, 19-16, 12-19, 25-10, 8-12, 24-19, 15-31, 22-8, 21-22, 25-18, 14-20, 10-11, 7-10, 20-11, B wins.

In playing the "Old Fourteenth," therefore, white should avoid the move 30-26 at this point in the trunk game. He might with safety move 32-28, but the trunk move is 31-20. We continue with this move. Instead of 30-26, thus: 31-20, 6-9, 15-6, 2-9, 20-22, 22, (a) 1-6, 32-28, 9-8, 30-26, 9-13, 19-16, 12-19, 23-10, (b) 14-17, 25-18, 8-12, 24-19, 26-22, 12-19, (a) 22-8, 14-17, 21-14, 10-17, 8-3, 7-10, 26-21, 17-22, 20-16, 10-14, 16-11, (d) 31-26. Drawn.

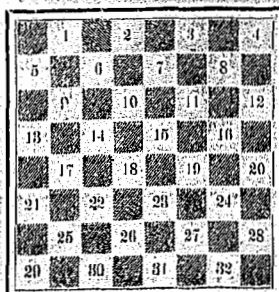
(a) A very natural move for black here is 9-13. Instead of 1-6 as in the text. If black moves 9-13 he loses. Please show us how—it is a beauty.

(b) 13-17 seems a foolish move, as it gives away a man. But let black try any other move and see where he would come out. 13-12 looks like catching a white man very easily. Instead of catching a man by this move, 8-12, black will lose the game. Tell us how—it is another beauty.

(c) Black has now got his man back, and is on even terms with white.

(d) While the game at this point is "drawn," as neither side can force a win, each side must move carefully to avoid traps. For instance, if white now moves 3-7, black will win thus: 14-17, 21-14, 22-25, 29-22, 24-3 and wins.

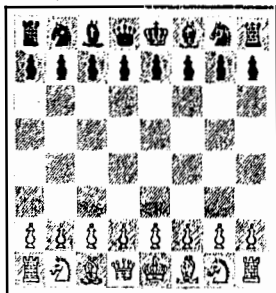

stating his position with regard to the Bishops' Bill. He said that he had been one of the movers to get this bill enforced. "Many people," he said, "have an idea that this bill to prevent the selling of liquor on Sunday, is something new. It is not nor has there ever been a law permitting the sale of liquor on Sunday. This bill is not for those that have a quiet, well conducted business, but it is to prevent certain abuses such as the 'back room' selling. That is why this bill has been enforced, and if there is any attempt to repeal this act, I will fight with all my power and the influence at my command."

Barroto Parrot was the next speaker. He talked very briefly and to the point. He mentioned the fact that all the "issuers" had been discussed by the previous speakers and that he only had one point to emphasize; it was "get out and vote, irrespective of whether you are a Democrat or Republican, when Election Day comes around—vote."

In his speech Nominee Carlton D. Pierce spoke of the dramatic situation at the Republican State Convention when the question of amending the excise plank in the platform was being debated. Assemblyman Barber, the speaker said, had saved the day by pointing out in a clear and forceful speech the importance of holding singly to the purpose of preserving the Bishops' Bill intact. The local option measure would make it possible for certain sections of the State to sell liquor on Sunday, whereas the Bishops' Bill preserved a uniform observance of the "old-time Sabbath." Mr. Pierce pledged his support to the maintenance of the Bishops' Bill. He received a hearty round of hand-clapping at the conclusion of his speech.
