

## BUDGET REQUESTS SLASHED BY \$279,046 TOWN COUNCIL DEMANDS MORE CUTTING

### What Makes These Candidates Seek Public Offices?

#### They're Unpaid, Unsung, And Are Seldom Thanked

With the Belleville Board of Education elections less than three weeks away, eight candidates are running for the two seats becoming available February 18 when the new Board reorganizes.

Two of the present Board members are incumbents seeking re-election to three more years in office.

With the exception of Ernest S. Arvidson, who is vice president of the Board, and Nicholas S. Juliano, a board member and incumbent seeking re-election, none of the candidates have made appearances at Board meetings until after, or shortly before, announcing their intentions of running for office.

**They're Middle of the Road**

While their intentions are of the best, most are vague when questioned about their plans for the policy-making position on the School Board. Their platforms are much alike: Good government, economy, and nothing's too good for the children.

The forthcoming election February 13 was being held under a cloud of legal troubles and personal animosity.

"It's a very unusual election year," said one school official. "I've seen nothing like it."

One candidate has already announced his intentions of withdrawing from the race.

**What Attracts Candidates?**

What, then, motivates the other seven to seek office in an organization beset by internal strife, grand jury indictments, and the controversial construction of a much-needed new high school?

Juliano and Arvidson, both incumbents, with pride point to their support of the new school and their concern for student welfare.

But both have also been criticized for delaying action on school repairs (a report has still not been made on their investigation of School 4) and their reluctance to place faith in professional opinion, preferring, instead, to rely on their own judgment. Arvidson, who is vice-president of the seven-man board, is a tool manufacturer; Juliano is a labor representative.

Among the Juliano petition signatures was that of Mrs. Elizabeth Arvidson, wife of fellow Board member Ernest S. Arvidson. Florence and Christine Juliano of 356 Union Avenue also attached their signatures. Juliano lives at that address.

**Who Backs Who?**

### Who's The Boss? Who's Arguing? Ask Officials

#### Risoli And Burdzy Say Peace And Calm Reign Supreme In Department

A tempest in a teapot went down the drain last week when both Ralph M. Risoli and Edward G. Burdzy, both Department of Health and Welfare employees, denied any conflict of authority existed in their particular departments.

"Where'd that story come from?" asked Risoli, town registrar and director of the Department of Health. "Nobody talked to me about it."

"I'm just doing my job," said Burdzy, who is the town health officer. As far as he knew there was a singular lack of strife within the department and he hoped it would stay that way.

Both were commenting on a news story in another newspaper in which both men were said to be at loggerheads over the command of the nine-man department.

Risoli said he had issued but one directive since taking office which had opposed a ruling made by Burdzy, but it had been over a minor point. Burdzy himself displayed no animosity and said the article couldn't be attributed to him.

### He's The Champ



Ralph Legge, the "Hole-In-One Kid" came in for some additional good news last week when a liquor distributor informed him he was eligible for a cash award and a trip to Bermuda because of his hole-in-one feat on the greens of a local golf course last year. Taking a professional stance before the Old Pill, Legge, who lives at 34 Memphis Avenue, said he had received letters from other hole-in-one golfers from throughout the country.

Town Hall Department Directors saw \$273,046 of their requested budget items cut out from under them by Acting Town Manager Charles Tedesco. But the Town Council isn't satisfied. Council members want another \$210,945 reduction to bring total expenditures into line with the 1962 figure of \$2,116,385.

The Town Council is meeting again tonight, Thursday, with Tedesco and various department heads to review the budget.

Department Directors submitted requests totaling \$2,606,376. The Acting Town Manager slashed their requests to \$2,327,330. At a conference meeting of the Town Council held last Friday evening Tedesco was informed to take the budget, confer with the Department Directors, and come up with an additional \$210,945 cut.

"The Town Council is determined to show better concern for the taxpayer's dollars than was

demonstrated under the Commission form of government," said Mayor Robert B. Laterza. "We are in complete agreement that our first budget should be as close to the 1962 expenditures as possible. As a matter of fact we envision the possibility of reductions once we complete a scheduled job evaluation. Some of us believe we can reduce the number of municipal jobs without curtailing any services. It is with that thought in mind that we originally approached the Belleville Foundation to enlist the organization's aid in underwriting the expense of a job survey. We are awaiting a decision from that group before an intelligent job reduction effort can be undertaken. In the meantime every Council member is pledged to seek out cost reductions wherever possible," concluded Laterza.

### Board Receives Six New Bids For New High School

#### Bids Are Still High At \$1,289,750, But Are Within Reason

Belleville Board of Education received bids Thursday night for six contracts for construction of the proposed \$2.7 million high school. The lowest bid exceeded the original estimate by \$150,000, but it was considerably lower than seven bids submitted last month which caused the Board to reject the lot and re-advertise the contracts.

Lowest bidder for general construction was made by the Pike Construction Co. of Paterson for \$1,289,750.

Despite the relatively high bids, the Board was pleased at the reduction from last month's bids and were optimistic that the figure could be reduced even lower after further study was made of specifications.

**McCool Objects Again**

Truly to blame for the excessively high bids, said architect Alfonso Alvarez, was the indictment of 10 farmer and present Board members. They were accused of withholding soil conditions from the public before the referendum last December 21, 1961.

Only objection Thursday night came from Mrs. Thomas F. McCool, who, disregarding a study (Continued On Page 3)

## Belleville Mothers Began Their March Of Dimes For Kids

#### 'Give, For The Life Of A Child' Is Their Theme

Nearly 100 Belleville mothers were busily canvassing the town last week as the 25th Anniversary March of Dimes got under way. Their aim: To provide the best of medical care for thousands of handicapped American children.

During 1962 the mothers of Belleville helped place their town third among more than 22 Essex County communities who took part in the annual fund raising campaign for the 50 March of Dimes Centers throughout the country.

Belleville campaign chairman is Under-Sheriff Harry J. Sullivan, treasurer is Charles B. Tedesco. Some 95 women began their job Monday under Mrs. William R. Brickell who directed collections in local banks. The drive will end January 31.

**Dollars For Children**

"We are asking everyone to 'Give for the Life of a Child' because there are so many communities that just do not have adequate facilities to care for the disabled child," said Sullivan. "In addition, millions of dollars must still be devoted annually to aiding the thousands of poor victims from former years."

There are now more than 50 treatment centers in many parts of the nation. Two of these are directly supported by Essex County Chapter and are available to Belleville residents. One is at

Mayor Robert M. Laterza signed a document Wednesday proclaiming the observance of Child Guidance Week January 21-27.

In a statement made simultaneously with the Mayor's proclamation, the Belleville trustees of the clinic said:

The main issue in the change for Belleville was, and still is, that Good Government with relief in taxes, and sound economy must come to our town with an honest, efficient manager, with a policy of that kind in mind, and that kind ONLY. ## 'WNJU-TV' To Designate New Television Station

The Federal Communications Commission has assigned the call letters WNJU-TV to the recently granted Ultra High Frequency Channel 47, scheduled to begin operations in Newark in late 1963.

Ed Cooperstein of Belleville, president of the New Jersey Television Broadcasting Corp. and general manager of Channel 47, said that the call letters had been requested specifically to "highlight both New Jersey and UHF in the continuing identification of what will be the first new commercial TV station in the metropolitan area in 15 years."

### A Newark Location

New Jersey Television was granted a construction permit for the channel by the F.C.C. on December 17 after submission last summer of an application which was endorsed by New Jersey Gov. Richard J. Hughes, Newark Mayor Hugh J. Addonizio and other key officials.

Present plans call for broadcasting from WNJU-TV's Mosque Theatre studios featuring all-New Jersey programming in the daytime and quality ethnic broadcasts in the evening.

### Programs All-Night

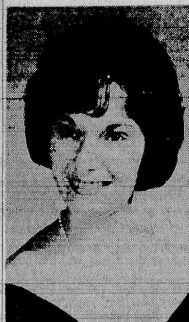

## Mr. Sommers Played Politics With Belleville's Most Vital Job

(Third in a Series)

In the memory of Belleville's old timers it is difficult to recall any Town Hall incident wherein a public official publicly admitted he attempted a brazen deal involving the use of taxpayer money to substitute a position which the public official deemed unnecessary — and freezing out a position which the public official claimed was incompetent. The public official who attempted to make the deal was ousted Town Manager William A. Sommers. The job was that of Registrar of Vital Statistics. The employee involved was Ralph A. Risoli.

The position of Registrar of Vital Statistics is our community's most important post. The duties involve keeping the community's vital statistics. Because of the fact that Clara Maass Hospital is located within our boundaries every birth and every death occurring at Clara Maass becomes a vital statistic of our community. This circumstance lends greater importance to the position. If there is any job at Town Hall which should not be a subject of political deals this is it. The position of Registrar of Vital Statistics should be above and beyond the reach of politics and its influence.

Sommers didn't see it this way. Almost from the very first day he assumed his job at Town Hall Sommers began scheming of ways to remove Risoli from the post of Registrar of Vital Statistics. Risoli held title to the job since November, 1961 although as Deputy Registrar of Vital Statistics he was actually discharging the duties of the position since August 26, 1958. The job carries no salary. Risoli receives \$4,800 as senior clerk although all of his time is taken up with his duties of Registrar.

The post of Registrar of Vital Statistics is exposed to supervision by the New Jersey Department of Health. And no one can be appointed to the position without the consent of the N.J. State Registrar. Risoli's appointment to the post in 1961 met with the approval of state authorities.

Former Commissioner Nuncio Pico attempted to place it under Civil Service in February, 1962 in order to remove it from the political arena.

Civil Service scheduled an examination for the post. The exam was held in the spring of the year. Only one person received a passing mark on the exam.

Sommers contended the post could not be placed under Civil Service jurisdiction since it was a statutory job and asked Civil Service to cancel the results of the examination. Civil Service complied with his request.

Soon after Civil Service danced to Sommers' tune the post of Registrar of Vital Statistics was caught up in a political chess game with Sommers calling the plays. At times it appeared that Sommers was holding Risoli as a hostage and at other times Sommers used Risoli's job as a pawn.

The consequence of his maneuverings upon Risoli, a 46 year old father of two children didn't appear too important to Sommers. He was determined to gain his objective at almost any cost.

But what was Sommers' objective? Clean government? Government without politics? Government without deals? Let's look at the record.

The Administrative Code adopted by the Town Council provides that the Registrar also head the Department of Health and Welfare. This provision of the Code enjoyed the support of all five Councilmen. As a matter of fact, soon after the new Council was elected, both Councilmen James R. Golden and Thomas P. Greco told their colleagues that Risoli was underpaid and was entitled to a substantial raise in pay. Golden and Greco were talking about a \$1,000 raise for Risoli.

Sommers "couldn't swallow" Risoli as Registrar and department head. Sommers legally attempted to change the Administrative Code substituting the title of "Town Manager" as head of the Department of Health and Welfare. Sommers' legal attempt failed due to the alertness of Mayor Robert M. Laterza who personally visited the offices of The Belleville Times-News and ordered a halt to the publication of the legal notice which was moments away from press time. The legal notice cost the town \$511.00 and if it was printed as desired by Sommers a second printing would have been necessary, thus costing taxpayers an added \$511.00.

When Sommers couldn't get away with his illegal effort to change the sense of an ordinance legally adopted by the Town Council he broached his first deal attempt.

"I will make Risoli secretary to the Town Planning Board at \$6,000 a year in exchange for his resignation as Registrar," Sommers is quoted as proposing. Both Mayor Robert Laterza and Deputy Mayor G. George Addonizio are the authorities for this quotation. Laterza and Addonizio said they rejected the deal on the basis that Belleville didn't have a paid secretary to the Town Planning Board and couldn't afford one.

"I'll make Risoli Administrative Aide to the Town Manager in charge of the Health Department if he will only resign his post as Registrar," pleaded Sommers, a professional town manager.

"No, you will not," replied Addonizio, Councilman Vincent T. Strumolo and Laterza. "Let Risoli perform the job the law prescribes for him and if Risoli proves incompetent, fire him," the three Councilmen advised Sommers.

Sommers later admitted, "I never gave Risoli a chance."

The above offers by Sommers were made between September 1st and October 15th.

Shortly after Sommers was appointed Town Manager by the Council but prior to his assumption of office he received a "briefing" on our municipal employees' political backgrounds and job efficiency from the then Acting Town Manager Francis McCoy, the municipal Town Treasurer. There is reason to believe McCoy also "briefed" Sommers on the Councilmen, their personal histories and political acumen.

There is reason to believe the McCoy "briefings" may have been brain washing sessions.

At any rate the record indicates McCoy won the complete confidence of Sommers. This point assumes great significance when one attempts to find a motive for Sommers' later effort to stop an investigation of Revenue and Finance Department in exchange for securing Risoli in the post of Registrar, a situation which Sommers protested he "couldn't swallow."

Within days after October 19 Sommers made a switch and suddenly offered to keep Risoli in the job of Registrar, permit him to function as head of the Department of Health and Welfare, if Addonizio, Laterza, and Strumolo would consent to call off the investigation of the Revenue and Finance Department which they authorized on August 28.

Sommers' offer of a deal to call off the investigation infuriated the three elected public officials. In well chosen, mainly language they informed Sommers' courier that no deal would be made to call off any investigation — that Sommers had better soon learn that Belleville was the wrong community to attempt such brazen political deals.

Early in November Sommers wrote to the N.J. Department of Health with the advice that he was firing Risoli from the post of registrar and was appointing Health Officer Edward Burdzy to the vacancy.

A week later, in an Atlantic City hotel room, at a cocktail party in connection with the League of Municipalities Annual Convention Sommers broke the news of the Risoli firing to several Belleville officials. Among those present when Sommers broke the news were Councilmen James R. Golden and Public Works Director Ralph Vara.

Returning to his desk two days later Sommers summoned Risoli into his private office and according to the sworn testimony of Risoli, Sommers said, "You are fired Ralph. The chips are down, you gotta go." Risoli said he at first thought Sommers was kidding but within minutes he found that only one week separated him from the throng of jobless people. Risoli promised to sue Sommers and the Town of Belleville for firing him from an appointive position he contended was his until November, 1964. Sommers contended he fired Risoli because he was incompetent and the job was unnecessary.

On November 20 Sommers was suspended from his job of Town Manager. Risoli's dismissal was to take effect November 26. The Town Council voted to replace Sommers temporarily with Deputy Town Manager Charles Tedesco, a lawyer. Tedesco immediately reinstated Risoli pending a legal decision from Town Attorney Thomas D'Avella.

Two weeks ago D'Avella ruled that Risoli was legally appointed Registrar of Vital Statistics on November 1, 1961 to a three year term which expires November 1, 1964. D'Avella supported his ruling with liberal citations of the law and cases involving the very same point.

Pawn or hostage — Risoli is contin-

uing to perform the duties pertaining to the position of Registrar of Vital Statistics and apparently his efficiency in the position meets with the satisfaction of the N.J. Department of Health which exercises a measure of jurisdiction over the Registrar.

The position of Registrar of Vital Statistics should never have been injected into the political arena. That Sommers succeeded in doing this does not speak well for professional town managers. And if this is an example of "compromises" characteristic of professional town managers Belleville is well rid of Sommers.

### BECK'S COLUMN

Some manufacturers still make a big issue of the fact that their sets are "hand-crafted." This is, of course, just an advertising term for handwiring.

In the early days of TV all manufacturers used this method of assembly. This has given way to precision built etched circuit boards, which are called erroneously by some people, notably the manufacturers of handwired sets, "printed circuits." Actually in "printed" circuits are not used any more. They gave a lot of trouble in the beginning.

Etched boards are one of the greatest advances of electronic science. They are much more reliable than old fashioned handwiring. Many repairs that previously could be done only in the shop can now be made in the customer's home, thus saving a considerable amount on repair bills. Sets with etched boards are more uniform in performance, because every single part is in the same position on every set. This is impossible with handwiring. Many times it makes a difference just how a wire is dressed in a TV set. Last but not least it is considerably cheaper to manufacture a TV set with etched boards. As a rule something cheaper is not as good, but in this case it is just the opposite.

It is amazing to hear some servicemen say they like handwiring better. They simply did not bother to learn what little there is to be learned about this new service technique. Usually these are the same mechanics who tell you color TV is not good yet or something similar. You can be sure that they don't know a thing about it having neglected to learn about color TV servicing, and that these fellows never repaired a color TV set. But that does not stop them to pass an opinion on something they don't know anything about.

The Kearny freshmen did not prove any trouble as the first quarter ended with an 18-2 Belleville lead. In the second period the cagers continued to pile on the heat as they shot 5 more field goals and 2 foul shots. The Cardinals won the second half 18-16 but the first quarter rally proved too much for the Hudson County visitors.

The Belleville bowling team, under the direction of Coach Michael Salzarulo, is currently tied with Irvington for the State Championship. The team, led by Tom Berkeley, has an 8-1 record. There are still 18 games left to the season. If the team can keep up their current trend of winning they may very well cop the championship.

The Belleville wrestling team won their second match of the season 27-13 against Cedar Grove. The team's record now stands at 2-1. The loss was to a very smart, strong Essex Catholic team. The Junior Varsity team led by Ben Schwartz, has one win and one tie so far. On the varsity, Captain Joe DelGuercio has fared exceptionally well, as he has won 3 out of 3 individual matches. Wrestling has begun to take an increasing hold upon the students of Belleville. One reason for this sudden interest is an orientation assembly presented by the team. ### Richie Luzzi Named To All American

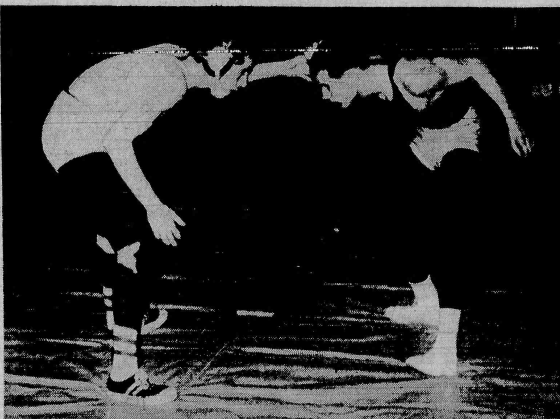

Losing four individual bouts by less than two points, the Bellboys of Belleville High School suffered their first wrestling loss of the season to a strong Essex Catholic squad at the Newark school last Thursday night, by a score of 28-11.

Bob Cashill of Essex Catholic gave away 70 pounds to the Bellboys Bill Heskindi but through smart wrestling managed to hold his opponent to a scoreless draw. This brought the tally to the final score of 28-11 in favor of the host Essex Catholic team.

Although the Bellboys were defeated, there is no reason for discouragement. The Essex Catholic wrestlers were more experienced in varsity competition. In a close match between wrestlers of equal ability the more experienced wrestler invariably wins.

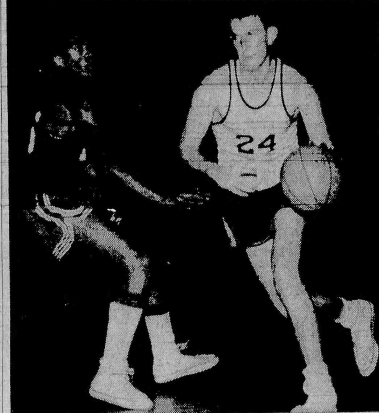

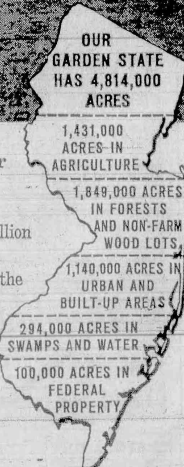

## Savannah's Fire Protection System Was Designed Here

Fire—the dread of all ships at sea—poses little threat for the first nuclear ship, Savannah.

The Savannah is fully protected against fire afloat by two basic type systems — an electrical fire alarm system for public spaces, offices, and lockers, and a smoke detection — fire extinguishing system for cargo and machinery spaces. The systems were designed and manufactured by Walter Kidde & Company, Belleville.

The electrical fire alarm system consists of thermostats located in the protected spaces and connected to the cabinet in the chart room which indicates the area reporting a fire.

The smoke detection system sets off both audible and visual alarms when air samples drawn from a protected area are passed through the main smoke detector which photoelectrically analyzes and finds the air contains smoke. The area reporting smoke is designated at the detector cabinet which transmits these signals to a repeater cabinet located in the chart room. A visual inspection device on the main detector cabinet provides a double check.

The main fire extinguishing system is supplied with carbon dioxide from a bank of sixty 100 lb. pressurized storage cylinders housed amid ships. The required volume of CO-2 for each protected cargo space is predetermined and designated on a bulk-head mounted chart. The main extinguishing system's supply of carbon dioxide is also used, if required, to maintain an

abnormal rate — of temperature rise in the protected area, causing heat actuators to set off the system. These independent systems also can be operated manually, if necessary, from control stations located outside the protected space.

A hose reel system, consisting of two CO-2 cylinders connected to hose, is installed in the machinery space for use on fires which do not warrant discharge of the main system.

## Garden State Farms Charges OMI Plots Against Lower Milk Prices

Disregarding the best interests of the public, the Office of Milk Industry is pursuing its planned campaign against lower milk prices in New Jersey, Garden State Farms charged today.

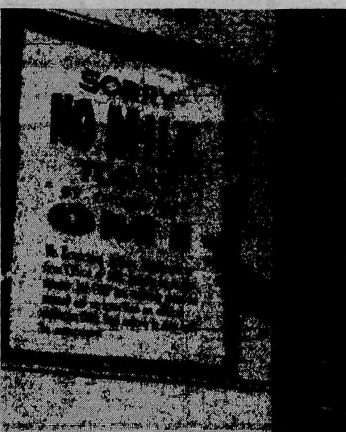
The latest case in point—refusal to grant two dairy store licenses in North Haledon and Walidwick—substantiates predictions by Peter Sandfort of Garden State Farms that "OMI has no intention of granting the licenses for the jug milk stores, and its true intention is to return to full milk controls."

"We paid for extra training personnel to help the OMI deliver the transcript of the three-day hearing (Jan. 9-10-11) in just five days rather than the promised 10 days," Sandfort stated. "Director Hoffman has had time to announce his decision. That he has not done so is proof that OMI has little interest in the consumer but rather, is serving special interests who would restrict the growth of jug milk and the lower milk prices the modern system has brought to New Jersey."

"Garden State Farms has proved beyond any doubt that the stores in North Haledon and Walidwick should be granted licenses in the best interests of the health and welfare of the people of these communities. Hundreds of people in these communities signed petitions urging the licensing. Affidavits that housewives were being charged exorbitant prices 10 percent above the OMI minimum were offered in evidence. The OMI produced not one shred of evidence that the licenses should not be granted," Sandfort declared.

Sandfort pointed out that reconsideration fees usually are paid by the state. Forcing Garden State Farms to pay for the extra personnel to expedite delivery of the testimony is just "another financial millstone OMI is hanging on us in the planned campaign against jug milk," Sandfort said.

Comments from consumers indicate Governor Hughes' mail is again on the increase as a result of public indignation over the return of milk controls. The governor rescinded milk controls just before last November's election—then in December asked the Legislature for 180-day emergency milk legisla-

tion. The lawmakers responded with the milk act, under which the OMI exceeded its authority in issuing regulation H-13, which it is using to deny Garden State Farms the right to sell milk in new stores, even though the dairy's other stores have been licensed for some time. The regulatory controls still have five months to run, and North Haledon and Walidwick families meanwhile would be forced to pay thousands of dollars more for the same milk. Garden State Farms wants to sell them for 87 cents a gallon.

For a brief period it appeared that the controversial milk controls were ended when Governor Hughes suspended them October 20, just before the election. Immediately after the election the governor asked the Legislature for temporary milk controls and they passed emergency legislation on December 3. With this as a springboard the OMI established Regulation H-13 which Hoffman has used to stifle Garden State Farms expansion.

**'Yield' Signs Help Improve Traffic Flow**

The "YIELD" sign, a fairly recent innovation now seen frequently at highway intersections in Nutley, Belleville and throughout the state, is already paying dividends in easing traffic flow, according to a spokesman for the New Jersey State Highway Department.

Law enforcement officials have found that the new sign has improved the flow of traffic without any apparent lowering of the safety factor afforded drivers, according to the Highway Department. It has been determined, however, that the purpose of the sign is not fully understood by some motorists.

According to the spokesman, "YIELD" signs are placed on streets, roads, and connecting ramps which intersect with major highways at locations where motorists have a clear view of approaching traffic. Normally, traffic volume on the major artery is of such volume that a stop is not always necessary prior to entering the highway.

Where the local road or connecting ramp is marked by a "YIELD" sign, motorists are required by law to slow to a reasonable speed from which they can come to a quick halt, if need be, and to yield the right-of-way to traffic on the major highway when good judgment indicates to them that to proceed further would be hazardous. The motorist approaching a "YIELD" sign must stop if necessary.

"YIELD" signs may be observed at various locations, as follows:

1. On minor roads at entrances to intersections where a stop is not always necessary at all times and where the safe speed of approach on the minor road to the intersection exceeds 10 m.p.h.

2. On the entrance ramp to an expressway where an acceleration lane is not provided.

3. Where there is a separate or channelized right - turn - lane without an acceleration lane.

4. At a point where a special problem exists which is best solved by the placement of a "YIELD" sign.
