Since the revitalization of Belleville's now decadent business area is getting little, if any, help from our Town Fathers, who should be taking the lead in such a movement, it would be a progressive move if the management leaders of our Manufacturer's Association and our local merchants with their Chamber of Commerce insisted upon a meeting with the Commissioners for the purpose of planning a move to restore the activity and business pace of the town.

When Bill Williams was Mayor he was the catalyst who took the initiative to bring these groups together for the purpose of exchanging views and discussing ways to help Belleville grow. The harmony and close bonds of helpful understanding brought about many gains for the town's people and its manufacturers and business people. If the movement could get underway speedily perhaps the combined thinking of the many competent people outside politics and government could give the drive the "shot in the arm" that is needed to get the town's business going for the Fall and impending Holiday Season.

Along with the coordinated effort that might mold from such collaborative action could come a job evaluation study of town jobs by the time study specialists of the manufacturers. Surely, industry would benefit, along with all the taxpayers, were needless positions or unnecessary employees found on the payroll and eliminated.

Likewise, a comparison of salary paid employees in private industry, in comparable positions with those on the town's payroll, probably would show the town help getting greater amounts than those in non-governmental service. If they should not prove justifiable, then ad-

# Mary Is Against Mayor's Proposal

Commissioner Mary Senatore this week said she will refuse to go along with Mayor Joseph McGreevy's two-year moratorium on apartments unless she is shown how the proposal could benefit the community. The bill comes up for a public hearing and final vote this Tuesday at the Commission meeting.

The measure, which passed on first reading by a 3-2 margin, would forbid the

erection of multi-family dwellings in Belleville for two years.

Mrs. Senatore charged that Mayor McGreevy's proposal, in its present form, is vague and could open the Town to expensive law suits.

"To begin with, the proposal is poorly worded. It doesn't even show in which zones the moratorium would be effective," said Mrs. Senatore. "I've consulted

several attorneys on the matter and they said the ordinance may not hold up."

McGreevy was recently quoted as saying that "Belleville is getting to look like a city," and he is obviously concerned with the Town's suburban image.

Commissioner Senatore, on the other hand, is concerned with the apartments as rateables. She said that one-bedroom unit apartments are a good source of rateables and place no burden on the education system by added children.

To prove her point, Mrs. Senatore said she is now researching a county planning survey "which will give me a whole rundown of the problem." Commissioner Robert Laterza, who also voted against the proposal on first reading, too is concerned with apartments as rateables.

# Bellboy Gridders Primed For West Essex

A tough head-knocking, bone-cracking, struggle seems to be in store for the Bellboy varsity this Saturday afternoon as they travel to West Essex Regional High School for the first time in the team's history. Game time is set for 1:30 p.m. and it is the season

opener for both squads.

Initially, Belleville was to play its first season encounter at home but the newly installed sod at Municipal Stadium field has not yet grown sufficiently to withstand game-type conditions so the contest was moved to

West Essex.

After playing out a two-year contract with Bayonne, Belleville dropped that Hudson County team in favor of meeting an Essex school.

Saturday's contest has been rated a toss-up by local grid experts, though West Essex

may have a slight edge by playing on home turf. Belleville, however, may have the more potent offensive unit as both clubs excel in the defensive column. Both teams are in the Group III size in state standings.

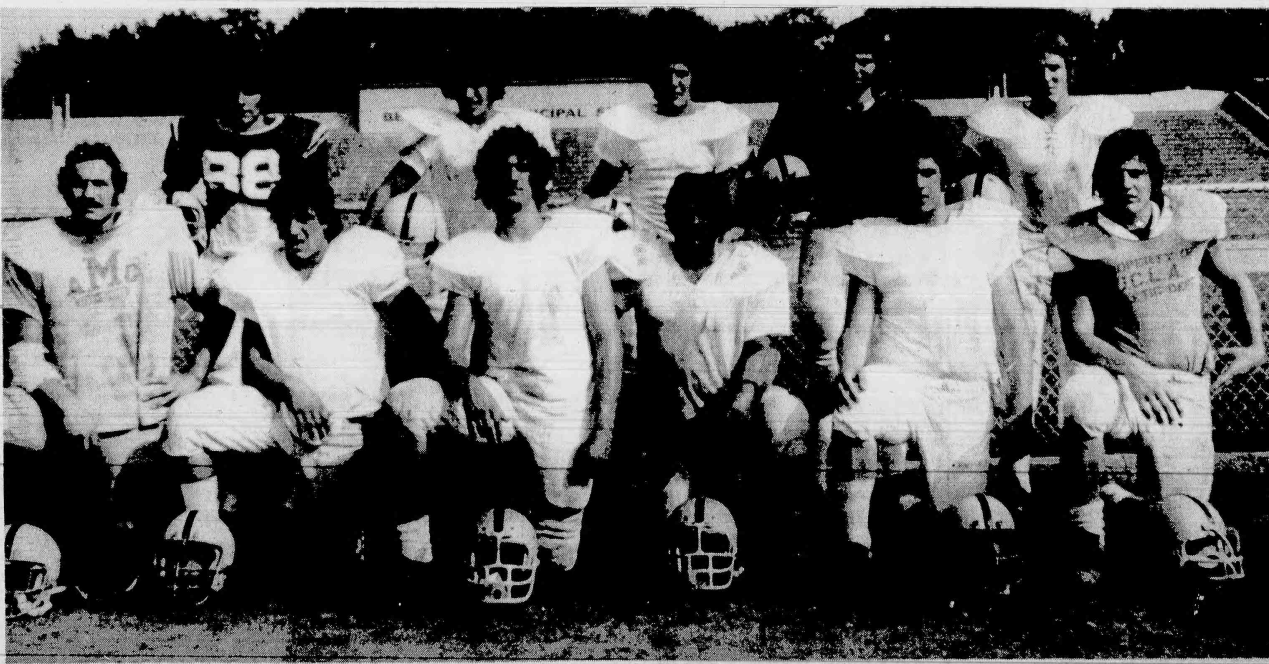
According to Bellboy head

coach Rocco Cafone, his club must move the ball on the ground if they expect to win. West Essex is noted for its defensive prowess and has seven returning veterans for a club that last year finished first in the county in total defense.

In fact, West Essex head coach Steve Tafari reports that his 1971 team was rated sixth in the state in the Dunkel high school ratings and was voted best team in the area by a Herald News sports poll. The Newark Star-Ledger rated West Essex 20th

in the state standings. Also, the upper-county powerhouse is coming off an excellent 8-1 season, one of the best in its history, losing only to tough Morris Hills.

justments could be called for by the survey team. This too could reduce needless town operating costs paid out as political largesse. There is a lot of waste and unnecessary sinecure jobs on the town paid that might be exposed if such a needed study were conducted.

How about it, you business and manufacturing executives? You have waited too long already for leadership from town hall. Now take the cudgel in your own hands, demand the Commissioners meet with you so you can spell out just what must be done, with their legislative cooperation, to get the mess cleared up.

If Belleville had an approved Master Plan and a Housing Authority, much of the blight and rookery that contributes to making some sections of our town look like a slum, could be eliminated. Apartments, in the right place, even "high rise type" wouldn't change Belleville from a suburban community, but, could bring increased taxables with many modernistic shops, stores and businesses, even professional offices that would give the town a much needed facelift. Times are changing, so too, must many of our old hidebound ideas and stubborn views. Let's unbend in the interest of saving our town from a fate that could spell disaster to the long cherished dreams of those who have contributed so much to make it a pleasant community.

Belleville is being hit with a rash of increased house burglaries, all of which point up the need of additional night patrols of our town to combat the incidence of rising crime. We can no longer adequately offer our citizens the needed police protection with three cars, with two officers, and a fourth, with a superior officer. The police in effect for over twenty years. Times have changed. Crime is on the increase. More manpower and patrols are needed for night duty to provide our citizens adequate law enforcement protection.

All this goes back to my contention that it would be a great idea to have our duly constituted police supplemented by properly assigned members of the military branches of the service as MP's to patrol our streets and highways. The police officer would be in charge of these well armed cadres of men and would make any arrests and question any suspicious characters, beelined up by the knowledge he had strong support behind him.

We'd get the protection needed. The cops would get capable armed aid and the military manpower, supplied by the Federal government, at no cost to our towns and cities.

Why doesn't some qualified legislative representative see the merit of such supplemental aid for our local police forces to aid in their fight against mounting crime...All that is needed to implement the proposal is proper authorization from the right agencies.

I understand that popular acting Tax Collector Jimmie Byrne has been given an extension to leave his Leave of Absence, by resolution of the Town Commissioners, from his position of Assistant Tax Collector. Having already had one six month leave granted by his Director, Mayor McGreevy, action by the Board of Commissioners was necessary.

The big question is being asked by those familiar with town hall affairs. How come McGreevy hasn't already appointed Byrne Tax Collector to replace retired Collector Bill Frie? Is there any credence to the oft circulated report that the Mayor would like to appoint his brother to this coveted post? Civil Service is, supposedly, in a dither over the legal status of this offer.

Jim has done a good job and sure deserves the position. There will be far reaching repercussions on the local political front if he doesn't get it. Just you wait and see.

That's all for this week. On vacation, and the "boss" has a lot of unwanted mental jobs around the manse in preparation for the Fall and Winter Season which I dread like the Plague.

## Minish Wants Rent Guidelines Overhauled

Congressman Joseph G. Minish, 11th District, New Jersey, today called for a "complete overhaul of the Price Commission's Rent Guidelines."

Minish said the Commission "has failed miserably to hold down spiraling rent increases." "Under the present system," Minish charged, "exorbitant rent increases are permitted, and even discouraged." Minish said the House Banking and Currency Committee has discovered numerous instances of "permissible" rent boosts of from 10 to 50 percent over rents prevailing in early 1971.

"In most cases," Minish maintained, "the average tenant is powerless to defend his position when faced with the complexity of the present rent rules. One may substitute cheaper food, distasteful as it may be, in order to compensate for higher prices, but housing is a different problem - one can scarcely take it or leave it. In a tight housing market, such as exists today, the tenant is largely at the mercy of his landlord."

Minish said that rents have continued upward over the last year despite claims by the

Price Commission to have held the line. Minish said, "Tenants are finding that, while their income has been the subject of close and effective control, their rents have increased with virtually no control."

Minish said he hears "almost daily" from tenants who have been subjected to exorbitant rent increases or to decreases in service.

## Air Is Charged With Excitement And Electricity When You're In the Presence Of Carol Yudin

The air is charged with excitement and electricity when you're in the presence of Carol Yudin. This reporter first met Mrs. Yudin some seven years ago when her work was displayed courtesy of the National Newark and Essex Bank in a Roving Show which toured their branch offices.

She is a diminutive lady who packs a powerful talent. The one kind of art which appeals most to her is the creation of prints which is a time consuming and rather messy process. It is an intricately involved step-by-step procedure from the first cutting out of matboard by razor

blades to the shellacking and immersing in nitric acid.

This process of steady work takes from six to seven days, "pulling a proof" on each stage as it goes through the acid. Prints must be produced ten times in order to be legally called a "print."

Carol was born in Brooklyn, studied at the Art Students League and with Michael Lenson, Michael Ponce deLeon, Sid Hammer, Roberto DeLamonia, Andrew Staski and Anna Wong. Presently she uses the workshop facilities at Pratt Center for Graphics in New York. She is a member of National Association of Women Artists, Hunterdon Art Center and president of Painters and Sculptors Society of New Jersey, she also holds membership in Artists Equity Association of N.J. and the Art Exhibitions Council.

Back in 1969 Carol and her husband Wilfred - owner of

Yudin's Paint Store in Belleville - attended the "Purchase Award Dinner" as guests of Governor and Mrs. Richard Hughes at Morven. The occasion was to honor artists whose exhibits at the New Jersey State Museum

were purchased for the permanent print collection at St. Peter's College in Jersey City. Carol has had three one man shows, exhibited not only in New Jersey but throughout the United States. One show was on a national tour under the auspices of Old Bergen Art Guild which toured the state of Alaska.

Free Eye Clinic Hailed As Successful Venture



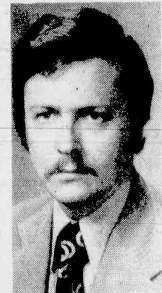

## A Proper Decision

At its last meeting the Town Commission unanimously decided to withhold action temporarily on the question of whether or not retail stores should be permitted to remain open 24 hours a day. We believe the decision to be a wise one. In the three months the local chain store has remained open 24 hours daily, the police report no problems arising from this activity. Various polls conducted among our citizens indicate the 24-hour opening does serve a convenience for local citizens who are unable to do their shopping during the daytime hours. Public Safety Director Robert Laterza was properly concerned over the effect the 24-hour opening would have upon crime statistics and the possible creation of a nuisance. Nothing has happened to increase crime in the area nor has the store opening presented a nuisance. Com-

missioner Laterza promises to keep a close eye on the 24-hour operation to be sure no Belleville citizens are inconvenienced by the activity. This is responsible government at its best — free enterprise is given a free hand to promulgate its own policies and citizens are assured that watchful eyes of an honest public official will be focused on an activity which should be of service to our people and not present a nuisance to our community.

We commend the Commission for the responsibility it demonstrated by its action and it is our belief the interests of our people are best served when they receive service at their convenience.

## Excellent Consumer Protection

N.J. State Consumer Affairs Director Charles J. Irwin this week announced his department will sponsor legislation to protect the public against unscrupulous repairmen.

The proposed legislation empowers the Department of Consumer Affairs to register all repairmen — television, automobile, radio, etc., — and temporarily or permanently revoke a registration if it is found a repairman lacks good moral character and would present a potential danger to personal property while in someone's home. The proposed regulations are similar to a system in effect in California where repairmen are

scrutinized very closely by state inspectors. We believe Irwin's proposals provide much needed protection to our people against the practices of crooked businessmen. Three more cheers for Mr. Irwin who is ranked among the best Consumer Affairs Administrators in the country. It is not by accident that Mr. Irwin serves as President, Nixon's Consumer Protection panel.

## Brazilian Troubles

A British authority, after long extensive study of the present conditions and trends, has warned that Brazil could be on her way to becoming another India, with teeming masses of unwanted poor, often starving, perpetually a problem to the government. Washington is, of course, concerned — unofficially.

Only the adoption of a workable birth control program by the Brazilian Government can change the outlook, it is said; it is thought the government will eventually take this step, as other governments already have.

Population estimates for Brazil range all the way up to 800,000,000 people by the end of this century though most observers agree this estimate is high. But even if Brazil's population soars to half that figure, immense social and economic problems will face the government, problems impossible of solution.

The bar to progress in the birth control

field, of course, has long been the Catholic Church, so strong in all of Latin America, the church's influence being strongest among the ignorant and poor — where birth control is most needed.

Americans, and polls show both Protestants and Catholics in the United States now favor birth control methods still denounced in Rome, can only hope that progress is not barred for so long the situation in Brazil becomes hopeless.

Another overpopulated India to the south of us would produce grave problems; inevitably it would be to America that Brazilians would look for dollars to alleviate the plight of these millions. As Sao Paulo continues to grow toward the world's most populous city and Brazil the most populous nation in the western hemisphere, Americans of all faiths should do what is possible to help Brazil avoid the threatened catastrophe.

One Year Ago

Two new bus stops serving residents on Joramelon Street for the Public Service Transport line No. 82 were added through the efforts of Vincent T. Strumulo, director of Public Affairs. The two new stops were set up primarily for residents living in the Bridge Brooke Estates apartment complex. A special committee of Bridge Brooke residents had told Strumulo that the stops for the No. 82 line were placed too far away from the apartments, making it difficult for them to reach the bus stations in inclement weather.

Phillip Grippaldi, a local young man who had made good on the national scene for his outstanding achievements in the weightlifting field, was to be honored at a dinner dance at the Fountain Restaurant. Grippaldi's feats included winning the Gold Medal and being voted the outstanding weightlifter in America. Grippaldi was state champion in 1969 and 1970 and won a Silver Medal in the World's Championship.

A motion for a restraining order from the Essex County Superior Court against Commissioner Michael Marotti was expected to come before the end of September, according to John Montefusco, attorney in charge of the suit against the Parks and Recreation director. Montefusco said he would ask the Court for the restraining order as soon as he received word from Civil Service that Marotti's two jobs with the Town created a conflict of interest.

Five Years Ago

The American Legion, with the complete endorsement of the Town Commission, began urging residents to fly the American Flag daily as a needed form of patriotic expression. Jack Gorman, Post 105 Commander, said the "patriotic gesture will provide a more determined effort to arouse the people regarding the present crisis in Vietnam." Gorman went so far as to appoint a committee of Legionnaires to survey the town.

The Nutley Alumni Football Squad, under the guidance of coach Mario Cocchiola, blitzed a veteran Belleville eleven with bursts of speed and a sturdy line, showing its superiority before a crowd of 6,000 fans at Belleville's Municipal Stadium. The final score was 26-13.

Ten Years Ago

The Belleville Community Welfare Council was formed at the DeWitt Savings and Loan Association. The new organization was to be patterned along lines similar to the Irvington Community Welfare Council. The Council was to serve as a medium through which citizens could coordinate general welfare services in town. Alan Bernstein was elected first chairman of the group.

The Professional Photographers Association of New Jersey named August Meks of Coast Wide Studio "Mr. Professional Photographer" at the PPA's ninth annual convention. The award, the highest honor which the state group bestowed, was given as a tribute to the member who had done the most to advance professional photography.

Route 21's Death Curve claimed another victim at the same location where four persons had lost their lives September 4. The accident brought demands from Town

Manager William Sommers, Mayor Robert Laterza, and Police Chief McGinnis that the State Highway Department take immediate steps to eliminate the death trap. Harry Hartmann, supervising engineer of planning and traffic of the Highway Department, stated that a study was almost completed and work would begin as soon as the situation had been thoroughly investigated. Belleville officials were not satisfied with Hartmann's promises and vowed to pursue the matter themselves.

Twenty-Five Years Ago

Support for Mayor James Tully for the Republican nomination for the 10th Congressional District seat arose in Belleville. There was a "Tully for Congress" move that had been started in the neighboring town of Bloomfield and a mass meeting was scheduled for Belleville citizens on Tully's behalf. The sponsor of the move, Fred Kumer, said that he was acting independently. Mayor Tully was out of town on vacation.

Citing the seriousness of the juvenile delinquency problem, the Board of Education moved to quell the outbreak of property damage to school buildings at their first meeting of the year. After hearing a report from Building and Grounds Chairman Charles Gebhardt, the Board agreed to have attendance officer Wesley Schneegas sign any complaints against children apprehended by police and charged with breaking school windows or committing any other acts of vandalism.

The Congregation of Wesley Methodist Church was to hold an informal reception in the church parlors to welcome the Rev. and Mrs. Frederick Hubach and their family to the parish. Greetings were to be extended by the Rev. Dr. George Flint, superintendent of the Newark district of the Methodist Church, and members of the Belleville Minister's association.

Forty Years Ago

As a result of a citizen's meeting in Town Hall at which the relief situation in Belleville was discussed, the following committee was named to serve with the Relief Administration as an advisory group: Bertha Kline, Charles Jones, John Portenstien, Mrs. Charles Smith, Andrew Boylan, Dr. O. Bell Close, Lawrence Keenan, Max Schwartz, Theodore Wells, and Mary Serritella.

"One-Eyed" Connolly, world's greatest gate-crasher, attended the George Younginger Post's Walkathon Connolly, who had crashed every major sports event since 1900 who was always "present" at the national conventions of the two major political parties, created the Walkathon by simply attracting the gate attendant's attention elsewhere while he slipped in.

Fifty Years Ago

For the first time in the history of Belleville two U.S. Senators spoke from the same platform. Senators Edge and Frelinghuysen addressed a large gathering arranged by the Belleville Republican League in Town Hall.

One hundred members and friends of the Pride of Daniel Webster Council Sons and Daughters of Liberty held their second annual outing at the home of Mrs. Grace Newshwander.

Nearly 3,000 children attended the playground pageant at the Cortlandt Street playground to close the season. Miss Clara B. Lehmann, superintendent, was in charge.

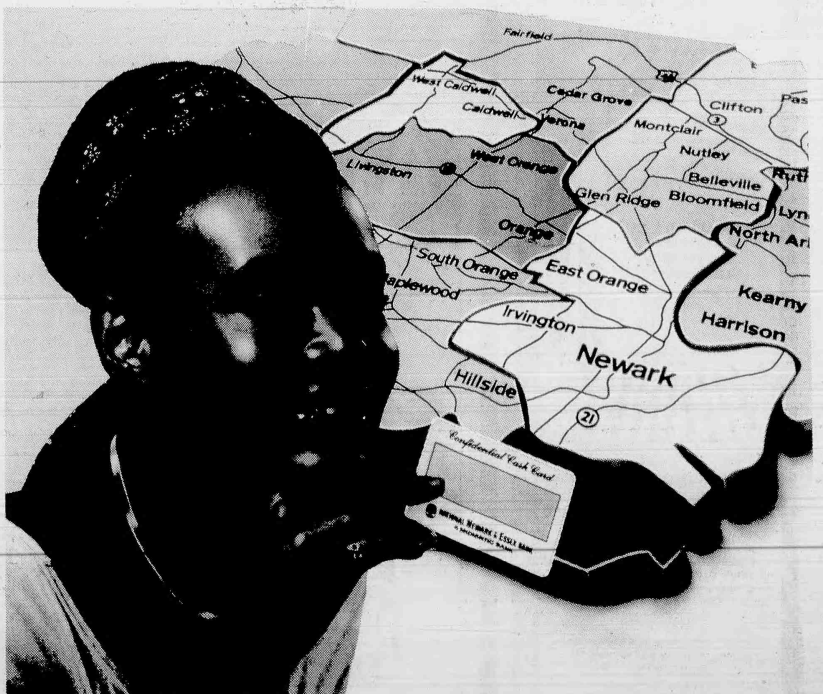

## New Courses Being Offered By Ebronix

Improvement of Scholastic Aptitude Test scores for high school seniors is the aim of one new program offered this fall by the Ebronix Learning Center, 500 Franklin Avenue, Nutley. The other new program will prepare adults for high school equivalency diploma tests.

An accounting of these new courses in continuing support of the educational community, Charles Houston, Director of the Center, said that speed reading courses will also be available, along with the Center's unique home tutoring programs in reading and math for students in grades 1-12.

Small, informal classes for the high school equivalency student are designed to help him be well prepared for the G.E.D. tests. The courses, beginning October 11, for 15 weeks, will stress improvement in math, English grammar and usage and effective reading in social studies, science and literature. Each student will be tested at the beginning of the program to determine the area which requires the most emphasis.

The individual home tutoring programs offered by the Center in reading, stress phonics or sight reading for the beginner and developmental reading, comprehension or vocabulary for the more advanced reader, according to his needs. Mr. Houston stated.

"I favor a strong system of rent-leveling and stabilization," Jim Klimaski, People's Party candidate for the 11th Congressional seat, said. Rheumatic fever, which can lead to heart damage in youngsters, is the only one among the major causes of cardiovascular disease that is definitely preventable, says the Essex County Heart Association. Yet, despite the effective treatment available, about 100,000 new cases of rheumatic fever and rheumatic heart disease still occur each year.

With this in mind, the Essex County Heart Association urges parents to have a physician check their back-to-school-bound youngsters, and advises teachers to be alert to danger signals in the "sore throat" season to come.

Chances are that sometime during the coming school year, virtually every classroom in the country will have at least one child with a contagious streptococcal infection. It might be strep throat, scarlet fever or middle ear infection. Prompt and thorough treatment can control the infection before it leads to rheumatic fever, which can damage heart valves.

The trend in all kinds of electronic apparatus has been away from tubes towards the use of solid state devices, better known as transistors. They do not burn much less electricity, don't create a lot of heat, and the theory at least do not wear out, while the life of a tube is limited. For many applications the use of transistors also means a lower price.

The transition from tubes to transistors in color TV has been very slow, and the prices for transistor color sets have been quite a bit higher than for tube sets.

There are a number of reasons for this slow transition. It was easy to use transistors in sound systems (stereo phonographs). The frequencies and voltages in audio systems are low, while, both frequencies and voltages in color TV are very high. It took years to develop transistors to meet these requirements.

Most manufacturers took their time changing over to transistors. Those that hurried had their share of problems. The most conservative and the slowest to make the change over was Magnavox. This company submitted their experimental color transistor sets to a national organization of color TV servicemen. This was the smartest thing they could have done. The suggested improvements and changes were then incorporated in a new design and again everything was checked by service technicians. The result is a Magnavox transistor color TV set which is the easiest one to service and the best in performance. As mentioned above, transistor color TV sets are higher in price than tube sets. It is expected though, that the price difference in the long run will be more than made up in a lower service cost.

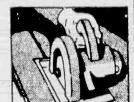

## Public Service Buys Nuclear Power Plant

Public Service Electric and Gas Company, which serves about 80 per cent of New Jersey's population, today (September 18) signed a contract with Offshore Power Systems for the world's first offshore nuclear power plants.

The contract signing took place on a boat at the site where the two 1,150,000-kilowatt nuclear units will be moored behind a huge breakwater. The site southeast of Little Egg Inlet is 12 miles northeast of Atlantic City and just within the three-mile limit.

PSEG said the offshore plants will be vital in helping to meet New Jersey's need for electricity in the 1980's.

Offshore Power Systems, a joint venture of Tenneco Inc. and Westinghouse Electric Corporation, will build the nuclear plants at a manufacturing facility now being designed in Jacksonville, Fla.

Total cost of the completed project, including the

breakwater, has been estimated at approximately \$1 billion. The value of the contract signed today was placed at about three-quarters of a billion dollars, the largest equipment contract in the history of the electric utility industry.

Among those attending today's ceremony were Rep. Chet Holifield of California, a ranking member of the Joint Committee on Atomic Energy; James T. Ramey and Clarence F. Larson, members of the U.S. Atomic Energy Commission; Mitchell Melich, Solicitor, U.S. Department of the Interior; state and local officials, and top executives of the companies involved in the pioneering project.

Offshore Power Systems plans to start construction of the nuclear units in Jacksonville in mid-1975. The first of the two nuclear units is scheduled for operation in 1980 and the second in 1981. PSEG will begin building the breakwater in 1976.

About 50 permits or authorizations will have to be obtained from local, state and federal agencies, including the N.J. State Department of Environmental Protection and the United States Atomic Energy Commission. An AEC public hearing on the application is not expected to be held until 1974.

Meanwhile, exhaustive environmental studies, which have been underway for almost two years, will continue.

After initial testing is completed at Jacksonville, the platform-mounted nuclear plants will then be towed to the site. The massive semi-circular breakwater will be finished after the units are in place. After additional months of testing the plants will be ready to produce electricity which will be transmitted to shore by underwater cable.

## Minish Explains His Position On Busing

Congressman Joseph G. Minish, 11th District, today said that his opponent in November's general election, Milton A. Waldor, "is engaging in the grossest distortion of my record which I have ever encountered in my ten years in the House of Representatives."

Minish said "I am opposed to the busing of school children in order to achieve arbitrary racial quotas and I have been."

"My opponent's efforts to distort my record on this subject and to deceive the voters of the 11th District will be dealt with on election day by citizens who don't appreciate being hoodwinked."

Minish said he usually refrains from replying to "obvious" political distortions such as Milton Waldor has issued on the busing question.

"However," Minish added, "the issue is much too serious and of too great a concern to thousands of parents to be the subject of political trickery on Mr. Waldor's part."

Minish cautioned voters to be on guard against further distortions "such as have characterized Waldor's past campaigns for public office."

"It will be impossible for me," Minish commented, "to counter each and every falsehood and half-truth which we expect from Waldor during this campaign. In the first place, I anticipate that Congress will be in session well into October and I must be on the job in Washington. Secondly, when I do campaign I intend to speak and act positively, outlining my record and my hopes for the future to the voters of the 11th Congressional District."

"Back in November of 1971," Minish explained, "I voted against certain busing amendments to the Higher Education Act. As anyone with common sense can ascertain, the busing issue is in no way germane to higher education legislation."

"Busing," Minish continued, "was injected into the Higher Education Bill by persons, led by Southern conservatives, who wanted to defeat this legislation which will provide billions of dollars in aid to students and to colleges throughout the country."

"The busing controversy," Minish stated, "imperiled the higher education measure, nearly defeated it altogether, and succeeded in holding up this vital assistance for a great many months."

"I heard from almost every college President in New Jersey and from many ordinary citizens and parents from the 11th District who were vitally concerned that the Higher Education Act pass Congress," Minish said.

"Those, like Milton Waldor, who are opposed to higher education assistance, were perfectly willing to

sacrifice the future of thousands of students in need of loans and grants to continue their college educations."

"Unlike Mr. Waldor, I chose to work for this needed help to America's colleges, universities, college students, and their parents."

"When the impasse over the busing amendments was finally broken and the legislation came back to the House for final passage, I voted for the measure."

"In addition," Minish pointed out, "I supported the strict busing restrictions which were written into the Equal Opportunities Act, which passed the House in August and is now pending in the Senate."

## Prominent Rabbi Philosopher Will Lead Ecumenical Council Series

The Nutley Ecumenical Council, which includes members of most of the town's religious congregations, is finalizing plans for its second annual lecture series this fall and winter. The first portion of the 1972-73 season will be a five session series entitled "Contemporary Jewish Thought: Relating Christianity and Judaism."

Lecturer for the series will be Dr. Fritz Rothschild, an associate professor in the philosophy of religion at the Jewish Theological Seminary of America (Teachers Institute-Seminary College of Jewish Studies) and adjunct professor in Jewish Thought at New York University. The series, which is open to anyone who is interested, will hold on five consecutive Wednesdays at 8 p.m. at Temple B'nai Israel and various local churches.

The first session will be held at Vincent Methodist Church on Wednesday, Oc-

tober 18.

This year's series is based on the success of a similar ecumenical effort in Nutley last fall and winter, when more than 150 people participated in a series chaired by Dr. Michael Ryan of Drew University. The new series, like last year's pilot program will be held in various churches and the local synagogue. Also like last year, a modest fee of \$3 per person or \$5 per couple and \$1 per student will be charged for the series, with

the participating congregations underwriting a large part of the total cost.

"Reaction to last year's series was nothing short of phenomenal," says Ecumenical Council President Guy Tienne. "The bridges of understanding built between people of various faiths will provide a basis of friendship and genuine rapport for the new series. Most people who participated found the lively discussion to be both mentally stimulating and spiritually

and culturally rewarding."

Dr. Rothschild who will lead the new series has been very active in adult Jewish education and has lectured extensively in the United States, Canada and South Africa before both lay and religious people of all faiths. Born in Germany, he emigrated to North Rhodesia in 1939 and came to the United States in 1948.

He was educated at Columbia University and the Jewish Theological Seminary of

America, where he received a bachelor of religious education degree, a rabbinical ordination and master of Hebrew literature and the degree of doctor of Hebrew literature.

Publications include a book "Between God and Man: An Interpretation of Judaism from the writings of Abraham J. Heschel" as well as numerous articles in Jewish thought in such publications as Commentary, Judaism, Conservative Judaism.

# Garden State Reluctantly Adjusts Its Milk Prices

Garden State Farm, which reluctantly adjusts milk prices Monday to the levels ordered by the State Division of Dairy Industry, but it protested that the higher prices are an unnecessary burden on the consumer.

Peter H. Sandfort, president, said, "It is with great reluctance that we comply with this inflationary order. We do not need higher prices and we do not want higher prices, and we are deprived of our right to give consumers the full advantages of the lower cost of reusable glass containers and of the efficiencies Garden State has developed with the gallon glass jug."

"We still believe in free enterprise and that a price that is fair for the consumer and for the dealer will establish itself in the traditional American free market. There is no governmental administrative agency so thorough or so wise that can substitute its judgment for the freely operating competitive controls of the market place."

The price changes and shift to no controls except at the store level follows a State Supreme Court decision upholding a DDI price increase it sought to put into effect three years ago. Garden State Farms appealed the order and the price hike was suspended while lengthy DDI hearings and court arguments took place.

"We cannot agree with the court's decision in this case, particularly when in the course of the past 10 years the court has been critical of the state's administration of controls and efforts to raise milk prices without cost supporting data required by the law," Sandfort said.

By the Supreme Court's previous action, consumers have been saved \$50 to \$60 million dollars yearly on their milk bills.

"It does not seem fair to me, that in this time of rising food cost and the concern expressed by all levels of government about them, that the state should add 10 percent to our customers' milk bills, by singling out our money-saving returnable glass jug."

"We have studied the decision carefully and we can see no alternative but to comply with the DDI order at this time, particularly in view of the fact that this is the first adverse ruling Garden State Farms has had from the Supreme Court."

"We do intend however, to pursue the alternative means of relief from consumer price controls the court suggested," Sandfort said these include seeking action by the legislature to repeal retail price controls, new hearings before DDI to correct abuses already evident and for a more equitable price schedule.

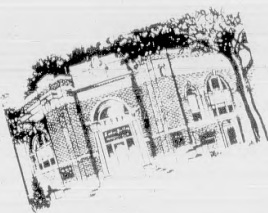

## Heart Assn. Views Rheumatic Fever

Rheumatic fever, which can lead to heart damage in youngsters, is the only one among the major causes of cardiovascular disease that is definitely preventable, says the Essex County Heart Association. Yet, despite the effective treatment available, about 100,000 new cases of rheumatic fever and rheumatic heart disease still occur each year.

With this in mind, the Essex County Heart Association urges parents to have a physician check their back-to-school-bound youngsters, and advise teachers to be alert to danger signals in the "sore throat" season to come.

Chances are that sometime during the coming school year, virtually every classroom in the county will have at least one child with a contagious streptococcal infection. It might be strep

throat, scarlet fever or middle ear infection. Prompt and thorough treatment can control the infection before it leads to rheumatic fever, which can damage heart valves.

Parents and teachers are urged to look for these danger signals: poor appetite, failure to gain weight, pallor and fatigue, frequent colds and sore throats, unexplained nosebleeds, pain in arms, legs and joints, unusual restlessness or irritability, behavior or personality changes, and a fall off in school work by a "good student."

Careful observation of the child is necessary for a few weeks after recovery from a strep infection, the Essex County Heart Association suggests, because there is a "silent" phase in the development of rheumatic fever, and one or more of the danger signals may appear to warn of trouble.

The child who develops rheumatic fever does not necessarily suffer heart damage. In those who are left with rheumatic heart disease,

The injury usually is the result of inflammation of either or both valves on the left side of the heart. In the healing process, scar tissue develops which prevents the proper opening and closing of the valve, and interferes with the normal flow of blood through the heart.

In some cases, injury to the heart does not become apparent until adolescence or young adulthood. Therefore, the Essex County Heart Association advises that children with a history of rheumatic fever be given regular physical examinations so that any developing heart

disease can be detected. For more information, parents should ask the Heart Association for a booklet titled "You, Your Child and Rheumatic Fever." Another publication available is "Children with Heart Disease: A Guide For Teachers."
