

Board of Ed accepts bid for sale of closed school

A \$275,000 conditional bid, proposed last month for the purchase of School 2, was accepted Monday

night by the Board of Education. The action put a possible end in sight to the 16 months of confusion and inaction on the fate of the vacant facility.

The fully convened board voted unanimously in favor of the offer submitted September 28 by Cerami Construction Company Inc. of Raymond Street, Belleville.

Cerami's offer was one of two bids tabled by the board at the September public business meeting for further study.

In a telephone interview on Tuesday, Charles Cerami, president of the construction firm, announced his plans to go before the zoning board as soon as possible, but declined specific comment on his plans if the municipality denies his variance ap-

"The construction business goes in stages and I have no idea how suc-cessful I'll be in this application," he said. Cerami continued, "If we don't get the variance the whole picture could be changed.'

Section I, paragraph 14, of the Constitution agreed to by the Legislature, and (1) requiring that all bills passed by the Legislature be presented to the Governor on the same or next day; (2) extending the time allowed for the consideration of such bills to 45 days, with certain exceptions; and (3) providing for special legislative sessions at the close of each legslative ter, so as to insure that all bills to which the Governor objects, except for bills passed within the last 10 days of the second legislative year, shall be subject to be approved?"

This amendment imposes a time limitation on gubernatorial con-

sideration of bills passed by both houses of the State Legislature. Currently bills are held until requested by the governor, a process known as 'gubernatorial courtesy." Thus, as the procedure now operates, bills may await the governor's call indefinitely and die without a formal veto. The amendment would require immediate forwarding to the governor and impose a 45-day limit on his consideration of such bills, after which time they would either become law or be returned, with objections, for reconsideration.



Jim Florio for governor

The gubernatorial campaign is now coming to a close.

The chief difference that separates the candidates is their fiscal approach to government.

Republican candidate Thomas H. Kean calls for the state's corporate income tax to be cut in half, the net worth tax to be phased out entirely, and the sales tax to be reduced by one cent on the dollar. It is a program, which, according to Tom Kean, will spur the type of industrial investment in New Jersey that will create jobs and improve the economy. This result is supposed to generate new tax revenue for New Jersey.

Congressman James J. Florio disagrees. Florio calls Tom Kean's proposal a give-away of tax money to industry. Florio, because, of recent federal aid

cutbacks, is more concerned over the state's ability to balance its budget without extensive cuts in state service.

Both Kean and Florio have stated they are against raising the income tax.

Florio asserts that Mr. Kean's tax proposals will reduce state revenues by \$400 million over a three-year period. Florio further charges that the results of the Kean plan will be higher property taxes as local governments struggle to make up for a loss in aid from the state and federal governments. Tom Kean concedes that it will be difficult to balance the budget in the first year of his plan when business taxes would be cut but few revenues would be generated.

The state statute requires a balanced budget.

Both Tom Kean and Jim Florio are decent and highly qualified men, competent to hold the high office of governor. We believe Tom Kean's fiscal proposals are not possible without shifting the tax burden from corporations to the homeowners — that is if we want to maintain the present skimpy level of public service. We believe that Jim Florio's fiscal approach makes more sense.

Both candidates are knowledgable of state issues. Both are perceived to have the same approach to the relationship of government to its people. Because of the difference in fiscal approaches because of our desire to prevent a possible shift of state taxes from business to the overburdened backs of the homeowners, for governor, we recommend Jim Florio.

Medicare charges to senior citizens participating in the Par "B" portion will be paying more and getting less starting in 1982. Even now the New Jersey Federation of Senior Citizens has charged the elderly are not fairly reimbursed for their doctor's bills.

At a recent session at kean College speakers sternly claimed 40 percent of seniors paying for this coverage are only repaid about 50 percent of a doctor's bill instead of the 80 percent intended by Law.

Pointed out, also, only 20 percent of New Jersey doctors are willing to accept assignment payment. Were they to agree to participate, all papework for direct payment from medicare at the "reasonable charge" for the regin would be settled without patient involvement in the claim payment.

volvement in the claim payment. Past president of hte federation, Gene Zappo, stated, "We're not asking for more money, just for an equitable system, we're asking that the intent and spirit of Medicare be used fairly throughout the nation."

He charged the state's method determines customary local charges by dividing the state into north, central and south districts which penalizes urban residents who are made to pay higher fees while the national economic index, which goes into deciding the "reasonable" fee under medicare law, is more than a year hebind inflation.

Thus, he cotended, doctor fees are too often higher than the rate authorized by the government administraiton which only authorized 80 percent reimbursement with the patient forced to pay the difference.

It was stressed that with the number of doctors who will accept assignment claims dropping, the quality of treatment care of medicare patients is deteriorating at a time when many of the elderly requiring treatment are delaying visits to the doctor because of their higher costs they must pay.

With experienced highly trained physicians refusing to take assignment, senior citizens are deprived of the best quality care availabe in the area except for those able to pay the higher fee.

Proposals were offered to change the local "reasonable charge" system by state grouping upon urban and rural characteristics rather then georgraphically, to change the national economic index that affects the rate and to make acceptance of asisgnment a condition of licensing doctors.

It was also suggested that doctors might be motivated to accept assignment if Congress would give them tax breaks based upon their volume of Medicare business...all valid proposals to land much needed relief to the burdensome costs of medical treatment ot the agee, especially, those dependent upon Medicare reimbusement for such care. These inequities would be corrected.

Senator Carmen Orechio is seeking re-election to a third term. A couple of illustrations of the manne) in which he has attempted to help taxpayers of our community may serve to point up the type of service he has rendered in Trenton for the people back home. In 1980, a muirk in the law was about to result in a 25 percent increase in the local property tax burden. He persuaded the Senate to waive its rules and had a bill to close the loophole introduced and passed without interference to committee. Then he marched over to the Assemby chambers and enlisted that body to adopt his bill, then walked it over to the office of the governor who signed it into law — thus saving our taxpayers. the tragedy of a potential 25 percent increase in property taxes

Early this summer, Orechio, Senate majority leader, he led the Senate and received the cooperation of the Assembly and the governor to adopt and sign into law a bill which enabled our town to change to

a "township," thus bringing to the local treasury a federal grant of about \$350,000.

Three years ago he pursuaded the Legisature to adopt a bill, signed by the governor, which authorized a state grant of \$6 million to build a water filtration plant which kept down the cost of water to our community.

These actions illustrate Senator Orechio's service. If the voter concludes that Senator Orechio's performance meets the high standard of honest, efficient government, then the obvious thing is for the voter to return Carmen Orechio to the Senate. He currently serves as majority leader of that body and if re-elected Tuesday, will probably be the new Senate president, the second most powerful position in state government.



Senior notes

We will have an opportunity to vote on Question #5 on the ballot in November. The following information is from a pamphlet by the New Jersey Federation of Senior Citizens.

Question #5 is a referendum question that permits the use of existing and future Casino Revenue Funds for expanded transportation and health care programs for senior and disabled citizens. In 1976, voters approved Casino Gambling with the provision that the taxes would be earmarked for senior programs. Question # 5 would allow new programs to be funded by these same Casino taxes.

For those near-poor seniors or disabled who cannot afford adequate health care, there would be a Medically Needy Program. New Jersey is the only industrial state with no Medically Needy Program.

The current income guidelines under PAA are set too low for most moderate-income seniors. Under Question #5, these guidelines could be increased to allow more seniors to receive help in paying their prescription drug costs.

Thousands of disabled receive no help with their prescription drug costs. Under Question #5, we could extend this program to help the disabled.

Transportation costs have gone up 17 percent in the last year. Thousands of seniors and disabled remain isolated in their homes for lack of transportation. Question #5 would permit enactment of an off-peak free-fare program for elderly and disabled.

Under Question #5, only new and expanded health care and transportation programs could be funded from Casino Revenue. The Federation of Senior Citizens is establishing a Senior Watchdog Committee to monitor legislative actions.

No new taxes would be levied with passage of Question #5. All programs would be funded by Casino taxes.

If you are a senior citizen, you know the hardships caused by inflation. Question #5 would ease the burden for poor and moderate income seniors. For the younger voter Question #5 is a way to help those in need at no cost to you in the way of taxes.

The New Jersey Federation of Senior Citizens, representing more thatn 125,000 elderly throughout the state urges you to support Question #5.

Also on the ballot is the bond issue that would allow \$350,000,000 for bringing our existing reservoirs and fresh water systems up to date and the building of new impoundments to alleviate the critical water shortage. This is marked Proposition #1 on the ballot and it needs your support.

They acted in good sense. I congratulate them," Risoli said Tuesday afternoon, just minutes after reading the letter.

The board's decision followed a monthly business meeting where Risoli and four township acitivists assailed the board for "delaying tactics" and trying to keep the public from voting on the issue.

The movement began last spring when Risoli, a former school board trustee and president, circulated petitions and collected signatures of citizens who were displeased with recent Board of Education members and policies.

At a meeting of fellow proponents last August, Risoli criticized the board for excessively high budgets, lack of consideration for the public, and excessive politicking as his motives

Risoli had said that "60 percent of the appointments made by the board resulted from favoritism and connections." He also complained that the school budgets "took 41 percent of every tax dollar to educate 5,000 children, but the town took only 17 percent to serve a community of 37,000.

According to New Jersey law governing school boards, Risoli submitted a petition bearing 1,156 signatures to the School Board Secretary Mary Shader on August 28. The board forwarded the petition to the Essex County Board of Elections for validation of the names.

Nearly one third of those were rejcted in October by the Edward A. Downey, superintendent of elections. Risoli then submitted additional signatures, a total of 1600, earlier this month in order to meet stipulation that such a petition bear signatures of 15 percent of the number of voters who cast ballots in the last general assembly election.

Two weeks ago, the county approved all petitions and the Board of Education presented them to School Board Attorney Lawrence Schwartz for a legal approval.

a new Section V and paragraph 1 thereto, requiring that lands shall have been tidal flowed within the last 40 years to be deemed riparian lands subject to State claims, and barring State claims not defined and asserted by law within that period?

This amendment would limit the state's claim on riparian lands to only those areas that have been subject to tidal flow within the past 40 years, and would bar any state claims to such lands if not defined and asserted within one year of adoption of the amendment

The third amendment involves use of state gambling revenues for health and transportation benefits for seniors and disabled persons. It reads: "Do you approve of the amendment of Article IV, Section VII, paragraph 2 of the Constitution of the State of New Jersey, agreed to by the Legislature, which authorizes the expenditure of state revenues derived from the licensing and taxation of gambling in Atlantic City for additional or expanded health and transportation services or benefits to eligible senior citizens and disabled residents?"

All state revenues from casino gambling operations are currently dedicated to reduce financial burdens, such as property taxes and utility bills, for eligible senior citizens and disabled residents. This amendment would add two new categories of aid, specifically health and transportation benefits, for the same two classes of citizens.

Two public questions appear on Tuesday's ballot. Both have been passed by the State Legislature and have been signed by the governor.

The first is entitled, "Water Conservation Bond Act Interest Rate Ceiling Elimination," and (Please see 'Poll' on page 16.)







Despite the baseball strike and the short season, the 1981 World Series is proving to be an exiting affair that could very well wipe out the memories of the past season and add a new zing to the upcoming 1982 season next March.

It is still the biggest showcase in sports, the World Series. While the Super Bowl might be the biggest one game affair, the series is still the most exciting, nail biting, action packed sporting event around. Each year, ball parks throughout the country are mobbed for the event and almost always a new hero is born from the game.

Looking back on some of the big series throughout the years, who can forget the 1975 classic between the Boston Red Sox and Cincinnati Reds. For seven games, these two teams battled each other on an even note, with the Reds winning with a run in the top of the ninth of the last game. Cincy won the game, 4-3 and took the series by the same count. But who can forget the Carlton Fisk homer in game six, the Luis Tiant shutout in game one and the big hitting by Joe Morgan, Pete Rose and George Foster of the Reds.

How about the 1977 series between this year's participants, the Yanks and Dodgers. Who can ever forget the big game by Reggie Jackson in game six of the series when he hit three homers off of three Dodger pitchers. The Yankees won that final game, game six, by a score of 8-4 and Mike Torrez was the big hero on the mound, winning game two and then the deciding game

The Pittsburgh Pirates and Baltimore Orioles engaged in two memorable series in 1971 and again in 1979. On both occasions, the Pirates woh in seven games, but in 1979, it took a miraculous comeback by the Bucs to wine. The Orioles jumped out to a three game to one lead but Pittsburgh won the final three, the last two games in Baltimore. The Pirates' relief pitching sensation, Kent Tekulve, shut the door on many Oriole rallies and Willie Stargell led the "We Are Family" chant as Pittsburgh added a new dimension to the series. While a lot of series' champs have been known as controversial and hot blooded, the Pirates "family" unity was something new and refreshing.

The 1968 World Series between the Cardinals and Tigers saw St. Louis jump out to a 3-1 advantage in games only to watch Detroit come back to win the last three games, the last two in St. Louis. Micky Lolich was the hero of the day as he won three series games and out dueled Bob Gibson in the final game to win the series for Detroit.

The Oakland A's won the series for three straight years, 1972-1974 with Reggie Jackson of course leading the way. In 1972, the A's defeated the Cincinnati Reds 4-3 as an unknown catcher by the name of Gene Tennace blasted four homers in the series and was named the MVP. The A's pitching staff in '72 was led by Ken Holtzman, Rollie Fingers and Vida Blue. Jackson missed this series because of a torn muscle in his leg, incurred while stealing home plate against Detroit in the deciding game of the American League Championship series.

In 1973, the New York Mets won three of the first five games, but returned to Oakland for the last two games and lost twice. Rusty Staub was the hitting hero for the Mets while Jackson and Billy North, when they weren't fighting, were leading the hitting department for Oakland. Jackson and Bert Campanaris hit back to back homers off of Jon Matlack in the seventh game that led to the victory

Finally, the A's made it look easy in 1974 by beating the Dodgers in five games as Fingers led the way out of the bullpen. Oakland would go on to the championship series in 1975 but Boston would upset the A's and go to the series. A's owner Charlie Finley later started to dismantle the A's by trades and sales and for many years, Oakland was on the bottom of the heap. When Billy Martin arrived in 1980, it marked the turnaround in the team's fortunes. Oakland was swept in the championship series by the Yankees this year but the team is on the upswing. Don't forget that before the Oakland dynasty of 1972-1974, the A's were swept in 1971 by the Baltimore Orioles before winning the series the next three years.

Whoever wins this year's series can look on it as a well earned championship. Despite the strike, the World Series has been a fine reprieve and will close out the 1981 season on a high note.

Did you watch the New York Marathon last Sunday? That was quite an event and Alberto Salazar certainly proved what kind of athlete he is. Salazar, from the University of Oregon, had predicted that he would break the world's record for the marathon and then in grand style went out and shattered the mark by some 18 seconds. Any runner who competed in the Marathon and completed it deserves to be called a winner. That is quite an accomplishment to run 26 miles and a lot of people, handicapped and a lot less fortunate than a lot of us, certainly proved what heart and desire is all about.




