School board accepts state asbestos grant

\$228,849 in state asbestos abatement funds are heading Bel-leville's way, following a unanam-ous - and enthusiastic - vote by the Board of Education to accept the money at the July 13 School Board meet meet

The grant is for the recommended removal of asbestos-containing materials in the Belleville school system. According to consultants hired by the board, there is no immediate danger to school-children or staff - but the condition could change at any time. Once asbestos becomes loose from the fixtures (such as pipes) which it is applied to it becomes airbornes applied to, it becomes airborne. The fibers can then be breathed in and potentially cause cancer. This condition is known as friable asbest-

The current state payment is the lion's share of more than \$300,000 which will eventually be granted to Belleville. However, school offi-cials say the total cost of the districtwide asbestos abatement plan will be about \$1 million, with half the work taking place this summer and the other half taking place next

The grant was apparently the result of some homework on the part of school board newcomer Patricia Pisano.

While still a candidate this past spring, Pisano appeared on a Bel-leville Times/OBC-TV "From The Editor's Desk" show where she stated that there were state funds for asbestos abatement available, and that she was looking into it.

Two months later, some of that New Jersey money is coming into town

But the grant is expected to account for just one third of the \$1 million asbestos abatement price-

In a related development, Con-cerned Citizens Vice President Gabriel Nazziola said that federal funds are also available. During the public hearing portion of the July 13 meet, Nazziola asked Board Secret-ary Charles Miele if they've been applied for yet. "We should be applying for

those funds next week," Miele replied, adding that the application entails detailed technical paperwork.

Sen. Orechio lauded for anti-hunger aid

To the editor: Thanks to the efforts of Senator Carmen A. Orechio "The Special Nutritional Assistance Sup-port Fund (WIC) was brought to a vote last Thurs-day in the State Legislature and is now on the Governor's desk for signature. During the years we have witnessed the sight of our State administrative agency returning millions of dollars to the federal government rather than using those millions for what they were intended for — reaching poor women, infants and children whose future depends om getting a healthy start in life. With the relatively small appropriation in the WIC support fund the steate agency can stop sending money back and reach more eligible people here in New Jersey. "We are within one short step of home," Elise

"We are within one short step of home." Elise Yorton, chairperson of the One Community Against Hunger, announced today. "Our organization targeted this bill as one of the most important before the legislature. We have wired the Governor asking him to sign the Nutritional Assistance provi-sion into law. We are advised that he is favorable to it."

"One Community is engaging in an effort to make "One Community is engaging in an effort to make sure that mothers and pregnant women who would benefit from the WIC program are fully informed." One Community chairperson, William Brach, said today. "We have been working with food pantries, day care centers and the Township's WIC program to get the word out. The paradox of funds being returned to Washington while eligible women are being turned down for insufficient funds can be resolved by the implementation of the 'Special Nutritional Assistance fund." One, regarding the \$2,500 fine (negotiated down from \$14,000 by the board attorney) paid by the current Board of Education (with taxpayers' dollars) for acts of omission by top school administrators in 1983 in failing to comply with the notification requirements of the federal Asbestos-In-Schools-Rule for over three and one half years. Since Bifani was made privy to actual documents, and knew better, he "selectively accepted" and failed to report the board attorney's attempt to mislead the public into believing that the act of omission was a trivial matter of a misplaced poster, instead of the reckless endangerment of the lives of students, faculty, administrators, maintenance men and enstodians for over three and ne half years.

Township Attorney Frank Coz-zarelli states, "The question has come up...is he (Fornarotto) in conflict?" Who, we ask, brought up this question? The Township Attorney offers the opinion, "He

cannot remain in both positions. "That is only an opinion. Had he been ordered, by a majority vote of the Board of Commis-sioners, to express an opinion on this matter or did he render such an opinion on his own initiative? Robert C. Gruhin, a prominent Belleville attorney, contends the commissioner is not in any con-flict and says. "The town at-torney is all wrong and using a decision from Union City, where commissioners gave themselves additional offices." Since Commissioner Fornarot-

additional offices." Since Commissioner Fornarot-to had the foresight to have ob-lained advanced written notice from a state agency that he would not be considered as being in a conflicting situation were he elected commissioner and holding the inspector position. It seems to reduce the matter to one of being academic mootness.

Why not a female commissioner?





This summer there are more than fifty pairs of school parents who have had to send their children off to summer school in order for them to graduate. The unusually high number of kids who didn't make the grade has been attributed to changes in the grading procedure and stricter graduation requirements. Many parents complained that the changes came "mid-stream" in the case of seniors who went

the changes came "mid-stream" in the case of seniors who went through minth, tenth and eleventh grades under the old procedure and then were "hit" with the new pro-cedure during senior year. The new procedure, they bel-ieve, should have been initiated with an instraining feature they bel-

ieve, should have been initiated with an incoming freshman class. School officials, however, say that the policy had to be implement-ed somewhere, and there's no time like the present. Further, the new procedure will raise up the stan-dards and thoroughness of educa-tion in the Belleville School System. Reminds me of my own senior year in high school, way back in the early eighties up in Bergen County. A new policy was put in place...a-

A new policy was put in place...a ny student who missed more than 18 days of school couldn't graduate (or in the case of underclassmen couldn't get promoted).

At the time I was more interested in rock n' roll, motorcycles and comic books than school and by mid-year I amassed enough

I had two choices. Drop out and take an equivalency, or graduate the following year.

I dropped out. Sure, I complained that I was hit with this new policy during the crucial senior year. But again, school officials simply said that the policy was deemed appropriate and there's no time like the present. That summer I paid ten dollars to take and pass the Graduate Equivalency Diploma test (GED.) My ceremony was opening a piece of mail and reading a computer

ed a valuable lesson: There's no guarentee that things will stay the same...life is full of burn deals. We have to prepare beforehand, and means a little more studying during the school year or a GED over the

And in the case of the fifty-plus kids who didn't graduate, most of them, we're told, were borderline in Enalder

Of all subjects to be lax in! Students should realize that there's alot more to passing English than just being able to graduate. Command of the English language is the prorequisite for success in the free world. Command of the Eng-lish language means command of your destine

I failed English, too.

On the American Constitution 'How deeply raged the spirit'

By Russell Roemmele

By Russell Roemmele Many myths have been created about the American Constitution. Perhaps no myth has been more prevalent, especially among modern liberal-oriented historians, than the myth that says the primary cause for the Constitu-tional Convention was the failure of the Articles of Confederation to govern

primary cause for the constitu-tional Convention was the failure of the Articles of Confederation to govern. On the contrary, for the Articles were replaced mainly because they failed overall to protect the in-dividual and property, rights of sizeable constituencies of A mericans from power blocs con-trolling the state governments. The Constitution did not come about because the people wanted more government; it came about because they wanted less govern-ment. The ordinary people, as did many of its Framers of the Con-stitution, dared to hope that the Constitution would insure the rights for which the American Revolution had been fought. To fully uederstand the temper of the Americans in 1787, it is bet ter we not read only the somewhat diaries, speeches, sermons and of-ficial papers. We then are remind ed how deeply raged the spirit of independence, of liberty, of private property. We hear of the "Spirit of 76", of the heroism at Valley Forge, of the courage of the Founders of Philadelphia in 1776, and of the ordinary farmers and townspeople who sacrificed so much for independence, liberty and private property in revolution against English tyranny. But how did the first Americans get that way?

way? The struggle for independence, for liberty and for private property brought about the Revolution and the Constitution. But such a strug the constitution at struggle de – so passionate a struggle – did not originate in a vacuum. No, the Revolution and the Constitu-tion had begun decades earlier, and in each of the 13 colonies. No lesson from this is revolution. lesson from this is more revealing than in our reading the histories of

the states and, as I emphasized earlier, to read the writings of those times. Each state can produce nume-

Each state can produce nume-rous examples of our forefathers in efforts to gain mational in-dependence and to institute a free republic in place of the oppression of a decrepit English royalty. New Jersey, as much as any state, can attest to this, and I shall be detail-ing some of the efforts in New Jersey for independence and for a republican system of government. In this brief article, however, I shall deal with similar efforts in three other states (Massachusetts, Pennsylvania and Virginia). Massachusetts

Demsylvania and Virginia). Massachusetts Let me begin with a quote from Garrett Wendell's classic bio-graphy, "Cotton Mather" "But it was no use The peo-ple of Massachusetts were ripe. for revolution on the 18th of April (1689), Boston rose in arms, seized the chief magistrates, besieged Sir Edmund (Andros, appointed by King James II of England) in the Castle, dismantled the Rose frigate, and took possession of the government in the name of 'His Highness' (the Prince of Orange, the new ruler of England and the English Parliament. To appreciate the full boldness of this bloodless revolution, we must remember for the Deireck for English Parliament. To appreciate the full boldness of this bloodless revolution, we must remember that no rumor of the Prince's for-tunes had reached New England, and that every man of those who put themselves at the head of the movement knew that if, as might well be, James had prevailed in England, their action would pro-bably cost them their heads." Let us remember that these revolutionists in Boston, about eight decades before John and Sam Adamas for example, were not never do-wells. They were pro-perty owners, elected members of local government, Protestant ministers, all united against the despotic rule of King James and his agents in the colonies. Un Massachusetts in general and throughout most of the colonies, support was given to the Prince of Orange and, more important, to what the English have named "the

Glorious Revolution," in which Parliament finally wrestled its in dependence from royalty and English constitutional law beccame dominant. In brief, Massachusets joined in solidifying the right of Parliament against the "devine right of kings." In so doing, the spirit of independence and of liber ty was nurtured. That spirit was in return and haunt thst very Parlia ment in 1776, when the colonists demanded the rights that English men enjoyed. men enjoyed.

Pennsylvania "Before the passage of the Stamp Act, the British Parliamenti had already entered upon its new post war approach to British American relations. The war had revealed the looseness of the em-pine and its failure to act as a coor dinated unity in time of emergen-cy. The British debt was colossal and there arose a general feeling that the col-onies should assume at least part of the current cost of defending and garrisoning British North America.
