Board members split over super search

Belleville's school board president said that the interim superintendent can continue in the capacity into the 2010-11 school year, but while one other board member strongly supported giving Persi another year, other school board members said they think the search for a permanent replacement should be ongoing.

Interim Superintendent Melindo Persi's temporary tenure officially ends at the end of June, but Board President Joseph Longo said that involving New Jersey School Boards Association in a search for a permanent replacement is not necessary at this time.

"We haven't begun a search [for a permanent replacement] yet," Longo said. "There is no particular rush. The guy we have can be extended to continue for up to two years. He's doing a good job getting things organized and putting together a lot of things."

Longo said former superintendent Edward Kliszus explained to him before he left at the end of last September that the interim label could be good for two years.

"There is nothing improper; we have a contract with Mr. Persi, and the board can vote to keep him," Longo said. "We're in the middle of putting together a bud-

get and have a lot of other things in place."

Former board president and current board member Arlene Schor did not endorse holding up the process of search for a replacement, saying, "Finding a permanent replacement is one of the key responsibilities of the board, to search for, interview and select a permanent superintendent. It is appropriate at the time of the resignation of a sitting superintendent. It usually takes a long time and involves the state School Boards Association."

"Nowadays a superintendent can be hired for up to three years. You want continuity"

Board member Carmen Bucco, on the other hand, said he supports giving Persi a second year as interim superintendent.

"If I could afford him in my business, I'd hire him tomorrow," Bucco said. "He's done more in a short time than the last superintendent did in three years. He's doing strategic planning, answering all our questions."

"The district's morale was beaten up the last couple of years, and now it's phenomenal. We want to do a better job. If I could, I'd give him another three years. As it is, he can lay the groundwork. It's like looking for the best for your business. The man has walked the walk. He's going to help us get

started with the hard part and the help us find a super just like him to take over."

Former board president and 12-year board member William Villano said he had no comment on the superintendent search.

Board member Vincent Strumolo Jr. was clear in his desire to look for a permanent replacement. He said it was "crazy" not to have begun a search for a permanent superintendent.

"Overall, the guy we have is doing a good job, and trying very hard," Strumolo said. "But it's our obligation to look for someone permanent. We don't want to wait until the eleventh hour, and have one guy leave one day and another come in cold, like what happened with Persi and Kliszus. They didn't even talk."

"This is a long process that takes months, and we're definitely at the cutoff point where we have

to keep Persi for another year. My big thing is that we don't want the next one to come the last day. We want a smooth transition, so the new person can say what they want to choose to continue and what not to."

Board member Eric Schwartz said he is not as sure as Longo that allowing the search to go undone is the proper move.

"The search should be going on," Schwartz said. "I don't know what's going on with it. The gentlemen in place is doing a pretty good job, but he's only supposed to be here for a year."

Board Vice President Bill Freda could not be reached for comment.

Last September, just two days before Kliszus left the district for a job in Hackensack, the board selected Persi to serve in the position until a permanent replacement is chosen. Persi is being paid at a rate of \$750 per diem for each day he serves, while collecting a full state pension, according to Board Administrator Edward Appleton. Appleton said the interim tag could continue into the 2009-10 school year.

The last-minute pick came because a divided school board could not agree on who should lead the district.

BHS student looks forward to her journey

Fantashiyaa Rivera has a chance to see the world, but needs help from here at home to make her dream come true.

Rivera, a Belleville High School freshman, was accepted in December into the People to People Student Ambassador class of 2009.

As a student ambassador, she has the chance to join "the effort to bring the world together through education and friendship while experiencing a wonderful journey of discovery," according to Mary Jean Eisenhower, president and CEO of People to People International.

Rivera will travel to Italy, Austria, Germany and France, and said that Paris and the Eiffel Tower, are the city and landmark she is most excited about seeing, respectively.

She said that after the trip she might consider a life living and working abroad.

Her mom Wanda said she has printed letters to teachers about sponsorship, and as a single mom, she needs financial help to make the trip happen.

"Times are difficult, and the trip is expensive, but I want her to see what is out there," Wanda said. "There is so much more out there in the world to experience than what she has seen in Belleville and Nutley. I'm excited, and I'm not

even going."

The ambassador group has meetings once a month to get the students ready, one of which includes learning four verses in each of the four languages of the countries they are to visit. There will be three days of home visits in each country.

"They will learn how these people experience life, from food to culture, and make friends internationally," Wanda said. "She will be there for 19 days, something most adults could never afford."

Fantashiyaa said, "I am really anxious to learn about other cultures."

One exercise in preparation involves grabbing a handful of M&M candies, and revealing something about yourself for each candy chosen, something she is practicing now to better share American culture with her new friends abroad.

Her mom said she expects her daughter to come home more mature and attuned to what is happening around the world.

In the meantime, both mom and daughter have nice things to say about their adopted hometown of Belleville, which Fantashiyaa said has been a good experience, "especially the social aspect," with people being welcoming and friendly.

Wanda said they have lived here about 12 years.

"It reminds me of growing up in Summit," Wanda said. "It's a small

Bystander rescues others from three-alarm blaze

Belleville firefighters battled a tough fire in an occupied multi-family dwelling in the south end of the township, driven by high winds, threatening near-by houses. A civilian working in a rear yard was credited for his quick actions to alert the occupants, and bring them to safety.

Authorities received 9-1-1 calls at 1:22 p.m. on Feb. 12 reporting a house fire at 26 Van Rensselaer St. with the possibility of people inside. Battalion Chief No. 1 and Engine No. 2 arrived within two minutes and reported heavy smoke coming from the eaves of the building. The building on fire was sized-up as a three-story, wood-frame, occupied dwelling in close proximity to a house of similar construction.

Firefighters stretched a hoseline and initiated a quick attack from Engine No. 2. Truck No. 1 and EMS No. 1 arrived on scene and began a primary search for any trapped occupants, and found that everyone escaped the building. Engine No. 3 stretched additional hose lines to cover the first crew, and established a water supply from a nearby hydrant.

The third floor was heavily charged with thick black smoke, and well involved in fire on the right side. Wind-whipped flames were extending outward, and threatening an adjoining house at

24 Van Rensselaer St., separated by a 4-foot alleyway. Firefighters had to breach walls on the third floor to extinguish the flames.

The fire spread quickly due to gusting winds, upwards of 30 mph from the west, and the building construction, with a concealed attic space. The house at 24 Van Rensselaer suffered exterior water and fire damage, and interior smoke damage.

Due to the intensity of the fire, weather conditions and the proximity to adjoining houses, additional alarms were called for by Incident Command. Firefighters from the neighboring towns of Nutley, Bloomfield, Newark and North Arlington responded to the scene. They rotated in crews to attack the blaze, and protect the exposed buildings from catching fire. At one point, the roof collapsed inward, and firefighters had to reposition their interior attack to avoid being trapped within the debris.

Initially, 11 Belleville firefighters responded with two engines, one ladder, one EMS unit and a battalion chief. The fire ultimately went to three alarms, and Essex County mutual aid was put into effect.

Fire departments from the county responded to Belleville to cover the fire stations and to the scene to assist extinguishing the blaze.

A Rapid Intervention Team was called, a duty assigned to the Nutley Fire Department. Its sole purpose is to stand ready with special equipment to go in and rescue any firefighter or civilian found to be trapped inside the burning building at any point during the fire.

The fire was declared under control at 2:30 p.m. and extinguished by 4 p.m. The Belleville Fire Department's Fire Investigation Unit remained on scene until 12:30 a.m. to investigate the fire and assist residents in retrieving any belongings they could salvage. Off-duty firefighters were recalled and responded with Engine No. 1 for fire-watch duties, checking for hot spots within the building.

The blaze burned through the top third floor and heavily damaged sections of the second floor. The first- and second-floor apartments had water and smoke damage. Fire officials identified the three-story structure as having

Council hopes permits will help parking around BHS

Neighborhoods near Belleville High School are finding parking more and more difficult, so township officials are granting permit parking to different stretches of road involving Greylock Parkway, Austin Street and the high school.

At the Feb. 10 Belleville Township Council public meeting, an ordinance was introduced establishing a parking areas on the north and south sides of Greylock Parkway, between Passaic Avenue and Nolten Street. The rules are also specific to the east-side of Austin Street, between Greylock Parkway and Mitchell Street. The third area encompasses the westside of Austin Street, between BHS and Mitchell Street.

The changes involve the hours between 8 a.m. and 4 p.m., when only one-hour parking is permitted in these areas because school is in session.

The council "has determined that due to one-hour parking during school hours on Greylock Parkway and Austin Street, it has resulted in residents of Greylock Parkway and Austin Street having difficulty in obtaining parking spaces near their home for more than one hour," the ordinance explains.

Greylock Parkway resident Florence Pentol said she supports the move.

"They should have parking,"

Pentol said. "They pay taxes there, and they live there."

The police department conducted a traffic study, and officials said they determined that many residents on those two streets do not have access to driveways and parking is difficult. So residential parking permits would be granted for all the above-mentioned areas, with signs to be posted advising the public that those locations are designated for permits only during those hours.

Township Manager Victor Canning is authorized to issue the parking permits, exclusively for Greylock Parkway and Austin Street residents in those specific areas.

Having a permit would not "constitute a guarantee to the person to whom the permit is issued that a space will be available for the designated motor vehicle," according to the ordinance.

The permits can be issued for a full year or six months, and are \$50 for a full year and \$25 for six months.

Every permit is supposed to be affixed as a decal in the motor vehicle in the lower right hand corner of the rear window.

Any person violating any provision of the ordinance, if convicted, could be punished by a fine not exceeding \$50 for each violation. The ordinance will become law 20 days after being published in the newspaper following a public hearing in March.

Keeping our neighbors and their houses

There are no easy answers to our economic crisis. In fact, no one is sure any answer given is the right one. But something has to be done.

State Assemblyman Ralph R. Caputo (D-28th) of Belleville made a move that will hopefully assist homeowners facing imminent foreclosure. Gov. Jon S. Corzine recently signed his bill into law.

According to Caputo, the law appropriates \$40 million from the state's Long Term Obligation & Capital Expenditure Fund to provide homeowners with two different options to help them stave-off foreclosure.

The first option is non-amortizing – or no monthly payment – second mortgage loans of up to \$25,000 to encourage homeowners and their lenders to refinance first mortgages to lower amounts.

The second option provides financial inducement, up to \$25,000, for "lease-purchase" agreements. The latter would last no more than 36 months between homeowners and non-profit sponsors, whereby homeowners sell their homes to the sponsors, but are able to remain in their homes in exchange for paying reasonable rents to the sponsors until they are able to buy them back.

The non-amortizing loans will be offered via a \$25 million Mortgage Stabilization Program/Fund, while financing in support of the "lease-purchase" agreements will be available through the \$15 million Housing Assistance and Recovery Program/Fund.

Both programs will be administered by the New Jersey Housing and Mortgage Finance Agency.

According to Caputo, to be eligible for either

program, the properties must be owner-occupied primary residences, the homeowners may not hold interest in any other residential real properties, and the homeowners' incomes may not exceed 120 percent of the area median household income.

This should help some families potentially facing financial ruin due to the mortgage crisis. It should also help keep our neighborhoods intact and not becoming blighted.

District tries to get foundation on its feet

At the most recent Board of Education meeting, the progress of the district's educational foundation was discussed, and then clarified in separate interviews.

Discussions about the Belleville school district's fledgling educational foundation were made by the school board president, who said that the district is "continuing to reach out" to appropriate private sources for donations.

The foundation is a private entity meant to raise funds for programs, supplies and repairs that the district is struggling to raise after years of school budget defeats and what officials say is shortfalls in state funding.

Board President Joseph Longo said, "We are not running the foundation, it is run by a separate board, but as it gets up and running, we continue to look outside the usual sources."

Board member Carmen Bucco brought up the subject, referencing a recent foundation meeting.

"There are a lot of movers and shakers who could have an interest, and this should be looked at," Bucco said.

Lisa Kistner, president of the Consolidated Home and School Associations, which encompasses all the associations, told the school board she had not been made aware of the foundation's

existence.

Board member Arlene Schor acknowledged that the board had made a mistake in not alerting Kistner about the foundation's existence.

"Mrs. Kistner is one of the key people in town," Schor said. "She communicates with people throughout the town. We should've informed her. She qualifies as a key communicator."

One of the components of the foundation is to identify the so-called key communicators in town and involve them in the foundation.

In subsequent interviews, Longo and Bucco talked in greater detail about the foundation.

Longo said the educational foundation was being put together

as a non-profit corporation for the purpose of raising money outside that raised through property taxes. What is raised will be applied to different areas of the district. He said the corporation is awaiting state approvals to make things official.

"We invite prospective trustees to look at what the district might be," Longo said. "Operating independent of the school board, they have been meeting about a mission statement and planning events. It's essential, especially in these economic times. It's going very well and has strong support by a group that is working hard."

Bucco said the foundation is part of a plan to make the district much better.

"It's a nice way to help students

get some things that taxpayers can't pay for," Bucco said. "It's amazing the way people are moving forward with a great outlook on what students can do."

For example, he said extracurricular activities could be funded through the foundation, many of which are now threatened by budget constraints.

"It can help move the town forward," Bucco said. "It was brought up by Mr. Longo, and we're really looking to raise money instead of digging deeper into taxpayer pockets. Everybody wants more, and the only way is to raise more money."

He said fundraisers and corpo-

rate sponsors could do a lot for the district.

"The public has to get on board, and from what I've seen, people want to get on board," Bucco said. "This is not for us [board members]. It's like a business, where the students and teachers are the revenue, and they cannot profit if we do not move forward. We can make sure students have the same opportunities as in every other district, by giving them what tax money can't give."

Details of the trustees and the mission statement will be coming as the foundation comes together, Longo said.

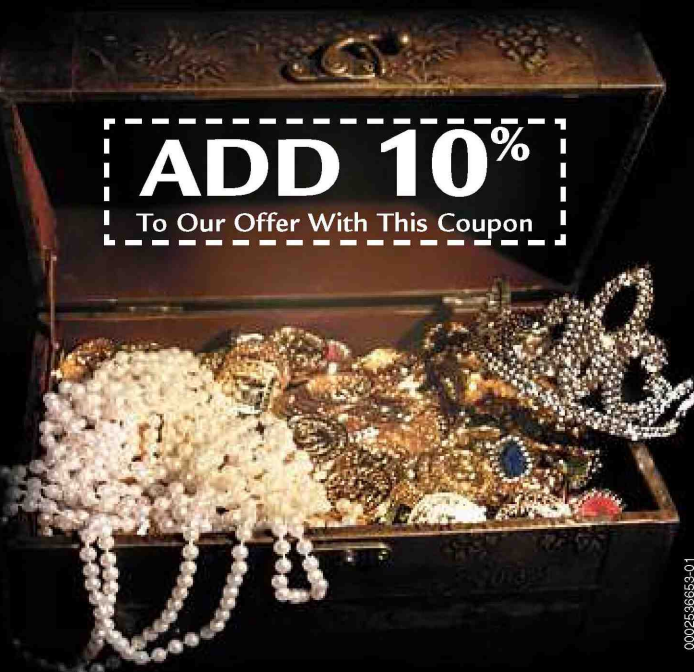

Township announces possibly more tax relief for some

Belleville Mayor Raymond Kimble and the Township Council has announced that senior citizens and disabled persons may qualify for tax relief due to a recent change in the law.

On Dec. 18, 2008, c 119 was signed in to law, which increases the income eligibility limits for the Property Tax Reimbursement Program, which reimburses senior and disabled persons for property tax increases.

The income limits for 2007 increased to \$60,000 or less for all applicants whether single, married or in civil union. The previous

income limits for 2007 were less than \$45,135 for single applicants and less than \$55,344 (combined income) for married and civil union couples.

As a result of this increase, some senior and disabled New Jersey residents, who did not previously qualify because their 2007 income was too high, are eligible for a 2007 reimbursement, provided they meet all other eligibility requirements.

The New Jersey Division of Taxation is doing a special mailing of 2007 reimbursement applications to residents who may be eligible

due to the increase in income limits.

In addition to the change in income limits for 2007, the income limits for 2008 have been raised to \$70,000 or less, and 2009 have been raised to \$80,000 or less.

Homeowners should soon be receiving applications for the 2008 property tax reimbursement.

FLU ALERT

Colds are ten times more common than the flu, and you can catch them all year. The flu generally strikes from late October to mid-April. A cold is an upper respiratory infection usually associated with a runny, stuffy nose with thick greenish-yellow discharge, and a scratchy throat. three apartment units, one on each floor.

Five adults and one child from three separate families were displaced as a result of the fire; some were relocated with the assistance of Red Cross disaster teams.

The cause of the fire has yet to be determined, but appears to be accidental. The Belleville Township Building Department was requested to the scene to evaluate the damage, and the house was declared uninhabitable.

There were no reported injuries to firefighters or residents. Two cats were removed from one apartment after the fire and turned over to their owners for care.

Fire officials are crediting a civilian who was doing work at 24 Van Rensselaer St. with saving the lives of two occupants. He saw smoke and fire coming from the roof and knew the third-floor tenant was home. He called 9-1-1, and then ran into the house. Reaching the third floor, he forced open the apartment door, and found the 75-year-old resident, who was unaware of the fire. He assisted the man downstairs, stopping at the second floor and kicking in that door, awakening a tenant. All three escaped as smoke filled the house.

Longo reiterated in September that he was part of a three-person board committee that first interviewed the candidates, but the committee's recommendation did not have the necessary votes, and that unnamed candidate was not chosen.

Since Persi took over, however, Longo has worked closely with the interim administrator on a number of initiatives, including a strategic planning process with committees helping decide the district's future. The board is also expected to hire an architectural firm to outline the specific needs of building repairs and the costs of those repairs.

Reflecting the split, board member Carmen Bucco still voted against Persi's hiring, the only board member to vote no. However, Bucco said Persi's actions have changed his mind about the vote.

Villano recused himself because his brother, Dennis Villano, is assistant superintendent and was presumed to be a candidate for the interim superintendent's position.

As the nation's economic quagmire worsens, an increasing number of area residents confront job losses and diminished wealth.

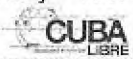

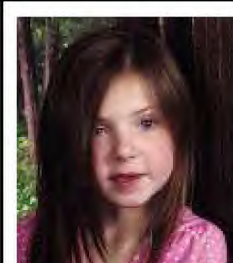

Fusco records big upset wrestling at 125 pounds

Belleville native Matt Fusco, a freshman wrestling at Rutgers University, won a big match last Friday when he defeated nationally ranked Ian Moser of Bloomsburg University, 10-7 in a dual match at Bloomsburg, Pa.

Fusco, who wrestles at 125 pounds, improved to 14-11 on the season for Rutgers, which is enjoying an outstanding campaign with 20 dual victories.

Moser was ranked 25th in the nation at 125 pounds and Fusco knew it would be a tough assignment.

"I had him in a cradle at one point and tried for the pin," Fusco said. "I knew Moser would be very good, but I felt confident I could compete."

Fusco and Moser were tied at six after one, but Fusco's defense proved to be the difference for the remainder of the match. Fusco took a 9-6 lead after two periods on a take down and escape, then wrapped it up with a third period escape.

Fusco, a graduate of Queen of

Peace in North Arlington, had a tremendous high school career. He started wrestling at St. Mary's in Rutherford before transferring to Queen of Peace in 2007. Last year, he finished third in the state at 125 pounds after winning the District 14 and Region 4 titles.

"I guess I'll be staying at 125 for a while," Fusco said with a laugh. "At my size, it looks like the right weight class. I'm really enjoying the college experience. Now that I'm settled in, the academics are going well and I'm getting the chance to wrestle for a (NCAA) Division I program. Most of the guys on the team are from New Jersey."

With the regular season concluded, Rutgers will begin post-season competition next week at the Eastern Intercollegiate Wrestling Association Tournament in two weeks. If Fusco finishes in the top portion of his weight class there, he'll move on the NCAA championships.

"Wrestling on the college level is a lot different than high school in that every match is a battle," Fusco said. "Those guys keep coming at you the entire match. It's a lot more technical."

Colon wins title; Murgueytio, Hamilton advance in districts

Make that five straight district titles for the Colon family.

Justin Colon continued the tradition by winning the 103-pound District 14 wrestling championship last Saturday at Livingston.

In addition to Colon, James Murgueytio and Chase Hamilton took third in their respective weight class and were slated to compete at the Region 4 preliminaries last Tuesday at West Orange. By virtue of his district title, Colon got a first round bye and will not have to wrestle until tomorrow night.

The regions continue tomorrow night at West Orange with the quarterfinals and conclude on Saturday with the semifinals, wrestle-backs and 14 championship bouts. The top three wrestlers in each weight class at Region 4 will move on to the NJSIAA championships from March 6-8 at Boardwalk Hall in Atlantic City.

Colon's older brother, Filiberto, won four straight District 14 titles from 2005-2008, en route to a Region 4 title and three NJSIAA medals. The younger Colon was quick to credit his brother for getting him mentally ready for the districts.

"He told me to do my best and work hard in every match," Justin Colon said. "My brother won four straight district titles, so he knows what he's talking about."

Seeded third at 103 pounds, Colon (33-4) pinned Lamont Davies of Newark East Side in 48 seconds to start the action last Friday. He then avenged a pair of earlier losses on Saturday, defeating Nutley's Sam Souza, 14-4, then

stopping Bloomfield's Chris Rosetti, 13-7, in the title bout. Souza had defeated Colon, 9-0, when the two met in a dual meet three weeks ago and Rosetti had edged Colon, 10-9, in the county semifinals on Jan. 31.

"Coming back to beat two guys who beat me earlier in the year feels good," Colon said. "I made some mistakes in those earlier matches and was hoping to get a chance to wrestle those guys again."

Murgueytio (25-12) pinned Akil Baptiste of Montclair in 54 seconds in the first round before losing to Michael Ferinde of Nutley, 5-2, in the 112-pound semifinals. He then came back to defeat Keith Arlotta of Livingston, 9-5, to clinch a bid to the regions.

"My goal was to get to the regions," Murgueytio, a senior, said. "You have to take these matches one at a time and I think I did a good job."

Hamilton, a junior, pinned Naquela Wright of Newark West Side in the first round, then lost a close bout to Michael Silverberg of Livingston, 11-7, in the 215-pound semifinal. Like Murgueytio, Hamilton battled back for third place, pinning Christian Marinaro of Bloomfield in 1:45.

Belleville coach Joe Nisivocchia was pleased that three of his wrestlers were moving on to the regions.

"I was very impressed with the way Justin wrestled," Nisivocchia said. "And I give James and Chase a lot of credit for coming back in the third place matches and moving on. It's not easy, but those guys really wanted to advance and I'm happy they'll get to extend their season at the regions."

Regions should provide excitement for Belleville, local schools

With apologies to the NJSIAA championships in Atlantic City, this weekend's regional championships are considered by many fans to be the most exciting two days of the high school wrestling season.

The regions will be held at eight different sites throughout New Jersey, with the quarterfinals set for tomorrow night and the semifinals, wrestlebacks and regions slated for this Saturday. The top three wrestlers in each weight class at the regions will qualify for the NJSIAA championships from March 6-8 at Boardwalk Hall in Atlantic City.

While Boardwalk Hall provides a huge venue and can hold as many as 17,000 fans for the three days of wrestling, the regions have a certain charm. The intensity will reach a fever pitch beginning tomorrow and will hit the summit on Saturday, especially during the final round of wrestlebacks, where grapplers will battle for third place and the final piece to state qualification. Those who reach the region finals are assured a trip to Atlantic City, and while those finals are indeed exciting, it's those third place wrestlebacks that determine whether a wrestler's season still has another week left.

In 2001, Joe Dubuque of Glen Ridge, a defending state champion, lost in the Region 4 semifinals when he was knocked unconscious. Dubuque was able to get a doctor's clearance to return to the wrestlebacks and had to win twice, later that day, to continue his dream of a state title. He did just that and a week later, he had completed an improbable assignment by winning a second straight NJSIAA title at the Meadowlands.

Dubuque's story was unique, but the wrestlebacks have that kind of intensity. Most wrestlers who take third at a region probably won't earn a medal in Atlantic City, but the ability to qualify and compete at Boardwalk Hall is indeed an honor and the culmination of many months of hard work.

Belleville, Nutley, Bloomfield and Glen Ridge will wrestle at Region 4 in West Orange tomorrow and Saturday. Let's take a look at the 14 weight classes and make a few predictions.

103- Very interesting weight class where Belleville's Justin Colon, the District 14 champion, will probably see Sam Souza of Nutley and Chris Rosetti of Bloomfield somewhere along the line. There are also talented wrestlers in Kevin Manthi of Passaic Tech, Harwin Wong of West Orange and Adam Swift of Secaucus. The choice: Manthi.

112- Chris Lantz of Bloomfield is a very talented wrestler, but he'll face stiff competition from Jimmy Ciampi of West Essex and Cory Monteforte from Cliffside Park. The choice: Lantz.

119- Anthony Polidore of Queen of Peace dominated at District 14 last weekend. Alex Richardson of St. Peter's Prep will be a tall order at the regions, as will Nick Pezzano of Passaic Valley. The choice: Richardson.

125- A loaded weight class features Frank Cagnina of Queen of Peace, a 2007 state champion, as well as Rich Lavarato of Caldwell and Bryant Lighty of Passaic Tech.

The choice: Cagnina.

130- James McGann of Newark Academy has been having an outstanding season and he's the choice here.

135- Barring a major upset, you have to like Nutley's Anthony Damico, who is closing in on the school record for career victories and is 34-0 this year.

140- Another one of those weight classes that appears to have a clear cut favorite in Passaic Valley's Ryan Dunphy. A little trivia, Dunphy's dad, Jim, was a tremendous baseball and football player during his high school days at

of Peace gets the nod in a very balanced division.


