

### DR. RAYMOND J. CURCIO



### WILLIAM J. DUNHAM





### EDMUND T. SULLIVAN









#### PROPOSED CONSTITUTION & BY-LAWS

#### ARTICLE 1 - ( NAME )

Section 1

This organization shall be known as: Edison Democratic Club

ARTICLE 2 ( OBJECT, AIMS AND POLICY )

Section 1

The object, aims and policy of this organization shall be: To promote and support the priciples and policies of the Democratic Party, and to support only Democratic candidates for elective office. To cultivate amicable relations among those interested in the civic, educational, political and social aspects of community life.

#### ARTICLE 2 ( JURISDICTION )

Section 1

The club shall accept members residing in Edison Township, Middlesex County, New Jersey.

#### ARTICLE 4 ( MEDBERSHIP )

Section 1

Any person, male or female, who is eligible to vote, and resides in the 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, or 19th Voting District of Edison Township, Middlesex County, New Jersey, may become a voting member.

Section 2

Any person residing outside of the voting districts enumerated in Section 1 of ARTICLE 4 may be accepted as an honorary member only, without the right to a vote in the affairs of the club.

Section 3: -

without the right to a vote in the arrairs of the citt.

No person who is a member of any subversive organization, in or out- Justile side of the United States, shall be allowed membership in the club.

# ARTICLE 5 ( DUES )

Section 1:

Dues of this club shall be \$1.00 per calendar year, and new members shall pay dues when joining the club.

Dues shall be payable in January of each year.

Section 3:

Dues for honorary members shall be the same as for regular members.

Section 4

Any member who is three (3) months in arrears shall lose his right to vote on club matters. Any member who is twelve (12) months in arrears shall be dropped from the membership rolls. Any member or former member can regain lost privileges by paying any back dues owed the club.

## ARTICLE 6 (OFFICERS)

Section 1:

The Officers of this organization shall be:



President, Executive Vice President, 1st Vice President, Second Vice President, Third Vice President, Fourth Vice President, Recording Secretary, Co Corresponding Secretary, Financial Secretary, Treasurer and Sgt. at Arms.

Section 2

In the event of detachment of the President from the club by resignation or for any other cause, succession to the Presidency will devolve upon the Executive Vice President who shall appoint a new Executive Vice President to serve until the next annual election of officers.

Should the new President be detached from the club by resignation or for other causes before the next annual election, succession to the Presidency shall devolve upon the First Vice President. Under no circumstances shall a Presidential appointee succeed to the Presidency, as it is the intention of this Section to insure that none excepting duly elected officers of this club may succeed to the Presidency.

#### ARTICLE 7 ( DUTIES OF OFFICERS )

#### Section 1

President:

He shall preside at all regular and special Meetings; Appoint the Executive Board and all Committees in accordance with the provisions of these By-Laws for such appointments; Act as Ex-Officio Chairman of all Committees; Appoint any necessary Special Committees;

Perform any and all duties which befit the office of Presidency.

Executive Vice President:

He shall preside at all regular and Special Meetings in the absence of the President;

Shall be Chairman of the Membership Committee.

First Vice President:

He shall preside at any meeting in the absence of the President and Executive Vice President;

Shall be Chairman of the Political Action Committee.

Second Vice President:

He shall preside at any meeting in the absence of the President, Executive Vice President and the First Vice President; Shall be Chairman of the Ways & Means Committee and be responsible for the fund raising activities of the club.

Third Vice President:

He shall preside at any meeting in the absence of the President, Executive Vice President, First Vice President and Second Vice President; Shall be Chairman of the Entertainment Committee.

Fourth Vice President:

He shall preside at any meeting in the absence of the President, Executive Vice President, First Vice President, Second Vice President, and Third Vice President;

Shall be responsible for all publicity on matters decided upon for public announcement by the President or Executive Board.

Recording Secretary:

He shall record all business transactions of the club:
Shall report Hinutes of the previous regular meeting and any special meetings in the interim, at the succeeding regular meeting;
Shall keep a record of Minutes of all Executive Board meetings and shall keep same as an independant record which may be called for by any Executive Board member in good standing, at any regular or appropriate special meeting, or Executive Board Meeting and read by the Recording Secretary upon a unanimous vote of the members attending;

Shall keep an accurate record of members in good standing. Corresponding Secretary:

He shall handle all correspondence for the club as directed by the President or acting President;

Shall read all communications at regular meetings:

Shall notify the membership, in writing, at least one week prior to a regular meeting of the date, time and place of such meeting.

Financial Secretary:

He shall receive all funds;

Shall keep an accurate record of all funds received;

Shall supply the Recording Secretary with information on delinquent dues members:

Shall, after recording same, turn all funds over to the Treasurer; Shall render a report of income for the month at each regular meeting; Shall notify Corresponding Secretary as to members in good standing.

#### Treasurer:

He shall receive all actual funds from the Financial Secretary; Shall pay all valid bills against the club:

Shall keep a complete and accurate record of club income, expenditures and balance, and shall make a Treasurer&s Report at each regular meeting;

Shall certify by an "Aye" or "Nay" as to the correctness of the Income report of the Financial Secretary as read at the regular meeting.

#### Sgt. at Arms:

He shall open all meetings by leading the Flag Salute; Shall record names of all members attending all meetings and submit same to the Recording Secretary for inclusion in the attendance record;

Shall introduce all new members to the club at regular meetings; Shall assist the president in maintaining order and in any other appropriate ways.



Section

All Officers shall be elected for one (1) year.

Section 2

Nominations shall be at the regular meeting in November.

Section 3

Election of Officers shall be at the regular meeting in December.

Section 4

Installation of Officers shall be at the regular meeting in January.

Section 5

All elections shall be by secret ballot and the Election Committee shall be three (3) members appointed by the President at the regular meeting in October.

Section 6

Any vacancies, due to resignations or other cause, shall be filled by appointment by the President.

Section 7

In the event of a single nomination for a given orfice the Secretary shall cast his vote and the Chairman of the Election Committee shall declare the candidate elected by consent.

# ARTICLE 9 (Executive Board Members)

Section 1
The Executive Board shall be comprised of the following:

a) All Officers of the Club as listed in ARTICLE 6, b) All Democratic Committeemen from the voting districts listed in Section 1 of ARTICLE 4 providing they are members of the Club and in good standing,

c) Chairmen of Standing Committees,

d) Two Presidential appointees from each from of the voting districts listed in Section 1 of ARTICLE 4, 8,13,15,16,18,19 e) Three Presidential "At Large" appointees.

## ARTICLE 10 (Duties of the Executive Board)

Section 1
It shall be the duty of the President to serve as chairman The Executive Board shall meet at such times and places as its chairman may direct. All matters which require political consideration of any nature, that may promote the interests of individual members or the club as a whole, particularly endorsements. shall be referred to the Executive Board, whereupon the Board shall decide the particular course of action to pursue; such decision shall be final offer humaning amount The Board shall have absolute control of all matters of an emergency nature which may arise between meetings. All motions, resolutions and questions of a nature requiring study or investigation must be refferred to the Executive Board.

Section 2

Fifteen(15) members of the Executive Board shall constitute a quorum at any of its meetings and no action can be taken, ora decision rendered, unless such a quorun is present throughout the meeting.

The following Standing Committees shall be appointed by the President:

Membership Committee - - three members

Political Action Com. - three members

Ways & Means Committee - three members

Entertainment Committee - three members

By-Laws Committee - - three members

Women's Committee - - three members

Chairmen of all Standing Committees excepting Chairmen of the By-Laws Committee and the Women's Committee are listed under ARTICLE 7. Chairmen of the By-Laws Committee and Women's Committee are appointed by the President.

## ARTICLE 12 (MEMBERSHIP MEETINGS)

All regular membership meetings of this organization shall be held on the fourth (4th) Thursday of each month unless changed by a majority vote of the membership at a regular meeting, if practicable.

Special meetings may be called by the President, a majority vote of the Executive Board or by petition of two-thirds (2/3) of the membership in good standing. If called by membership petition, the names of the petitioning members must be presented to the Gorresponding Secretary to verify the good standing of the petitioning members. If verified, it shall be the duty of the Gorresponding Secretary to inform the membership in writing of the special meeting not less than one week previous to the scheduled meeting date. The meeting notices shall give the reason for the meeting as stated on the petition presented to the Gorresponding Secretary. At the special meeting no other business may be transacted other than that stated in the petition.

No regular or special meeting shall start unless a quorum is present. A quorum shall consist of twenty five (25) members.

# ARTICLE 13 (MEMBERSHIP CONDUCT)

All members shall at all times conduct themselves in a manner that is not detrimental to the club and fulfill the obligation to uphold the constitution and by-laws of this club.

Section 2

In the event of a formal charge of "detrimental action", such a charge shall be made only by the officers of the club and must be submitted for a membership vote on whether the club as a whole is in accord with the charges and recommendations of the officers.

# ARTICLE 14 (AMENDMENTS)

Any proposed amendment(s) to the constitution must be made at a regular membership meeting. The proposed amendments(s) will then be referred to the By-Laws Committee for consideration and recommendation as to the proposed amendment's validity



applicability and validity. If applicable and valid the Chairman of the By-Laws Committee will present the proposed amendment to the general membership. If there are no objections to the proposed amendment as read by the Chairman of the By-Laws Committee this reading shall be considered the second reading of the proposed amendment. At the next regular meeting, subsequent to another reading of the proposed amendment by the Chairman of the By-Laws Committee, a vote on the proposed amendment will be taken by secret ballot.

Section 2

It shall be the duty of the Corresponding Secretary to inform the membership, in writing, at least one week prior to the meeting that the vote on a proposed amendment shall be taken at the forthcoming meeting.

It shall require a two-thirds (2/3) vote of the members present, providing they are a quorum, to adopt an amendment.

# ARTICLE 15 (Questions Relating to these By-Laws)

Any question regarding this Constitution which may arise and require explanation or interpretation shall be referred to the Chairman of the By-Laws Committee for clarification. His explanation, interpretation or decision shall be final excepting as follows:

a) A majority vote of those present and in good standing may require study of the question by the By-Laws Committee as a whole;

b) A majority vote of those present and in good standing may require the question to be placed before the membership at a regular or special meeting if the explanation, interpretation or decision of the By-Laws Committee as a whole is still unacceptable.

A majority vote of the membership at a regular or special meeting shall be final in that it will, by its vote, either uphold the explanation, interpretation or decision of the By-Laws Committee or cause that committee to reconsider the question and render another interpretation.

# MEMORANDUM

To: Democratic Members of the District Election Boards

From: Robert J. Burkhardt Executive Director

Your attention is hereby called to a vitally important provision of our election laws which is now being violated and which must be strictly observed in the coming November election.

Each board will be given a form prepared by the office of Secretary of State for district returns. These sheets are numbered Form C-26 and in four counties (Hudson, Essex, Passaic and Monmouth, where there are Superintendents of Elections) they are numbered Form C-26A.

The law requires each district board to fill out these sheets when the polls are closed and deliver or safely transmit one copy to the Municipal Clerk, one copy to the County Clerk and mail one copy to the Secretary of State. In counties with a Superintendent of Elections, a fourth copy shall forthwith be filed.

These forms shall be transmitted or mailed on election night.

The purpose of the election laws is to provide a three-fold or four-fold check on the basic returns.

It is the duty of the Municipal Clerk, having received the district return sheets, to report the results to the County Clerk.

It is the duty of the County Clerk to compare his survey of the district return sheets with the survey of the Municipal Clerks.

It is then his duty to report to the Secretary of State.

If discrepancies exist, it is the duty of Municipal Clerks and County Clerks to find out why they exist.

Meantime, if the law is observed, the Secretary of State, having received returns from each one of the districts, is able to make his own survey to find out whether the reports from the districts agree with the report of the County Clerks.

The law intends that each agency (Municipal Clerk, County Clerk, Superintendent of Elections where that official exists, and the Secretary of State) should make its own independent canvass of the election results.

Where differences exist, the reason should be determined by going to the original source, namely, the district election boards.

The Secretary of State in statewide elections is the check on the County Clerk; he, in turn, is the check on the Municipal Clerk; and at the base of the whole pyramid is the accuracy or inaccuracy of the district return sheets.

A true check can only be workable when the machinery functions from the district boards to the Municipal Clerks to the County Clerks to the Secretary of State.

And the Secretary of State is unable to fulfill his function unless he receives the district election sheets from each district, to be mailed to him immediately after the vote has been counted.

The chairman of each district board should be held responsible for mailing each envelope and this mailing should in all cases be witnessed by a member of the opposite political party serving on the election board.
