# Recorder Stanton's Record

Against Unionism

And of His Protection to Green Goods

Men and Backers of the

Policy Game



Read carefully the record of Edward R. Stanton who condemns Dr. Stack. The New York World Almanac of 1894 shows when he was Sheriff in 1893, filling out the unexpired term of the late John J. McPhillips, that Stanton fathered and protected everything that was indecent and unlawful, protecting policy playing, green goods men, and drew his pet Grand Jury to indict the World Editor for showing him to the county as a Sheriff who had no respect for his oath of office. The proof is he was beaten by 7,000 majority in 1893 when he was the candidate to succeed himself.

He also proved himself to be the workingman's enemy, in the hard drawn-out strike of the boilermakers and machinists at Fletcher's Iron Works on 14th and Hudson streets, in every case which came before Stanton in his Court of which he is Recorder. He always believed the scab and refused to listen to the striker; he openly declared on the bench that he was opposed to unions and that they were a disgrace to the country. He also sentenced John O'Donnell, a union picket in the machinist strike, to jail for five days without a fine. When Judge Blair was appealed to, he ordered John O'Donnell discharged on the ground that it was illegal and that it was an outrage to allow the rights of citizens to be trampeled on in such a manner. This proves that in his zeal to punish organized labor for asking for their rights, he has overstepped the boundary laid down by law and decency.

In the case of Robert Lackey and John O'Donnell, two union pickets who Stanton had warrants issued for assault on a scab, when the case was called the scab exonerated the pickets, much to Stanton's disgust. He discharged them. To prove again his malice, he made the same scab go before the Grand Jury, and had the same two pickets indicted, which indictment the Grand Jury reconsidered at the following session, and they, too, completely exonerated the union men.

In another case against Robert Lackey, a scab charged Lackey with insulting him, which Lackey denied. There being no witnesses on either side, Stanton believed the scab and fined the union man \$10, at the same time abused organized labor shamefully. At the last session of our Legislature Stanton had a bill passed whereby he would have his power increased and also his salary raised from \$2,500 to \$3,500 a year. The same bill to raise his man Friday, James Laverty, his clerk, from \$900 to \$1,800, and further, to make Laverty's job for life the bill passed with the proviso that before it became effective the County Prosecutor would have to approve it. The Prosecutor, being a fair-minded Republican, seen it would be an injustice to the rent payers and tax payers, refused to approve of such a bill which would saddle \$1,800 a year extra on the people of Hoboken. Stanton then went to the Republican leader and offered himself to

become a Republican if the Republican Prosecutor granted him his raise and also that of his clerk. His wish and services were refused. Now he is calling people renegades. Judge for yourself Stanton's calibre when the so-called renegades refuse his support or his company.

He absents himself from his duties three months every year sojourning in Europe, and leaves his clerk, Laverty, Acting Recorder, and places a police officer to fill Laverty's place as clerk, which is extra expense on the rent and taxpayers. He accuses Harris, the Bucket Shop Co., of robbing him out of \$10,000. His own son was placed in this office as a clerk by the Recorder himself. Do you believe that he did not know that they were transacting illegal business. It ill becomes Recorder Stanton, in view of his past record, to cry wolf.





MY DEAR SIR:-

For the first time the candidate for Mayor of our city must be nominated directly by the voters without the intervention of delegates or a convention as heretofore. Under the old system the people had little say in the selection of candidates. The political bosses generally dictated the respective candidates of both parties, leaving the people the opportunity of voting for one or the other on election day,

No longer can the politician make the nomination for that important office. The nominating machinery is in the hands of the people. This is the result of a wonderful movement, every inch of the way having been contested by the politician and political boss. The rights of nominating the candidates belong to the many and to no one man. This is in accord with the spirit of a free country and must result in the election of such men as the majority desire in office.

If the people will vote at the primary, they may nominate and secure the election of business men, who are independent of the politicians, and who will regard the wishes and interest of the people paramount to the wish of the political boss. It is not American that a few who make a business of political activity should make the nominations for the great army of partisans who comprise our voters.

Everyone must agree with this progressive step, and everyone should participate in the advantages the new law affords.

You should attend to register in your respective election district on Tuesday, September 28th, instant, between the hours of one o'clock P. M. and nine o'clock P. M. Having registered you may request of the Election Board the party ticket you desire to vote. Being furnished with an official ballot of your political party, you retire to the booth and prepare that ticket by erasing with a black pencil all other names thereon other than those you vote for. If challenged you may make oath that at the last election for Members of Assembly you voted for a majority of the candidates whose names were printed upon the party ticket, and that you intend to support the candidates of the said party at the ensuing election. In case of any voter voting for the first time, that portion of the oath in reference to previous voting shall be dispensed with.

### When the voter, who has been challenged, makes this oath, his vote must be accepted.

But two short years have elapsed since the treacherous perfidy was practised upon our present Mayor, the Honorable George H. Steil, and a political boss conducted a convention whereby, through gag rule and unfair tactics, he succeeded in obtaining the Democratic nomination for Mayor, which a majority of the delegates did not desire him to obtain. The scandal connected with that stolen convention and method of obtaining a nomination and its overwhelming repudiation by our voters is yet fresh in all minds. When the people rebuked the men responsible for that disgraceful convention, it would seem that a candidate, thus defeated, would understand the pulse of the people. But to the man without a business, or means of earning an honest livlihood other than the crumbs obtained in politics, there is nothing to lose in repeated defeats and perhaps a chance to win.

When the political boss in Jersey City selected Mr. Stack as the Democratic candidate for Mayor of Hoboken, good citizens wondered, and I have determined to challenge the authority and right of Mr. Davis to issue from his home in Jersey City his precept to the Democratic voters of this city that the Democratic nomination for Mayor of Hoboken, must be given to one, so often, and so lately defeated by the suffrage of our citizens. Under the old system, with the old primary boxes, Mr. Davis could undoubtedly give Mr. Stack that nomination, but the old system is of the past. The voter who heretofore shuned the corruption of the old primary, may now attend and cast his ballot in the regular box, and be assured that his ballot is protected by the general election law of the State.

Manifestly it is the duty of the voter to attend the primary on September 28th, and vote for his choice. His conscience, his pride, his welfare and his honor must assist him in making his selection. If he agrees with the selection of Mr. Davis he should nevertheless vote at the primary, because the selection should be made by the majority of Democratic voters and not by one man.

Tuesday, September 28th, is primary election day. Under the new direct nomination law, you can by your ballot decide who will be the candidate for office on your party ticket on election day.

#### TAXES ARE HIGH BECAUSE WE LET POLITICIANS RUN OUR CITIES.

Jersey Journal, Saturday December 11, 1909

Mayor Steil's tax bill on the house in which he lives is \$19 more this year than was his tax bill for the same house last year. He wanted to know why this should be, and called a conference of the heads of the city departments. He learned that the sum to be raised by taxes for local purposes in Hoboken this year exceeds the sum raised last year by \$129,000—or to be exact, that it is \$648,959.80, as against \$528,734.62 a year ago.

There is nothing strange about this exhibit. The increase might have been even greater without causing very much surprise. The same condition exists in hundreds of other American cities and towns. Everywhere the taxes go up, if not one year another, and taxpayers complain, but keep right on paying without doing anything to stop the waste.

In Hoboken salaries have been increased and assistant park keepers appointed to trim the grass in winter. New jobs had to be created to keep up the supply of political workers. In other cities similar ways of spending money and piling up the tax load have been invented.

Europeans who study our tax system think the American people are crazy. With all our boasted talent for business, we apply no business principles at all to the problems of municipal government. We leave that to the politicians. The average citizen knows nothing about the financial affairs of his city, and will not take the trouble to learn. He is too busy making money. Even when high taxes are an issue in an election, he usually votes with his party and takes his chances for betterment. If any private business was run as loosely and extravagently as our cities are conducted, it would go bankrupt. There is nothing to compare with it except the condition prevailing in banks in which the directors go to sleep and let the cashiers forage in the money vaults.

The politicians should not be blamed for increasing our tax bills. We are foolish to think that they would do otherwise. Don't we place our money in their hands and tell them in effect to spend it as they please and let us know when they need more? And when we do occasionally lose patience and turn out one set of politicians, don't we turn in another set commissioned to do exactly as the others had done?

There is no remedy for high taxes except public vigilance. This means more than merely keeping the public eye open. An eye that can't see things as they are might as well be closed. Every citizen should study municipal questions, especially those relating to finance. He should understand how money raised in the tax levy is expended and cry out when he detects extravagance or graft. Then the politicians would go slow.

Of course, a citizen can't do these things alone by himself. But he can join some civic organization in which every helpful idea will have the support of a multitude. He can join his ward improvement association, or the Board of Trade, or whatever club interested in civic betterment happens to be convenient to his home. Then these clubs can all work together for a better Jersey City, or a better Hoboken, or a better Bayonne.

This is not silly idealism. The time is coming when citizens will have to organize to study municipal problems, if they expect to keep the cost of government within reasonable bounds. A city is a corporation in which every taxpayer is a stockholder. He elects the directors and is responsible for their actions. When all citizens fully realize this, they will feel ashamed to remain ignorant of their obligations, and then we shall have a public vigilance which amounts to something, and the tax rate instead of going up will go down.

To the Voters of the City of Hoboken:-

How much money must be taken from the City's Treasury in repeatedly registering Hoboken's disapproval of Commission Government? How many elections must be held at the expense of the people, before a halt is declared? Twice heretofore have the attempts for this un-American, aristocratic and experimental government failed, each election costing Hoboken at least Five Thousand Dollars (\$5,000.), and now after an interval of but twenty-two months a third election is to be had, with the City still paying the bills.

There seems but little need to repeat the numerous arguments against Commission Government. We see the results in Jersey City. Instead of a theory we see Commission Government in practise. What close observer will deny that there is more practical politics among the Jersey City Commissioners than formerly existed, in view of the fact that the Commissioners in their wrangling accuse one another of playing politics; and that Mayor Mark Fagan at a meeting of the Commissioners publicly stated there was more politics in the transaction of the City's business by the Commissioners than ever before in the history of the City.

We see no economy produced by Commission Government. There are more officials and office-holders, the pay-rolls increase, the individual's liberty is interfered with, harsh taxes are imposed and collected even by the arrest of small store-keepers and citizens, the police courts come under the control of the politicians, and there is substituted for a representative government in which the great mass of the people have a voice, an aristocratic rule akin to a monarchial form of government that is truly and surely A long, long way from the people.

It is not for us to defend the Charter of Hoboken and the general laws of the State applicable to cities of the second class. The question is not whether they can be improved, but, WILL THE ADOPTION OF THE SO-CALLED WALSH ACT BE AN IMPROVEMENT; AND WE SAY MOST EMPHATICALLY THAT IT IS NOT ONLY NO IMPROVEMENT, BUT THAT IT IS INFINITELY WORSE.

Commission Government is fundamentally wrong as it does away with representative government, and eliminates ward representation. It absolutely stifles the clean young man who is ambitious to take part in municipal affairs. Such a one has had and now has the opportunity of being elected as Councilman in his ward at a small outlay of money, but the great cost of running as a Commissioner throughout the city, while of no consequence to one with the means of a Mr. Keuffel or a Mr. Cordts would be prohibitive with him.

The theorists claim it will eliminate politics, but it tends to the building up of a political machine and the establishment of an autocratic administration by three men, who readily become despotic. The three Commissioners (the combination of the five elected) may be selected from one portion of the City, and have little or no sympathy or feeling for the people of other sections, whose needs, style of living and labors, they do not understand nor care to understand.

The principle which empowers three men for the period of four years to make the laws and regulations for this city, to appoint and employ an unlimited number of political friends and henchmen, to make the assessments on real estate and all personal property, to collect the taxes as they see fit, to make all contracts, incur expenses, grant the franchises and special privileges, disburse the public funds, control and regulate the police, fire and every department of the city, and in fact to regulate and manage the property and liberties of 75,000 inhabitants, is too radical, imprudent, dangerous and un-American to be adopted.

What argument can be advanced to take from the people of Hoboken their right to elect their Recorder? In this Court the troubles of our city are aired and fairly settled according to law. The Recorder is unfettered and untrammeled. His judgment is impartial. He is responsible to no politician and subservient to no man. His conscience and the law are the guides of his conduct, and he is entitled to the salary fixed by law during the term to which he was elected. From this system you are asked to change to Commission Government wherein the Commissioner of Public Safety appoints the Police Justice and permits him to remain such magistrate during his pleasure. Who understandingly would desire such a change? Who would wish to have in the place of our Recorder, elected by the people for his fitness to office, a man selected by a Commissioner, who is dependent on the Commissioner for his bread and butter? Under Commission Government the Commissioner of Public Safety can and does make arrests, and his cases are taken before the police judge appointed by him and holding office subject to his pleasure, for adjudication, and the answer is "WE ARE ALL HUMAN."

What valid reasons do the disgruntled soreheads, politicians and the coterie of aristocratic seekers of special interests offer for ousting from office the men specially fitted, and for years past chosen by the electorate, for such important offices of trust as the City Treasurer, the Collector of Revenue, the Water Registrar and the like?

When you examine the persons advocating Commission Government and the turning out of the City officials, the desires of some of them to obtain an office or position, the hopes of others for special privileges and contracts, and the selfish personal motives of most of them is clear and manifest; all of which, however, is one of the best reasons for bringing about their defeat. Ask yourselves this simple and plain question: "HAVE THESE MEN EVER DONE ANYTHING FOR THE GOOD OF HOBOKEN? HAVE THEY BY ANY UNDER-TAKING OR SACRIFICE MERITED THE REWARD WHICH THEY ARE SEEKING UNDER THE COVER OF A GOVERNMENT BY THREE MEN?"

The City's best interest will be promoted by again repudiating the special privilege seeking malcontents,

the office seekers, and the has-been politicians of sere and yellow age.



#### To the Voters:

The voters of this State welcomed the passage of the present primary law. Among its pretended friends was the Mayor of Jersey City, who lost no opportunity to proclaim that its passage had sounded the death knell of bosses. This act is now being put to the test, and it is now up to the voters of this County to determine whether or not this election shall be free of the boss rule that Mayor Wittpenn has openly condemned and is secretly trying to establish. 
