## Central Park Residents Petition Erection Of Gas Stations

Residents of Central Park petitioned the Township Committee in an effort to halt construction of two gas stations to be erected in close proximity to their development. There were 327 signers on the petition. Present plans before the Township

Committee and the Zoning Board of Adjustments call for the erection of two gas stations and a motel. One gas station to be erected on Highway 34, while the other will be on Route 9. The petition stated that they are protesting construction because of

increased traffic dangers, increased safety hazards.

The committee promised to study the matter further before taking any action on the request.

A letter was received by the Township Committee from Leo G. Costine of Central Park, Mayor

Phillips stated that the letter contained "alleged charges" against a member of the Zoning Board of Adjustment, Phillips declined to read the letter until a latter date. He ruled that it might be "libelous".

Leonard Paff, a member of the Zoning Board of Adjustments, in attendance at the meeting, requested a copy of the letter. Paff said that he would accept an apology from Costine.

The meeting was held in the new Cheesequake Fire House. Mayor John Phillips as well as other members of the committee commended the members of the Cheesequake Fire Co., for their new building. Phillips stated "that the building was a great improvement over their old wooden building".

In other business to come before the committee: Harry Messenger Chairman of the Street Lighting Committee stated that lights were being installed in Central Park, a letter from the Home Owners Assn., was received thanking Messenger and the efforts of the Madison American in helping the Central Park residents obtain street lights.

Messenger noted receipt of a \$638.21 check from the Old Bridge Boy's Club for equipment at Duernal Lake, he moved that a special banking account be established for the money.

Committeeman John Keating, Chairman of the Road Department reported that the road crews were busy scrapping, cleaning drains and making temporary patching. Keating said that the roads were in very poor condition because of weather conditions.

An ordinance expanding the Fire District #1 was read on first reading and will be advertised as prescribed by law for a Public Hearing on the matter.

The committee moved to instruct the building inspection to rescind building permits issued for the construction of gasoline stations, issued prior to the December 21, 1959 ordinance. The order would cover building permits where actual construction work has not begun.

A letter was received from Robert J. Baier, former township engineer in regards to the tax map, reporting that the second part of the township tax map had been completed. Phillips instructed the Township Clerk to write Baier a letter stating that the committee would be glad to receive the second part of the tax map, but to instruct him not to begin the next section of the map. Baier had been awarded the Tax Map by the previous administration at a total cost of \$50.

## Miller Again Trying To Establish Borough

Thomas F. Miller of English-town Road announced that a meeting for the purpose of forming a Borough of Old Bridge will be held at the Madison Township Rescue Squad Building, English-town Road, Old Bridge, Tuesday, March 29, 1960 at 8 p.m. All residents of voting districts 2-6-8 as well as those within the tentative boundaries are urged to attend.

Tentative Boundaries, beginning at the South River and East Brunswick Township at the bridge north along the said river to the Sayreville line, thence north along Bordentown Avenue, and Sayreville line to Water Works Road. Thence East Along Water Works Road to 9-4 Highway, thence South along 9-4 highway to the Monmouth County line, thence West along Monmouth County line to Monroe Township line and the Matchaphonix Brook, thence north along Matchaphonix Brook, Duernal Lake and the South River to Point of beginning.

Miller a former Board of Education member, and a member of the Township Committee, was defeated in a bid for re-election

to the Township Committee under the G.O.P. banner. Miller has run in several primary elections as an Independent Republican. He also ran as an independent candidate in the 1959 November election. The formation of a Borough of Old Bridge has been "kicking" around ever since Miller's defeat in 1954.

His reasons for starting a Borough are listed as follows: To make Old Bridge a town in reality, not a mythical name; To avoid confusion, more civic pride and a better government, progress.

A unified Government in this area would provide a closer tie with existing industry and be in a better position to negotiate for additional industry, local officials of the new government would have one loyalty, Old Bridge, instead of the widely diversified demands or rural and urban interests.

The formation of the borough would in no way alter the status quo of our fire companies, churches, veterans organizations and emergency squads, community spirit would improve because of common interest.

## Faces ABC Charge

Benjamin and Genevieve Oskierko, proprietors of the Water Tower Liquors Inn on Bordentown Avenue, Parlin have been charged by the state Alcoholic Beverage Control Division with selling alcoholic beverages to a minor.

They are charged specifically with selling the beverages to a 16 year old boy on February 6, it was announced by William H. Davis, ABC director.

## Pair Held On Rape Charge

Two South Amboy juveniles were lodged in the County Detention Home in New Brunswick to await juvenile court trial for the alleged rape of a 14-year old East Brunswick girl in Madison Township.

Detective Sgt. Charles W. Boice said that the two boys, one 16 and the other 17, were picked up and after questioning the older youth admitted the rape.

Boice, said that the girl was attacked in the back seat of an automobile parked in the woods off Bordentown Avenue, while she was held by the 16-year old boy.

## Mark Tenth Anniversary Of Church

On Sunday, March 20, 1960 members of the Bayview Presbyterian Church Cliffwood Beach celebrated the beginning of the church ten years ago. On March 21, 1950 sixty-seven persons under the leadership of the Rev. R. Douglas Merrian signed a covenant indicating their desire to organize a church.

The celebration consisted of special worship service at which the organizing pastor preached. His topic was "The House of God".

Following the worship, dinner was served in Fellowship Hall. Elder, Harold Hatfield, Sr., introduced the guests which included Rev. Chester Galloway, moderator of Monmouth Presbytery and the Rev. Norman Riley, president of the Greater Matawan-Keyport Area Council of Churches. Mr. F. Howard Lloyd under whose guidance a church school was begun in the Cliffwood Beach area prior to the organization of the church, was the after-dinner speaker.

Mr. Joseph Sinclair, the first and also the present superintendent of the church school spoke

reviewing the history of the church from its inception to the present. He was assisted in his talk by slides and photographs assembled from the members. Special music was furnished by an all male vocal group from Morgan known as the Raritan Bay Singers.

Some of the highlights in the history of the church were reviewed, the present pastor of the church is the Rev. Francis R. Osterstock who was called to serve the congregation in October, 1955. The church membership now consists of almost 200, while the enrollment in the church school totals 208.

Along with its growth in membership in the course of its ten-year history, the congregation erected an eight-room split level style building at West Concourse and Lakeview Way. It was completed in February, 1957. In May, 1959 a cottage immediately adjacent to the main church building was purchased which is now in use by the church school and other organizations. A new two manual Allen electronic organ was installed in the sanctuary in June, 1957.

## Salvest Named Planning Board Lawyer

John J. Salvest of 24 Clemson Road, Madison Park was named attorney for the Madison Township Planning Board. The move came at a recent meeting of the group held at the Brown-town Townhall. Salvest will also serve as attorney to the Zoning Board of Adjustment.

Mr. Salvest is a graduate of Washington Grammar School in Harrison, N. J. and St. Peter's Prep of Jersey City. He received an A. B. degree from St. Peter's College, Jersey City in 1947 and an L. L. B. degree

from John Marshall Law School, also Jersey City, in 1949. In June of 1950, Mr. Salvest was admitted to the Bar of the State of New Jersey.

A veteran of the Korean conflict, he has resided in Madison Township with his wife and two sons for the past four years.

Salvest is active in political and civic organizations in Madison Township. He is a former vice-president of the Madison Park Civic Association, past secretary for the Madison Park Democratic Club, a member of

the Holy Name Society of St. Bernadette's Roman Catholic Church and was one of the organizers of the Young Democrats of Madison Township. Salvest served as temporary acting president of the group during its formation.

Mr. Salvest had formerly been associated with the law firm of Marley, Winkelreid and Hillis in Newark, New Jersey.

He maintains an office for the general practice of Law at his home on 24 Clemson Road, Madison Park.

### \$4,400 For \$1,750

The Board of Education made a very wise move in settling Charles Williams' claim. The Negro teacher alleged that he was not hired by Dr. Eugene Schronk on account of his color, and preferred charges of discrimination. The State Department of Education ruled in favor of Williams and the matter was appealed by Henry M. Spitzer, the Board's attorney. Dr. Schronk, the former superintendent of schools originally recommended to the Board that Williams did not have qualifications to teach the educable or retarded students. Unfortunately, Dr. Schronk died and the prosecution of the Board's appeal was therefore seriously hampered, and upon Mr. Spitzer's recommendation, a compromise was affected for \$1,750.00. Had the colored teacher won the appeal, he would be entitled to about \$4,400.00.

We feel that it was good sense to amicably work out a claim which might have cost the taxpayers much more. We applaud the Board's good judgment.

## Funds Needed By Library

Public donations are still being sought by members of the Madison Township Public Library of Old Bridge. A door to door fund drive is being conducted. Won't you please help the library group?

Thousands of books were gathered through door to door campaigns and new books were sent by many leading publishers. Cake sales, rummage sales and a dance helped to add to the needed funds. Mrs. G. Graydon, with a group of volunteer workers, spent many hours cataloging and pasting books and storing them until needed.

Through the cooperation of the Segal Construction Co., a large tract of land on Highway 18 was donated to the group for the library. A Board of Trustees was then appointed and incorporation papers filed. The Township Committee recognizing this worthy project, sent a worthwhile donation.

A down payment was made on a former U. S. Army Medical building now stored in New Egypt. The building once purchased, will be moved to the Route 18 site and after renovation

tions will be dedicated as the Madison Township Public Library of Old Bridge.

Dear Mr. White:

I see, by the papers, that the Old Bridge Republican Club has endorsed the out-of-town candidates, who care nothing about Old Bridge, except the votes that they might obtain. These handful of Charley MacCarthy's knowingly or unknowingly, have literally sold their own community down the river. In other words, to them, the welfare of the party organization candidate comes before the welfare of the community. 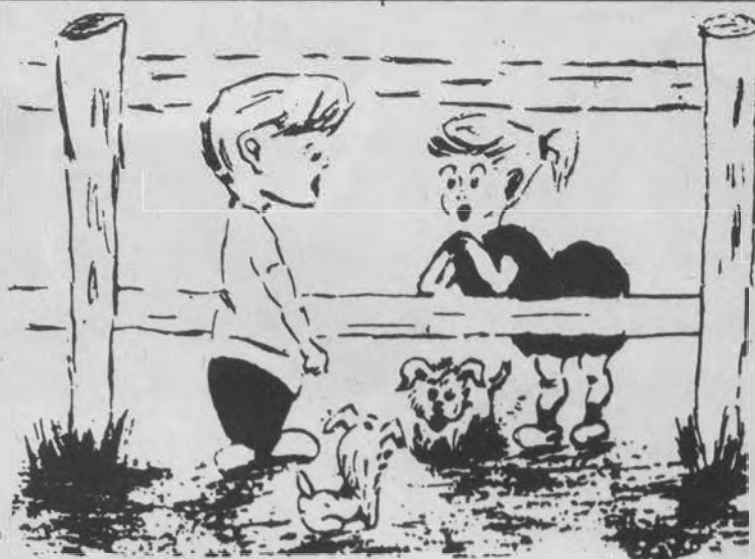

Since when did the Republicans ever carry Laurence Harbor? I wonder will the local people support them? Let's hope that the Old Bridge people will awaken to the fact that they are only being used by the party bosses for their own political gain.

I have always, as the record will show, placed the welfare of the community far above any party or the political ambitions of any individual, including my own. Therefore, I propose the following to both political Chairman and their stooges:-- That both the Democratic and Republican organizations each drop one township committee candidate and replace them with candidates from the Old Bridge area. 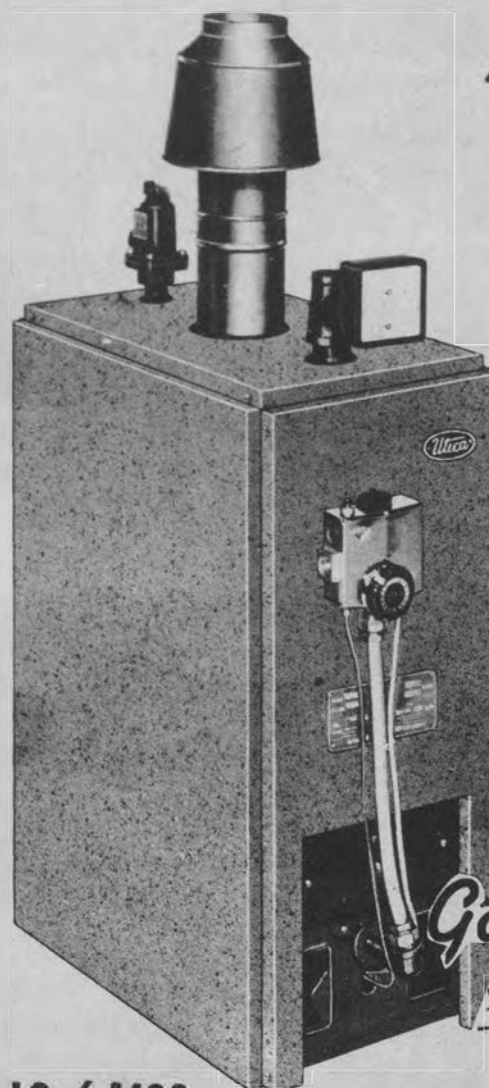

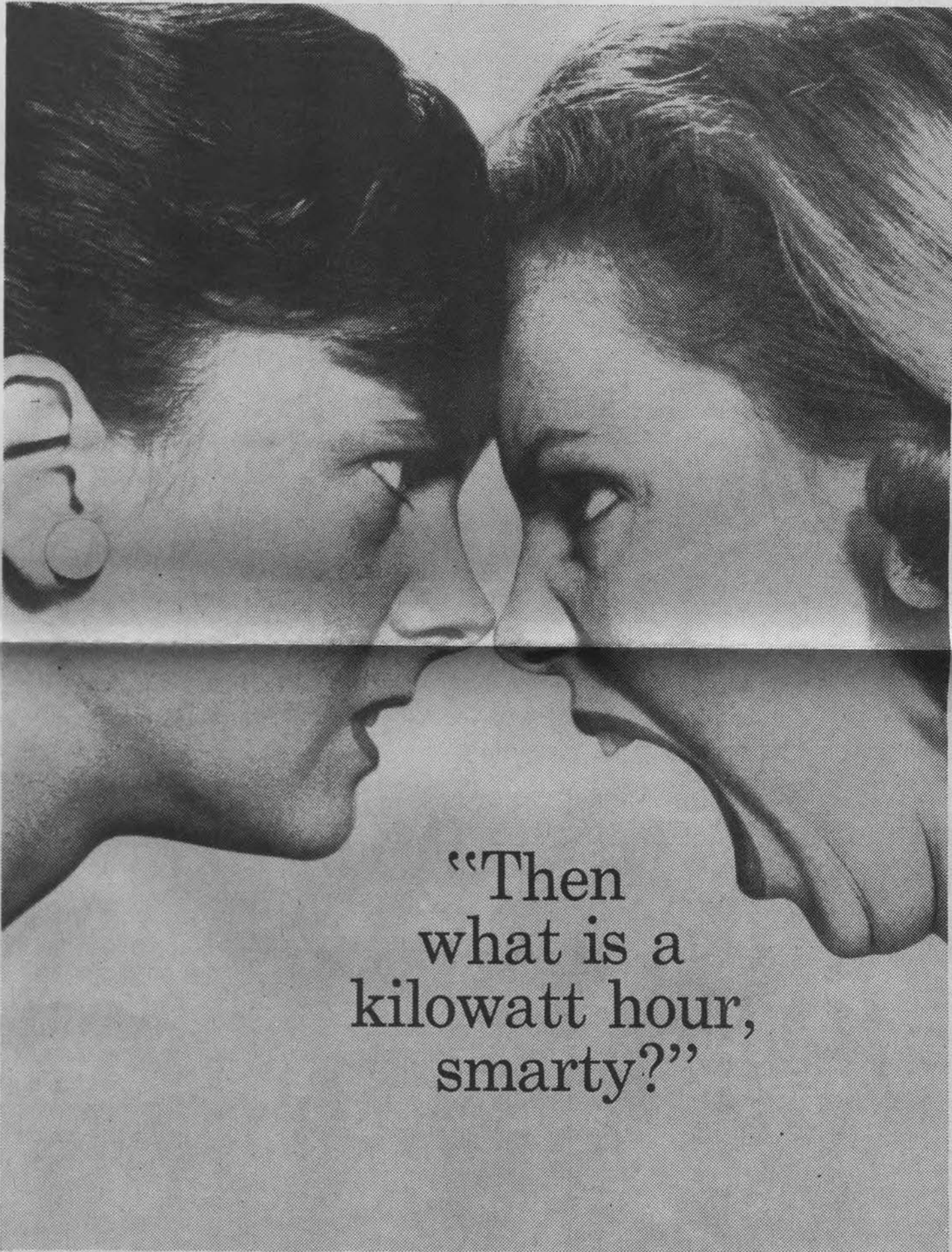
