Sayre Woods South **Group Voice Complaints**

The executive committee of the newly organized Sayre Woods Souh Civic Association Inc., recently invited representatives of the various newspapers covering Madison Township to a press con-ference "to give their side of the

Sayre Woods South story".

Members of the committee freely volunteered complaints against the firm of Cantor and Goldman, developers of the 2,000 home community, the session was three hours long. The executive committee charged that:- The firm is trying to turn a tract of land into a commercial site, while originally the property was supposed to be a park site or school site; that a water drainage area on Ledge Terrace presents a potential hazard; that the firm advertised four schools would be built on the property; Residents contend that their homes are over-as-

Jerome Zuckerman, president of the association stated "that the organization is not an "anti-builder" group and that it desires most of all to work harmoniously with the building firm, not

How she is doing it, Silvers continued, is a source of resentment to the association, Silvers claimed, that ideas of the residents have been quickly grasped by the public relations specialist and turned into accomplishments by the developer and that once desired publicity has been obtained the project is promptly dropped. He cited a teen-age dance project. He said a couple of dances were held and then the project was dropped.

Zuckerman stated that residents of the development had to "pay" out money they were not told about at the time of their purchase of the homes. A deposit of \$18,75 had to be made to the water company, while a deposit of \$60 went to the gas company. Zuckerman also bemoaned Continued on Page 7.

Madison Township May Get Ball Club

Plans to bring a major league baseball team in Middlesex County were disclosed at a press conference at the Waldorf -Astoria Hotel in New York late last week.

A prominent group of Middle-sex County businessman plus some outside investors will attempt to obtain the Kansas City

tempt to obtain the Kansas City Athletics, the former Philadelphia Athletics.

If the syndicate is successful in purchasing the franchise, it will build an all purpose stadium in Madison Township. The designer Jack Thalheimer estimates the cost of the stadium at the 30 million dollar mark. The stadium would have a collapsible roof and would allow year round roof and would allow year round operation and cover seating for 75,000 people during full stadium use and 40,000 for baseball games.

Options on a 350 acre tract have been obtained as the site of the proposed stadium. The of the proposed stadium. The syndicate is headed by the Berg Agency of Metuchen. The company is controlled by Leonard and Kenneth Berg.

Attorney for the group is Middlesex County Prosecutor Warren W. Wilentz.

It was disclosed at the elaborate press conference by the Berg brothers that the syndicate has submitted a bidfor the franchise but it hasn't been acted upon by the club's board of dir-

Parke Carroll general manager and executive vice president of the club reported "There is no intention of selling the club or moving it from Kansas City. In five seasons we have drawn over the five million people.

Never - the - less despite the denials of sale speculation ran wild as far as residents of Madison Township were con-cerned. The possible location of a ball park in Madison Township had residents of "Our Town" walking on cloud "Number Nine". Most business men in the area were overjoyed with the prospects of such a club and ball park, most were of the opinion that this would be a "sure shot" to put Madison Township on the

Despite the opinion of some residents of Madison Township who believe that most civic groups are formed as 'hate-the-builder' Clubs and are sometimes used as a "stepping stone" for a few who seek political gain. We firmly believe that civic organizations can be of great value to Madison Township.

We've heard the same type complaints

Many of the new residents who join civic associations do so with the sole purpose to 'better Madison Township," we feel that most new residents ban together to solve problems confronting them and not to create problems.

from time to time.

If a civic association concentrates too much on the fighting of a builder, you will find that when he completes the development and leaves the area the civic association collapses and dies.

Too often a civic association will forget the main purpose that it was created for "the betterment of the community" and try to deal with individual problems, this too, will eventually lead to the collapse of the group.

Civic associations can be strong but only as strong as the members. Each new resident of Madison Township has a "stake" in Our Town, certainly, things can be worked out.

Civic association can build playgrounds, they can start fire companies, build swimming pools, parks. They can establish balanced recreation programs in their respective communities. They can do a score of things for Our Town.

However, no civic club or association can run the whole town, if this is not remembered by the members of the civic group then the group will falter and die.

Our Town will survive with or without the help of civic groups, we will certainly prosper, however, it will be much easier with the co-operation of the civic organizations.

This is Our Town, let's strive to keep it strong and healthy, it isn't a bad place to live. Eventually conditions will improve, but it will be much quicker if we New Members Added work together.

HOW ABOUT ENFORCING ORDINANCES?

Madison Township is well armed with ordinances of various nature, covering such things as dog control and licensing, refrigerators and bows and arrows. About the only thing lacking in the whole setup is the enforcement of these ordinances.

Many of the ordinances were created with the sole purpose of controlling a serious situation, which had resulted in death or injury to children of Madison Township.

The bicycle ordinance was adopted after two youngsters were struck by a car while they were riding "double" on a bike on Route #35. Remember?

The ordinance governing 'the abandoment of refrigerators" after a rash of deaths of children who were accidently locked in refrigerators.





the fact that the taxes were approximately \$150 more per year than they had been told.

Officials of the firm of Cantor and Goldman angrily denied many of the charges. The property in question which will be used for commercial purposes had been set aside for a recreational or school site, but that the planning board and school board had rejected the property as such a site because it was too close to the highway.

The water condition and drainage pipe on Ledge Terrace had been corrected prior to the com-plaints of Mr. Zuckerman. Spokesman for the firm said

that originally the firm intended to build four schools on the development site as was advertised in early advertisements, however, the Madison Township Board of Education, asked that only three schools be built, stating this would reduce the expenses to the board. There would be one less janitor to hire. The school rooms were built on a formula worked out by Township Officials and Cantor and Goldman.

As far as the taxes, we have nothing to do with them, that is a problem of the Township Tax Assessor and the indivudal residens.


