Democrats Hold Tax No Increase In Rate

mittee adopted the 1960 budget and despite predictions earlier in the year of tax increases by Mayor John Phillips, the Demo-cratic Controlled Committee were able to come up with a tax rate that showed no increase over the previous year. Phillip's stated "that his

earlier predictions of a tax increase were based on his belief that an increase in the taxes would result, however, we have been able to hold the line".

The hearing held at the Cheesequake Fire House on Route #34, was the quietest budget hearing we have witnessed in many years in Madison Township.

The hugh audience present at the hearing included three newspaper reporters, two candidates for Township Committee and two janitors from the Fire Company.

Speaking at the meeting were candidates for the Primary Election Thomas Miller, former G. Township Committeeman and John Chamberlain former

Miller questioned the committee if everyone was in favor of the budget including the minority member. Donald Macrae, lone Republican on the committee, stated that he was 'in favor of everything that was in the bud-

Former Mayor John Chamberlain also agreed with the budget, and explained that the Democrats were following the G.O.P. ad-ministration in returning "surpluses" to the residents of Ma-dison Township.

Miller did not agree with the budget and urged that the budget be reduced. The Old Bridge resident questioned the increase in the police budget and demanded "What's the object of a raise for the police?" Harry Messenger answered that it was to compensate for the rise in the cost of living felt by every other working man." Messenger went on to explain that School Crossing Guards would also be given a pay raise. Miller stated, "I'm glad to see that the ones that police department will receive a raise, but I object to a increase to the rest of the de-

Miller also took Township Tax Collector David Watson to task for increases in his department. Watson replied that "much of the increase would be used to purchase modern bookkeeping equipment and machines to be used in the Tax Collector's office, It was pretty close to ridiculous in this day and age that the tax collector's office did not pur-chase some equipment." The tax collector went on to add, "We process some 14,000 tax-bills and at the present time we are doing all the computing and work by hand. The purchase of such equipment has been needed for a

Miller also questioned Harry Messenger on the new Town Hall and noted that money had been set aside in the budget for furni-ture and equipment. Millerwondered if this was duplicated by the increase in the Tax Collectors account, Messenger replied, "There is no duplication the money will be spent to purchase necessary equipment and furniture for the new townhall, we will also have to provide janitorial services at the new building."

Miller turned his attack to Frank Gominger, Township Auditor, in an attempt to have the auditor state that it was his budget. Miller praised Gominger as being a very clever man and that perhaps he should move into Madison Township and seek election to the Township Committee, Miller said Madison Township could sure use you. Gominger, stated that the budget was prepared by the Township Committee that he (Gominger) had merely placed the items in the right accounts as prescribed by law.

The budget was approved by all members present and it was ordered that the Budget be filed with the county and state as the adopted municipal budget for Madison Township.

Dear Sir:

At a recent meeting of the Central Park Home Owners Association, a motion was proposed to have the Association sponsor a movement in Madison Township to have all homes, wherein an Invalid, Infirm or Handicapped person resides labeled with a large Decal.

This label could be approxi-mately 3 inches in diameter, printed with iridescent ink showing a Letter 1 in the center. It would be placed on the Front Door and/or Window of these

A small 1 1/2 inch miniature of the decal would be placed on the window of the room where this person is confined.

In case of any emergency a Policeman, Fireman, Auxiliary Policeman, First Aid Squad, Civil Defense Worker, and even civilians would recognize this symbol and render assistance to the handicapped person.

Of course, this movement could not be accomplished without the cooperation of all Services in Madison Township and News -

papers serving this community. On March 23, 1960 I forwarded a letter on this subject to Chief E. Adler of the Madison Township Police Department for his approval. He agreed this was a splendid idea and suggested that Sgt. Charles Boice, Liaison Of-ficer of the Auxiliary Police and Civil Defense, arrange a meeting with our committee and all Services concerned to formulate a plan.

I was privileged to speak on this subject at the Cheesequake Fire Company's meeting March 31, 1960, and received many faable comments which can be joint committees.

Sergeant Hanson of Madison Township Police Department was instrumental in getting a very good price on these Decals.

The Press is vital to the success of this plan by bringing this idea before the public and asking for their cooperation, May we count on your support to further this movement? Comments and suggestions will be greatly appreciated.



BOARD OF EDUCATION: Rumored around town that the Board of Education will soon fire another of the janitors. Board of Education seems to have quite a time keeping janitors. Wonder what's wrong? Could it be that the salary is pretty low? Too many bosses? 

There Was A Sad Man In Old Bridge, That Night!

Borough of Old Bridge collapsed last week as only 17 persons turned out to hear plans of the "Old Bridge Secession" from Madison

Prior to the meeting Thomas Miller was jubliant over his plans to form a Borough of Old Bridge. Miller charged that residents of the Old Bridge area were not getting a fair shake as far as representation on the Township

Committee was concerned. The Old Bridge resident who served as a former Township Committeeman for Madison Township and member of the Madison Township Board of Education earlier expressed hopes that the residents of the area including section of East Brunswick and Madison Township would turn out in a large group to seceed from Madison Township. 


