GARBAGE DEPARTMENT: Signs all over State Highway and various roads point out the fact of a campaign to keep New Jersey roads clean and free of trash, Signs read "No Litter-ing \$50 Fine." So what hoppen! If Madison Township had to pay a \$50 fine for each piece of paper that flew out of the township truck collecting garbage, the total fine would have run into several thousands of dollars. 
