Wall Urges Safer **Highway Planning**

"Connie" Wall, Middlesex County Safety and Traffic Coordinator appeared at the regular meeting of the Madison Township Committee held at the Cheesequake Fire Co. Fire House on Route 34. Wall pleaded that the township committee give atten-tion to careful planning of shopping centers and other commercial enterprises to be constructed along already busy highways.

In a rare appearance the Traf-fic Co-ordinator stated "that he was not present at the meeting to critize local officials, but was merely pointing out the need for better highway planning." Wall continued "that traffic safety is everybody's business. Most highway and municipal roads are antiquated and it is fortunate that most development in Madison Township borders along State highways. Traffic in Middlesex County is steadily increasing with the rapid popula-tion growth. Commercial enterprises planned along major highways presents a serious traffic problem that must be coped with. Local municipalities have to invest taxpayer's money in the erection of traffic signals and "jg-handles" to correct some of these dangerous problems. It is quite easy to build a shopping center along a highway, but what of the traffic problem, can this be solved as easily?"

The committee awarded a bid for road supplies and materials to the Manze Co. of Route #34, Matawan. The Matawan firm was the only complete bidder on road materials as advertised.

Township Attorney Harold Smith informed the committee that there was no State Statute governing the creation of First Aid Squad Districts.

The township received a peti-tion with over 200 signatures to correct a drainage condition in the Cliffwood Beach area. Residents of the area complained about a water condition on Ocean Blvd., a spokesman for the group also stated that cars have been using Ocean Blvd. for a racetrack and urged that the committee do something about it before some child is killed.

The engineer was instructed to obtain a right of way in the rear of the property bordering the water condition. The road department supervisor was instructed to clean out, clear and flush and open sewer in the area and notify the Mosquito Control Commission about a sewer.

over the tuition rates as esta-blished by receiving districts. When the local school budget is prepared for presentation to the voters of Madison Township, there is no way of knowing what the tuition rate per high school pupil will be. This necessitates a little "guess work" on the part of the Board. No receiving district can "charge" the local Board of Education more than the cost of education. This is based on the total budget figure for the receiving district and is divided by the enrollment figures to obtain, cost per high school pupil. The figure established by the receiving district may be higher or lower than the estimated figure set by the local Board of Education, nobody is "robbing" anyone and Madison Township is paying a fair share of the cost.

PLANNING BOARD: At the April 11th meeting of the Zoning Board of Adjustment, at the Town Hall, A TAX MAP was still not available. What's holding up the works ?? The Zoning Committee says this is the responsibility of the Planning Committee. Maybe we need a new committee who will get on the ball! It is not fair to the taxpayer when he goes to these meetings to appeal 'use permits, etc., and there isn't even a map there to show them exactly where the lots for these permits are located.

BE IT ORDAINED by the Mayor and Township Committee of the Township of Madison in the County of Middlesex and State of New Jersey as follows:

Section 1 - Definitions

(a) As used in this ordinance the term taxicab shall mean and include any automobile, motor car or other vehicle com-monly called taxi, engaged in the business monty called tax, engaged in the business of carrying passengers for hire, which is held out, announced or advertised to operate or run over any of the streets or public highways of this Township, and particularly accepts such persons as may offer themselves for transportation within the Township of Madison. Provided that nothing herein contained

shall include autobuses, public liveries, eys or other such vehicles which are hired by charter or for a particular con-tract agreed upon in advance for such public conveyances as are by law subject to State and/or Federal regulations exclusively. (b) "Person" means and includes any individual co-partnership, association, corporation, joint-stock company or their (c) 'Street" means and includes any street, avenue, park, parkway, highway or other public place.

Section 4 - Applicant's Qualifications Each applicant for a driver's license shall be at least twenty-one (21) years of age, a citizen of the United States, and the holder of a State driver's license issued by holder of a State driver's license issued by the State of New Jersey. Each applicant shall prove to the satisfaction of the Police Committee of the Township Committee that he is in good health with good eyesight and that he is able to read and write the English language and is of good character and that he has knowledge of the traffic regulations and geography of the Township. All applications for taxicab licenses shall be made in writing to the Mayor and Township Committee which applica-tions shall be made upon blankforms to be furnished by the Township of Madison and

furnished by the Township of Madison and shall give, in addition to the information required by this Section, such further in-formation as may from time to time be deemed by the Police Committee of the Township Committee as requisite to de-termine the fitness of the applicant to act in the capacity specified. Each applica-tion shall be accompanied by the full amount of the license fee as hereinafter provided.

Section 5 - Insurance Provision and Com-

Section 5 - insurance provision and com-pliance with State Law No owner's license shall be issued until the applicant shall submit the in-surance policy or Certificate in lieu there-of required by Section 48: 16-3 of the Revised Statutes of New Jersey covering the taxicab to be licensed and until the said taxicab has been thoroughly and carefully inspected under the direction or super-vision of the Police Committee of the Township of Madison and found to be in Township of Madison and found to be in a safe, clean and sanitary condition for the transportation of passengers. Each owner's license issued hereunder shall state the make, motor and serial number of the car licensed and license number of of the car licensed and license humber of said vehicle as granted by the State of New Jersey. No owner's license shall be trans-ferred from one vehicle to another until the owner shall first obtain written per-mission from the Police Committee of the Township Committee for such trans-fer and pay to the Township Clerk a transfer fee of Five Dollars (\$5,00). No owner's license shall be transferred from one owner to another except by direct action by the Mayor and Township Committee and the payment to the Township Clerk of a transfer fee of Ten Dollars (\$10.00). Taxicab drivers licenses shall not be transferrable. All applications for transfer of owner's licenses shall be made upon forms furnished by the Town-ship of Madison and shall be accompanied by the full amount of the transfer fee. All changes of residence on the part of the holder of any license issued under this Or-dinance shall be reported in writing to the Chairman of the Police Committee of the Township Committee within three (3) days after said change.

Section 6 - License Fees

All licenses issued under this Ordi-nance shall be good and valid from the date of issue until the thirty-first day of December next after granting the same. The fees to be paid for said licenses shall as follows: For every taxicab - Twenty-five Dollars

For every taxicab driver - Five Dollars (\$5.00)

Where licenses are issued after the be-

ginning of the year, the license fee shall be pro-rated on a quarter annual basis.

Section 7 - Duty of Licensee

Every driver or operator when in charge of a taxicab licensed under this ordinance shall have in his immediate possession a valid taxicab driver's li-cense which license shall be exhibited at any time upon request by any member of the Mayor and Township Committee, any police officer, any duly authorized agent of the said Township or any passenger.

Section 10 -

No owner or driver of any taxicab shall induce any person to employ him by know-ingly misinforming or misleading any such person either as to the time or place of the arrival or departure of any train or bus, or as to the location of any hotel, public or private place, nor shall any such owner or driver deceive any person, make false misrepresentations to him or convey any passenger to any other place or with any other route than that indicated by the passenger.

Section 12 -

Every taxicab licensed under this Ordi-nance shall carry affixed therein so that the same may be conveniently read by any passenger a card containing the name of the owner of the vehicle, the number of the owner's license and the rates to be charged for the first quarter-mile and each subsequent quarter-mile.

Every taxicab shall have painted on both s sides thereof, the words, "Taxi" "Cab" or "Taxicab" in letters at or 'Cab or 'Taxicab in letters at least six (6) inches high or the name of the operating owner containing the words, 'Taxi", ''Cab" or ''Taxicab''. Every taxicab shall also carry in such

Every taxicab shall also carry in such a position as to be visible from the out-side, an electric sign not less than five (5) inches by nine (9) inches by ten (10) inches which shall be illuminated at night and shall plainly show the word, "Taxi". Every taxicab shall have painted on each side thereof in letters at least one (1) inch high the name of the owner there-of, followed or preceded by the word.

of, followed or preceded by the word, "Owner,"

Section 13 -

The owners or operators of taxicabs within the Township of Madison may only charge the schedule of rates of fares for transportation within the Township or to points outside the Township as have been submitted to the Mayor and Committee with the application for a license and which schedule of rates have been duly approved by the Mayor and Township mittee.

Section 14 -

Any license may be revoked or suspend-ed at any time for cause and such license when so suspended or revoked shall not be re-issued except for good and suffi-

cient reason shown. Licenses may be suspended by the Mayor, Township Magistrate or the Chairman of the Police Committee, but no li-cense shall be revoked except by action of the Township Committee.

Section 15 -

There is thereby reserved to the Ma-There is thereby reserved to the Ma-yor and Township Committee the right to make such rules and regulations in relation to the operation of taxicabs and the conduct of the operators thereof as they may from time to time determine to be necessary and proper in the best in-terest of the citizens of the Township, It is further declared that any violation of such rules and regulations as made by of such rules and regulations as made by the Mayor and Township Committee of the Township of Madison shall constitute a violation of this Ordinance, punishable a violation of this Ordinance, punishable as hereinafter provided. Such rules and regulations, however, shall not become effective until forty-eight (48) hours after they have been promulgated and posted in a conspicuous place in the Township Hall and copies thereof mailed to the current holders of taxicab owners and taxicab operator licenses.

Section 10 -Any person, firm or corporation who shall violate a provision of this ordi-nance or fail to comply therewith or who shall violate or fail to comply with an order or regulation made thereunder shall severally for each and every such violation and non-compliance forfeit and pay a penalty not to exceed the sum of \$200.00 or be imprisoned in the Middlepay a penalty not to exceed the sum or \$200.00 or be imprisoned in the Middle-sex County Workhouse or Jall for a period of not more than 90 days or both.
