WE DON'T THINK IT'S CRICKET!

Located on Highway 9 in the Borough of Sayreville, New Jersey, is a small but powerful sign. This sign has already accounted for perhaps a score of traffic tickets. There are many signs placed along state highways, and, of course, we must realize that the signs were put there for a reason.

Going north from the intersection of Route 9 and Ernston Road which is also the Sayreville-Madison Boundary line we read various signs placed along the road, some read 'Speeders Lose Licenses' while others

read 'Do Not Litter, \$50 Fine".

The sign we are referring to is the little sign that reads 'No Left Turn'. This little 'monster' is placed on the center island near the Sayreville Shopping Center.

We question the erection of the sign. If the island opening is so dangerous at this particular spot, why not close it up? Why is it not permitted to make a left turn from the Northbound lane, when you can make a left turn in the Southbound lane?

Resdents of Madison Township are in an uproar about "dust conditions" alleged to be coming from the Manzo Plant. We believe that the plant was ordered by the former engineer to install "filters" last year? Wonder if they have been installed? Members of the Madison Township planning board evidently feel that Madison Township is not getting proper consideration in the locating of new industries in the area.

Members of the local planning board place the blame at the foot of the Middlesex County Planning Board and Middlesex County Industrial Commission.

John Keating, Madison Township Committeeman and member of the Planning Board voiced 'I don't think that we are getting a fair shake from the Middlesex County Planning Board or the Middlesex County Industrial
