Lack of Signs Presents Dangerous Problems

State Highway Department workers are busily completing the final stages of the road construction program in the Madison Township area from the intersection of Ernston Road and Route 9 to the intersection of Route 9 and ROUTE #\$.

The rehabilitation of the area has seen the erection of two jug-handle turns one near the SayreWoods Shopping Center and the other near the Central Park Homes,

State Highway workers last week started to close off all the crossovers on the safety islands, making it impossible to turn with the exception of at the "jug-handles", merchants in the area had protested the closing up of the safety island but to no avail.

Saturday evening during the heavy North Bound traffic return, traffic became snarled at the jug handle at Route 9 and Ernston Road, there were as many as fifty cars waiting patiently to make the cross over, Route 9. One police officer explained that the timing trip for the traffic signals at the intersection may not be timed properly or was possible out of order.

The highway department has provided an emergency cross over near the Madison Township Municipal Building on Route 9 for use by polic cars in an emergency. Police Chief Edward Adler reports that unless the cross over is used for emergency only, ther is a possibility that this will also be closed.

Vehicles traveling south and wishing to reach the Township Municipal Building on Route 9 must use the "jug handle" near the Central Park Homes, the only sign in evidence as of Tuesday evening was a stop street sign, several motorist have already reported near misses in trying

New Shopping Center Wins Approval

At the recent meeting of the Madison Township Planning Board members present voted to recommend to the Township Committee that a zoning change be granted to permit the construction of a new multi-million dollar shopping center on Route 9 and Throckmorton Lane in the Browntown section of Madison Township. The recommendation practically warrants approval as members of the Township Committee also serve on the Planning Board.

Before final approval is given to the proposed shopping center, an ordinance must be adopted amending the zoning and planning ordinances for Madison Township, the ordinance is approved on first reading and then advertised for a public hearing to be held. The hearing will give opportunity to all residents and interested parties to raise objectsions to the proposed change in ordinance.

Application was presented by State Sen. John A. Lynch representing the Altersair Realty Company of Madison Township.

Proposed plans call for a shopping center on a 22 acre tract off Route 9, beyond the present 300 foot maximum depth from the Highway #9 presently

Plans call for a 24 lane bowling alley, a large supermarket and several small rental stores, construction is expected to be underway within four months, provided that the ordinance change is granted.

Henry Sevrin, attorney for the developers present a written agreement to construct a buffer zone between the shopping center and adjacent homes, the buffer zone to be landscaped and a six foot fence erected with an additional 10 foot wide strip of screened planting which is supposed to grow to maturity within three years, the planting would attain a height of at least ten feet.

shopping center will also include parking facilities for several hundred cars.

Youths By Local Police

Calls started pouring in the Madison Township Police Head-quarters on July 18, residents of the Sayre Woods South development were complaining that while they were away from home for the weekend someone had broken into their homes and valuables and money had been taken.

With the number of calls and the police investigation which revealed that no forced entry had been committed, officers at the scene presumed that the thefts were being committed by a person or persons that had a master key to all the homes in the area, Madison Township Police promptly placed the area under close observation and warned residents in the area to be on the look out for suspicious persons. This bit of advice later paid off.

The police dispatcher notified one of the patrol cars in the area. Ptl. Einar Nielsen and Ptl. William Barry sped to the scene and began a search of the area for the two youths. The patrolmen sighted a boy sitting on a curb in the area and began questioning him. The youth admitted that

of which he was sitting.

"Rough And Tough" On Speeders

Madison Township Police Magistrate Samuel Sladkus vowed "open warfare" on speeders in Our Town. Sladkus stated that a "rough and tough" policy will be enforced against any and all speeders in this township.

The reason for the police magistrates alarm is the increase in traffic violations since last year. There have been an 85 percent increase in traffic violations since last year. At the present time there are 1.100 cases on the books for 1960 compared to only 650 for the corresponding period last year.

We certainly agree with the police magistrate that something must be done to impress motorists traveling

on various roads in Madison Township.

We feel that a "rough and tough" policy coupled with more radar and police patrols along the various highways in Madison Township will certainly tend to slow down passing motorists who use the various highways for their own private race tracks.

Madison Township is divided by several major highways which proves to be adding to the influx of traffic violations. Much of the speeding takes place on Routes #35, 34, 9 and 18 with Englishtown Road getting its fair

share of speeders.

We certainly hope that the Police Magistrate carries through with his 'rough and tough' policy, because when word gets out to other motorists that Madison Township is "rough" on speeders you will notice a August 6 decline in the traffic violations rate.

With excessive speed there is always the danger of traffic accidents and death by automobile. Let's all in our own little way contribute to the police magistrates program. Participation by the residents of Our Town would call for driving just a little slower and just a little more careful. Good Luck in your campaign Magistrate Sladkus.

Hole-In-Wall" **Action Taken**

Elimination of the dangerous railroad crossing and bridge known as the "Hole-inWall" at the intersection of Ernston Road and Bordentown Avenue came one step closer as Middlesex County Freeholders authorized the county to enter into contract with the Pennsylvania Railroad for elimination of the "Hole-in-theunderpass bottleneck in Wall" Sayreville.

The resolution was introduced by Freehold William Warren, under the term of the agreement the underpass will be widened and paved and a pedestrian walk will also be built.

The Pennsylvania Railroadhas agreed to pay one half or ap-proximately \$50,000 for the construction work while the county and borough of Sayreville will contribute \$25,000 each.

Police Probing Robberies.

Madison Township Police after successfully solving several robberies in the SayreWoods South development are attempting to solve two more.

Police are investigating the theft of \$20 worth of tool from a tool box at the Ceco Steel Products Company of Millstone working at the new Madison Township High School on old Route 18 in Browntown.

Listed as missing were two shortwhite aprons, a ratchet wrench, three sockets and one aluminum window sill.

Also under investigation is a search for a thief or thieves who have carted off over \$11,000 worth of building materials from the construction site of the new St. Thomas R. C. Church in the Old Bridge area, during the past

Police reported that the culprits may have used a truck to make off with the heavy loot, Local police were called in on the case by Robert Burgeson, supervisor of the construction, who noted the theft of the materials after an inventory was made. The supervisor believed that the thefts could have been going on for over a year.

Listed in the missing items were \$10,000 worth of lumber; 1,300 colored cinder blocks, valued at \$450.; 30 pieces of angle iron, valued at \$200; slate window sills, valued at \$16.; cable at \$36.; 13 bags of cement and other items amount to over \$50.

Police reported that a watchman is on guard at the site from 4:30 to 9 p.m. daily.

youth to come out of the house, as he stepped out, he walked into the arms of Nielsen and Barry, the second youth readily admitted his part in the robberies.
