Board of Education also heads the local planning board.

Hardest hit for lack of school rooms are the pupils in the Old Bridge area where approximately 370 pupils will have to be transported to schools out of the Old Bridge area. A recent report by the superintendent of schools Dr. William Sample, pointed out to the members of the Board of Education that a 14 room school could be used in the Old Bridge area. The transportation is necessary to keep the children off double sessions and possibly triple sessions.

Dr. Sample pointed out that the shortages of classrooms exist now without taking in consideration any further increase in population before September.

Eight more additional rooms are needed in the Laurence Harbor area at the present time. Also under possible considera-

tion will be a achool for the Central Park area which is presently being served by the Whited-Brown School and Rehfus Whited-H School both these schools are two room buildings. The Board of Education also rents school room space from the Cheesequake Fire Company. Smith Gains in Assembly Bid

Township Attorney Harold Smith of 16 Princeton Road, picked up more support for his bid for the state assembly seat vacated by William Kurtz of South Amboy.

At a meeting of the Madison Park Democratic Club, one of the leading forces in Madison Township, the young attorney was endorsed by the members of the club.

Frank DeMatto of Princeton Road, Madison Park moved that the Madison Park Democratic Club endorse the Madison Park resident, the motion was seconded by Irving Collaci, former vice-chairman of the Madison Township County Com-

mittee and presently serving as Madison Township Democratic County Committee Chairman there was no opposition to the motion, Smith is a member of the Democratic Club in Madison Park, he was not present at the meeting.

In another motion which was also passed by the Madison Park Democrats, it was moved that a letter be sent to the Madison Township Democratic Municipal Chairman, Walter Staeger informing him of the local Democrate Club's pleasure.

Smith had already received the endorsement of the Young Democrats of Madison Township and the Sayre Woods South Democratic Club. Shopping Centers More Than Stores

Many male residents of Madison Township are opposed to any plans to construct gigantic shopping centers along the highways of Madison Township. Many of these males feel that they have purchased their homes in a community to escape the din of city traffic. Some are opposing the shopping centers just to be different and we are afraid that some are just being selfish.

In a community such as Madison Township, shopping centers, are more than just a group of stores where you can spend your money to purchase the essentials for daily living. Shopping Centers become a part of the general welfare of the community and serve to act as recreation for many of the mothers and youths of Our Town.

The Shopping Center with its modern snack bars and beauty parlors become a mecça and meeting place for hundreds of housewives and teen-agers who otherwise would find recreational facilities in Madison Township pretty boring. Many of these women welcome the op-portunity to "escape" to the shopping center to get away from the quiet of their home.

Remember that most of the residents of the newer communities in Madison Township are "city bred" and are not used to being isolated out in the woods.

The breadwinner in the family as in most families in Madison Township doesn't work in Our Town, but travels daily to work in New York City or some other metropolitan center. He can pick up a daily paper, have his shoes shined, his hair cut, enjoy a few drinks. How about his wife who is stuck out in the middle of nowhere with no car and no place to go? All she has is the serene peace and quiet of her community day in and day out, with no paper, no cigarettes, nothing but the birds. Let's face itl After a few months of this and it's all for the birds!

Husband comes home from the city where he h able to see people, see what's going on with all modern conveniences available to him, and retires to the peace and quiet of country living. Then for a night out will attend a Township Committee meeting to object to the building of a shopping center because he feels that it will not be peaceful and quiet anymore and that's what he is looking for peace and quiet. How about the wife?

The builders and developers of shopping centers have been quite generous with their facilities at the shopping centers. They have permitted meetings, carnivals and a host of other events to take place on their premises. We haven't seen a first aid squad or a little league team that didn't seek permission to solicit funds at a Shopping Center.

Merchants from the various stores in the Shopping Centers take active part in the various service clubs in Madison Township such as Rotary Clubs, Lions Clubs, etc.. The clubs in turn seek ways to improve health, social and recreational activities in Madison Township.

Various merchants sponsor Little League Baseball teams, bowling teams and are often called upon to donate merchandise for various clubs and organizations.

Most important to all of us as taxpayers is the fact that shopping centers become one of the larger tax payers in Madison Township and a continued source of venue to Our Town for yea rs to come.

Let's Take A Look At Our Township Recreation Program

The Madison American wanted to find out more information about Madison Township's Recreational Program so we called on Harry Messenger of Madison Park to come up with some answers.

Messenger, serving on the Madison Township Committee heads the Recreation Committee

for the Township. According to Messenger "this year marks the first attempt to my knowledge of the township erecting playgrounds for the thousands of deserving children who live here. It is not being done on an isolated basis but it is being done one a township wide basis. Messenger continued "in the past we have had to depend on various private groups to erect some pieces of equipment. Places like Madison Park Whited Brown School, School #9 and maybe some others have received some equipment from these groups, they were the fortunate ones. This year, however, the township committee is doing its part in supplying equipment. The first playground has been erected and has been in use, it is located at Duhernal Lake, it is one of nine installations that when completed will cover our entire township. It is what we like to think of as our first giant step toward progress in the recreational field. Each year with the aid of the township committee, more equipment will be added and more areas will be covered with good adequate playgrounds for our children, this might sound easy but lets take a look see into what needs to be done.

The recreation chairman stated "the very first step in our township recreation program was the assembling of active interested people, interested in the future of their childrens playtime and that of others, from each and every section of Madison Township, These people came out not for personal glory or recognition but out of the sincerity of their hearts to work with and for our youngsters. They met with members of the Township Committee and discussed the various problems. Where is the best location for an area? How much should go into an area? What about the future development of an area? How can the equipment be best used? Who handles the sales of equipment? What age children are most important in the beginning? What type of equipment shall we purchase? How soon can we get it. These are but a few of the questions these people helped unanswer. This only covers only one subject as far as recreation is concerned, multiply it by ten or twenty and you have a wague idea of what goes into a recreation program for your children.

After answering these questions we had to move on to the actuality of purchasing this equipment. This meant the advertising of bids, but first you must obtain the night specifica-tions for the equipment had to be

League World Series. This is accomplished by bringing the presidents of the 4 leagues together. They came up with the winning teams in their own respective areas to play each other and the winning team to be crowned or named Madison Township Little League Champs. An easy matter in this case but why hasn't it been done before? Could it be because nobody ever took these people into their con-fidence and made them feel they were a part of the town?

One of our committees came up with another excellent idea, a Junior Olympics for the township. Here again a group of interested people are at work because they have been given the opportunity to do so. There will be five major areas in-volved, Madison Park, Sayre Woods South, Old Bridge, Cheesequake-Central Park area and Laurence Harbor-Cliffwood Beach. It gives the boys and girls ages 7 to 14 an opportunity to compete in the events in their area and if successful in these eliminations to go on to the Madison Township Junior Olympics to be held at the Old Bridge Stadium on September 17 from 10 a.m. until 2 p.m.

Here again is a township first for recreation, why hasn'titbeen done before? Much more work involved! I'll say so get up a schedule, work in the various age groups, assemble the necessary equipment, get out side advice so we don't go wrong, arrange for the necessary forms to be printed, and most of all to arrange for the very important help needed. Then the areas to be used, insurance must be arranged for, transportation must be available and last but not least various awards must be obtained for the winning children.

So you see by looking into only three of our recreation attempts, that all is not quite so easy, far from it. I don't know why a committee like this wasn't formed before, but I know we have one now representative of the entire township. On the behalf of the committee and muself I ask the people of the wonderful town to be just a little patient, and little by little we will try to give our town more recreation facilities and more equipment,

As we have said this is only one subject, there are and will be other firsts in our township for the children. One of which we are working with right now is the first township wide Little







Presently under construction and expected to be occuppied for the 1961 term in September is a \$2,000,000 high school, this will be the first high school for the pupils of Madison Township.

The Board of Education presently transports several hundreds of high school students to receiving high schools outside of Madison Township. Madison Township pupils attend, South River High School, Matawan High School, Sayreville High School and Hoffman High School, South Amboy. A few pupils were attending Perth Amboy High School.

The South River High 'Board of Education recently was directed by Education Commissioner Frederick M. Raubinger to continue to take high school pupils from Madison Township.

The ruling came after the South River Board of Education de-cided to cancel its policy of taking Madison Township pupils after the Madison Township Board of Education announced plans to withdraw 9th and 10th grade pupils in September 1961.

Raubinger in his directive announced that the welfare of the students must be the prime consideration. Moving of the school pupils back to Madison in 1961 would ease a crowded classroom situation in South River and provide other educational benefits often lost in a crowded school system. The financial loss to South River next year will be offset by the fact that the South River Board of Education budgeted for only 75 Madison Township students and will receive tuition for over 120 this year. Other receiving districts for Madison Township are also ex-




