## Urge Reopening Of Route 9 Safety Islands

The Township Committee voted to ask the State Highway Department to open two safety islands it closed several weeks ago, local merchants and many of the residents of the Route 9 area between Ernston Road and the Route 34 junction have complained about the island closings.

Businessmen in the area claim that the closings have caused a large drop off in their businesses, some residents have to travel quite a distance by automobile just to get on the other side of the road.

Mayor John Phillips stated that the limination of the openings accomplished very little in the way of safety. He said that the job handle corssing at the intersection of Route 34 and 9, causes more motorists to make turns in the face of incoming traffic than before the openings were closed. Phillips also complained about the traffic tie-ups at the Ernston Road-Route 9 intersection.

Many Madison Township residents have found themselves forced to make extra long trips to get to the Township Municipal Building which is located on the right side of Highway 9 going north. Phillips declared that instead of the closing and jughandles promoting safety, he feels that they are causing more safety hazards than before and urged that the safety islands be reopened in at least two places.

At the township committee meeting an ordinance was introduced and approved on first reading. The new ordinance would hike the lot size from the present 100 by 100 feet minimum to a 100 by 150 foot minimum, the lot size increase came on the recommendation of the Madison Township Planning Board. Mayor Phillips commented later on the ordinance "We make no bones about the fact that this ordinance could prevent any Electric City settling in Madison Township.

The officials of Electric City have made no contact with any township official to come in here and they won't get in."

In other business to come before the Township Committee, Township Committeeman John Keating Chairman of the Road Department requested and received issuance of an emergency appropriation of \$20,000 to finance road repairs caused by hurricane Donna. Keating reported that the Township Road Department was busily at work trying to make all the necessary repairs in the roads, but the job ahead was great. Keating reported severe damage to the roads in the Laurence Harbor and Cliffwood Beach area. Storm sewers in the area were also reported damaged by the large amount of water from the hurricane. Keating stated "that the road department is making every effort to complete the necessary repairs to the roads before cold weather sets in."

The Committee also voted to renew its request for a traffic light at the intersection of light at the intersection of Throckmorton Lane and Route 9. Mayor John Phillips stated that this is the main entrance to the Sayre Woods South Development and a traffic light at this point is needed. Phillips stated that when the new Madison Township High School is completed this would add to the peril at this crossing. Phillips urged that the State re-open the investigation of the traffic light at the intersection. The state Highway Department turned down previous application of the Township Committee.

Jack Haltaway of Madison Park urged that the Township Committee take some action with Middlesex County Officials on the matter of drainage on Ern-

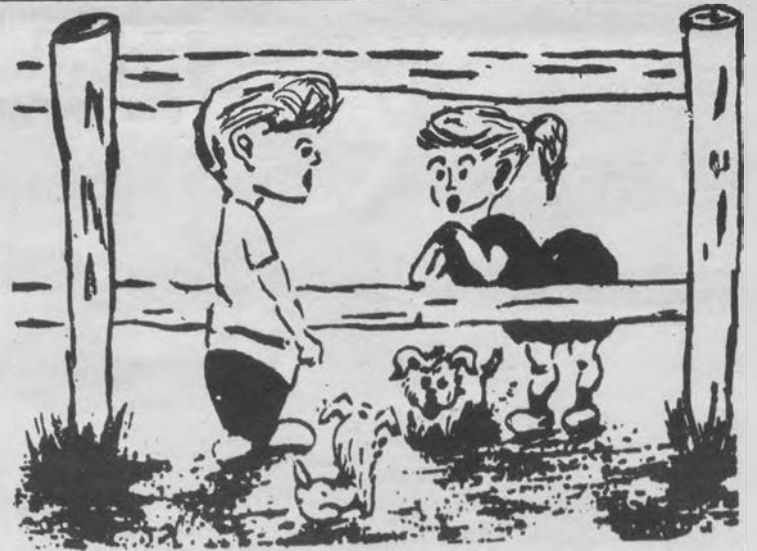

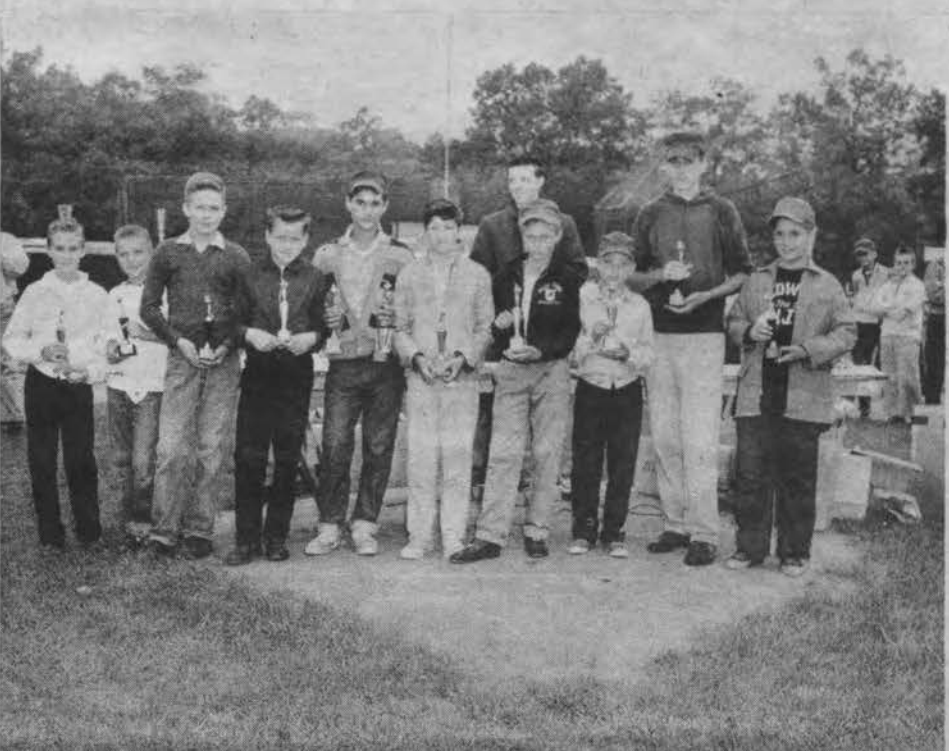
