It is hoped that next year the olympics planning can begin early and include swimming events as well as track and other special events.

Trophies were awarded to the winning contestants for First, Second and Third places, trophies also were awarded to the winning relay teams.

Phillips Cites 11 Point Democratic Program

"Me Thinks He Protest Too Loudly"

Former Republican Mayor John Chamberlain, again a candidate for Township Committeeman has been doing quite a bit of "yelling" about the proposed "Electric City Project". Perhaps he protests, too loudly?

Perhaps the G.O.P. candidate knows more about the Electric City project than he is letting on?

Present Democratic Mayor John Phillips has repeatedly denied any knowledge of any plans for Electric City in Madison Township, but Chamberlain continues to push the "Electric City" subject. Perhaps there is a method to his yelling?

Could it be possible that there will be an "Electric City" or is all the ranting and raving on the part of Chamberlain and his puppets a mere cover-up for some other development coming into Madison Township? After all, Chamberlain is an expert on developments, he's approved so many.

Chamberlain in his Election Campaign Platform of 1956 promised an end to developments in Madison Township, look at the record. How many building permits were issued in the three-year Chamberlain administration? You'd like to forget all that wouldn't you, Mr. Chamberlain?

How about the Special Meeting held at the old Town-hall on Route 18, in Browntown, when as Mayor Chamberlain you waited patiently for a developer to arrive at the meeting and then proceeded to sign for permission to build a 3,500 home development, plus apartment houses. You'd like to forget that too wouldn't you? Area newspapers screamed the headlines, "Chamberlain Approves 3,500 Home Development". It is quite possible that the 3,500 home development might run as high as 6,000 homes.

It's all in the records of the Township Committee, it's in the minutes of the Township Committee, it's part of the history of Madison Township. It's there for all to see.

So when you start "yelling" about "Electric City" or any other development, "Me Thinks You Protest Too Loudly"!

"King Size Lots Not The Answer"

Mayor Phillips and the township committee recently introduced an ordinance establishing the size of lots in Madison Township at 100' x 150', evidently the aim of the "king size lot" is a method to control building in Madison Township.

We don't feel that the mere upgrading of lot sizes is the best possible answer to development building, we feel that at it's best the upgrading of the lot sizes represents a mere stalling for time.

We feel that the township committee has been "pushed" into this ordinance by the planning board, which is using the larger size lots as a stop gap measure.

The upgrading of lot sizes in Our Town does not solve any of the problems of development building. The best solution to the whole development picture is complete planning, the Madison Township Planning Board and it's hired planners have been "stalling" around long enough in the preparation of a master plan.

It's time that the Mayor and Township Committee took the "bull" by the horns, and presented to the residents of Madison Township a complete master plan for Madison Township.

We do not feel that this ordinance will solve any of the problems of Madison Township. We feel that this is a stop-gap measure and is not the solution to the building program in Madison Township.

Madison Township General Hospital

Our Town has grown up and reached its maturity. We now boast some 22,000 men, women and children. Grown up towns deserve and need grown up facilities, such as its own hospital. In many ways Madison Township is still in the 19th Century, no sewers, and many houses without toilet facilities; for example, Laurence Harbor and many other sections of Madison Township. If there was an epidemic and if disease ran rampant because of it, we would have to depend upon hospitals of strange cities in far off places. We now have about ten doctors in Our Town. This is a sufficient nucleus to start a small hospital and would be a step in the right direction. We have excellent First Aid Squads. We have dedicated

Park Squad Lists Monthly Report

The Madison Park First Aid Squad completed plans last night on its annual fund drive. Every member of the squad will cover his assigned area this weekend in the hopes of collecting enough funds to permit the squad to operate for another year. With building plans in the near future and the squad operating on a deficit the task this year seems extra large.

J. Veradi of the Building committee discussed the minimum size of building needed and plans are being formulated to go ahead with this project.

In his monthly report Capt. A. Anslinger stated that the squad answered 34 calls last month, drove 500 miles and expended 130 man-hours of work in the completion of these calls. Broken down this included 6 house calls, 7 transports, three police and two fire calls, two auto accidents. Also included were 5 drills of the squad, 6 stand-bys at sporting events and three false alarms where the services of the squad were not needed, 8000 lbs. of oxygen were administered and an unrecorded amount of material and supplies dispensed with.

M. Makris of 11 Princeton Road was voted in as a probationary member and assigned to the day squad and the entire Squad voted to accept the sponsorship of the "Explorers Club of Madison Park".

After selecting Mr. James Clark of Princeton Road as "HONORARY BOOSTER OF THE MONTH" the meeting was adjourned.

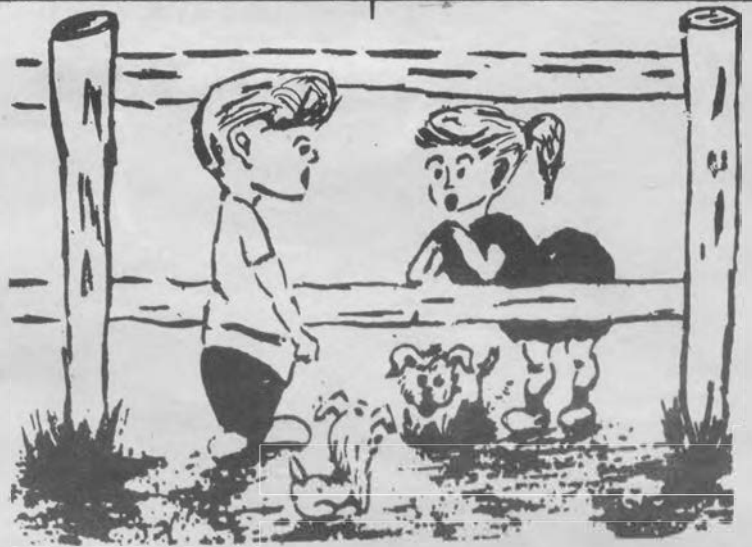

County Clerk Duffy Again Heads Dimes Campaign

M. Joseph Duffy of 132 Rector Street, Perth Amboy, has been reappointed Middlesex County chairman of the 1961 March of Dimes campaign.

Duffy's appointment was announced today by Dr. Lester Clee, state director of the organization.

Duffy will head an organization of volunteer workers who will campaign for funds in January for The National Foundation's broad scale attack on three devastating, crippling diseases: birth defects, arthritis and polio. One out of four American families are victims of the three diseases it was pointed out.

Dr. Clee praised Duffy for directing the Middlesex County chapter with exceptional ability for 21 years. Clee said "We search for four essential qualities in a county MOD chairman: efficiency, compassion,

character and devotion. M. Joseph Duffy is blessed with these rare and fine attributes. He is one of the best MOD leaders in the state and we are depending on Mr. Duffy again to lead and inspire assistants and workers to another successful campaign in the county."

Duffy, who is Middlesex County clerk, has served as county MOD chairman since 1939.

He said that "250,000 infants-one out of every 16-are born every year with significant birth defects."

Duffy also disclosed that "arthritis and rheumatism are the nation's foremost cripplers, afflicting more than 11,000,000 persons."

The county leader said "because of public apathy regarding the Salk vaccine, polio continues to be an expensive and heartbreaking problem."

Duffy revealed that after municipal chairmen and other key volunteers are selected, a meeting will be called to discuss and determine plans for the county MOD drive.

He was optimistic about a successful 1961 campaign. "Our cause is great, humane and noble and the residents of Middlesex County have responded and contributed magnificently in the past," he said.

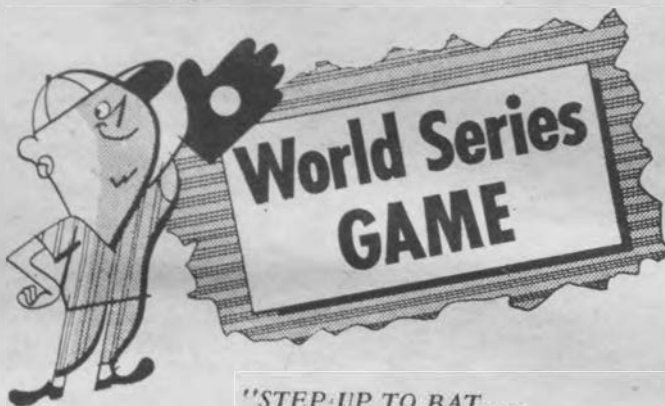

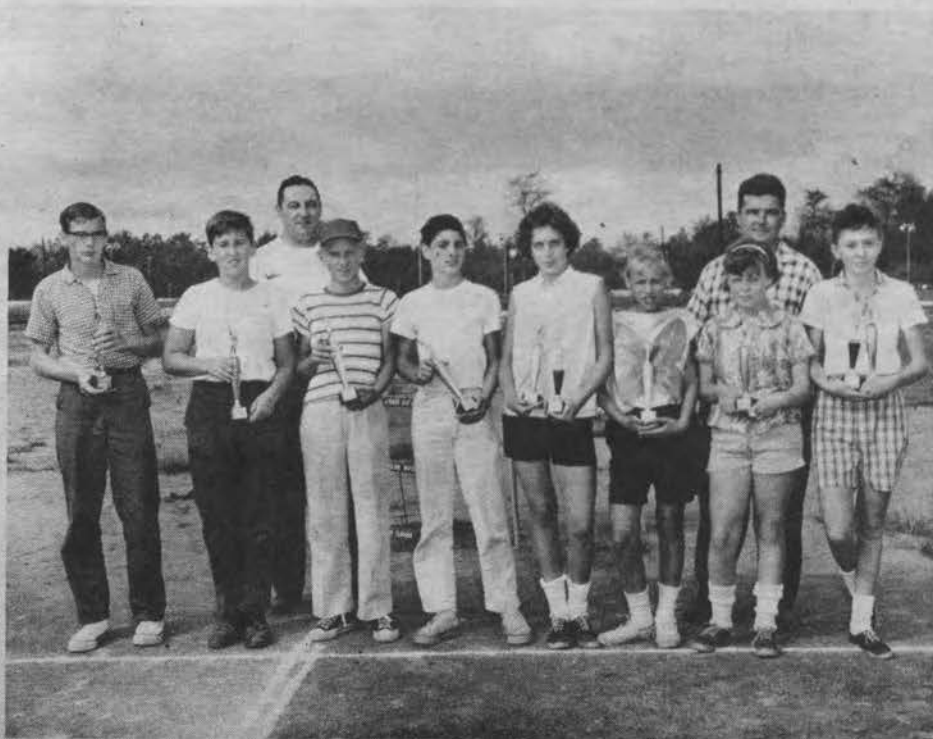
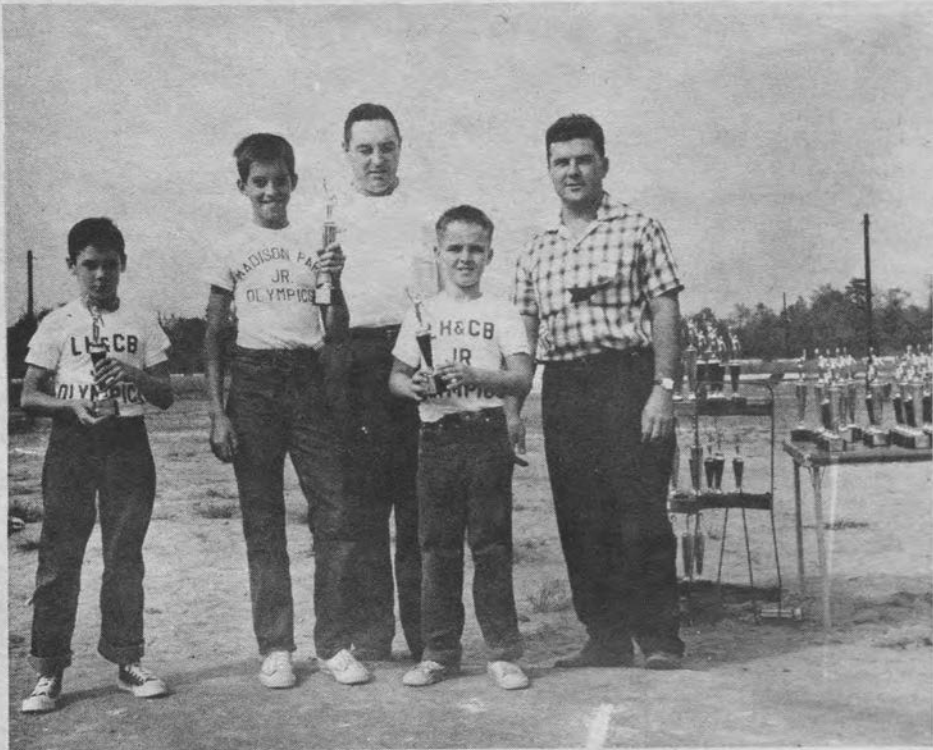
