Phillips Brings Industry To Madison Township

Lashing back at charges made by John Chamberlain that the Democrats could not bring industry into Madison Township, Mayor John Phillips called a special meeting of the Madison Township Committee, Planning Board and Industrial Commission

and announced that plans are being completed for the location of a \$30,000,000 industrial park within the boundaries of Madison Township. Phillips declared that Benjamin Okin and Marshall Sachs, the owners of the proposed indus-

trial park have been in contact with him within the past few months and that they have worked out the details of the first concrete plan to bring industry into Madison Township on a large scale. Mr. Okin and Mr. Sachs are well known builders who

have completed the construction of three industrial parks throughout the State of New Jersey as well as several shopping centers and other varied commercial enterprises.

Phillips said "The industrial park includes plans to erect in excess of twenty varied industrial enterprises within the limits of the park. The plans include the construction and installation of railroad spurs and a major roadway through the tract. The plans also call for the installation of a major trunk sewer line and a vastly enlarged water supply system to handle the needs of such a large scale industrial operation."

Mayor Phillips, after viewing the proposed plans of the industrial park was jubilant over the prospects of an immediate large scale industrial influx into Madison Township. He said, "This is what Madison Township has sorely needed for the past thirty years. It will result in tremendous benefits to every resident of Madison Township by providing substantial tax rates which will thereby stabilize our local tax rate. It will also tend to put Madison Township on the map by bringing in several nationally known manufacturers whose names will lend prestige to Madison Township in a way that towns like Edison and Sayreville have been able to benefit from for the past twenty years."

The location of the industrial park in Madison Township will undoubtedly provide many employment opportunities for the residents of our Town. Many residents who now commute to Newark or New York will be able to find an outlet for their skills in their own back yard, thereby doing away with troublesome commuting problems.

The plans for the park cover an area of approximately 200 acres. The proposed location has direct access to several major highways in the Township, being located less than five minutes travelling time from the Garden State Parkway and ten minutes from the New Jersey Turnpike. Railroad facilities are adjacent to the tract which will be extended to serve each of the plants that will require rail service.

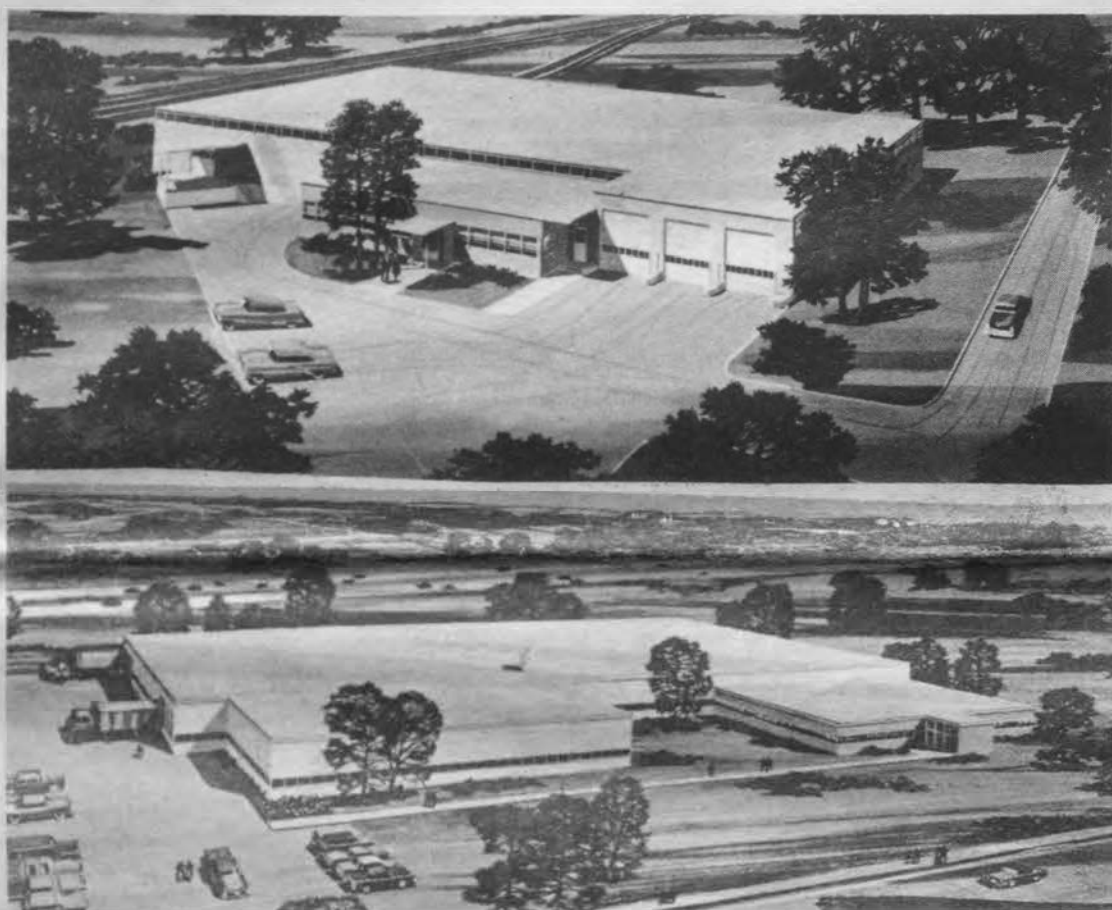
Mr. Okin and Mr. Sachs have announced that they have already engaged an engineering firm, an architectural firm an industrial consulting firm, a public relations firm and have said that they have secured definite financial commitments from several large banking institutions.

The development will be called "The Golden Circle Industrial Park." The name is derived from the fact that there are approximately 71,000,000 potential customers within a radius of 250 miles of the park. Within that circle is the greatest complex of transportation facilities, technical facilities, financial facilities and the all important labor market that exists anywhere in the world.

Phillips stated that this could be the greatest single event in the history of Madison Township. He said he would "leave no stone unturned in an effort to make real progress toward this milestone within the next year."

Mr. Okin and Mr. Sachs stated that they plan to work in close cooperation with the Madison Township Industrial Commission. Phillips said that he was not at liberty to release this important news at an earlier date because he did not wish to jeopardize the intricate financial

Debunking The Bunk

The Republican Candidates in Madison Township are running "scared" and nothing runs faster than a scared politician at election time, perhaps this is the reason they have been making speeches citing an increase of 400% in the local tax rate.

All that any resident of Madison Township has to do to disprove this ridiculous claim is to compare a 1959 Tax Bill with a 1960 Tax Bill. In 1959 you will find that the 1959 Tax Rate was \$11.65 and in 1960 the Tax Rate is \$ 11.73.

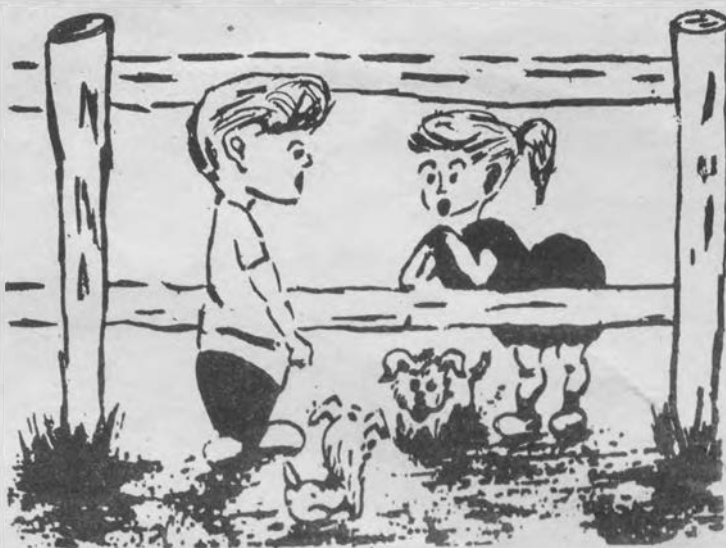

The father of two sons, Smith said that there is a good reason for the 1961 slogan of the campaign: Please Say Yes To The New March Of Dimes.

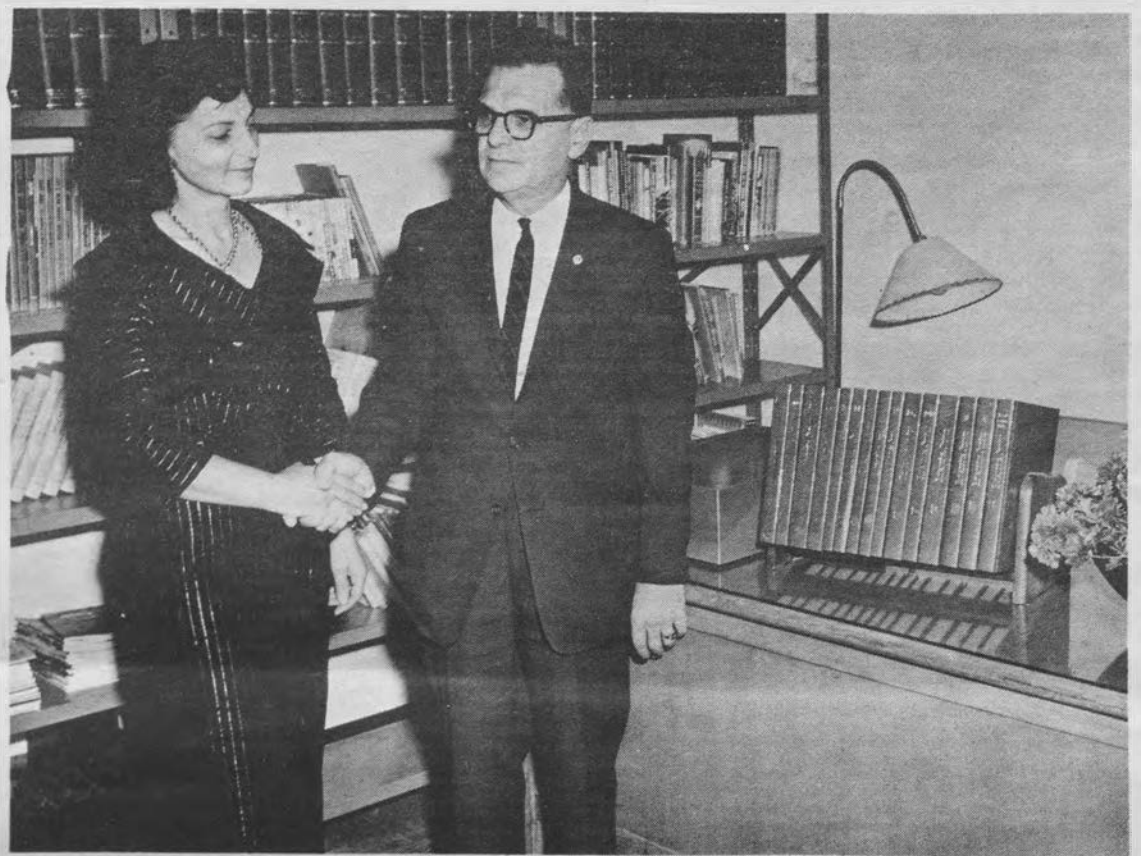
