## SCHOOL ELECTION SLATED FOR FEB. 14

C. D. McHenry, Jr., Secretary of the Madison Township Board of Education announced today that the annual school election will be

held on February 14th, 1961.

Four seats will be up for grabs in the annual school election, residents of Madison Township

will have the opportunity to vote for candidates and the all important Board of Education budget.

Most voters go to the polls at the November election however, at the annual school election this figure is greatly reduced and yet most circles agree that the Board of Education election is the more important election as far as the taxpayer is concerned, because most of the tax monies collected in the Township of Madison are for school purposes.

The Township Committee have very little control over the school budget and are reduced in most cases to merely a collection agency for the school board.

The local board of education prepares a budget which is presented to the residents of the township to be voted upon. If the budget is approved by the voters then the township committee must make the necessary arrangements to collect the money.

If the voters disapprove the budget, the Board of Education holds a special election. The Board of Education may reduce the figure, or leave the total amount the same, and on occasion the local Board of Education has presented an even higher figure than the original budget.

The new budget is presented to the voters for their approval, if the budget is again rejected, then it goes to the Township Committee where they can approve the total budget as requested by the Board of Education or may "cut" the budget. If the local Township Committee refuses to act on the passage of the budget, it then goes to the State for their approval. In most instances the budget figure is approved by the township committee.

In the past two years the budget established by the Madison Township Board of Education has won the approval of the voters of the township, however, there are many instances in the history of the township where the budget was voted down, not only once but twice.

Most voters going to the polls vote for candidates rather than on the budget. Most years slates or tickets have been established. For the past two years the voters of the Township have returned incumbent members to the Board of Education.

In 1960, voters of Madison Township returned Richard Pine,

William Joyce and William Kerr to the Board of Education, each were running independently of the other.

In 1959 the voters of Madison Township returned Joseph Hoff, John Partridge and Stanley Kordzinski to the Board of Education, again in this case the voters of Madison Township voted a split vote and returned Board members to the township post.

In 1958 the voters of Madison Township seated Charles Aumick, David Watson and Carol Delbasco (Mrs. Henry Kosobucki), the trio ran as a slate of candidates and defeated board of education members.

It is not expected that David Watson who later was elected Township Tax Collector will seek re-election.

Joseph Hoff recently elected as Township Committeeman resigned as of December 31, 1960.

Charles Aumick is expected to file with a complete slate of candidates for re-election to the Board of Education, Aumick is a Democrat.

Mrs. Henry Kosobucki, who is expecting the stork has not officially announced her intentions of running, although, it is expected that she will again seek re-election. Mrs. Kosobucki, the former Carol Delbasco was married in June of 1960. She presently resides at the home of her parents Mr. and Mrs. Henry Delbasco, Morristown Road, Cheesequake.

It is expected that at least ten candidates will file for the four seats open to the Board of Education.

### Music Program Set For High School

The Music Department of the Madison Township High School will offer an extensive program in vocal and instrumental music and theory. Expanding their exploratory work in music which is currently being done in the elementary grades and which will be incorporated in the program of the 7th and 8th grades. High School freshman will elect general music, in this course is included instruction in how and what to listen for in music, the appreciation of rhythms, popular, classical and jazz music as well as opportunity to discover and develop individual talents, in vocal and instrumental areas.

Those interested in choral music will enroll in chorus, which will be the nucleus from which smaller ensembles and novelty vocal groups will be composed. Music theory and harmony will be offered to those students who desire a more thorough understanding of music based on a knowledge of techniques and

skills in its structure. These courses are especially valuable to the youngster who is planning a career in music. Creative work in composition, choral and instrumental ensemble arranging will be encouraged.

The High School Band is expected to be nearly 100 in number in its first year. This group will to a great extent draw its members from those who have had the experience of being in the Township Elementary School Band.

Madison youngsters will be eligible for participation in New Jersey All State High School Band, Orchestra and Chorus as well as Regional Scholastic Organizations.

The wings of the multi-sided auditorium will be home base for musical organizations and instruction in the new High School. Large acoustically designed rooms on either side of the stage are provided for this department.

Public Notice is hereby given that the undersigned, the Collector of Taxes of the Township of Madison, Middlesex County, New Jersey, will sell at Public auction in the Municipal Building, Route 34 & 9 intersection, on the 30th day of December 1960, at 12:00 noon, the following described lands.

Said lands will be sold to make the amount of municipal liens chargeable against the same on the first day of July 1960, exclusive, however, of the lien for taxes for the year 1960, as computed in the following list together with interest on said amount to the date of the sale, and costs of sale. The subscriber will sell in fee to the person who bids the amount due subject to redemption at the lowest rate of interest, but in no case exceeding eight (8) per centum per annum. The payment for the sale shall be made before the conclusion of the sale or the property will be re-sold. Cash or certified check only will be accepted in payment.

Any parcel or real property for which there shall be no other purchaser will be struck off and sold to the Township of Madison for redemption at eight per centum per annum and the municipality shall have the same remedies and rights as other purchasers, including the right to bar or foreclose the right of redemption.

## Alien Registration

E. P. BOUCHARD, DIRECTOR of the New Jersey District of the Immigration and Naturalization Service stated today that approximately 155,000 aliens are expected to file their annual address reports during the month of January. Last January 151,436 aliens filed address reports in New Jersey. Although more than 9,000 of those who filed address reports last January have now been naturalized as citizens of the United States, the increase in the expected number of reports is attributed to the normal flow of immigrants from abroad as well as from the number of Cuban citizens who came to this country temporarily, but because of the political situation in Cuba have not returned to their homeland.

Address report forms will be available at any United States Post Office of Immigration office during the month of January. Mr. Bouchard said it was very easy for an alien to comply with the law. An alien completes the form and hands it in to a Postal or Immigration employee. The parents of non citizen children under 14 years of age must submit an address report for them. The only aliens not required to file an Address Report card are those non citizens who are diplomats, members of certain international organizations, and persons admitted temporarily as agricultural laborers.
