Motorists and pedestrians alike have experienced great inconveniences as the result of the State Highway Departments revamping of the Old Bridge Circle at Route 18.

Many businessmen in the area have suffered great loss of business because of the State's building program, several have since closed their doors and others report that business has fallen off greatly.

The latest in this campaign seemingly aimed at thoroughly confusing the motorist and businessmen in the area was the recent erection of a sign on Matawan Road, near Route 18, announcing NO LEFT TURN.

We have seen some wonders of the world, but the erection is lone sign leads the list. We suppose that the sign was erected with the intentions of keeping motorists from making a left hand turn across Route 18, the only way to get off Matawan Road now is to go down to the traffic light. This presents a problem, because the angle of the road causes serious traffic tie-ups at the intersection.

Perhaps someone thought that this would prevent accidents, this mysterious sign that appeared out of the blue, no one in the area seems to know just exactly when the sign was erected or

who put it up.

The traffic light at the intersection of Route 18 and Matawan Road is set for the smooth operation of traffic on Route 18 with little care about the traffic that is piling up on Matawan Road, if three cars stop for the light. you have a major traffic jam.

We feel that more accidents will be caused because of the erection of this sign. At the present time it is possible to make a left hand turn from the right lane going toward Englishtown on Route 18 to Matawan Road, however, according to the sign you can't make a left hand turn from Matawan Road to Route

We think that if the State Highway Department or County Road Department erected the sign they should either straighten out the "mess" at the traffic light at the intersection of Route 18 and Sunset Avenue in Old Bridge or remove the sign entirely.

It seems rather odd that the Mayor and Township Committee have been trying for several months to get the State Highway Department to erect a traffic light at the intersection of Throctmorton Lane and Highway 9 near Sayre Woods South without

success and all of a sudden a sign appears in Old Bridge reading NO LEFT TURN.

If you are interested in safety projects, how about that one for a start. How about erecting some sort of fence on the bridge over Route 18, before some child falls off? How about putting more lights and more signs at the jughandle turn at Highway 9 and Route 34? What ever happened to a traffic light for Route 34 near

the entrance to Central Park. Take care of these little projects first then you can put up NO LEFT TURN SIGNS all over


The Card Party and Penny Sale will be held at the Laurence Harbor Community Church Auditorium on Laurence Parkway.

For The Handicapped

"The Federation of the Handicapped, whose executive offices are at 211 West Fourteenth Street, is a non-profit rehabilitation center founded in 1935 by three amputees. Its highly laudable main objective has always been to enable severely disabled adults to lead independent lives and to become at least partly self-supporting.

In its main building and two annexes it trains men and women for private industry. In addition, it has carried on a pioneering project in exploring prevocational and vocational opportunities for badly handicapped homebound adolescents.

The federation's industrial divisions train disabled workers for jobs in private industry and also execute subcontracts for both commercial concerns and the military forces.

All contracts are obtained competitively in the open market. Since its founding, the federation has given all its services without cost to the disabled. No one is turned away, regardless of race, color or creed. But a project of this kind needs generous contributions from its friends to keep up its work."

The above editorial appeared in the New York Times on Saturday, January 6, 1961. We agree wholeheartedly with its function and its purpose. We go further, however, and say that the United States Government should sponsor this project and not depend on voluntary contributions. We make this suggestion - every factory that does business with the United States Government should be forced to hire a certain percentage of disabled people. This will insure rehabilitated persons a livelihood, a sense of security and a standing in the community, and not a liability and a frustrated disorganized piece of humanity. These people can take care of themselves if given the opportunity. In Madison Township there are many such unfortunate persons. We can't let them down. This editorial is being sent to our Senator and Congressman for action. You write too - Only by pressure will we succeed. Please help.

The Southwood School P.T.A. will meet at the Old Bridge school on Monday, January 16 at 8:00 p.m.


