## Madison Primary Election Draws Near

In a few more days it will be all over but the shouting. On Tuesday April 18th the voters of Madison Township will go to the polls to vote in the Primary Election.

As usual in Madison Township there is a Primary Battle on both sides. Thomas Miller of Old

Bridge is seeking election over James Burton who has won the support of several of the Republican Clubs in Madison Township.

On the Democratic side of the Primary election Bernard Herman of Old Bridge is seeking to over-turn John Keating for the Township Committeeman candidacy in the November election.

Keating has won the support of most of the Democratic Clubs in Madison Township and a group of women from Madison Township have formed a Women for Keating organization almost 150 women attended a rally held at the Cheesequake Fire House on Route 34 in honor of Keating.

To the Editor:

Much fuss has been made about insurgents and incumbents. My opponent was an insurgent in the primary battle of 1958. He ran against the then incumbent Joseph Scanlon of Laurence Harbor. M. A. Staats of Old Bridge and Lawrence Prestivac of Cliffwood Beach also ran.

Mr. Keating was not the peoples choice since he took only four voting districts, one by 2 votes, one by 4 votes and two by ten votes. He obtained only 503 votes of a total 1378 cast. This would make the vote 875 against and 503 for. Of approximately 5,000 Democratic voters in the township this is approximately 10%. It seems a shame that 10% of any group can constitute the peoples choice.

It has been pointed out that Mr. Keating has been the author of "2" ordinances and has attended every township meeting for the past 2 years, this is the record he stands on, I know of many people who have attended these meetings as regularly, including myself.

I am a Democrat and believe in a Democratic form of government. Mr. Staeger is also a Democrat but seems to believe in democracy for a chosen few. Which would constitute people of his choice, since he will not issue nominating petitions except to who ever he sanctions. This is not a choice of the people but a dictatorial way of maintaining one man control, the same as any dictator controlled country.

People ask me why I am running, I am running because I have a child growing up in this township. When he is old enough to ask about democracy and representative government I would like to be able to answer with true facts instead of theory.

The choice is for you the voter to make, whether you want a voice in government or whether your decisions should be made for you.

**Could It Be A Empty Victory?**

The case between the Township Committee and Mid-town will soon be presented in court. The Township Committee will try to have an agreement between the developers and the township disposed of. The agreement was entered in good faith between township officials and the developer.

Five years ago the developers of Mid-town Properties were given preliminary approval for 5,500 homes on 65' x 100' lots. After several months of legal maneuvering, Mayor John Chamberlain and other officials entered into a signed agreement with the developers.

The lot sizes were expanded to 75' x 100' lots, with 3,400 houses to be built, the agreement also included apartment houses, industrial sites and park areas.

We wonder if the Township wins the case and if the agreement signed by Chamberlain and other township officials is disposed of, will it mean that the developer can then build the 5,500 homes on 65' x 100' lots.

What price victory?

We feel that Madison Township would have more to gain if this was settled out of court. We think it wiser for both parties concerned to do some plain old American "horse-trading".

Could this case, if won by the Township, develop a trend by which other developers would take the township to court and set aside other agreements?

Would the residents of Madison Township then have to pay for school rooms built by developers?

Would the Township Committee be made to return money to the developer that was collected for school purposes?

By winning the court case, we could also be the losers?

What price victory, could it be an empty victory?

**Miller Speaks At Harbor Club****THOMAS MILLER**

Thomas Miller of Old Bridge was one of the guest speakers at the recent meeting of the Laurence Harbor Republican Club. Invitations were extended to all other G.O.P. Clubs in Madison Township.

Approximately 70 people were in attendance including several from out of town.

Speeches were made by state candidates for governor or their representatives and local candidates were limited to six minutes each.

Miller listed his program if elected and nominated to the township committee which included the Repeal of personal property tax; periodic reports to various clubs, civic groups in the township to the happenings in local government; the desire that people bring their problems to him so that he (Miller) can intercede for them at township meetings; to welcome constructive criticism.

Miller stated that in the last four general elections the Democrats have won by landslide margins. This is a do or die year for the local G.O.P. We

must win in November for if we lose, the Democrats will be so solidly entrenched that it will be just about impossible to unseat them. We will be in the same position as the county G.O.P. who have not elected a single candidate in 31 years.

The candidate for Township Committeeman in the Republican Primary continued "the only way that we can win is by nominating a well known experienced candidate who devote time to the job, also one who can secure hundreds of Democratic votes in November. We need Democratic votes in order to win because we are outnumbered. I feel that, if nominated, I can secure more Democratic votes than any other G.O.P. candidate. Even the Democrats realize that they would have a much tougher time trying to beat me, therefore they are hoping that I do not receive the nomination. The Democrats, from experience, would settle for anyone rather than me on the committee. If nominated and elected, I intend to be the proverbial "Watch Dog", as most people know, including the Democrats, that I can both bark and bite. In any event, if nominated and elected, the Democrats will surely know that I am there.

AN ORDINANCE ESTABLISHING A CODE REGULATING THE INSTALLATION, MAINTENANCE, REPAIR AND CONTROL OF PLUMBING AND THE CONNECTION THEREOF WITH OUTSIDE SEWERS, CESSPOOLS, AND OTHER RECEPTACLES, REGULATING THE PRACTICE OF PLUMBING AND THE ISSUANCE OF LICENSES TO PRACTICE PLUMBING AND PROVIDING PENALTIES FOR VIOLATION THEREOF:-  
BE IT ORDAINED BY THE BOARD OF HEALTH OF THE TOWNSHIP OF MADISON, COUNTY OF MIDDLESEX, STATE

OF NEW JERSEY.

8.9.1 Water distributing piping shall be made of brass, L copper, lead, cast iron, wrought iron, open-hearth iron or steel. All threaded ferrous pipe and fittings shall be galvanized or cement lined. When used underground in corrosive soil, all ferrous pipe and fittings shall be coal-tar enamel and the threaded joints shall be coated and wrapped after inspection.  
9.1.1 Soil and waste piping for drainage systems within a building shall be of cast iron known as medium, galvanized wrought iron, galvanized open-hearth iron, galvanized steel, brass, type DWV copper, or class D lead. The pipe and the fittings for each type of pipe shall comply with the specifications as given in Section E-300, Table 3.4.  
9.1.2. Underground piping within buildings shall be of medium cast iron soil pipe, type K copper tubing.  
9.1.3. (a) Building sewers installed in a separate trench from the water service pipe, will be of medium cast iron. Joints shall be water tight and rootproof.  
9.1.3. (b) Building sewers installed in the same trench with the water service pipe, shall in addition to the requirements of 8.1, be constructed of medium cast iron soil pipe.  
11.2.8. The permissible distance of a fixture trap from a vent fitting shall be two (2') feet.  
14.1.2. A permit may be issued to a person to do plumbing in a single family dwelling used exclusively for living purposes, including the usual accessory buildings and quarters in connection with such building, provided that person is a bona fide owner and occupant of such dwelling and said owner purchases all material and personally performs all labor in connection therewith. In exception to the above, sewers connecting to a public sewer and water service piping connecting to a public potable water supply shall be installed by a licensed, bonded, and insured master plumber.  
14.9.1. Master plumbers license shall expire on the last day of December of each year and may be renewed at any time within thirty (30) days of their expiration date without reexamination of the licensee. Licenses not renewed within thirty (30) days of their expiration date may not be renewed until the applicant has been re-examined.
