# Mayor Phillips Gets Dem Freeholder Nomination

Madison Township's Mayor John Phillips of Laurence Harbor was endorsed by the Middlesex County Democratic Organization as a Freeholder candidate. Philwill replace George

Otlowski, who decided to run against the Democratic Organization candidate Edward Patten for the newly created 15th Congressional District.

The nomination of Phillips

came after weeks of "political | manuvering" on the part of Madison Township Attorney Harold G. Smith and James E. White, Publisher of the Madison American. The Madison Mayor's first

break in his Freeholder bid, came as a result of a feature story published in the December 14, 1961 issue of the "Madison American" which asked "Will Phillips Be the Next Freeholder."

From there on in the Smith and White combination carried the ball in obtaining the Freeholder candidacy for Madison Township. Several other prominent Democrats also aided in the support of "Phillips for Freeholder."

At the January meeting of the Madison Township Young Democratic Club, which is the most powerful Democratic Organization in Madison Township, the members endorsed Edward Patten for Congress and Mayor John Phillips for Freeholder.

Endorsement by the Middlesex County Democratic Organization in the past has meant election to public office, The Middlesex County Republican Organization has failed to elect a candidate on the county level in over a score of years.

He urged everyone to support the Republican candidates all across the line in November. Mayor Bernard Rodgers of Dunellen, the Republican Party candidate for the newly created 15th Congressional District, delivered a spirited keynote speech. He too commended the efforts of local Republicans and went on to discuss his qualifications, his reasons for running in the Congressional race. Several times, enthusiastic applause interrupted his speech. He blasted the principles of the machine run Democrat party, declaring that they had picked their candidate because he was the one most easy to control. He stated that, like the candidates selected at this convention, he too had been selected at an open meeting of all municipalities.

The Laurence Harbor residents' first political adventure came in 1957, when he was elected to the Township Committee for a three year term. On both occasions Phillips was strongly supported by the Smith and White combination.






