Commencing January 1, 1964 the schedule shall be as follows: Patrolman - during first year of service - \$5,520.00; during second year of service -\$5,770.00; during third year of service - \$6,070.00; during fourth year of service and all years thereafter - \$6,420.00; Detectives - \$6,620.00; Sergeants -\$6,920.00; Detective Sergeants - \$7,120.00; Lieutenants - \$7,-

420.00; Captain - \$7,920.00; Chief of Police - \$8,420.00. Section 2. That the salary schedule shall be effective for the first increase as of January 1, 1963 and shall be effective for the second increase January 1, 1964.

The present salary schedule for patrolmen in the Township is a starting salary of \$4,720 and top salary of \$5,620 after three years service. The new salary guide would start at \$5,120 with a maximum of \$6,020 after three years service.

The official further explained that negotiations with the township committee failed to provide any increase for the police de-partment and the officers voted to seek the pay increase through the voters of Madison Township.

Madison police officers presently work a 42 hour week and are subject to call 24 hours per day. They receive no paid holidays.

The Madison Township Police Department is rated the lowest in the county as far as pay is concerned. There are 14 full-timed manned police departments in Middlesex County.
All police officers in Madison

It was pointed out that the average cost of equipment during the first year is almost \$600. Police are required to supply their own clothing, guns and handcuffs. Each police officer must have three uniforms, during the course of the year.

At the present time the Madison Township Police Department is composed of 26 officers and patrolmen. The township commit-tee is expected to appoint three additional patrolmen at its next regular meeting of the committee.

Twenty-four of the police officers are married and have children and the police officers must provide their family plan on hospitalization which runs approximate \$125 per year. It was estimated by one police officer that the dry cleaning bill for uniforms runs between \$50-70 per year.

Patrolmen must successfully complete the State of New Jersey Policeman's school which is held in Sea Girt, N.J. during the year The officers must qualify in First Aid and take additional courses as directed by the Chief of Police

and the Township Committee. The Committee for the Police Referendum is made up of Sgt. George Gillard, Chairman; Chief Charles Boice; Detective Sgt. William Volkert; Patrolman William Hatfield, State PBA Delegate; Ptl. Robert Weiss, local PBA president; and Detective Robert Cotton.

Anyone wishing to have a police officer call at their home in order to sign the petition should call CLifford 7-6879.

The last pay raise granted the police department was in 1960. The Madison Police department is comprised of mostly officers below the age of 40 and most patrolmen have not yet served three years service. The police department is serving a community of almost 25,000 residents.







Blast G.O.P. Charges

In a joint statement, Township Committeemen Harry Messenger and Victor O'Brien, Democratic Candidates for reelection announced the opening of their campaign.

It is with a great deal of enthusiasm that we look forward to the campaign leading up to Novembers election. We intend to run on the record of the Democratic Administration of which we are proud to be mem-

It is interesting to note that our opponents on the Republican ticket have suddenly become highly critical experts in all matters of local Government. This is evidently upon the advice of their so-called advisors since they themselves did not see fit to oppose any item in the entire budget. They asked a few questions which were answered to their satisfaction. Now with the day of election coming near they see fit to announce their objections thru throwaway literature and press releases. Why did they not voice their objections the night of the budget hearing? Was it because they were ill informed at the time and are still ill informed.

During the course of the campaign which they opened very early in the year they have attacked the Tax Assessor, the Tax Collector, a Member of the Sewerage Authority, and the Industrial Commission. Strangely enough they then have the temerity to praise the Industrial Commission for their successful efforts in bringing in The Discount Store and the new Supermarket on Route 9. This undeserved criticism towards men who donate their time 12 months a year without compensation to try to make a better Madison who have become very active just prior to election makes it very difficult for such bodies to continue their work.

It is about time that the candidates opposing us face the fact that they are facing Harry Messenger and Victor O'Brien and get down to the basic issues in the election. It is with great pleasure that we inform our opponents that the Discount Center and Supermarket are not part of any deal regarding development of that area. The proposal they speak of were never entertained by the Planning board for longer than the night it was proposed for exploratory purposes. This is the same Planning board that has stopped Major subdivision approval for the past 3 years in almost every instance, including the well known 3500 home Mid Town approval.

The Republican Candidates in each and every statement show their ignorance of township affairs as well as the ignorance of their so-called advisors. In a recent press release they criticize the Health Board for failure to follow thru on the recommendations of the State Dept. of Health. The Republican Candidates say "What is \$100,000 compared to the health and safety of our children and families". We feel the same way about it but we also feel for the pocketbooks of the taxpayers of Madison Township. These problems that exist and are gradually being corrected are the results of the many years of inactivity on the part of the Republican Party which was in control of the management of the affairs of the township for many, many years. They speak lightly of \$100,000-this would mean an additional \$5.00 for every \$100 evaluation, still
