## Petition In Final Stages

### Over 2,000 Signatures Obtained By Police

Members of the Madison Township Police Department are elated over the terrific response they are receiving from the residents of the township in support of their request for a Special Question to be placed on the ballot for the November 6th election. Off duty officers have been soliciting the necessary names to place the Pay Referendum Question before the voters.

Attorney Harold G. Smith of Farrington Road, Cheesequake who is lending legal advise to the police department stated that the police officers have more than enough petitioners already to place the question on the ballot. Smith estimated the total number of signatures to exceed 2,500 at the present time. The township attorney pointed out that members of the police department received their last pay increase in 1960.

## Banks Sings "As Time Goes By"

### Charge Democrats Administration's "Laxness"

The Township's delay of two years in filling an Industrial Commission vacancy was questioned last night by Ken Banks and Gary Murtha, GOP candidates for Township Committee. The Republican hopefuls say the Democratic administration's "laxness" in bringing the Commission up to full strength immediately may be a clue to the Township's failure to attract new industry.

On Sept. 17, at a regular Township Meeting, Mayor John Phillips announced the resignation of a member of the five-man industrial commission and made an appointment to fill the vacancy.

"But that seat on the Commission has been vacant for almost two years," Banks said, "since the resignation of the fifth member of the board. Why has the Mayor waited until now to put the commission back in business?"

The candidates spoke at a candidates reception at the home of James Pond, Piedmont Drive, in Sayre Woods South.

Murtha remarked, "It is not surprising that the industrial commission has difficulty attracting ratables to the Township when we find out that the group has had to operate under the handicap imposed by vacancies like this.

The Commission member whose resignation caused this vacancy has been out of the picture for two years. His resignation came about as a result of frustration with the commission procedures which directed every inquiry into the fumbling hands of the Township Committee, with no significant results."

The GOP candidate continued, "Discouraged by Township interference and unhappy with the Township's tendency to pigeon-hole new prospects were at the root of the commission's losing one of its five members two years ago."

Banks asked, "If the Township administration means to be taken seriously when it says it wants new industry, how can it explain

its willingness to let this commission operate undermanned until only last week?"

Murtha added, "First Township officials talk 'big' about industrial prospects for the community, then they refuse to provide the co-operation needed to insure the Industrial Commission's success. First the en-

thusiasm of the members of the commission itself breaks down and finally the Township ignores the commission's needs by delaying an appointment as important as this for two years."

The candidates concluded: "Could it be that the Township is just going through the motions of seeking industry,

## Madison's Biggest Traffic Snafu

Sometime ago the MADISON AMERICAN protested the closing of the openings in the traffic safety islands on Route 9 in Our Town. Despite heavy objections from businessmen in the area the State Highway Department proceeded to make the safety island a solid ribbon from Ernston Road to the junction of Route 34 a distance of over a mile and a half.

In neighboring Sayreville with almost the identical situation the openings in the safety islands have remained OPEN. WHY? Why did the State Highway Department choose to discriminate against Madison Township?

The Highway Department also constructed three "elaborate" jug-handles. One at the intersection of Route 34 and two at the intersection of Ernston Road on Route 9. The "jug-handles" themselves lend to cause confusion to motorists in the area, the closing of the safety islands was detrimental to businessmen of Our Town, residents are forced to make three mile trips out of their way, and school buses are often late for student pick-ups.

More recently various commercial enterprises have been constructed along Route 9 in Our Town, many are presently under construction and many are in the planning states.

The traffic situation at the traffic signal on Route 9 and Ernston Road is almost "impossible". Motorists have had to wait twenty and thirty minutes to cross Route 9. This is ridiculous!

We would like to see State Highway Commissioner Dwight R. G. Palmer visit the area and observe for himself this "fouled up" traffic problem.

This is Madison Township's biggest traffic SNAFU's (situation normal all fouled up). We are no experts in the traffic engineering field but we do offer the following suggestions:- Install several "left turn" lanes on Route 9 safety islands and speed-up the traffic signals at the Ernston Road intersection.

### Show Shaping Up

Joseph Hoff, general chairman of "Mountain Dew In '62" announced today that the show is shaping up to everyone's satisfaction and will probably be one of the best in the history of the annual performances.

This is the first attempt on the part of the members of the police department to seek a pay raise via the referendum question in the history of the department. Members of the Police Pay Raise Committee stated that if the Township Committee had negotiated for a pay increase the members of the police department would not be now seeking to place the question before the voters of the township.

Patrolman Robert Weiss, president of the P. B. A. local stated today "that the police officers of Madison Township will continue to seek signers and support of the residents of Madison Township until the filing of the petition with Mrs. Mary M. Brown the Township Clerk.

Recently plans for the Madison Township Police Referendum Pay Raise were further formulated at a meeting held at the home of Sgt. George Gillard, Rizzo Lane, Browntown. Gillard heads the Pay Raise Committee. Attending the meeting were Attorney Harold G. Smith, Police Chief Charles Boice, P.B.A. president Robert Weiss; Detectives William Volkert and Robert Cotton and Patrolman William Hatfield.

Weiss emphasized the necessity for the Police Department to stay out of "political issues". The P.B.A. president predicted a smashing victory based on results of petitions being circulated in the Township in support of the Police Pay Referendum.

Gillard, urged continued support from the residents of Madison Township and the various merchants. He stated "We the members of the police department are very grateful for the splendid co-operation and support we are receiving from the resident of Our Town. If any organization would like a off-duty police officer to explain the Madison Township Police Referendum please contact Patrolman Robert Weiss.

The group plans to obtain a central headquarters to conduct the campaign on November 6th. Special telephones will be installed and manned by volunteers and arrangements are being made for babysitters for parents that might need these services in

### Stalling Around

After months of negotiating with the Madison Township Board of Education representatives of the American Federation of state, County and Municipal Employees were flatly told that the Board of Education doesn't want to discuss janitorial policy any further.

The reason presented by the Board is that the janitors in the school system have already signed contracts of employment and that the budget doesn't include any further increases for the janitorial staff.

There are many other items that could be and should be discussed between the Board members and the representatives of the Union. These include holidays, grievance procedure, sick leave and tenure of office.

These things are very important to the janitorial staff of the local school system.

The Board of Education would like to make everyone think that the present "set up" is like one big happy family. Talk to some of the janitors many of them feel that they are being pushed around.

We wonder under the present system how long a janitor in the school system would last if he or she made any complaints about the salary scale or other working conditions? The person making the complaint could be given a thirty day notice without any other provision. All it would require for cancellation of a contract is five votes for the motion from a nine man board. This leaves the hiring and firing of the janitorial staff wide open.

We feel that the Madison Township Board of Education should offer the janitorial staff some immunity. We feel that the Madison Township Board of Education is once again showing their true colors. We wonder how much longer people are going to be pushed around by the local Board of Education?

The janitorial staff of the school should be further considered by the Board of Education. Why the stalling around?

order to vote on election day. Copies of the various petitions will be made available to various police officers on election day and each officer will call on the signer to solicit the vote.

Gillard concluded "the pay scale for the Madison Township Police Department is one of the lowest in the county and negotiations with the Township Committee have failed. We are still open for negotiations but the deadline for filing the petition is drawing near. We must rely on the support of the voters of Our Town to support the Police Pay Referendum."

The Madison Township Young Democratic Club at a recent meeting held at the Penguin Club endorsed the Police Pay Raise Referendum. The Young Democratic Club is probably the strongest political club in Madison Township.

The Sayre Woods South Republican Club earlier endorsed the Pay Raise Referendum. Other endorsements have been received from the Cheesecake Fire Company and the District II Democratic Club.

It is expected that statements from both political chairmen will be obtained in the very near future. Members of the committee have instructed police officers soliciting signatures "not to become involved in political discussions of any kind".

The deadline for filing of the petition is drawing near, once the petition is filed with the Township Clerk the question must appear on the ballot. It is quite possible that the Township Committee in view of the "warm" response given the Police Pay Question may grant the pay increase by ordinance. If the Police Pay Referendum Question is placed on the ballot it is expected that one of the largest turn-out of voters in a off-year election will result. Another public question to be voted on by the residents of Madison Township is the Change in the form of government. Many feel that if the Pay Raise Referendum is approved by a heavy majority of the voters the Public Question of the change in the form of government will also be approved.

Parade Chairman, permission has been granted by Dwight Palmer, Commissioner of State Highways, to have the right hand lane of northbound State Highway #35 closed to regular vehicular traffic from 1 p.m. to about 3 p.m. while the squad and its guests march from the Pirate Ship in Cliffwood Beach to Laurence Harbor. As part of the festivities later in the day, there will also be a wet down of the organization's most recent acquisition, a 1962 GMC chassis converted to an ambulance in accordance with the specifications of the squad. (The chassis was purchased from Freedman's in New Brunswick and the conversion made by Adam Black in Jersey City.)

To date, in response to invitations sent throughout the entire fourteenth district which comprises Middlesex County and to many other farther distant communities, twenty-one first aid squads, eleven fire companies, and four marching bands have agreed to participate. Delegations and equipment will be coming from as far away as Newark and Bucks County, Pennsylvania. Music will be provided by the Guadalcanal Drum and Bugle Corps of Matawan, the Melrose Fife and Drum Corps of Sayreville, the Union Hose Company Bugle and Drum Corps of Perth Amboy and the Madison Township School Band.

The Laurence Harbor First Aid and Safety Squad, the second oldest in the state of New Jersey—South Amboy was the first—and the first in Madison Township, originally served all 42 square miles of the township singlehandedly. The license number of its vehicles - NF 2 attests to its longevity. The response to its invitation to celebrate indicates its continued vigor. It is the mother squad of the Madison Park First Aid Squad whose members were instructed by its present Captain John Di Giovanni, and has assisted in the formation of numerous other first aid groups in the surrounding communities.

The parade will assemble at the Pirate Ship at 12:30 p.m. and begin at 1 p.m. There are expected to be between 900 and 1000 in the line of march. Paraders will proceed northerly to the light at Laurence Harbor, easterly around Plaza Circle, then westerly across Route 35, down Laurence Parkway past the

judges stationed at the First Aid Building, around the park, and back to the junction of Route 35 and Laurence Parkway, where they will disband. Vehicles will be parked behind Plaza Circle, opposite the Madison Township Free Public Library, formerly headquarters of the Madison Police Department, and personnel will join spectators near the First Aid Building, where prominent residents of the township and representatives of the state and district First Aid Councils will address the paraders and guests.

There will be dancing in front of the First Aid Building, 20 Laurence Parkway, with music provided by the Twilight Dance Band, and refreshments will be served. The wet down of the new ambulance will also be held. This vehicle brings the squad's strength to three ambulances and a light crash truck.

At about 5 p.m. eight trophies will be awarded. Vehicles and personnel must be present at this time in order to be eligible. Awards will be presented to the best appearing ambulance, the

best appearing rescue truck, the best appearing cadet corps, the best appearing ladies auxiliary of a first aid squad or fire company, the best appearing first aid squad, the best appearing fire company, the best appearing fire apparatus, as well as to the organization with the most men

in the line of march. The judges will be Madison Township Mayor John A. Phillips, retired life member William Kerr, and local merchant, Isidore Garber.

Following the presentation of the trophies, dancing and refreshments will then continue into the evening.

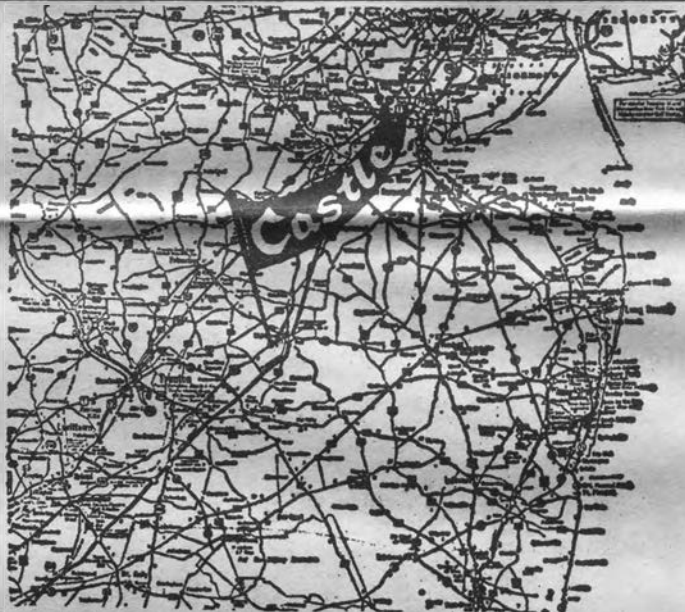

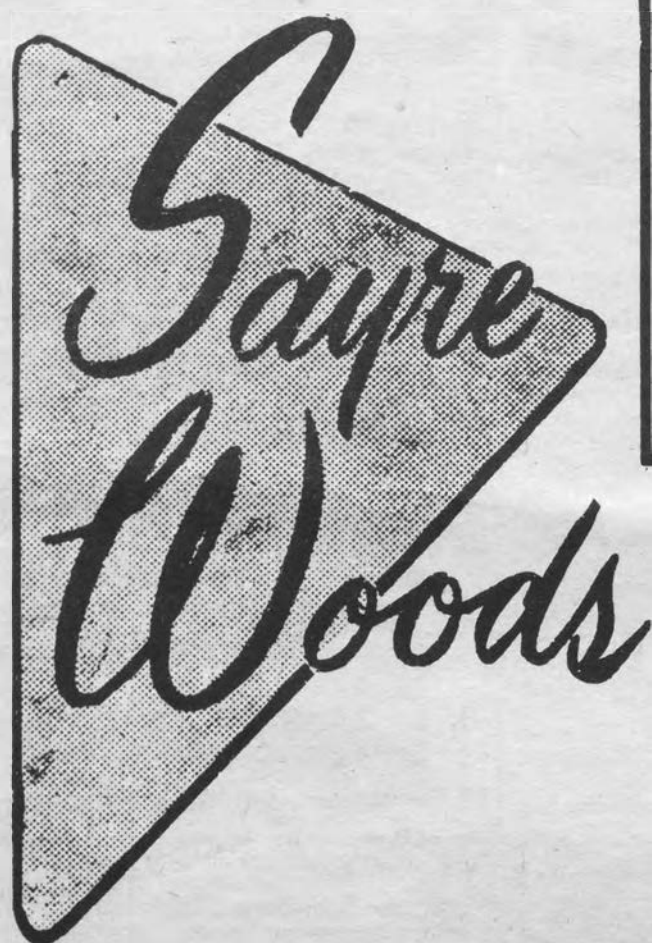

# Union Head Charges Board With Stalling

Victor Catano, President of Local 1099, State, County and Municipal Employees, AFL-CIO, announced that the Board of Education of Madison Township had refused to deal with the representatives of their janitorial employees and were compelling the Union to take action to get the Board to live up to the provisions of the New Jersey Constitution.

Mr. Catano said that he first notified the Board in May of this year that a substantial number of employees had designated the State, County and Municipal Union as their representatives. There followed meetings with the Board and with the Board's attorney in the hope that the Board would practice what is taught in the school system, i.e., respect for the laws and Constitution of our State and Country.

Mr. Catano stated that the Board stalled despite his repeatedly quoting the applicable portion of Section 19, Article I of the Constitution which reads "Persons in public employment shall have the right to organize, present to and make known to the State or any of its political subdivisions or agencies, their grievances and proposals through representatives of their own choosing."

Last Thursday night Mr. Catano, Stephen Remsen and Leon Wilcox appeared at the Madison Township Junior High School in accordance with arrangements made with the Board of Education two weeks previously.

Mr. Remsen and Mr. Wilcox

represented the State office of the Union. When William Kerr, Chairman of the Board advised them the Board had decided not to deal with the Union, they informed him that this was their first experience in the State where a Board had violated the Constitution they were sworn to uphold.

Mr. Catano indicated that he did not believe the public or the State Board of Education would long stand for a group of elected officials acting as one might expect a Communist government to act. He said we teach our children Democracy and representative government and then find the Board of Education itself arbitrarily determining that it is not bound by the Constitution.

Mr. Remsen said the Union would seek the support of the entire labor movement in this obvious attempt to refuse to deal with the duly designated representatives of the employees of the Madison Township Board.

Mr. Wilcox indicated that plans would be made to bring the whole matter to the attention of the public and the State Commissioner of Education, Frederick Raubinger. He said newspaper publicity, handbills and picketing would all be utilized to compel the Board of Education to come to its senses and uphold its obligations to the schoolchildren and to the community.

## Meeting Held

The Woman's Club of Laurence Harbor met at Webster Hall, Community Church, Laurence Harbor, N.J. with Mrs. Robert Martin, presiding. 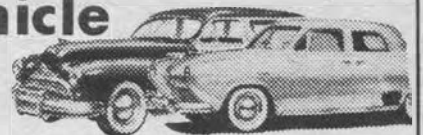

## Motor Vehicle QUIZ



Q. I hold a New Jersey driver license. Lately, I have been thinking of purchasing a motor scooter. Is any special driver license required in order to operate one of these scooters?

A. Any person desiring to operate a motor scooter, motorcycle, or motorbike is required to demonstrate his or her ability to operate a motor vehicle of this type upon their applying for a driver license and as such, are issued a specific license for the operation of any of these vehicles upon their passing of the required examination.

Q. I have noticed while traveling on New Jersey highways numerous persons attempting to hitchhike. I was under the impression that New Jersey had a law prohibiting hitchhiking. Is this so?

A. New Jersey Motor Vehicle Law states that no person shall stand on a highway for the purpose of or while soliciting a ride from the operator of any vehicle other than an omnibus or street car. Any person so apprehended would be subject to a fine or imprisonment or both.

Q. What is the maximum overall dimension permitted for a house trailer or privately owned utility trailer when being towed by a vehicle through the State of New Jersey?

A. The legal dimensions permitted by New Jersey Motor Vehicle Law are 8 feet in width, 13 1/2 feet in height, 35 feet in length for the trailer alone, and 45 feet for the overall combination of towing vehicle and trailer. Any unit or units exceeding these dimensions require a Special Over-dimensional Permit, which is issued by the Division of Motor Vehicles.

Q. I have had numerous discussions concerning several cars in line halted at a stop street sign. Is every driver in line required to make a full stop at the stop sign before proceeding through the intersection?

A. One or more vehicles following directly in line with another vehicle and coming to a complete stop caused by the first vehicle nearest the intersection complying with the stop sign at the intersection may proceed into or across the intersecting street without again coming to a complete stop. No driver of any motor vehicle approaching the intersection on the "through" street shall fail to yield to the vehicle so proceeding into or across the "through" street.

Q. I was prepared to sell my automobile but I cannot find my certificate of ownership. What can be done in this instance?

A. If a certificate of ownership, or title papers, are lost, the Director of the Division of Motor Vehicles may, upon proof by certification or otherwise in the manner required by him, and if satisfied of the bonafides of the application, prepare a certificate of ownership, certify it and authorize its use in place of the original. A fee of one dollar is assessed for this duplicate certificate.

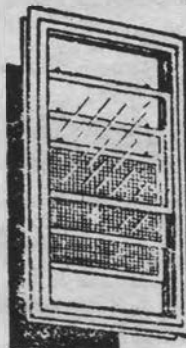
