## Murtha Resigns, GOP Picks Woman

Word of the indictment by a Grand Jury in Kansas City, Kansas of Gary Murtha Jr., who was to have been the "standard bearer" for the Republican Party in the November 6th Township elections spread through the town like "wildfire". According to Newell A. George, U. S. Attorney for Kansas the Sayre Woods South resident is charged with one count of having mailed into Kansas "vile, lewd and obscene letters and pictures".

Democrats and Republicans alike were "stunned" by word of the indictment and many could not believe the charge. Mayor John Phillips who also serves as

Democratic Municipal Chairman stated at a meeting of Democratic workers at the Penguin Club on Route 34, "that this is a Democracy, whether the Republican Candidate is guilty or not is entirely up to the courts of the United States to decide. I am of the belief that every person is innocent until proven guilty."

On Sunday evening (September 30th), Murtha presented the publisher of the Madison American with his signed statement resigning as a candidate for Township Committeeman. Because of the seriousness of the situation the "complete statement" of the former G.O.P. candidate is printed in whole.

STATEMENT BY GARY MURTHA JR.- SEPT. 29th, 1962;

Recent newspaper articles have stated that my name is involved in an indictment returned from Kansas City.

Before going any further, I want to express my sincerest, most heart felt appreciation to the many people who have called to offer their help and expressed their confidence in my being innocent of any wrong doing.

It has made me feel very humble and also very proud to have these people as friends. I want to assure everyone that this faith has not been misplaced.

Despite the urgings of these and other people not to, I must, and with a great deal of personal regret, announce my resignation as a candidate for the Township Committee. At the same time, I would like to tell the people of my reasons for withdrawing now. The decision to withdraw came after many hours of long, careful and soul-searching consideration of the facts as stated by the newspapers. There are two things I want to make very, very clear. One, I am not resigning because of guilt or

sense of guilt. The allegation is an indictment on one count - it is not a verdict. Guilt has not yet been established. I know that the outcome of this trial, should there be one, will vindicate me completely.

I want to say now, that I have never, at any time, sold, caused to be sold or wilfully and knowingly indulged in the transmittal of any material considered obscene. I have nothing to hide. My conscience is clear on this matter.

However, the mere fact that this does hang over my head, will not allow me, in all good conscience and with full consideration for the people of Madison Township, to continue any longer as a candidate.

I am, or was, a candidate for public office and in making any decision effecting that candidacy, I must consider my responsibilities toward my friends, my party, my running mate and my family.

I am not willing to submit these people to the type of campaign methods which I am sure the opposition will use.

I refuse to subject my family to the maliciousness I am sure the opposition will resort to.

Moreover, I will not run for any public office while this cloud hangs over my head. I will not, and cannot, show the same contempt for people certain officials have who continue in office or candidates who continue as candidates while an indictment hangs over their heads.

I will not, in all fairness, allow the voters to decide on my innocence or guilt on election day. I refuse to force them to make this decision.

The people of Madison Township deserve to have a candidate on the ballot about whom there is not the slightest doubt. And, at present, there is that doubt. This would not be fair to the people. It is not fair to my family. It is not fair for me to run for public office now. I will not, until I have been completely exonerated. Until then,

## Revolt Brewing In Republican Ranks

Carl W. Hood, Republican County Committeeman in Voting District Three, Laurence Harbor today lashed out at the local Republican Party.

**Should Stay In**

We feel very strongly that Gary Murtha of Sayre Woods South, former candidate for Township Committeeman on the Republican Ticket should have stayed in the November election race regardless of the Grand Jury in Kansas.

Operation Blood Brother has been greeted with enthusiasm by many of the township organizations.

Operation Blood Brother is the name given to the bloodmobile unit which will visit the Madison Township High School on Wednesday, Oct. 10, from 1 p.m. to 6:30 p.m. for the benefit of all township residents wishing to participate.

ANY PERSON DONATING ONE PINT OF BLOOD TO THE BLOODMOBILE UNIT WILL AUTOMATICALLY BE COVERED FOR THE NORMAL BLOOD NEEDS FOR THEIR ENTIRE HOUSEHOLD FOR ONE FULL YEAR.

Women who cannot leave their children at home may bring them with them, since baby sitting services will be available at the high school, in order to meet the 350 appointment quota which is necessary to make the bloodmobile visit a success.

Many men have indicated that they felt they might not be able to get home in time to donate, since they would be working;

### Auxiliary Unit To Meet In Harbor

The Junior Auxiliary of Laurence Harbor Unit 332 of the American Legion Auxiliary will be held at the Legion Home Saturday afternoon at 1:30 p.m. with chairman Theresa Rathbun presiding.

This will be the final meeting for the girls to bring in their project items such as nylons, coupons, soda caps, stamps etc. to receive their points to be included in the figures they have accumulated during the past year for the awards which will be presented during the installation which will be held in October.

The Point System which was started some years ago enables the girls to acquire points for various items which they collect and turn over to the Unit. Although the awards are given on a yearly basis for the girls acquiring 1,000; 5,000; 10,000; 15,000; 20,000; etc. each girl has the same opportunity to save the many items designated by the Auxiliary and her points are added each year until she reaches any of the above totals. Points are credited each meeting during the year from Sept. to Sept. Starting in October the girl has a new record with her previous totals, thus enabling her to reach any of the required totals.

Awards are given each year to the girls collecting the most nylons and coupons, since these are two of the most valued projects of the Auxiliary. The nylons are sent either to Grey-stone or Skillman Hospitals where officials of the Auxiliary and the Hospital are able to secure Televisions.

Coupons are redeemed for cash by the Department Auxiliary and the money received is used to further the rehabilitation work in the veterans hospitals throughout the state.

At the present time the girls are saving caps from Pepsi Cola, Teem and Patio soda so they can be redeemed for cash to help secure funds for their local work.

Sometimes people do not realize that many items which are usually thrown away can be put to some worthy cause. The girls also save eyeglasses which they send to New Eyes for the Needy in Short Hills, canceled stamps to missions, greeting cards or picture postal cards are made into scrapbooks for children,

however, past experience indicates that most employers will gladly allow time off in order that a man may donate blood to protect his family for one full year.

"It has been a gratifying endeavor for the many people responsible for bringing the first Red Cross Bloodmobile unit to Madison Township," Jaconetti, co-chairman of the Madison Township Blood Bank indicated recently.

One of the many advantages of donating blood to the Bloodmobile on October 10 is that through the National Red Cross Reciprocity System, members' blood needs can be met wherever they are hospitalized in the U.S. or Canada. The Red Cross will also provide blood derivatives to members if needed. These include gamma globulin, for protection against measles and hepatitis; serum albumin for treating shock and burns and for certain liver and kidney diseases; packed red cells for certain types of anemia and for cardiacs and the elderly who cannot tolerate the volume of whole blood; fibrinogen for certain cases of childbirth hemorrhage, and vaccinia immune globulin for treating severe reactions to small-pox vaccination.

Anyone between the ages of 18 and 59 years inclusive who is in good health may give blood. The Red Cross medical team will check each donor before allowing him to give. Unmarried minors between 18 and 21

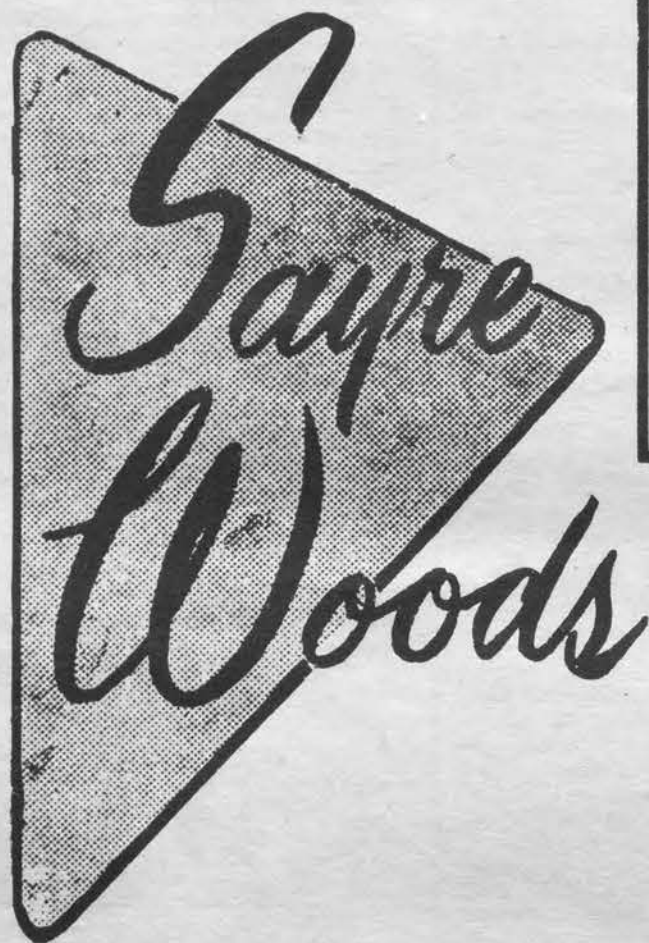

After the matter had been discussed and they had heard my story, they dropped all charges here and stated that under the circumstances they had no desire to prosecute in any way whatsoever. I had thought this matter closed until informed recently of the action being taken by the Kansas City authorities. If I had had the slightest idea that this matter would have been reopened, I would never have permitted myself to be a candidate and would have resigned then, in all fairness to the people of Madison Township.

Ohnsman has received instructions from the Post Office Department, Bureau of Operations, Washington, D.C. to post the following notice: "The Post Office at Laurence Harbor, N.J. will be converted to a Classified Branch of South Amboy effective October 12, 1962 and city delivery service will be extended to patrons. Patrons may continue to use the same mailing address."

After October 12 the Laurence Harbor Post Office will be administratively attached to South Amboy, N.J. This will have no effect on the present location of the Laurence Harbor office or the usual business transactions such as money orders, stamps, parcel post, etc.

Patrons should see that their house number is displayed and a mail box or door slot is erected in order to receive delivery service.

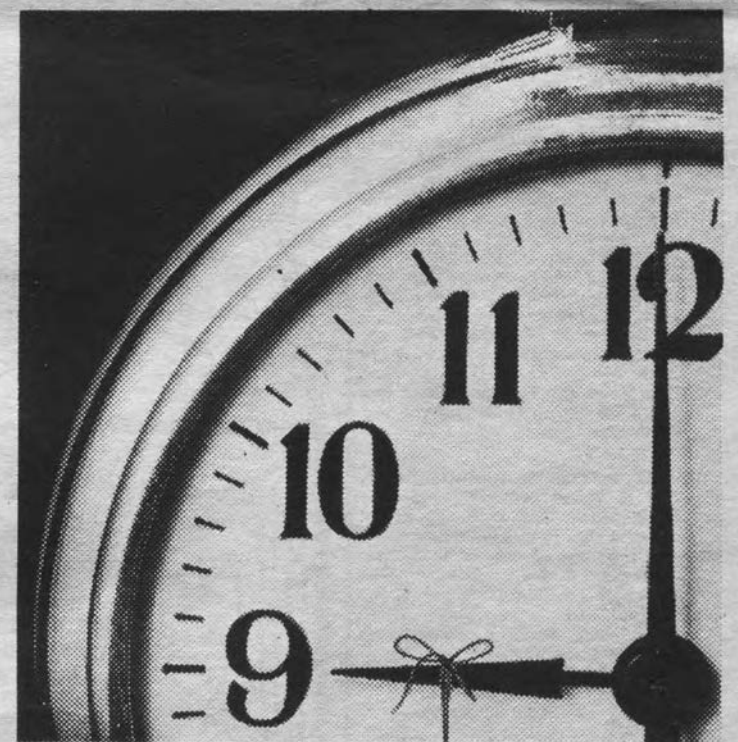

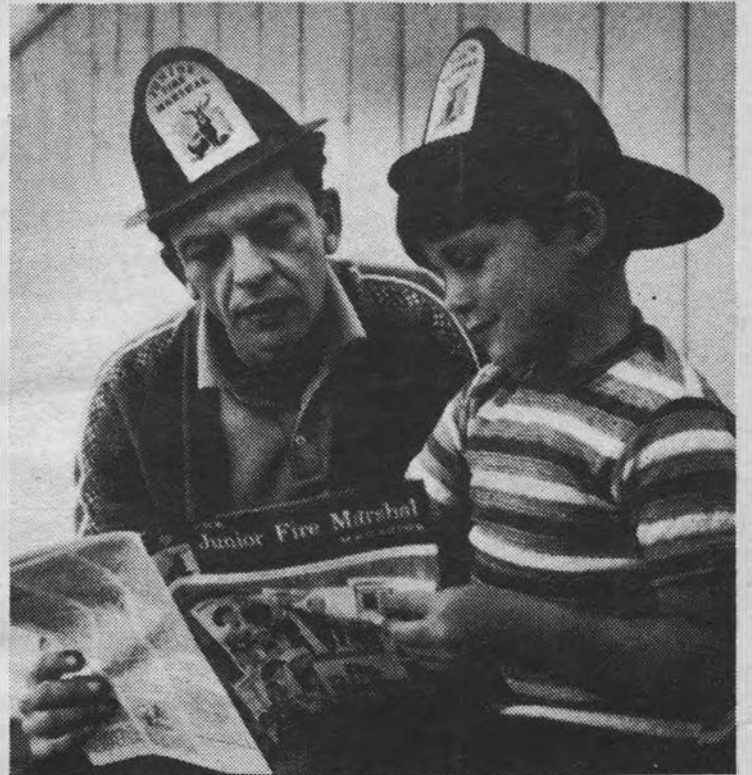
