Madison Police Score A "Strike" And A "Spare"

In rapid fire police team work the Madison Township Police Department made a perfect "strike" and then came up with a "spare" as far as the "Bowling Bandits" are concerned. Madison Police recently apprehended two "out-of-towners" for breaking and entering at the Hill Lanes Bowling Alley on Route 9 on two separate occasions. Despite the fact that the apprehended culprits stated that they alone pulled the job the detective de-

partment felt differently about the crimes and had continued their investigation of the case.

On October 4th the "Bowling Bandits" struck again at their favorite bowling alley. Madison Township police sought the culprits in the Newark area but to no avail.

Early Sunday morning at approximately 3:50 a.m. Edward Kiersgaard the manager of the Bowling Alley was in the process of closing up for the night he

heard some unusual noises and upon checking he saw two fellows trying to break into the building the manager found both suspects in the building. The pair fled from the manager who chased them across the parking lot and then notified the police department.

All police cars responded to the alarm and all main routes of escape were blocked off by patrols. At approximately 7:45 a.m., Sgt. George Hanson appre-

hended two young men walking on the highway and upon routine investigation and questioning found that they were the two who had broken into the bowling alley that morning.

The subjects were brought to police headquarters and turned over to Detective Sgt. William Volkert and Detective Robert Cotton of the Madison Township Detective Bureau and upon questioning admitted their guilt.

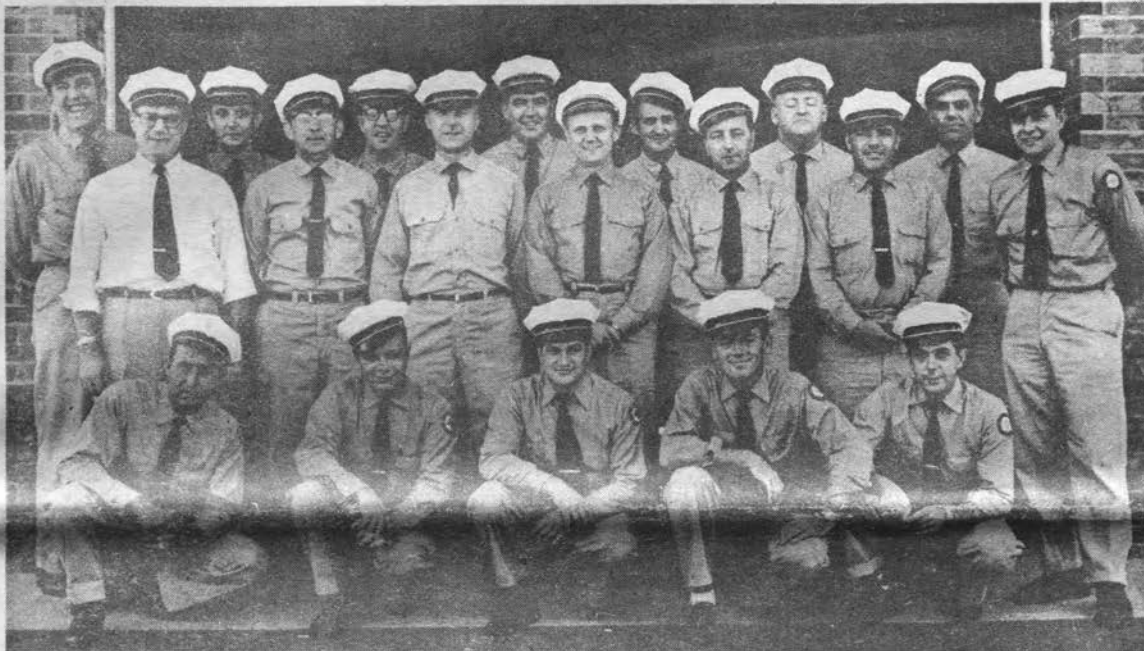
Robert Rezzonico, age 19, 562

According to the latest word from the Madison Township Board of Education it is hoped to place a referendum before the residents of Our Town in the middle of January 1963.

This is rather ridiculous because the regular school board elections are in February. May we remind the members of the Board of Education and the residents of Madison Township that in February 1963 there will be "five seats" vacant.

The Board of Education consists of nine members and control of the Board hinges on the election of five candidates to fill these vacancies.

We feel that the present Board of Education has already spent money on three special referendums that were defeated by the residents of Our Town. Why not present school building program on the same day that the School Board Budget is voted on and the same time that candidates are elected to serve on the Board of Education?

Why burden the taxpayers with extra expenses of a Special School election? Why not present a "package deal" to the voters of Madison Township?

We notice that a meeting is scheduled for October 22 to discuss the school building program. We doubt that any major changes in the school expansion plans can be accomplished between October 22nd and the middle of January. Property sites have to be obtained and options must be obtained. These can't be picked out of "thin air" unless the program has already been decided by the Board of Education and the October meeting is another "smoke screen" of the Board of Education.

You don't have to convince the residents of Madison Township that there is a shortage of classrooms, you do have to convince the voters that the Board of Education is sincere and that a entirely new approach to the school room problem will be undertaken by the Board of Education. Remember "You may lead a horse to water but you can't make him drink". We Madisonian's are a stubborn breed.

Candidates Hit At Industrial Commission

MADISON TOWNSHIP - The township's industrial commission has operated for at least a year with two of its five seats vacant, say the two Republican candidates for township committee.

Kenneth Banks and Mrs. Eugenie (Jean) F. Hampton, the GOP hopefuls discussed the township's difficulty in attracting new industry during a recent meeting of the 11th District Republican Club at 4 Jupiter Court in Central Park.

The candidates noted that the GOP organization had already criticized the township administration for failing to fill a two-year vacancy on the commission. That vacancy was filled finally two weeks ago at a meeting of the township committee.

"We are shocked to learn now," said Banks and Mrs. Hampton, "that two vacancies - not merely one - have existed since last year when the resignation of a second member was submitted."

"The people of the township were astonished to learn that the present township administration

had failed to fill one vacancy which existed for two years. But it is almost incredible that the present Democrat regime could have been so callous towards the moods of the township as to permit the commission to operate with two seats vacant - 40 per cent under strength."

Banks and Mrs. Hampton said, "The work of the industrial commission in attracting new ratables to the township is crucial, affecting the tax bill of every single resident of Madison Township."

"No wonder the commission has been so unsuccessful in its job of bringing new industry to Madison Township. The Township has been ignoring its responsibilities to that board."

The GOP candidates continued "Two years ago the Democrat regime scored an election victory on the strength of banner headlines announcing that the Democrats had brought an industrial plant to the Cliffwood Beach section of the township."

"To date, the only thing that has materialized on that 'Golden Circle' site has been a lone billboard which stands as a stark reminder of the emptiness of the 1960 headlines," Banks and Mrs. Hampton asserted.

"This year the overburdened taxpayer will need a little more convincing proof than brash promises and headlines. Perhaps the township administration will succeed in getting a few holes dug in the ground at the 'Golden Circle' site."

"But no matter how convincing the Democrat administrations may argue that they really want ratables for the township, they will still continue to be haunted by two glaring vacancies on the township industrial commission," the candidates said.

"Democrat action - and inaction - speaks louder than all their words."

Patten Guest Speaker At Young Dem Dance

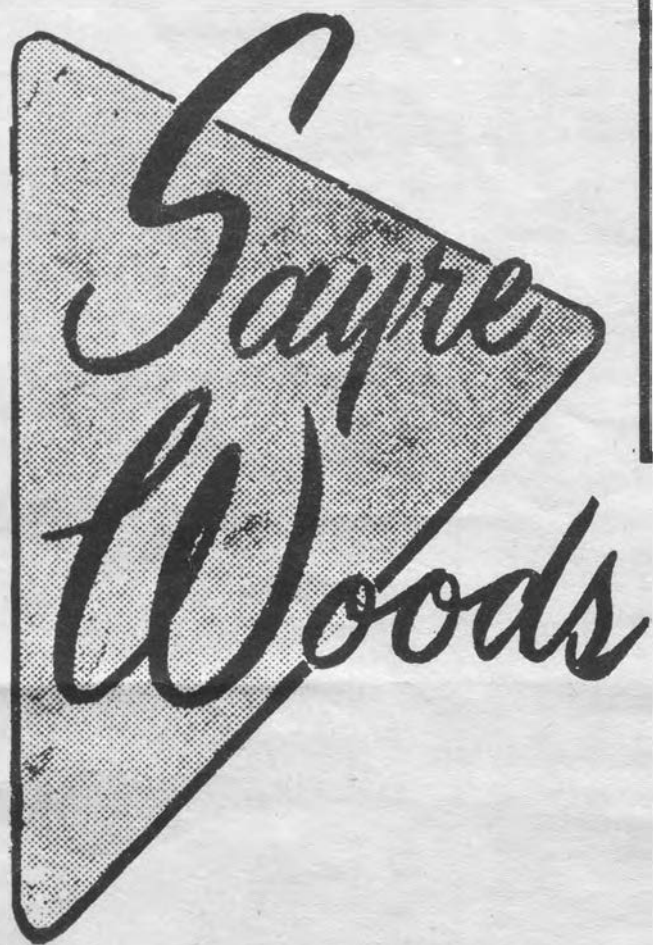

two subjects they implicated a third person Anthony Miranda, 18 years old of 725 South 17th Street, Newark. Madison Police arrested Miranda and charged him with Aiding and Assisting he was arrested at his home by Detective Joseph Laskiewicz and Patrolman E. Nielsen.

Further questioning led to the arrest of the 4th suspect police identified as Raymond Carlton White who was also charged with aiding and assisting.

According to Madison Township police reports all subjects are suspected to be narcotic users.

Rezzonico and Dale were held at the Marlboro State Hospital prior to arraignment, while Miranda was placed in the Middlesex County Jail pending arraignment and was held in lieu of \$1,000 bail.

Tuesday evening the quartet appeared before Madison Township Police Magistrate Samuel Sladkus who ordered that they be held for the grand jury. The bail will be set by the County Prosecutors Office. The local magistrate commended the police department on the work they had accomplished in apprehending the quartet.

Sgt. Detective William Volkert stated "that he believes that with the arrest of the quartet the case can now be closed".

ORDINANCE REGULATING THE PLANTING, CARE AND CONTROL OF SHADE AND ORNAMENTAL TREES AND SHRUBBERY UPON AND IN THE STREETS, HIGHWAYS, PUBLIC PLACES, PARKS AND PARKWAYS OF THE TOWNSHIP OF MADISON, EXCEPT STATE HIGHWAYS AND EXCEPT COUNTY HIGHWAYS, PARKS AND PARKWAYS.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MADISON, COUNTY OF MIDDLESEX AND STATE OF NEW JERSEY, that

1. The regulating, planning, care and control of shade and ornamental trees and shrubbery upon and in the streets, highways, public places, parks and parkways, except state highways and except county highways, parks and parkways shall be exercised by and under the authority of a commission which shall be known as the Shade Tree Commission of Madison Township.
2. The Commission shall consist of five (5) members to be appointed by the Township Committee of the Township of Madison.
3. All members of the Shade Tree Commission shall be residents of the Township of Madison.
4. The first Commissioners shall be appointed within sixty (60) days after this ordinance shall become effective and their term of office shall commence upon the day of their appointment and be for the respective periods of one, two, three, four and five years, commencing on January 1 next succeeding such appointment.
5. The Shade Tree Commission shall have all of the powers enumerated in R. S. 40:64-5, the same as if said powers were expressly enumerated herein.
6. The Shade Tree Commission shall in all other respects have all of the powers and duties as set forth in R. S. 40:64-1 to 40:64-14 inclusive, the same as if said provisions were set forth herein in length.
7. This ordinance shall take effect immediately upon passage and publication according to law.
8. All ordinances or sections of ordinances, amendments thereof or supplements thereto inconsistent herewith are hereby repealed.

We Don't Want It You Can Have It

Once again the Madison Township Zoning Board of Adjustment listened to residents of Our Town and the usual cry of "You can have it we don't want it". An application by a Sayreville automobile dealer who requested a variance to operate a new car show room on Englishtown Road and Leon Avenue.

Herbert Beirman attorney for Michael Spinelli owner and operator of Spinelli Motor Sales pleaded his case with the Board of Adjustment, he stated that the proposed showroom was suitable for the area and would not be detrimental to the general scheme. The attorney stated that this was "one of the most desirable ratables a town could ask for. The operation is clean there is no manufacturing as this is no factory. This is a desirable commercial ratable that can be a credit to the community.

The proposed building was estimated by Spinelli to be worth approximately \$80,000 and calls for the erection of a modern structure with adequate setbacks on landscaped grounds and there wouldn't be any on the street

parking allowed.

Over a score of residents turned out to voice complaint against the proposed new car show room. Michael Vass of Englishtown Road was one of the objectors. Vass said that the business would serve no immediate requirements of the area and stated that he felt it would downgrade the area. Vass suggested that the land site which measures 428 by 258 feet or approximately 100,000 square feet be used for some sort of recreational facility such as a roller skating rink. Others felt that the area should be left wooded and used for a park site.

Beirman stated that he knew of no such project as a park slated for the area and that he doubted very much that anyone would purchase the land site for recreational facilities.

Other residents of Leon Avenue pointed out that the street is very narrow and the location of a new car show room would mean additional traffic to the area creating further traffic problems. Residents said that car carriers would park on the street at all times of the day making it almost impossible to negotiate the narrow street. Others voiced protest that the proposed show room would bring additional traffic into the area and would represent added hazard to the youngster that must walk along the road. They pointed out that there are no sidewalks in the area and the youngsters have to walk in the street.

There was quite a bit of discussion over the needs of the variance between the attorney

and the chairman of the board. The attorney said that the ordinance created for handling garages and automobile repair shops did not cover a new car dealership. He said that only minor service would be done. Spinelli stated that the only servicing that will be done at the site is "incidental to the sale of a new car". He said that this does not include body work or the sale of gasoline. He stated that a gasoline pump will be located on the premises but will be used only for the service of new cars.

Leon Arrowsmith Board of Adjustment chairman said decision in the matter would be reserved to determine whether proper notification of property owners within 200 feet of the proposed site has been accomplished. Several residents in the area stated that they had been improperly notified or not notified of the proposal.

Actually 300 feet of the proposed site has previously been zoned for commercial purposes and the variance is needed to allow the remainder of the property to come under the commercial zone.

Union Head Urges Support

According to John R. Deisler, Business Representative for Heavy and General Construction Laborer's Local 472 (AFL-CIO) representatives of the New Jersey State Department of Labor, Division of Wage and Hour have been investigating charges made by several non-union employees of the United Foundation Construction Company.

The New Jersey firm has been struck by members of Local 472 since July 17, 1962 in a wage and labor dispute. The contractor is presently working on the construction of the Old Bridge sewerage project under installation by the Madison Township Sewerage Authority.

According to Deisler investigation and statements of non-union employees concerning present wage policy by the United Foundation Construction Company have been obtained by Vincent Higgins a representative of the New Jersey Labor Department.

According to the union official the non-union worker has the right to be paid the prevailing union rate involved in all Public Works in Middlesex County as determined under State Statute 34:10-1. The union efforts if successful will result in large sums of retroactive pay to employees of the United Foundation Construction Company regardless whether they are union or non-union.

Deisler recently completed special courses in Labor Law, Labor History and Accounting at Harvard, stated that Local 472 will continue to press for all the rights that the workman is

entitled to under provisions provided by federal and state laws. We are determined to win in our fight against the contractor. The law provides that each man and woman working in our great State has the right to seek union representation, without threats of firing or other intimidation. Deisler urged the support of all union workers in Madison Township to urge support of the Local 472's fight with the contractor and appeal to local officials to sit in and settle this strike.
