We talked to Township Committeeman John Keating on Monday afternoon, Keating admitted that he had "thrown his hat in the ring for the appointment as mayor." The Old Bridge Committeeman said "that he felt that he deserved the appointment over Messenger or anyone else because he was the senior member of the committee.

We questioned Keating about replacement for Phillips when and if he resigns. Keating felt that the seat should be given in SayreWoods South because they should have some representation on the Township Committee.

This should stir up a hornets nest in the Democratic Party, many workers in the Democratic Party feel that SayreWoods South Democrats have failed to stem the Republican tide in that area and that the replacement should be given to a substantially stronger Democratic area.

The strength of the Democratic Party in Madison Township is in the Laurance Harbor, Cliffwood Peach and Madison Park areas. In the past the G.O.P has failed to crack this Democratic fortress.

Robert Knight from Laurence Harbor who has served as a Municipal Committeeman and president of the Laurence Harbor Democratic Club has been mentioned as a replacement for John Phillips. Knight has been active with the Little League and Babe Ruth League and various recreational activities in the township. Other potential candidates in the Laurence Harbor area are Arnold Lauer, Lauer was a strong supporter of former Municipal Chairman Walter

William Kerr, member of the Madison Township Board of Education could be a possible dark horse candidate from the Harbor area Kerr is probably better known than most potential candidates. Kerr had previously run on a Fusion Ticket for the Township Committee in 1956. He had been seen at Democrat affair preceeding the November election.

Joseph Pandozzi of Sayre-Woods South is also another possible candidate, however, it is expected that the Municipal Committeeman from SayreWoods South will run into a wall of opposition, many of the Sayre Woods South Democrats feel that one of the reasons of the failure of the Democrats to produce votes in the SayreWoods South area is the Municipal Committeeman Joseph Pandozzi. Other potential candidates from the area could possibly be Robert "Jack" Sapir, Edward McLane or Herbert Gordon.

#### The Thrill Is Gone

It all started in Akron, Ohio when a group of stamp collectors noticed a misprint on the Dag Hammerskjold Commemorative Issue which was put up for sale on October 24, 1962 by the Post Office.

Other reports of the misprint were reported to be in the hands of stamp collectors and the furor was on. Early this week the post office halted the sale of the commemorative stamp, to try to determine how many imperfect sheets got past the postal inspectors.

The printing error that raised the value of the imperfect stamps was caused by an inverted yellow plate. In the flawed stamps, the lower portion, which should be yellow, is a blank white and the four cent designation, which should appear in the lower left corner, is at the upper right.

Original reports had the stamps valued between \$250 and \$350 each, which is quite a percentage of markup on a four cent investment.

Now the post office intends to print several thousand more of the imperfect stamps, in order to deflate the value of the imperfect If things keep going on, it might prove that the perfect stamps will be of more value than the imperfect stamps.

### Why Not Apartment Houses For Madison?

The Planning Board of the Borough of Bergenfield, New Jersey recently completed an exhaustive study concerning the future status of apartment houses in that borough.

Many of the facts brought to light by this survey were very interesting and could prove to be a valuable asset to the over-burdened taxpayer in Cur Town.

The study determined that the existence of apartment houses did not place additional burdens on the police and fire departments. That 85% of the apartment units had private garbage disposal. The report showed that recreational facilities were adequate and provided at the apartment site.

The survey also pointed out that only one child in seventeen in the Borough Public School system resided in an apartment unit. The newer apartments had less of a ratio of school children than the older apartments. This was undoubtedly due to the smaller size of the newer units, there were generally less than four rooms per apartment.

In the course of the study it was found that apartment house families with children of school age invariably move to private residences before their children reach high school. Thus the greatest majority or children in public schools are in elementary school, where the educational costs per pupils are approximately 26% lower than high school costs.

Perhaps, the Madison Township Planning Board should contact the officials of Bergenfield and obtain additional information. We feel that apartment houses in Madison Township would be a benefit to the homeowner. The additional residents would greatly add their purchasing powers to the economy of Our Town. Businessmen and merchants in Our Town would greatly be aided by the additional With the increase in population revenue. Madison Township would receive additional tax money from cigarette and gasoline tax. Additional taxes would be obtained from the various utility companies serving the area. Perhaps the apartment houses would be a way to stabilize the tax rate in Madison Township.

How about it fellows? Why not try to obtain some apartment houses for Our Town?







#### Tax Conference

Accountants, attorneys, tax practitioners and individual business taxpayers or company representatives actively engaged in the preparation of Federal business tax returns are invited to attend a conference sponsored by the Internal Revenue Service in the Terrace Room of the Mosque Theater at 1060 Broad Street, in Newark at 1:00 P.M. on Thursday, November 29, 1962. The purpose of this meeting is to discuss input requirements for the Internal Revenue Service's Automatic Data Processing System and to explain the use of the revised forms for business tax returns.

The Acting Director of the Newark District, John H. Rauen, Jr., in explaining the purpose of the meeting stated that business tax returns from all districts within the Philadelphia Region for periods beginning after January 1, 1963 will be nandled by the Automatic Data Processing System recently installed in the Philadelphia Regional Service Center. This innovation has necessitated the use of Taxpayer Identification Numbers, the revision of some of the forms used for tax returns and has placed a stringent emphasis upon following prescribed procedures in their preparation. Mr. Rauen explained that the agenda for this meeting has been limited to these specific topics.

Professional associations, practitioner groups, trade as-sociations, industry organiza-tions and local Chambers of Commerce have already been asked to notify their members of this meeting. Any individual

#### G.O.P. Chairman Hits Back At Critics

Madison Township Municipal Chairman Donald L. Borst dismissed Monday night as "completely erroneous and without foundaton" recent statements which alleged that the services of challengers for the county GOP were refused in Madison Town-

Speaking before the Cliffwood Beach Republican Club where he was nominated as president Monday night, Borst said that the names of challengers for GOP congressional candidate Bernard F. Rodgers and the Republican ticket were filed in every elec-tion district in Madison Township. #### Change In Hunting Laws Needed

We'll probably hear from more than one hunter, but we feel that certain provisions in the New Jersey Game Laws should be changed.

The present state law concerning the discharging of a gun for the purpose of hunting is as follows: - No person, excepting owner, or lessee of property, may for the purpose of hunting, discharge a firearm within 300 feet of any occupied dwelling.

We firmly believe that this part of the law should be amended to state 500 feet. In Madison Township many of the home development border on wooded areas, these are ideal hunting areas. With modern ammunition there is presented greater danger to human life with hunters discharging weapons 300 feet from an occupied dwelling.

We think that perhaps the township committee should enact a local ordinance prohibiting the discharging of weapons for the purpose of hunting at least 500 feet from any occupied dwelling. Perhaps the committee should also include in the ordinance that hunting for game be limited to land zoned for heavy industry. This would keep the hunters away from the developments. .
