After a long wait of over 2 1/2 years the Corps of Engineers and the New Jersey State Department of Conservation Economic De-velopment presented a preview of the plans for Hurricane Protec-the and Reach Freeder Department

the plans for Hurricane Protec-tion and Beach Erossion Preven-tion to the Township of Madison, Mr., James Ranking Chief En-gineer, Bureau of Navigation, Mr., Frank Cogan, Mr., Frank Berid also of the Bureau of Navi-gation, Mr., John Mulryne, Green Acres, Mr., Robert Wilcox, State Highway Department and Mr., Henry Sevrin Deputy Attorney General met with Mayor John Keating, Township Engineer Fred Katz representing the Township Katz representing the Township and Freeholder John Phillips re-

presenting the county. According to present plans proposed Route 35 is to be raised to a maximum elevation below Cheesequake Creek, a series of dikes and ditches and protective mounds will be constructed from below Cheesequake Creek all the way to the Township line at Whale Creek. In addition to this con-struction the beach front will be creek. In addition to this con-struction the beach front will be raised to an elevation of 5 1/2 feet to 10 1/2 feet depending upon the location. In the areas where homes are located and where there is an overhanging bluff, the beach will be built up to 10 1/2 feet in the other areas the height of development will be 5 1/2 feet.

The plan calls for a gradual sloping of the beach to provide a bathing area along the entire bay front. In the very near future Madison Township will possess the only salt water bathing beach in Middlesex County. The cost of the project will be divided by the Federal, State and local governments, with the Federal and State governments paying the highest percentage of the costs.

This program of beach erosion has been anticipated by the local government since its inception about 2 1/2 years ago and will reach its climax this summer with the start of the beach ero-

The letter read in part as fol-lows: - "Due to the fact that I am the Township Attorney for the Township of Madison and I am the Township Attorney for the Township of Madison and attorney for the Planning Board for the Township and also en-gaged very actively in private trial practise of law, it is with much regret that I am tender-ing my resignation as co-coun-sel to the Madison Township Municipal Utilities Authority with meand for the alway cardinand Municipal Utilities Authority with regard to the above captioned matter (Madison Township Muni-cipal Utilities Authority vs Browntown Water Company). It has been a pleasure to have been associated with the Municipal Utilities Authority and I appre-ciate all your courtesies and cooperation extended during our relationship. regret that it is necessary for me to take this action due to other legal commitments." Recently the Madison Township Utilities Authority had acquired the purchase of the Garden State water Company and the Sayre-Wood Shopping Center Water Sys-tem, the authority was immedi-ately under fire from residents of the Madison Park and Central Park area. The Authority raised the water rates in the two de-velopments from 20% to 100%, A group of citizens formed The Committee for Fair Water Rates and immediately took the Water Authority to task. In a two hour P.U.C. hearing on April 9th, 1963 Committee Co-Chairman, Don-ald D. Tierney of Madison Park soight to have declared null and wold the Water Authority pur-chase of the Garden State Water Company. The Company was purchased on Decemeber 10th 1962 at the price of \$427,000. As ot this writing a P.U.C. deci-sion is still pending.

School Referendum June 5th

The residents of Madison Township will be given the opportunity to vote on a \$4,-The 150,000 School Expansion Program. local Board of Education has presented previous school building programs on three different occasions. The members of the Board prior to these elections have stated that this is the best program for Madison Township, they stated also that this was the most economical program available.

Once again the Board of Education is urging for a YES vote for the School Referendum stating that there is a severe shortage of classrooms. Ture there is a shortage of classrooms but have you looked at your bank account lately, there is a severe short-age of that "green stuff" money.

Most of the residents of Our Town have recently received notices from the tax collector or mortgage companies that there is an increase in the monthly payments. This is without any additional construction of costs.

The Board of Education estimates that the schools will cost each taxpayer only \$1.95 per hundred on his assessment, this means an increase of between \$40 per home in Laurence Harbor to over \$100 per home in other areas.

Board of Education is relying heavy YES vote from the SayreWood South area, they hope that the voters in the other areas stay away from the polls.

The Madison American urges that every voter in the township turn out on Wednesday, June 5th and register his vote. If you feel that you can afford an increase of \$100 per year in your taxes, vote yes. If you can't afford the increase vote no. It's as simple as that. We predict passage of the School Referendum because few residents of Our Town will exercise their voting rights.

Same Old Story

We had hoped that the G.C.P. candidates and the one Independent candidate for Township Council would conduct a vigorous campaign and present to the voters of Our Town something new and something different. It seems that they both are now relying on the "same old story" mass housing development.

It seems very odd that the majority of the candidates seeking election would not have had the opportunity to be candidates in Madison Township if it were not for the fact that they had the opportunity to purchase a development home, the majority of the G.O.P. candidates and the one Independent Candidate have lived in Madison Township less than six years.

Now they are screaming that "mass development" is the downfall for Our Town. The Madison American is of the opinion that in order for Our Town to prosper, in order that we obtain industrial ratables, commercial ratables - - Madison Township must continue to grow.



Clinic Chairman Robert Muller reports that the local Jaycee Chapter project received tremendous response from the public in 1962 when over 300 seat belts were installed. "As before," Mr. Muller stated, "the seat belts, normally retailing for \$10.95 plus installation, will be sold and installed by Jaycee members in all types of cars at a cost of only \$6.00 installed. Available in many attractive colors, the belts themselves are

The National Safety Council in cooperation with the automotive crash injury research group of Cornell University has estimated that more than 5,000 lives could have been saved and serious injury reduced by 1/3 during 1962, if seat belts had been installed and used in all automobiles. The chances of death or serious injury are 5 times greater when a person, not protected by seat belts, is thrown from the car during an accident. In addition to the safety factor, seat belts provide comfortable support while driving and are an effective means of keeping children safely in their seat during sudden stops.



LEGAL NOTICE

AN Ordinance accepting and adopting the "New Jersey State Housing Code" as a standard governing supplied utilities and facilities and other physical things and conditions essential to making dwellings safe, sanitary and fit for human habitation and governing the condition of dwellings, authorizing inspection of dwellings and fixing penalties for violations.

The BOARD OF HEALTH of Township of Madison of the County of Middlesex of State of New Jersey do ordain that:

1. The Health Officer of the Board of Health of the Township of Madison be and he is hereby designated as the officer to exercise the powers prescribed by the within ordinance, and he shall serve in such capacity without any additional salary. 2. Pursuant to the provisions of Chapter 21, P.L. 1946 (N.J.S.A. 40:49-5.1) the "New Jersey State Housing Code" as approved by the Departments of Health and Conservation and Economic Development and filed in the Secretary of State's office is hereby accepted, adopted and established as a standard to be used as a guide in determining whether dwellings in this municipality are safe, sanitary and fit for human habitation and rental. A copy of te "New Jersey State Housing Code" is annexed to this ordinance and three copies of the same have been placed on file in the office of the Township clerk and are available to all persons desiring to use and examine the same. 3. The Health Officer is hereby authorized and directed to make inspections to determine the condition of dwellings, dwelling units, rooming units, and premises located within the Township of Madison in order that he may perform his duty of safeguarding the health and safety of the occupants of dwellings and of the general public. For the purpose of making such inspections the Health Officer is hereby authorized to enter, examine and survey at all reasonable times all dwellings, dwelling units, rooming units, and premises. The owner or occupant of every dwelling, dwelling unit, and rooming unit, or the person in charge thereof, shall give the Health Officer free access to such dwelling, dwelling unit or rooming unit and its premises at all reasonable times for the purpose of such inspection, examination and survey. Every occupant of a dwelling or dwelling unit shall give the owner thereof, or his agent or employee, access to any part of such dwelling or dwelling unit, or its premises, at all reasonable times for the purpose of making

such repairs or alterations as are necessary to effect compliance with the provisions of this ordinance or with any lawful rule or regulation adopted or any lawful order issued pursuant to the pro-

visions of this ordinance. 4. Whenever the Health Officer determines that there are reasonable grounds to believe that there has been a violation of any provision of this ordinance, or of any rule or regulation adopted pursuant thereto, he shall give notice of such alleged violation to the person or persons responsible therefor as hereinafter provided. Such notice shall (a) be put in writing; (b) include a statement of the reasons why it is being issued; (c) allow a reasonable time for the performance of any act it requires; and (d) be served upon the owner or his agent, or the occupant, as the case may require; provided that such notice shall be deemed to be properly served upon such owner or agent, or upon such occupant if a copy thereof is served upon him personally; or if a copy thereof is sent by registered mail to his last known address; or if a copy thereof is posted in a conspicuous place in or about the dwelling affected by the notice; or if he is served with such notice by any other method authorized or required under the laws of this public health, or safety, he may, without ficate, permit or license except for a state. Such notice may contain an outline of remedial action which, if taken, will affect compliance with the provisions of this ordinance and with rules and regulations adopted pursuant thereto. Any person affected by any notice which has been issued in connection with the enforcement of any provision of this ordinance, or of any rule or regulation adopted pursuant thereto, may request and shall be granted a hearing on the matter before the Board of Health provided such person shall file in the office of the President, Board of Health, a written petition requesting such hearing and setting forth a brief statement of the grounds therefor within ten days after the day the notice was served. Upon receipt of such petition the Board of Health shall set a time and place for such hearing and shall give the petitioner written notice thereof. At such hearing the petitioner shall be given an opportunity to be heard and to show why such notice should be modified or withdrawn. The hearing shall be commenced not later than ten days after the day on which the petition was filed; provided that upon application of the petitioner the President, Board of Health may postpone the date of the hearing for a reasonable time beyond

such 10-day period, if in his judgment the petitioner has submitted a good and sufficient reason for such postponement. After such hearing the Health Officer shall sustain, modify, or withdraw the notice, depending upon his findings as to whether the provisions of this ordinance and of the rules and regulations adopted pursuant thereto have been complied with. If the Health Officer sustains or modifies such notice, it shall be deemed to be an order. Any notice served pursuant to this ordinance shall automatically become an order if a written petition for a hearing is not filed in the office of the President, Board of Health within ten days after such notice is served. The proceedings at such hearing, including the findings and decisions of the BOARD shall be summarized, reduced to writing, and entered as a matter of public record in the office of the Board of Health. Such record shall also include a copy of every notice or order issued in connection with the matter. Any person aggrieved by the decision of the Board of Health may seek relief therefrom in any court of competent jurisdiction, as provided by the laws of the state. Whenever the Health Officer finds that an emergency exists which requires immediate action to protect the requiring that such action be taken as he deems necessary to meet the emergency. President, Board of Health shall be January 1st of each year. afforded a hearing as soon as possible. it, or revoke it. 5. The Health Officer is hereby authorized and empowered to make and adopt such written rules and regulations as he may deem necessary for the proper enforcement of the provisions of this ordinance, provided, however, that such rules and regulations shall not be in conflict with the provisions of this ordinance, nor in anywise alter, amend or supersede any of the provisions thereof. The Health Officer shall file a certified copy of all rules and regulations which he may adopt in his office and in the office of the Clerk of the Township of Madison. 6. No person shall occupy as owner occupant or rent to another for occipancy any dwelling or dwelling unit for the purpose of living therein which does not conform to the provisions of the "New Jersey State Housing Code" established hereby as the standard to be used in detr determining whether a dwelling is safe, sanitary and fit for human habitation. 7. Any person, firm or corporation who shall violate any of the provisions of this ordinance shall upon conviction, be punished by a fine of not to exceed Two Hundred Dollars (\$200.00) or by imprisonment in the county jail for a period of not to exceed ninety (90) days or by both such fine and imprisonment, and each violation of any of the provisions of this ordinance and each day the same is violated shall be deemed and taken to be a separate and distinct offense. 8. All other ordinances and parts of ordinances in conflict or inconsistent with this ordinance are hereby repealed, but only to the extent of such conflict or inconsistency, and this ordinance shall be in full force and effect immediately upon its adoption and its publication, as provided by law. 9. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invaid for any reason, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared to be severable. 10. This ordinance and the code herein

fixing penalties for violations is hereby established pursuant to Revised Statutes 26:3-69.1 to 69.6. A copy of said code is annexed hereto and made a part hereof without the inclusion of the text thereof herein.

Section 2. The said code established and adopted by this ordinance is described and commonly known as the "Retail Food Hnadling Establishment Code of New Jersey (1952)".

AN ORDINANCE TO AMEND AN ORDI-NANCE ENTITLED "AN ORDINANCE LIMITING AND RESTRICTING TOSPECI-FIED DISTRICTS AND REGULATING THEREIN BUILDINGS AND STRUCTURES ACCORDING TO THEIR CONSTRUCTION AND THE NATURE AND EXTENT OF THEIR USE; PROVIDING FOR THE AD-MINISTRATION AND ENFORCEMENT OF THE PROVISIONS HEREIN CONTAINED; and providing for the repeal of inconsistent ordinances.

BE IT ORDAINED by the Mayor and th. Township Committee of the Township of Madison, Middlesex County, New Jersey, that the above-entitled ordinance be amended as follows:

SECTION X(2)

MULTIPLE DWELLING GROUPS shall be permitted in any district under the following conditions which shall not be subject to variance by action of the Board of Adjustment unless so specified

1. That 'the applicant submit six (6) copies of the plat plans together with storm drainage maps and topography maps of the proposed development ten (10) days prior to the next regular meeting of the Planning Board and that a filing fee of Ten Dollars (\$10.00) per family unit accompany the afresaid application, which fee shall be payable to the Planning Board to cover the administrative costs and expenses incident to the approval of said plans. The aforesaid plans shall be based upon tax map information of some other similarly accurate base at a scale not less than 400 feet to the inch to enable the entire tract to be shown on one sheet and shall show and include the following information: a. The location of that portion which is to be developed in relation to

- a. The location of that portion which is to be developed in relation to the entire tract.
- b. All existing structures and wooded areas within the portion to be developed and within 200 feet thereof.
- c. The name of the owner and of all adjoining property owners as disclosed by the most recent municipal tax records.
- d. The tax mapsheet, block and lot numbers where applicable. e. All streets or roads and streams within 500 feet of the property line.

(A) The Planning Board shall approve said plans upon a showing of compliance all of the conditions hereinafter enumeall of the conditions hereinafter enumerated and upon a finding by the Board that the proposed plat exerts no detrimental effect upon surrounding areas because of poor arrangement, inadequate parking, traffic dangers, inadequate provision for light or circulation of air,




