veloped by a joint committee from the faculties of Rutgers University and Union Junior College.


# Fund Drive Set

# Legal Opinions And Other Opinions

Much ado and furor has been activated because of a recent legal opinion presented by the attorney for the Madison Township Board of Education. Residents of the Pine Haven development had sought transportation for their youngsters living within the two mile transportation zone.

The parents of the youngsters involved had threatened the members of the Board of Education with reprisals at the next school election. The Board of Education was on the "hook".

We're very glad to see that the children involved will be transported to the school. However, we wonder if the legal opinion would have been the same had only one or two youngsters been involved? The Board of Education according to assistant superintendent of schools Patrick Torre is transporting 108 youngsters in the area.

Any lawyer or even a layman can give you a legal opinion on anything. This doesn't mean that his opinion is necessarily cor-

We understand that the attorney for the Board of Education did much study and research before he gave his "legal opinion". We wonder if he ever investigated the Zoning Code and Building Code adopted by the Township of Madison?

We firmly believe that there is no question of trespassing involved. The decision of the Board of Education to provide transportation for these youngsters can be taken to court and the courts would decide the issue. We certainly hope that it doesn't go this far. We would prefer that the Township Board of Education press for legislation to amend school transportation rules and regulations which have long been outmoded.

In this day and age there is not only a question of the length of the trip to and from school but other dangers involved. Youngsters on long treks to school in isolated areas could be subjected to the whims of sex deviates.

School transportation laws regulate the number of pupils to be transported on a bus. Some of the school buses are equipped to carry 100 children, but according to law they may carry only 60. We feel that this is ridiculous. The transportation laws regulate the area of a seat for each youngster, these regulations must have been figured out of very thin children.

We would like to see the entire transportation laws effecting the transportation of school children and state aid revamped. The year is 1963 not 1923, instead of legal opinions and "bending" of other laws, press for effective modern legislation. That's our opinion.

At the regular meeting of the council of the Lutheran Church of the Good Sheperd, held Sept. 25, it was resolved to discontinue the monthly subsidy as of Oct. I, coinciding with the congregation's third anniversary. The subsidy is the financial support made available by the Missouri Synod.

The current operating budget for 1963 totals \$17,000, including \$3,300 earmarked for missions and benevolences. congregapon is composed of 120 communicant members and 140 Sunday school children. The Sunday School and Bible Class are held at 9:15 a.m. and the regular Sunday service at 10:30 a.m. in School #18, on Bushnell Rd., Sayre Woods South. Additional educational opportunities are currently provided for all children from the 3rd to the 12th grades in the Mid-Week Church School.

Since the organization of the Church in 1960 the congregation has acquired 17 acres at the intersection of route 9 and 516 for the permanent building site. Ground breaking for the first phase of the building program is anticipated within the next 18 months.



# **Urges Consideration Of Public Question**

Walter J. Vohdin Jr., former commander of the Hoffman Prince Post V.F.W., Laurence Harbor, urged residents of Madison Township to study the public ques-

The voters of New Jersey will find on their ballot on November 5, 1963, a Veteran's Tax Exemption proposal to be voted on. It will appear on the ballot in the following form:

Shall the amendment of Article VIII, Section I, paragraph 3 of the Constitution of the State of New Jersey granting an annual deduction not to exceed \$50.00 from the tax bill for taxes on real and personal property as therein provided of certain veterans and their widows, instead of the \$500.00 exemption presently provided on the aggregate assessed valuation of such property, be approved?

This proposal has the support of the Democratic party. It was pledged in the 1961 Party platform, and sponsored in the New Jersey State Senate by all 10 Democratic Senators, and passed both houses of our Legislature with strong Democratic support.

Under a New Jersey Supreme Court decision, all real estate is supposed to be assessed at 100% market value.

Fire Chief George Bean of the Madison Park Fire Department announced today that the week of October 6 to October 12 has been designated as Fire Prevention Week. The main purpose of Fire Prevention Week is to provide a yearly reminder for every one for the year round need for fire prevention and fire safety. As Chief of the Madison Park Vol. Fire Co. I would like to offer a few suggestions that may keep your home safe from fire.

1. Never leave small children alone. Even if you are only leavresponsible person to stay with them. When you are going out for an extended stay, employ a responsible baby sitter.

2. Small children and elderly people are the most frequent fire victims. If there are elderly persons in your household, plans should be made to get them out of the house in the event of fire.

3. Use care with cigarettes. Never discard a lit cigarette or match without being sure that it is completely extinguished. It is good practice to break a match after using. Keep matches away from children and never smoke in

4. Never use matches or a lighted candle in an attic or

5. Keep all electrical appliances in good working order. Especially the cords.

6. Throw out all old newspapers and magazines. Store necessary combustibles in approved

7. Impress upon everyone in your household that in case of fire, first, get everyone out of the house, then call the fire de-
