## Town Fair Plans Continuing

Plans continue to be made for the Madison Township Fair and coordinating those plans is Alan Bourassa, vice-chairman of the fair's general management committee.

The fair, sponsored by the Junior Chamber of Commerce, is scheduled for Sept. 18, 19 and 20 at the Old Bridge Stadium.

Bourassa said that the money from the fair will be earmarked for a Madison community center.

"A center has been the dream of resident for quite a while now. Along with a central library, it was the most requested project when a community attitude survey was conducted by the Jaycees," he declared.

Another purpose of the fair, in addition to raising money,

is "to get all the township organizations to work together," Bourassa said. About 40 organizations are working on the fair project, the vice-chairman noted.

Special events planned for the fair include a hootenanny, a beauty pageant, a puppet show, and a rodeo. Bourassa said he expects 15,000 people to attend.

Bourassa expressed his appreciation to the Old Bridge Stadium for donating the stadium and grounds for the three days the fair will run.

A charter member of the Madison Township Junior Chamber of Commerce, Bourassa has served as the group's vice-president, secretary and treasurer. He also served on Mayor Donald Macrae's community center study committee.

## Council Awards Liquor Licenses

The Madison Township Council meeting in special session Friday evening, approved the issuance of two Plenary Retail Distribution Liquor Licenses. The licenses had come about as the result of the 1960 census figures and the creation of an amendment to the local ordinance governing the issuance of such license. Recently the township council approved an ordinance making four Plenary Retail Distribution Liquor Licenses available in the township.

Applications of six parties had been received by the council for the two remaining liquor licenses as follows: - Dominick and Philomena Picciano of Spring Valley Road and Route 9, R. D. Old Bridge; Theodore and Margaret Leitereg of 112 Matawan Road, Laurence Harbor, John Dumphy Jr. of 2 Clover Street, Old Bridge, Buy Rite Liquor, Peter and Elizabeth Condo of Kensington Avenue, Old Bridge and Edward and Mildred Robinson of 95 Burnet Street, New Brunswick.

The licenses were approved for Edward and Mildred Robinson of New Brunswick for premises to be situated on Ernston Road, Parlin and to Peter and Elizabeth Condo of Old Bridge for premises to be located at 399 Englishtown Road.

There were several objections to the location of at least four of the applicants for the licenses, but Council Richard Dealy who conducted the meeting because Mayor Donald Macrae disqualified himself because of part ownership of an existing liquor establishment.

When several residents attempted to voice verbal objection to the issuance of the licenses, Dealy cut them off hearing only objections from persons who presented their objections in writing to the clerk.

Voting in favor of the issuance of the liquor licenses were Councilmen Dealy, Banks, Tierney, Cancelleri, Messenger and O'Brien, Mayor Macrae abstained from voting because of a possible "conflict of interest".

This in all probability will end any further issuance of Plenary Retail Distribution Liquor Licenses, until perhaps after 1970 when the next Federal Census will be taken.

## Operation Blood Brother Extends

### Blood Coverage Policy

At a recent meeting of the Madison Township Blood Bank it was announced that its Blood Coverage Policy has been broadened, effective immediately and until October 9, 1964.

John J. Jaconetti, Chairman of the Blood Bank, indicated it will accept requests for blood and blood derivatives from all residents of Madison Township. This temporary extension of Blood Coverage Policy is of particular importance to households who have not donated blood to the Madison Township Blood Bank in the past.

All requests for blood will be reviewed by a Screening Committee and those approved will

be advised. All requests will be held in the strictest confidence.

It was also announced that the third Bloodmobile visit of Operation Blood Brother will be held this year on Saturday, October 10, 1964, from 10:00 a.m. to 3:30 p.m. at the Madison Township High School. Since the Blood Bank has grown so rapidly it is necessary to ask for volunteers to assist in the planning and coordination of the Bloodmobile visit. All persons willing to help should phone James P. ## Ground Breaking Held In Harbor

Ground-breaking ceremonies were held Saturday morning for the New Laurence Harbor Little League diamond to be located at the rear of the Laurence Harbor Memorial School.

The new diamond borders the present facility which will be continued to be used and will organize the two fields. Due to the planned construction of the new Cliffwood Beach Elementary School the league was forced to seek additional space. The Cliffwood Beach diamond is on the site of the proposed school grounds.

The league headed by Mac Du Pre, supports six major and six minor teams involving some 215 boys from 8 to 12 years of age. There are leading squads for girls of the same age.

The new baseball diamond when completed will be fenced in completely and will be one of the most modern plants for Little League Ball players in the area.

On hand at the ground breaking ceremonies were League and School Board officials including Mrs. Michael Jenning President of the Little League Auxiliary, Mac Du Pre, President of the League, William Kerr, Richard Pine and Charles Thompson, members of the Madison Township Board of Education.

## Township To Save Over \$3,600 On Gasoline

The township will realize a saving of some \$3600 in its purchase of gasoline for the public works and police departments in the next year as a result of action taken yesterday by municipal officials.

Township manager Paul H. Hermann and municipal engineer Robert J. Baier received bids yesterday afternoon for the purchase of 30,000 gallons of gasoline for the public works department and 30,000 gallons for the police department.

Hermann, in announcing his decision to award the contract to the Sinclair Refining Co. of Montclair, on its low bid of \$8,994, said the price included the supplying of a gas tank to be located at the township public works department's headquarters on Route 516.

Municipal officials decided earlier this year to discontinue the current practice of purchasing gasoline for township vehicles from private distributors in the community and to establish a central gasoline pump and tank at the Route 516 location.

The police department has been using its own gasoline pump for some time, but by permitting public bidding on the gasoline contract the township will realize a saving of about two cents per gallon - or \$600.

Public bidding on the public works department gasoline supply reduced the price by approximately ten cents per gallon, for a saving of about \$3,000.

The municipal council approved an ordinance in April authorizing the use of capital funds for renovations at the municipal building and at the public works department headquarters,

preparing for the transition to the new system with a township-operated pump.

Among other changes, the renovation program provided for the construction of an anchor fence at the Route 516 location to safeguard the new pump against unauthorized use and to protect new equipment recently purchased by the township.

Mayor Donald Macrae, expressing approval of the change-over, noted that "the savings in gasoline costs will more than pay for the renovation charges at the public works headquarters."

"The savings reflected in this move are fully in keeping with this administration's determination to seek out areas in local government where costs can be cut and passed on to the homeowner in tax dollar savings."

Also bidding on the contract recently was the Globe Petroleum Co. of Red Bank, with a bid of \$9,095. Bids were received at the municipal building.

## Legal Aid Needed

Mayor Donald Macrae at a recent meeting of the Township Council suggested the hiring of an attorney to aid members of the local police department in their presentation of "drunken driving" charges.

We certainly agree.

Police officers are not in any position to cope with a well trained attorney and therefore make a poor presentation of their case, which results in lowering of police morale.

Police Magistrate Samuel Sladkus has often spoken in favor of a Township Attorney representing the local police on all serious charges. Judge Sam feels that this would simplify his work, he points out that the Judge can't also serve as the prosecuting attorney.

The police officer should only have to testify as to what the circumstances were in regards to issuance of the ticket, he can't be expected to present the case, the way a trained attorney could present it.

Without a township attorney representing the police, the police officer in many cases finds that he is the "big bad guy" that issued the ticket and is often discredited by the defense attorney in his attempt to win for his client. The police officer is subjected to in many cases uncalled for ridicule. We are all human and in many instances this ridicule often reflects later on in the police officer's performance of duty. He might feel "why should I give this fellow a ticket for "drunken driving" he'll hire an attorney and I'll get my brains beat out in court."

Dear Mr. White:  
I would like to go on record for the benefit of "Dear Virginia" as saying that I wholeheartedly agree with your stand on mob violence, and I am not afraid to sign my name and address when I say so.

Virginia and her type of "dog-godders" are mainly responsible for this mess that we find ourselves in. If she and her kind weren't so quick to sympathize with criminal elements just because of their color, there would be more respect for the law. When a man commits murder, should he be exonerated simply because he was "socially oppressed?" I wonder how Virginia would feel if she were that woman who, with her escort, was attacked by the mob in Harlem for doing nothing more than riding down the street in an automobile? Or perhaps Virginia closes her eyes to pictures like that.

It is not bitter hate that makes people speak out against mob violence - it is bitter resentment at having to be afraid to walk the streets after dark. It isn't even safe for a woman to drive alone in a car in broad daylight on a public highway. Negro men at this point will

Nothing is handed to anyone on a platter. In our country, everyone is guaranteed an equal start in life, but no one can guarantee an equal place at the finish line. I have seen nice neighborhoods taken over by negroes - in a few years the houses are falling down, and the yards are filled with trash. I have also seen homes owned by negroes that would put a great many white homeowners to shame with their cleanliness and neatness, but these unfortunately are in the minority. Trash is trash, whether it is white trash or black trash. And mob rule is mobrule, and a mob does not think.

I wonder if the business owners in Harlem though "We'll excuse them. They buy in our local stores and vote for our local candidates." when the mobs were destroying and looting the businesses which were these peoples' livelihoods?

Some of these people like Virginia should come down from their Ivory towers, and take a really close look at what is going on - their grasp of the facts of life might be a little better then. And maybe the people who wrote in praising your editorial didn't sign their names because they have looked around, and they were afraid that they might be burned out of their homes by a mob, simply for saying what they felt, or taken into

These drinks, non-alcoholic counterparts of cocktails, are catching on fast with the "teen set." They're high in energy and low in the calorie department. Bite-size snacks, like tiny cherry tomatoes stuffed with a sardine filling and some cheese dips, complement the drinks and go easy on teen-age allowances.

To be sure the evening is good fun all the way through (no broken dinnerware during refreshments!) and to limit those clean-up chores to a wee minimum, serve your favorite snacks on gay "party-proof" melamine plates. The patterns are pretty and colorful, like this perky floral design; the plates are lightweight and *very* durable; and they're dishwasher proof, too!

You can start the fun rolling with the quick-and-easy "Soup Fizz" shown here. Make it this way:

### Soup Fizz

1 can (10½ oz.) condensed tomato soup	1 bottle (7 oz.) chilled lemon-lime soda
½ soup can water	Lemon peel
1 tablespoon lemon juice	

Combine soup, water and lemon juice. Stir to blend. Add soda just before serving. Pour over cracked ice in glasses. Garnish with twist of lemon peel. Serve in glass mugs, small highball glasses or tumblers. Makes 3 to 4 servings.

For a beverage variation, here's another delicious quickie:

### Red Cow

1 can (10½ oz.) condensed beef broth	1 can (12 oz.) V-8 juice
--------------------------------------	--------------------------

Combine broth and juice. Serve over cracked ice, in cocktail glasses or stemmed wine glasses. Makes 4 to 5 servings.

## Vacancies

A few vacancies remain in the U.S. Coast Guard Officer Candidate School class convening on September 13, 1964. College graduates between 21 and 26 years of age who meet rigid mental and physical requirements can become commissioned officers in the Coast Guard in 17 weeks. Qualified applicants are enlisted in the Coast Guard Reserve with a guarantee that they will be admitted to Officer Candidate School.

Classes convene at the U.S. Coast Guard Reserve Training Center in historic Yorktown, Virginia each September and February. Here the officer candidates are given highly specialized instruction in navigation, seamanship, antisubmarine warfare, law enforcement, and military drill. Graduates are commissioned as ensigns in the Coast Guard Reserve and join the 3,000 Coast Guard Officers who are charged with enforcing Federal Laws and protecting life and property on the high seas and the navigable waters of the United States.

U.S. Coast Guard Reserve Officers on active duty receive 30 days annual leave, free medical and dental care, and the same benefits and pay as officers in the other Armed Services. Reserve Officers serve 3 years on active duty (after 17 weeks at Officer Candidate School) as part of a total 6 year obligation.

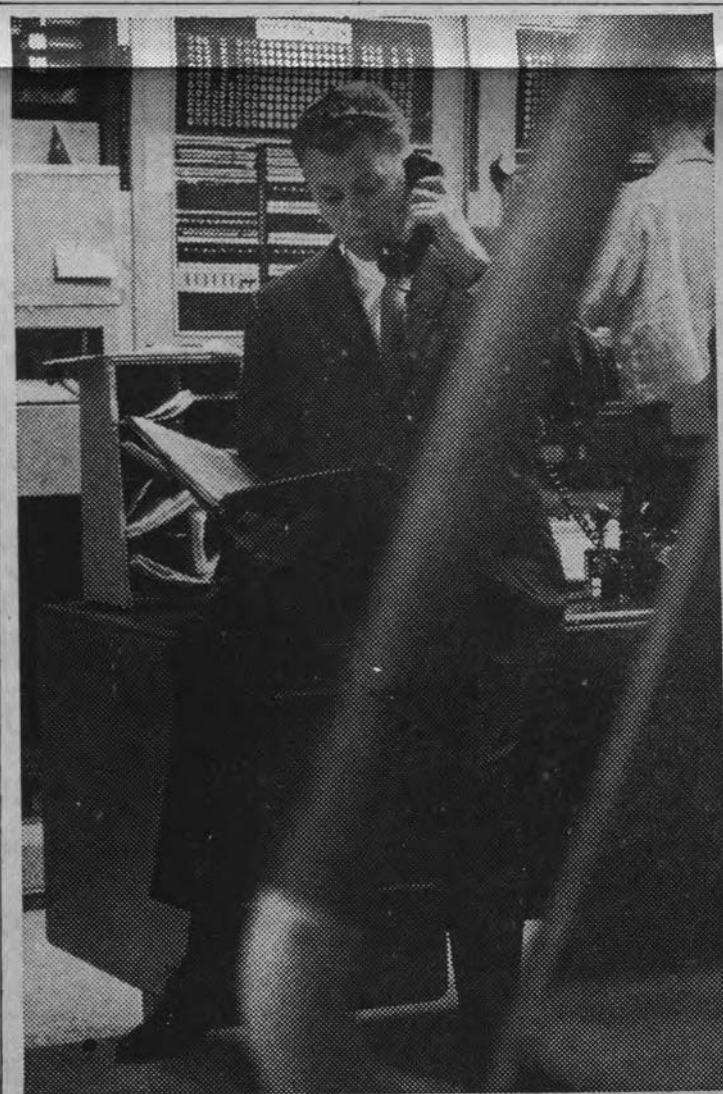

EDITORS NOTE:- We'll continue to publish the Madison American as far as wearing a sheet, I don't. Contrary to popular belief I am not a member of the Ku Klux Klan. I wrote about what I saw. Since then I have been an "eye witness" to other demonstrations, all of them were senseless and ugly. The police departments have been criticized by many for using "force" to break up the mobs. We don't know any other way for them to destroy a mob than to lock up the leaders and doing so there are going to be a few broken heads. Trying to appease a mob is a foolish thing, give them an inch and they'll soon want a yard. Most of the participants of the "mob riots" couldn't even read the Civil Rights Bill signed recently by the president, let alone understand it. Since writing the articles I have personally received over a score of tele-

phone calls that "I had better watch myself, white boy, cause we are coming to get you." Other callers "threaten to blow up my house." This is par for the course. We have little fear of telephone calls, because most of the callers haven't got the courage to show up at anytime. In the event that one or more should happen to show up they'll soon be martyrs for a cause which they wouldn't even understand, they'd leave town in a horizontal position.

The F.B.I. and other law enforcement agencies are investigating the recent out-breaks, they'll find out that they were inspired by Communists and other "world travelers."

If the negro feels that he isn't getting a fair shake out of life, then it is up to the negro to correct the situation. This isn't done by breaking up the joint, civil disobedience, throwing rocks at police officers. There wasn't a nationality that came to this country that wasn't discriminated against, the Irish, Polish, Slovaks, Jews, Italians, Japanese and Chinese all had their share of discrimination and hard-knocks. They studied, they worked and became accepted into the community, no one takes over a town by sheer force, the community accepts you. President Kennedy probably summed it up best of all "Ask not what your country can do for you, but rather what you can do for your country." This goes for the negro white, yellow, redman, that goes for every American.
