## "Missing Building Permits" Plays To Standing Room Only

Democrats and Republicans fought to a stand-off over the controversial building permit issue Monday night, as a standing room only crowd of partisans cheered their political teams on.

Meeting in special session for a report on the building permit question, the township council heard manager Paul H. Hermann declare that he has succeeded in establishing that about 100 of

the "missing" 131 building permits were paid for by builders in 1962 and 1963.

Hermann unloaded a political bombshell when he reported on October 19 that he was at "an

impasse" in trying to locate records proving that 131 homes constructed in those years had permits issued for them.

He reported Monday night that he had gone to the developers involved--the builders of Sayre Woods East and Pine Haven--and asked them for help in clearing up the discrepancies in building department records in 1962 and 1963.

He said he is satisfied that the builders paid for the permits in question, even if it is not possible to find records in the building department to prove this. He added that he was accusing no one of wrongdoing, but rather of "book-keeping errors."

Earlier, he had described the 1962 and 1963 building records as "a shambles." When Mayor Donald Macrae pressed him for an answer to the question, "Can you prove with the records you have that the permits were issued?" Hermann replied, "I'm sorry, I cannot. I can rely only on the outside records provided by the developers in this case."

But he emphasized that he is satisfied that the builders paid for their permits.

Attorney Harold Smith, former township attorney, was present representing the two former building inspectors for the years in question.

Smith said he was satisfied that no accusation of wrongdoing had been intended by Hermann and that the matter had finally been resolved.

But former township committeeman Joseph Hoff, who was defeated in his bid for re-election last November, was not so satisfied.

"Someone up there is lying," he charged, pointing his finger at the council. "You're trying to make political hay out of this."

As Hoff shouted his denunciation of the council, Mayor Donald Macrae rapped for order and asked the former township official to restrain himself.

Pointing his finger at Hoff, trying to our children is one of him traveling 90 m.p.h. on a highway and throwing beer cans out of the window. There is no firm policy of the present administration on foreign aid and no set program".

Deputy manager Joseph P. Leo stated, "Maybe someone out there is telling an untruth, but you're getting the straight facts from this council tonight."

"It is unfortunate for this community that certain political opportunists have tried to smear Mr. Hermann and throw partisan mud at him. In this building permit matter, Mr. Hermann has been doing the job he was asked to do by the township council."

As the meeting grew more unruly, Macrae cautioned the spectators that he would "tolerate no foolishness. You will behave civilized while you're attending this meeting, or the room will be cleared."

Former township committeeman Joseph Pandozzi, who also was defeated for re-election in November, raised his hand and shouted, "are you the mayor?" But Macrae had already assigned the floor to another speaker.

Annoyed, Pandozzi rose and said he was "disgusted with what's going on here." He returned and left the court-room, amidst cheers from his supporters and boos from the Republican contingent which lined the hall.

Macrae pleaded with the audience to avoid partisanship and halt the pre-election campaigning at township expense.

"We're here on serious business that affects the township. We don't need all this campaigning during this meeting," Macrae said.

As the meeting drew to a close, it was apparent that The Republican Councilman Kenneth H. Banks, who is seeking to retain his council seat in the coming election, had not been subjected to any attack at all. Most of the Democratic attack was launched at Macrae and at Hermann.

The feeling most common after the session drew to a halt was that both sides had fought each other to a standoff.

Democrats comforted themselves with the fact that they had satisfactorily cleared the good names of past Democratic officials. Republicans beamed over their charge of "sloppy book-keeping" in past administrations, making possible the fracas over the building permits.

The rally will be sponsored by the Madison Park Republican Club in support of Banks' bid to retain his council seat in the coming municipal council election.

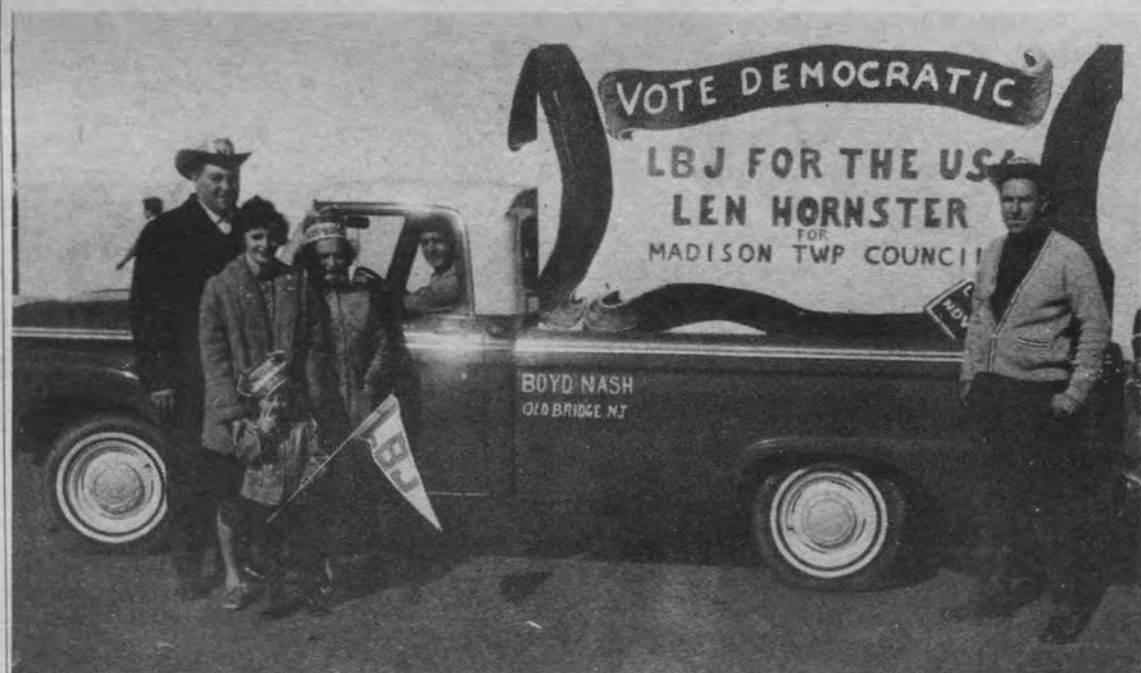
Republican county committeeman Kurt Resenhoft is coordinator for the rally.

**We Endorse Johnson**

On the most crucial issue facing Our Nation Today. . .so crucial that the future of our democracy may well depend on how it is met. We think that Mr. Goldwater is wrong. How to keep this country at peace in a dangerously complex, rapidly changing world.

Mr. Goldwater's supporters are displeased when he is accused of oversimplification. It seems clear to us, however, that Mr. Goldwater's approach to foreign policy is based on a world that doesn't exist--a world where everyone is either a friend or a foe, where the threat of military force will solve every problem, where one must either win or lose in every engagement.

We think the senator is dangerously eager for simple solutions. We deplore Communism as much as he and we admire his stand on Civil Rights, but we don't think ultimatums will intimidate our enemies or reassure our friends.

We don't doubt the senator's devotion to peace or the sincerity of his views. We do question the range of his knowledge and understanding of today's nuclear world.

President Johnson has continued the approach of his predecessors, whereas Mr. Goldwater would strike off in new directions. Without cheering everything the present administration has done or not done, we believe Mr. Johnson is on the right course. It is essentially the same course on foreign policy that Mr. Eisenhower and Mr. Kennedy steered before him, and it has been approved many times by Congress and therefore indirectly, by the people.

The choice must be made on the broader question of who is likely to provide the abler and wiser leadership for this nation. Mr. Johnson has made a good record in his short time in the White House. He has been energetic in dealing with domestic problems, he has been firm but prudent in foreign affairs and he has exhibited rare political ability in working with Congress.

We love to gamble, play cards, but we can not afford to gamble with our vote for President of the United States another time, another era Mr. Goldwater may have been right. With earth shaking events all around, with the recent shake up in Russia, with the exploding of the Chinese atom bomb, crude though it may be, we can not gamble.

We urge the residents of Our Township to vote for President Lyndon B. Johnson in his own words "A tragic twist of fateful sorrow made me President. From that awful day of November 22nd, when President Kennedy was assassinated, I have had but one thought, but one conviction, but one objective: To be the President of all the people, not just the rich, not just the well fed, not just the fortunate, but President of All America."

In my heart I know I'm right.

### Claims G.O.P. Building Surplus

John H. Conover, Independent Candidate for the one year unexpired term on Town Council, again scored the present administration and particularly his opponents for their failure to inform the public of all facts relative to the 48 per cent increase in local purpose taxes which included .87 cents per hundred of assessed valuation for the purpose of raising the senior citizen and veterans tax exemption. Conover charged that the 48 per cent tax increase was unnecessary and it appears to have been a deliberate scheme perpetrated by individuals in the local government who put political power and control first and the already hard pressed, taxpayer last. The Independent Candidate referred to the public statement of Frank Viafore, tax assessor, who stated the amount to be raised for tax exemptions at .87 per hundred per taxable homeowner would be \$225,000.00. Therefore, Conover said if \$225,000.00 equals .87 per hundred of valuation simply by dividing 87 cents into \$225,000.00 you will determine the

amount of monies the entire taxable township contributes at .01 (one cent) per hundred of assessed valuation which is \$2,586.00. Again, using simple arithmetic, we multiply \$2,586.00 by \$3.24 per hundred which is the total cost of local township taxes (\$2.37) and .87 exemption cost, we then determine the total amount of monies raised by taxation to run the local government, \$837,864.00.

Conover then pointed to the 1964 local municipal budget, which called for \$616,950.14 and said, if we are taxed for more monies then was needed to meet the budget which is quite apparent because figures do not lie, then what has happened is obvious-- there has been a SURPLUS CREATED, not accumulated but created and at the taxpayers expense approximately \$220,913.86 surplus. We are not only paying to receive our own tax exemption, if that isn't enough, but we have been used to enable this administration, particularly Mr. Banks, to predict a tax cut at our expense.

### Manager Orders Halt To Drain Work

Municipal manager Paul H. Hermann said today he has halted all work on drainage facilities and all road construction in the Heatherwood development, Route 9 and Ticetown Road.

His basis for action, in keeping with a report made to the municipal council Monday evening, was that the developer has been installing drainage pipes which do not conform with the plans approved by the planning board in 1963.

And he added that the developer had agreed to halt all road work pending a formal report from the township engineer on questions raised by the council Monday.

Hermann said he met with the

developer and with a representative of the developer's engineer firm yesterday.

"The engineering people retained by the developer have conceded that they are at fault in not having submitted proposed revisions in the drainage provisions prior to Monday afternoon.

"These revisions must be approved by the planning board before such work is undertaken, and since they were not approved, I have directed them to cease all work on drainage until they have approached the planning board for action."

Hermann also stated that special soil conditions at the development site may require extra stabilization to insure a good road. A report from the township engineer should clear up that question, he said.
