## NO MAJOR CHANGES ON TOWNSHIP COUNCIL G.O.P. Still Holds Control

Following the election and swearing in of Councilman Len Hornster of Cliffwood Beach the complexion of the Township Council has actually changed very little. The previous control of the Council was 5 Republicans and two Democrats, now there is a

4 - 3 split with the G.O.P. members still holding control.

Despite reports and rumors that if this one makes a deal with this one and this or that is accomplished the control will shift to the Democrats we feel that there will be little change on the

township council or the general arrangement of various department heads in the township.

There is little doubt that at the first of the year Mayor Donald Macrae will be renamed mayor. In November 1965 the control of the council will be up for grabs,

there will be four seats up for election.

At stake in the November 1965 election will be the seats now held by Vincent Cancelleri of Old Bridge, Victor O'Brien of Cheesequake, Harry Messenger of Madison Park and Len Hornster of Cliffwood Beach. In order to wrest control of the Township Council from the G.O.P. the Democrats must elect four members to the council.

In 1967, the seats belonging to Donald Macrae, Richard Dealy and Donald Tierney will be up for election, so that if the Democrats are unable to elect four in November 1965 they will not have another try at gaining control until 1967, which is a long way off.

One of the best ways to commit political suicide is for a elected official to cross over party lines and vote for a member of the opposition party. This practically would assure party disfavor and would mean the end of most political careers, especially on the local level.

Politics at its best is a business and voting for the opposition candidate for mayor would be a cardinal sin, that is not done in business and certainly not done in politics.

We certainly do see a tightening up and closer co-operation between the remaining members of the G.O.P. on the council, we don't see any major changes in the nature of the Township Council.

Macrae has been serving as Mayor for the past year and he has been able more or less to control the public portions of the meeting, he yields the gavel and can cut any argument short. Former Democratic members of the Township Committee voicing disagreement with policies etc., at the various meetings have come under the gavel of Mayor Macrae.

Attending various meetings in the township in most cases the Mayor or chairman of various public groups usually comes under the fire of residents making protests to the government. The mayor or chairman in most cases has to give the answers and most not only give an answer that cannot be challenged the following meeting.

We sincerely doubt that the G.O.P. has anyone at the present time on the council that could carry on the meetings as well as Mayor Macrae who is constantly under fire from various residents of the township.

There are many residents that attend the township council meetings because they believe they have legitimate complaints but as

have legitimate complaints but as election time draws near these are usually replaced by the hard core of politicians who attend the meetings for making political hay. If the Democrats are in control then the audience would be made up of a large portion of Republicans, if the G.O.P. has control of the council then the audience is comprised of mostly Democrats prior to the November election.

The mayor's seat in the past score of years has been a jinx seat to the majority of mayors. Leon Arrowsmith was actually the first mayor of Madison Township, he did not receive the support of the G.O.P. in the primary election. The next mayor was Walter Jurman. The Cheesequaker was a popular fellow but was defeated in his bid for reelection. Jurman was replaced by John Chamberlain. Chamberlain served as the mayor and when his term of office expired he was badly beaten in his re-election bid.

The next mayor was John Phillips, Phillips was elected to the Middlesex County Board of Freeholders and resigned as committeeman. John Keating of Old Bridge was named by the committee as his replacement. Keating was defeated in his bid for re-election.

True, there may be some changes made in the Sewerage Authority or Water Authority but basically the local government will remain unchanged.

The interesting part of the entire situation is that Democrats Victor O'Brien and Harry Messenger have voted for many of the ordinances and approvals sponsored by the G.O.P. Perhaps this will change now that he has additional support with the swearing in of Len Hornster but in any event it ought to be an interesting year.

Probably one of the first major issues will be the proposed budget for 1965. There will probably have to be made transfers in the 1964 budget where items were overexpended. Hornster has already publicly stated that he will not vote for any transfers, it will be interesting to see if the other two Democrats go along with his wishes. Messenger at the beginning of the 1964 year termed the budget too low. The Budget was prepared by Joseph Leo and was not defended by Paul Herman, Municipal Manager who stated at the budget hearing that he did not have enough time to study the proposed budget.

### Fulltime Engineer Needed Now

For the past several years the MADISON AMERICAN has been urging the Township Council to appoint a full-time engineer. During various political campaigns we have seen the appointed engineers come under political fire from both camps.

The recent case which was brought to light at a township meeting where a developer is alleged to have installed undersize drainage pipe is one example why the township council should employ a full time engineer.

The population of Madison Township is close to 30,000 residents, we are in the midst of a gigantic building boom. Hundreds of apartment houses will be built, several hundred houses will be constructed within the year. Everywhere you look Madison Township is expanding.

With the appointment of a full time engineer he would be responsible only to the residents of Madison Township. The engineer would be available for inspections, consultations and a host of other building items made necessary by the rapid expansion of Our Town.

The engineer on a full-time basis could be paid by various inspection fees now being collected by a part-time engineer. It could be quite possible that a full-time engineer with the co-operation of the Tax Assessor could complete the much voiced and argued tax map.

Not only would the present residents of Madison Township benefit by the appointment of a full-time engineer but future residents would also be assured that the drainage plans and other items would be installed as per agreements with the township planning board.

We flatly state with the money that we have spent this year and in the past to employ a part-time engineer, we could very well have employed a full-time engineer.

### Pay Increase For Special Police

Probably one of the most underpaid groups working in behalf of the residents of Our Town are the special police. These men haven't received an increase in pay since 1955.

The regular police department received a substantial pay increase on a referendum voted upon by the residents of the Township. The school crossing guards received an increase in pay by resolution of the committee.

Special Police in Madison Township are called upon to do the duties of regular police and yet their pay scale doesn't come anywhere near the hourly rate of Madison Township patrolmen.

It is about that time of the year where the various department heads are asking for money to run next year. We believe that the special police officers ought to receive an increase in pay. We urge the Township Council and the Business Manager to consider a pay increase for these dedicated men.

The Madison Township Kiwanis Club heard Doctor John Khouri, newly-installed Superintendent of Schools of Madison Township, discuss the topic: "Madison Township Schools -- Where do we go from Here?" at the weekly meeting held Tuesday, November 3 at the Turf Restaurant on Route 9. The Superintendent listed several areas wherein township educational problems lie.

He stated first - that there were three "certainties" facing residents: more developments, more children to be educated, more schoolrooms to be built and more teachers to be hired. Also, some sure probabilities are ahead for the community: expansion of split sessions coupled with some overcrowding (as negative forces) and improved curricula in elementary, secondary and adult education (as positive forces).

Dr. Khouri went on to state that improved curriculum measures must come in the form of the addition of high school work-experience programs, and a concerted effort on the part of schoolmen and the Board of Education in the area of community music programs library services and other "cultural" areas.

Finally, said Dr. Khouri, the educational improvement and implementation program he outlined would falter without "concerted action" by dedicated educators and citizens a "clear definition of problems" as various
