# You Can't Tell The Players Without A Scorecard

There's one more Democraton 7 the Madison Township Council, but the magic number at Monday night's council meeting was still five to two.

That's the vote by which Brentwood Apartments -- a 248 unit garden apartment development on Route 516 -- won approval at the council session, and it was a vote which saw party lines split in the first meeting of the council since the November 3 election.

Taking his council seat for the

cilman Kenneth H. Banks three weeks ago, Democrat Leonard Hornster sided against his two Democratic colleagues in his first key vote as a member of the council.

Councilman Harry Messenger and Victor O'Brien sided with three of the four Republican members of the council to guarantee approval for the apartment unit. Also voting for the project were Mayor Donald Macrae, and Councilmen Vincent Cancellieri and Richard J. Dealy, Jr. Only Republican Donald D. Tierney of Madison Park voted with Hornster against the approval. Tierney cited as his reason for the vote that he had "an option of voting "no" on any matter involving approval of a subdivision of land use referred to the council by the planning board."

Hornster gave no reason for his vote, but seconded Tierney's motion at first to deny the application and then, when that motion move by Cancellieri to grant approval. Mayor Macrae pressed both

had been defeated, voted no on a

councilmen to provide "a good reason for knocking this down. This property owner has com-plied with all township ordinances in his application. How can we deny him the right to use his property within the framework of the statutes?"

Attorney Henry Sevrin, representing Brentwood, insisted that approval had to be granted or the township would be subjected to legal action, since the planning board had voted approval and all ordinances were adhered to.

"Gentlemen if you don't vote to grant this approval, you will be violating your own ordinances as well as state statute," Sevrin informed the council.

Tierney countered that Sev-rin's client, Brentwood Apartments, had not received clearance from the township sewerage authority. Sevrin, in turn, produced a letter from the Sewerage Authority's consulting engineer. Charles F. Kupper, indicating acceptance of Brentwood's offer to comply with sewerage authority plans.

On the final vote, the majority of the council affirmed their belief that the council could not prevent approval of the apartment application.

In action on another planning board matter, the council unanimously voted approval of Cheese-quake Park Gardens for Senior Citizens, an apartment development restricted to residents 55 years or older. The council agreed that the project would be an improved ratable for the town-

Once again the Heatherwood Development located off Ticetown Road and Route 9 in the Browntown area of the Township came under the fire of Democratic Councilman Harry Messenger. Most of the disagreement came as a result of Messenger arguing with Assistant Manager Joseph Leo.

According to Leo's version of what happened on October 26. the Township Engineer Robert Baier came into the Manager's office with a set of plans which according to Baier were not the plans for storm drains called for in the Planning Board and Township. approvals. According to both Leo and Paul Hermann, who was later drawn into the argument, work on the project was stopped.

Following the meeting of Monday, October 26 the Heatherat a meeting of the Madison Township Planning Board, Mes-senger discussed what went on

at the Planning Board meeting and Leo's reply was "I wasn't there". Messenger at one point of the

discussion tried to insist that a recommendation from the former Township Engineer be presented. The Madison Park Democrat argued that the former engineers professional reputation was at stake. No action by the committee was authorized.

Messenger carried the battle on for the major part of the meeting.

Mayor Donald Macrae said "the people that are really getting hurt in this situation are a bunch of little guys like you and me, people that entered into contracts to move into their new homes. Macrae stated that he has received at least a score of telephone calls requesting aid from future residents of Our Town, some of their stories are pitiful, they are hard pressed and are at wits end. If something can be done to alleviate this situation the sooner the better, this council should make some attempt to get to the bottom of this gross situation, my heart

bleeds for these people.

Messenger replied "I feel sorry for them too, but if we allow this developer or any other developer to get away with anything then it will not only be the fellow that's moving into the township that will get hurt it will be all of the people of

Mrs. Jeanette McKelvey, Smida's secretary at Madison, presented a gift to the school head on behalf of all his well-wishers.



the prime factor in the recent election and will be the only person in the Democratic Party that can hold "it" together for the 1965 election. They feel that if Phillips drops out as chairman, too many potential chairmen will come forth and there will be knife wounds all over which couldn't possibly be healed in time for the November election. The Democrats have to take four seats in November to gain control. Up at stake are scores of political jobs and appointments.

POLICE DEPARTMENT: Rumor has it that the Madison Township Police Department will seek another pay raise. The way we get the story is that the police will ask that senior patrolmen would attain \$7,000 salary immediately. This would also mean that all higher ranking officers would also attain increases in salary. We don't feel that the police will get their demands but they probably will get a pay increase. We'd rather see additional patrolmen appointed to the police force than any pay increases at this time. With additional development coming into the township and apartment houses, additional police will be needed. You can move 1,000 persons into a Garden Apartment project overnight but it takes at least 6 months to train one police officer.

ROAD DEPARTMENT: We saw a youngster sticking his head in a drain opening in Sayre Woods South, then he was trying to climb down after his little plastic ball. Wouldn't it be possible to place some type of iron bar so that youngsters wouldn't be able to climb down into the drains. If a youngster ever gets caught down in one of the drains there might be a tragic ending to the story. We would suggest that the township municipal manager check with Middletown Township if our memory serves us right, they had similar problems.

SEWERAGE: Well the taxpayers suit was withdrawn against the Madison Township Sewerage Authority and work is supposed to start. We hope that they will hold up on any digging until early spring because we still feel that regardless of what the contractor says, the roads are going to take a beating and there will be lots of inconveniences caused the residents of Madison Park. A few more months wait won't hurt any one.

WATER, WATER, WATER: Well the Township Council of Madison and the Township Committee of Matawan have hired an attorney to represent them in their fight with the Cliffwood Water Company over rate increases. We still say that the water company will obtain a substantial rate increase. We still can't see why we needed an extra

attorney. We have a township attorney and the Madison Township Municipal Utilities also have an attorney. It is our opinion that these gentlemen could have handled the situation satisfactorily.

BOARD OF EDUCATION: Rumor has it that the Board of Education budget will be the highest in the history of the township. We predict that the budget will be defeated at the polls and any Board of Education member seeking re-election will be defeated. Every time you turn around some body connected with the school system is seeking and getting pay increases. It's got to be curtailed somewhere along the line.


