Banks Named Director of Water

Former Councilman Kenneth H, Banks was named executive director of the township water authority in a move last week which made complete the local Republican organization's decision to make major changes in the policies and direction of that body.

With the help of the lone Demlast week, the GOP members last week unseated Salvatore Salvo as chairman of the agency. Then, in a move later in the week, Salvo was also replaced as the authority's executive di-

Charles Searleski of Madison Park, the authority's newest member lent his vote to the "dump Salvo" move, but did not go so far as to support Banks for the executive director's slot. Banks was appointed to the part-time salaried post by a 3-2 vote, with Arthur Bottone, the authority's new chairman, and members George Doran and John Nesenkar voting yes.

Searleski and Salvo opposed Banks for the position. The form-

er councilman was hired by the authority on a trial basis at the salary of \$1,500 per year-a \$200 increase over the stipend offered last year. After the initial trial period, Banks may be permanently hired at the new salary of \$3,000.

Ironically, it was Salvo who led the fight to establish the new

salary for the director but he never was able to collect the new salary, in that his fellow authority members declined to support him for re-appointment to the post.

Banks was elected to the job after Salvo nominated councilman Donald D. Tierney for the job. The motion died for lack of a second. Then Searleski nominated former authority executive director William Lambert, a Democrat, for the post. That nomination also failed for lack of a second.

The move was widely regarded as a repudiation of the Tierney-Salvo-Dealy axis which has mounted opposition to the local leadership of Republican chairman Donald L. Borst.

Fire Report

Chief Frank Moscarello of the Cheesequake Independent Fire Company, Route 34, Cheesequake issued his monthly report for January.

According to the Chief the fire company answered 10 alarms and 91 man hours were put in by the various firemen responding to the votes to lead his slate. Newcomer Capelli garnered 1,908 votes with Lindley Higgins polling 1,733. All three won three year terms. Mrs. White scored with 1,913.

The losers were Robert Nixon with 1,196, Spiros Columbus with 1,194 and William Swiderski with 703.

Mrs. White ran against James Garland for the one year term. Garland wound up with 792 votes. Garland ran as an independent.

The budget won by a small majority. Current expenses wound up on top by 161 votes, 1,416 to 1,255. The other question on the ballot, land, buildings and equip-ment won by 127 votes, 1,398 to 1,271.

The heavy vote in Sayre Woods South was entirely responsible for the victorious four. The Laurence Harbor-Cliffwood Beach area, counted on heavily by the losers, did not turn out to vote as they did last year when they elected Richard Pine, Charles Thompson, Carol Kosobucki and Nixon. Last year a snow storm prior to the election kept the Sayre Woods South residents from the polls.

Rice captured four of the eleven election districts. Capelli was first in one district and Higgins, who failed to set the pace in any district, ran an even race in nearly all areas, Mrs. White took nearly all areas. Mrs. White took top honors in eight districts.

The campaign was marked by furious fighting between candidates of the two slates. Rice-Capelli-Higgins-White team were critical of the opposition, Charges and counter charges were made by each all the way down to the wire.

Garland split from his three

mates because he felt that he could not run with a fellow candidate he had previously teamed up with. He said that his philosophies differed with those of of his running mates.

This evidently hurt the Nixon-Columbus-Swiderski slate as did additional counter charges by Nixon which seemed to thoroughly confuse the voting public, especially in the Laurence Har-bor-Cliffwood Beach area.

Nearly 3,400 voters turned out for a record showing in a school board election.

Maresca cited the obligations of elected officials to "the party workers who have borne the battle," as well as to the electorate at large.

Continuing the parallel, Maresca said the local Republican Party could also learn much from the second inaugural address of Lincoln, after the war president and Johnson had been elected and sworn in.

Lincoln told his party and his nation to act "with malice towards none and with charity for all, with firmness in the right as God gives us to see the right."

One of the larger owners of property in Madison Township is presenting a proposal to the Madison Township Sewerage Authority to construct a sewer line in an area where presently there are no sewers.

Also tied in with the sewer line would be the immediate construction of a 50 acre industrial tract. We've heard plenty of offers from developers before but we believe that the proposed plan could be of great benefit to the residents of Cur Town, course they would also be helping the developer.

However, we justly feel that the various agencies involved such as the Township Council, Water Authority, Industrial Commission, and Sewerage Authority should at least sit down with the developer and by some good common old fashion "horse trading" come up with some sort of proposal or counter proposal in order to obtain Industry for Cur Town.

We feel that a meeting of this sort would be most beneficial to Our Township. At least listen to the proposal, it's quite possible that a good deal could be made to benefit Our Town.

Very Little Progress

Madison Township officials seem to be making very little headway in the fight to obtain better traffic safety conditions from the New Jersey State Highway Department.

About the only thing accomplished so far is a lot of promises and surveys. We get surveys and promises but very little else. The traffic safety problem is becoming more acute as each day passes. With additional traffic along the highways and increased population of the entire area the safety problem can only get worse.

There are traffic control problems on Route 9, Route 18, Route 35 and traffic on Route 34 is steadily increasing. Several years ago traffic on Route 34 was virtually nil in the winter time but take a look at the problem Route 34 has become a fairly busy highway and for most of the length in Our Township it is only two lanes wide.

Route 9 from the intersection of Route 34 to Route 18 is also a very dangerous two lane highway with some exceptions where the Route 516 overpass is. Several deaths have occured on Route 9 and still very little has been done by the state to eliminate the traffic hazard.

Years back when Route 9 was planned the State Highway Department obtained the necessary property to widen the highway to four lanes. The property has just been sitting there for all these years.

Some action should be taken immediately, perhaps the officials of Madison Township should "camp" on the doorstep of the Governor.

In January 1964, Sal Salvo was elected as chairman and executive director of an entirely reorganized water authority. This was decided because the Republicans won control of the Township Council in November 1963. Not one member of the previous authority was kept, although they had years of experience. The Authority under the direction of Salvo completed or continued under study those items started by the Authority under the direction of William Lambert. No new or major projects were developed, nor was any private water company negotiated for or pur-


chased. Still Salvo was able to secure a year of experience. Recently, three members of the Authority, under apparent orders from Republican bosses, de-

throned Salvo because of internal political reasons, and appointed a three time defeated Republican candidate Kenneth Banks, as executive director.

The members of the Authority who selected Banks even questioned his ability by cutting his salary and placing him on a three month probationary period.


