Final Touches On Shore Erosion Program

Madison Township put its finishing touches on the Laurence Harbor - Cliffwood Beach Shore Protection Program Monday night with the passage of a resolution authorizing the purchase of approximately seven acres adjacent to Paul's Beach in Laurence Harbor.

The Morgan Beach tract will cost the township \$98,000 the funds for which were allocated

two months ago in an ordinance providing for the floating of bonds or notes for the funds.

The figure of \$98,000 represented a negotiated settlement between the township and Sommer Brothers Construction Co., which had initially asked several hundred thousand dollars for the property. The purchase includes several hundred feet of riparian rights, off-shore from the beach

property, valued at several thousand dollars.

Municipal Manager Paul H. Hermann and Deputy Manager Joseph P. Leo stated the property acquired would be used for completion of the shore protection project in the Paul's Beach section. Work has already started on the project at the south end of the township's short front.

Only Councilman Donald D. Tierney opposed the move to finalize the shore program, arguing that more than one appraisal should have been sought by the Township. But Councilman Richard J. Dealy, Jr., countered that seeking additional appraisals would present the township with prohibitive additional costs and delay the project.

Dealy reminded Tierney that the figure of \$98,000 represented a negotiated settlement, based on the figures of a reputable appraiser.

Dealy was joined by Mayor Harry Messenger and Councilmen Donald Macrae and Vincent Cancellieri, Republicans, and Leonard Hornster and Victor O'Brien, Democrats, with passage of the resolution taking place with a six to one vote.

Also on the agenda Monday was approval of a transfer of the package liquor license of Elizabeth and Peter Condo from an earlier Englishtown Rd., Old Bridge, location to a new locale on Route 9, near Route 516.

Councilman Dealy and Tierney opposed the license transfer, Councilman Macrae absented himself from the proceedings, because he holds a license himself, and the remainder of the council voted approval of the resolution approving the transfer.

The move came after the council twice defeated efforts by Dealy and Tierney to defeat the

transfer and to delay the council's action on the move.

The council filled a vacancy on the sewerage authority with the appointment of Martin Fossetto. Fossetto replaces Samuel Bloom of Sayre Woods South, who resigned because of a change in the location of his employment. The term expires Jan. 31, 1966. The appointment came after Hornster, liaison to the sewerage authority, reported that authority chairman Samuel Clark had suggested Fossetto's name for the job.

The council also approved on second and final reading an ordinance upgrading the lumber and glass requirements in the township building code.

And the governing body voted approval of a variance granted by the board of adjustment permitting Midtown Properties, Inc. to construct an 18-hole golf course on Route 9.

Pandozzi Wins, Smith In Again

Joseph Pandozzi was re-named chairman of the Democratic Party despite an up-hill fight by Joseph Pettrissi of Laurence Harbor to unseat him.

Immediately following the nomination of Pandozzi, who had served as Democratic Municipal Chairman since January when John Phillips resigned as party leader, named Harold G. Smith as attorney to the county committee. Smith had served as Municipal Attorney under various

Pandozzi's strength was quite evident as his forces swept in all other posts on the County Committee. Also elected was Mrs. Mary Brown, Township Clerk, by a 28-20 vote over Ann Redd of Old Bridge for Vice Chairlady. Mrs. Brown often referred to as the Queen of the Democratic Party in Madison Township is well known in political circles in Middlesex County. She has served as vice-chairlady for many years.

Jean Danton of Old Bridge defeated Sayre Woods South Committeewoman Dorothy Nemschick by a 27-21 vote.

Thomas Durney defeated David Watson and Phillip Romeo 26 to 15 to 7 for treasurer.

Theresa Metzger defeated Mrs. Dorothy Nemschick by a 25-23 vote for Recording Secretary. Nemschick had served as recording secretary last year. Mrs. Metzger is new to the county committee.

Brownie Lauer of Laurence Harbor soundly defeated Cecil Patton of Old Bridge 17-11 for sgt-at-arms. Lauer has worked in the Democratic Organization for many years and was a close supporter of the late Walter Stagger who served briefly as Municipal Chairman.

Pandozzi stated that he considered the primary election results as a vote of confidence and vindication for the leadership of the Democratic Party and said that he would hold an "open door" policy to all in the party and asked for their cooperation and support in the future.

Joseph Pettrizzo who was defeated by Pandozzi refused a request to make the vote unanimous. He declared "that he was 100% against Pandozzi."

Pointless Opposition

We fail to see what possible good was gained for the township by Councilman Donald Tierney's efforts on Monday night to block the final moves in the shore protection project.

Tierney's only argument against the property acquisition authorized by the council was that more appraisals should have been sought by the township before settling on a price. But even Tierney's constant companion and voting-partner-in-politics, Richard Dealy stated that more appraisals would cost the township more money and only delay a sorely needed project.

Could it be that Tierney's action reflects the contemptuous attitude of so many of his supporters -- the so-called "good government" Republicans, who would just as soon see Laurence Harbor float out into the bay?

The sectionalism which we saw reflected in the "good government" Republican campaign during the past primary election was not at all a good thing for Madison Township. We can never progress so long as one section -- such as Sayre Woods South -- or Central Park -- or Madison Park -- seeks to prevent any other section from securing just solutions to their local problems.

We wonder how Tierney's stand on the Shore Program will affect the candidacy in Laurence Harbor and Cliffwood Beach of Tierney's GOP candidates for council.

They say the voters of Laurence Harbor have long memories. WE say Tierney's move was pointless opposition and very bad politics.

Trooper Youth Week Set

The first annual TROOPER YOUTH WEEK will be held at the New Jersey Police Academy, Sea Girt, June 28 through July 3, according to an announcement made today by Colonel D. B. Kelly, State Police Superintendent.

Fifty eleventh-grade boys, two from public schools in each county and two from parochial schools in each diocese, were selected by school authorities on the basis of character, scholarship, and physical ability. Those selected to participate in this pilot program will attend a full week of simulated police training at the academy.

The fast-moving program of lectures, films, demonstrations and practical exercises parallels the academic and physical training required in the preparation for a law enforcement career. High spot of the week will be a field trip to Division Headquarters in West Trenton. There, the boys will see a State Police class in training and tour the headquarters' sections and the State Bureau of Identification. This unique educational experience is

designed to provide a better understanding of the function of law enforcement in our free society.

Governor Richard J. Hughes will be the principal speaker at formal graduation exercises to be held at the Spring Lake Community House, on Saturday, July 3. The ceremonies will include the presentation of awards to Troopers who have distinguished themselves in the line of duty during the year.

Commenting on the program, which was conceived as an experiment in understanding, Colonel Kelly said, "I am extremely pleased with the enthusiastic response that we have received from all concerned and particularly grateful to Governor Hughes for his interest in the program from its very beginning. I am sure that the boys will benefit by their experience and, equally important, will be able to convey something of value to their fellow students as they prepare to assume the responsibilities of adult citizenship."

Commended

The physical education department of the Madison Township Board of Education has been commended by the Rutgers University teacher training division for the program practiced by the local school system in instructing its students in physical training procedure. Al Colacichi and Jean Sadenwater, respective heads of the boys and girls physical education curriculum, were especially singled out by Rutgers officials for "their meritorious conduct" of classes in physical education.

This observation was made during the past several weeks of experimentation in styles of teaching physical education. Rutgers students who participated in the experiment found out the real meaning of the discovery process, problem solving and individual programming, according to the university officials.

"It was most gratifying to work with a school that did not fear a new idea and that would not reject the spirit of experimentation," said a state university professor. The college professor also stated that often great ideas emerge in universities and in the minds of scholars and researchers but not too often do they seep to the level of the public schools so that children and teachers could benefit from changing ideas and current contributions.

The college professor said that it was different at Madison where so much was gained by the weeks long experimental period. He also lauded Dr. John W. Khouri, superintendent of schools, Albert Jacobs, principal, and Evelyn Ogden of the staff, for their aid in the experiment "in which we have learned so much."

Dem Meeting Held

AN ORDINANCE TO AMEND AND SUPPLEMENT AN ORDINANCE ENTITLED, "AN ORDINANCE TO ADOPT THE NATIONAL BUILDING CODE 1949 EDITION RECOMMENDED BY THE NATIONAL BOARD OF FIRE UNDERWRITERS AS THE BUILDING CODE OF THE TOWNSHIP OF MADISON" ADOPTED ON FINAL READING JUNE 20, 1955, AS AMENDED.

BE IT ORDAINED by the Township Council of the Township of Madison, County of Middlesex, New Jersey:

1. That Section 2 of "AN ORDINANCE TO AMEND AND SUPPLEMENT AN ORDINANCE ENTITLED, "AN ORDINANCE TO ADOPT THE NATIONAL BUILDING CODE 1949 EDITION RECOMMENDED BY THE NATIONAL BOARD OF FIRE UNDERWRITERS AS THE BUILDING CODE OF THE TOWNSHIP OF MADISON" ADOPTED ON FINAL READING JUNE 20, 1955, AS AMENDED," adopted on final reading February 1st, 1965, is hereby amended to read as follows:

2. That the above entitled Ordinance be and is hereby further amended to add the following:

All lumber must meet F.H.A. requirements as shown on page 57 Section 705-1.5 in the F.H.A. code and will include table 7-4 as follows:

705-1.5 Wall Framing*

A. Lumber for exterior wall and partition framing shall be of a grade suitable for the intended use. Framing lumber of any softwood species may be used provided members have sufficient strength and rigidity to support the design load and are suitable for the attachment of wall finish materials.

B. Conventional wall framing methods, such as described in these standards, will require framing members to be at least the grade indicated in Table 7-4. Grades lower than those shown in Table 7-4, may be permitted for blocking, cripples, etc., and for non-bearing partition framing or exterior wall framing supporting roof and ceiling only, provided any serious defects are removed which would make the members unsuitable for the specific use.

C. Special wall framing methods shall be designed in accordance with standard engineering practice using the design criteria contained in Appendix A.

3. That the above entitled Ordinance be and is further amended to add the following:

All glass must meet F.H.A. minimum property standards for one and two living units as shown in the F.H.A. code page 66a, Section 711-2, 711-4.1, and 711.5, set forth more particularly as follows:

711-2.1 Each installed pane in windows and doors shall be appropriately labeled. The label shall show the name of glass manufacturer and quality and nominal thickness of glass.

711-2.2 Insulating glass shall be similarly labeled with fabricator's name.

711-2.3 Tempered or laminated glass shall be permanently labeled in lower corner. The label shall be visible when installed and show the manufacturer's (temperer's or laminator's name, type of glass and nominal thickness.

711-4.1 The area, thickness and type of glass used in exterior prime or storm doors, including sliding glass doors, shall be determined as follows:

(a) Single strength glass may be used when:

- (1) area of pane is not more than 6 sq. ft.
- (2) glass is not less than 10 inches above the floor, and
- (3) short dimension of each pane is is not more than 15 inches.

(b) Double strength glass shall be used when:

- (1) area of pane is not more than 6 sq. ft.
- (2) glass is not less than 18 inches above the floor, and
- (3) horizontal muntins or exterior and interior bars supported on stiles are located 34 inches above floor.

(c) At least 3/16 inch tempered glass shall be used when:

- (1) area of pane is more than 6 sq. ft.
- (2) glass is not less than 18 inches above the floor, and
- (3) horizontal muntins or exterior and interior bars supported on stiles are located 43 inches above floor.

(d) At least 7/32 inch tempered glass shall be used when:

- (1) area of pane is more than 6 sq. ft.
- (2) glass is less than 18 inches above the floor, and
- (3) horizontal muntins or exterior and interior bars supported on stiles are located 34 inches above floor.

(e) Safety glass shall be used when:

- (1) area of pane is more than 6 sq. ft.
- (2) glass is less than 18 inches above floor, and
- (3) horizontal muntins or bars are omitted.

(f) Safety glass shall be used in fixed panel of sliding door assemblies.

711-5 Shower or tub enclosures
When glass doors or walls are installed in shower stalls or tub enclosures, they shall be safety glass. Minimum thickness, same as safety glass for doors.

This Ordinance shall take effect immediately after final passage and publication according to law.

Choose Fried Chicken For Picnic-Time Treat



Pack cracker-crust fried chicken in your summer picnic basket for a deliciously different feast! What makes this chicken unusual is its gently spiced jacket of thin saltine crackers, ground ginger, garlic salt and paprika. You can cook it the day before the big outing, and keep it wrapped in foil in the refrigerator. Take along a cool beverage, potato salad, fresh fruit and cookies and have a happy day. Here's how to prepare the chicken:

With blender or with rolling pin, crush crackers into fine crumbs between sheets of waxed paper. Mix with ginger, garlic salt, salt and paprika; divide onto 2 squares of waxed paper. In a pie plate, beat eggs well with milk. Roll chicken pieces in crumb mixture, then in egg mixture and again in crumbs. Place in shallow pan, skin side up. Drizzle with melted shortening. Bake in moderate oven (350°F.) for 45 minutes, or until done. Cool and refrigerate until picnic-time. Yield: 4 servings.

New Shortcake -- Berries Royale
