
TAKE FIVE REV. JAMES SILVER

Madison Personnel Ordinance Approved

The four Republicans on the township council voted together Monday night to enact a personnel ordinance granting job security of a sort to the current municipal employees.

The measure was opposed by the Democratic minority, although they had voted in favor of the ordinance on first reading a few weeks ago.

Councilman Submitted

Donald Macrae, the new personnel measure stipulates the reasons for dismissal of employees and protects municipal workers from political pressures or firings as a result of political disagreements.

The move was widely interpreted as an effort to protect the current office staff--of which many members are Republican Party officials-from partisan

The three Democratic mem-bers of the council, Mayor Harry Messenger, and Councilmen Leonard Hornster and Victor O'Brien voted against the measure--but did not elaborate on the reasons for their vote.

It has been understood, however, that, with or without

That state statute, which governs the council-manager form of government, places all responsibility for hiring and firing in the hands of the municipal manager, and specifically excludes members of the council from attempting to influence hiring and firing policies of the manager.

Municipal Manager Paul H. Hermann has informed the township, in response to questions posed at a meeting of the council recently, that he expects "no mass turnover of personnel" after January 1.

Throughout the township, there has been a degree of confusion concerning the status of municipal employees when the Democrats take control of the council in the new year. Under the old Township Committee form of government, employees were hired only for one year, with terms expiring December 31 of

New Industry

The Madison Township Industrial Commission announced plans for the Alexander Research Corp. to locate in Madison Township on a ten acre tract adjacent to the tract to be occupied by Food Additives Inc., on Water Works Road.

The Alexander Research Corp. is a stock corporation engaged in the manufacture of glycerin and glycol material, used as a base for brake fluid and antifreeze, via a closed system. They plan to conduct their operations in a 15,000 square ft.

Then, as the governing body would reorganize, the new majority would pass a resolution hiring or re-hiring the personnel who would administer the township's business in the coming year.

However, under the Faulkner Act, the municipal employees hired by the manager serve at his pleasure, and therefore do not require re-appointment each This factor could mean some disappointments for Democractic workers who have interpreted the recent Democratic Council victory to mean that there will be a rash

of new jobs available.
In apparent retaliation against Hermann for his position on hiring and firing practices, municipal chairman Joseph Pandozzi last week placed an advertisement in the New York Times, seeking applications for the post of municipal manager. However, as Hermann has pointed out, the hiring and firing of em-ployees "promiscuously" is something which even a newlyinstalled manager could not undertake under the provisions of the Faulkner Act.

Vincent Fox, Publicity Director of the Madison Town-ship Industrial Commission praised the efforts of all bodies of government for their aid in bringing the ratables to Madison Township, and said outstanding aid was rendered by Councilman Don Macrae, Leonard Hornster, Mrs. Ruth Crawford, and Mrs. J. AN ORDINANCE REGULATING THE INSPECTION OF SEWER LINES IN GARDEN APARTMENT DE-VELOPMENTS AND ESTABLISH-ING INSPECTION FEES TO BE CHARGED.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL FOR THE TOWNSHIP OF MADISON, COUNTY OF MIDDLESEX, NEW JERSEY: Section 1.

After installation, no sanitary sewer line which runs from the curb to the laterals which extend five feet beyond the basement of buildings in Garden Apartment developments in the township shall be covered over until such lines have been inspected, found satis-factory, and approved by the plumbing inspector, or his agents, servants or employees. Section 2.

Section 2.

To defray the expense of such inspection, a charge amounting to seven per cent (7%) of the estimated cost of each sewer installation, for each inspection, shall be charged to the builder. The estimate of cost shall be made by the engineer employed by the Madison Township Sewerage Authority at the time of the inspection. Section 3.

All fees, penalties, and moneys col-lected under any provisions of this ordinance shall be paid to the trea-surer of the municipality.

Section 4.
All ordinances and parts of ordinances inconsistent with any of the provisions of this ordinance are hereby repealed to the extent of such inconsistency. Section 5.

In the event that any section, sentence or clause of this ordinance shall be declared unconstitutional by a Court of competent jurisdiction, such declaration shall not in any manner prejudice the enforcement of the remaining provisions.

AN ORDINANCE ESTABLISHING PERSONNEL POLICY, PRACTICES AND REGULATIONS OF THE TOWNSHIP OF MADISON, MIDDLE-SEX COUNTY, NEW JERSEY.
Be it ordained by the Township Coun-

cil of the Township of Madison in the County of Middlesex.

1. Declaration of Policy
The Council does hereby declare th following principles to constitute the personnel policy of the Township;

(a) Employment in the Township government shall be based on merit

and fitness free of personal and political considerations.

(b) Just and equitable incentives and conditions shall be established and maintained in order to promote efficiency and economy in the operation of the

Township government.

(c) Positions with similar duties and responsibilities shall be classified and compensated on a uniform

(d) Appointments, promotions and other personnel actions requiring the applications of the merit principle shall be based on systematic rests and evaluations of knowledge and performance.

(e) Every effort shall be made to

stimulate high morale by fair admin-istration of this ordinance, and by consideration of the rights and interests of employees, consistent with the best interest of the public and the Town-

ship,

(f) Continuity of employment shall be subject to good behavior, satisfactory performance of work, necessity for the performance of work, and availability of funds.
2. Power of Appointment

All employees, officers and depart-ment heads of the Township shall be appointed and promoted by the Town-ship Manager, except where the powerso

appoint rests with other Township Boards or bodies as provided for herein or by general law or ordinance.
3. Probationary Period: Right of Sus-pension or Dismissal

(a) Each new employee shall serve

a probationary period of six (6) months. If, at the end of 6 months the probationary employee shall have been deemed to have successfully completed his probationary period by means of writ-ten recommendation by the department head and the Municipal Manager, the employee shall be granted status as a regular employee with all rights and regular employee with all rights and privileges pertaining to his employment or position. If, however, at the conclusion of his probationary period, the employee shall not have been deemed to have successfully completed his probationary period he shall be dismissed. Nothing contained in this ordinance shall be construed to probability the suspension be construed to prohibit the suspension or dismissal of a probationary employee at any time during his probationary period if in the best interests of the Township.

(b) Each new police officer shall be required to satisfactorily complete a basic police training program recognized by the New Jersey Police Training Commission prior to receiving a permanent appointment.

Permanent Employment Status after Satisfactory Completion of Probationary Period: Ground and Manner of Removal Employees who satisfactorily complete their probationary period shall have permanent employment status, conditioned upon good behavior and satisfactory job performance, and where required by status, continued residence in the Township. They shall be subject to removal by the appointing authority only for cause or for reason of economy, 5. Types of Separation

5. Types of Separation
Employees who have acquired perman-

ent employment status, as provided in Section 3, may be temporarily suspended from the Township's employ by layoff or suspension, or permanently separated by resignation, dismissing as more by resignation or dismissal, as more particularly set forth in this article, 6. Layoff

Whenever there is a lack of work or a lack of funds requiring a reduction in the number of employees in a department of the Township government, the required reductions shall be made in such job reductions shall be made in such job classification or classifications as the Township Council may designate in consulting with the department head. Employees shall be laid off in the inverse order of their length of service. Within each affected job class, all temporary employees shall be laid off before probationary employees, and all probationary employees, and all probationary employees shall be laid off before any permanent employee. Employees so affected shall be given a minimum of 2 weeks notice or 2 weks pay in lieu thereof. pay in lieu thereof. 7. Resignation

(a) An employee may resign from his position by tendering a written resignation to his department head, who, in turn, shall forward it to the Municipal Manager. Unless there are cipal Manager. Unless there are disciplinary charges pending against the employee, the Municipal Manager shall notify the employee in writing the acceptance of his resignation in good standing. An employee shall give a minimum of 2 weeks notice before the effective date of his resignation. Failure to do so may result in loss of vacation and sick credits.

((b) An employee will be required to resign if during the course of his employment, he becomes a candidate for municiple office, 8. Dismissal or Demotion

A permanent employee may be dismissed from the service or demoted for cause. The causes sufficient for removal from the service shall include

S. 40-47-3, as amended;

(d) Insubordination or serious breach of discipline;

(a) The Municipal Manager may, when in his opinion, the circumstances surrounding disciplinary charges pending against a permanent employee are sufficiently serious, temporarily suspend such employee until final decision is reached, unless otherwise

(b) When, in the judgement of the Municipal Manager, any employee's work performance or conduct justifies disciplinary action short of dismissal, the employee may be suspended in Iteu of dismissal without pay for a period not exceeding 10 working days, unless otherwise provided in State statute.





Borst's plan for eliminating the entire concept of garden apartments from the zoning ordinance came as a result of the planning board's feeling that "sufficient number of apartment units have been approved by the township to permit an appraisal of the value of such ratables to the municipality."

There has already been a rash of reports and studies submitted to the township indicating that garden apartments constitute an township.

It had been anticipated that the Democrat minority might bolt the apartment ordinance, holding out for Messenger's plan; however, when the chips were down, with the mayor in the lead, all three Democrats joined the GOP majority to vote approval of the measure.

The township has approved a total of 4100 apartment units during the past few years, but all will not be constructed for at least several more years.
