Much later came the famous dispute over plumbing inspections and the installation of clean-out plugs. In the less than two years of his sentence, Manager Paul Hermann had no easy time of it.

According to the Faulkner Act the manager can only be dismissed for certain reasons and the Democrats had already prepared the reasons they charged that Hermann failed to enforce the building and plumbing regulations in the township-that he involved himself in controversies which brought bad publicity and embarrassment to the members of the Township Council and that he had failed to work harmoniously with the township as a whole.

The vote was along party lines with the Democrats in favor of dismissal.

The Democrats also moved for the appointment of a Finance Director and named John Barbomembers of the council questioned the appointment and wanted to know what he looked like, what were his qualifications. Councilman Donald Tierney wanted to know if the man was in the room and asked that he stand up. Barbalegato stood up and was introduced.

The following day the newly appointed Finanace Director presented Deputy Manager Joseph Leo with his "pink slip," he then appointed Mary M. Brown, the township clerk as the acting manager and held a meeting with the various heads of departments in the Township.

According to the Faulkner Act, Hermann had a right to appeal the entire affair. We spoke to Mr. Hermann recently in regards to a Public Hearing, the former manager who was suffering from a heavy cold or virus stated there are many people who would like to see me appeal their case for them but I won't fight the council-they have acted and nothing that I could do or say would make much difference the move was purely political and I will not fight the council-I shall seek employment elsewhere.'

It is rumored that Hermann is seeking the post of manager in nearby Matawan Township.

So it appeared that London Bridges were certainly falling down in Madison Township, However, we are certainly glad that Madison Township is governed under the Faulkner Act-this keeps politics out of the office of the Business Manager.

Melvin M. Roessler, candidate | for a three year term on the Madison Township Board of Education, attacked Mrs. Frances White's voting record during her one year term on the Board, and accused her of "perpetrating a fraud on the intelligence of the voters by campaigning on a platform that her voting record negates."

In a r speeches before PTA groups" Roessler said, "Mrs. White stated she is in favor of expanding free transportation to every section of the Township where a hazardous problem exists. However, Mrs. White's voting record does not substantiate her platform. On September 9th and again on September 14, 1965, Mrs. White voted against providing free transportation for Laurence Harbor and Clifford Beach. Mr. Kerr voted for providing this free transportation. It was only after a school boycott and picketing of the school by distraught parents, worrying over the safety of their children, that the BEC-majority faction of the Board saw the wisdom of Mr. Kerr's stand and granted free transportation to this area."

On November 30, 1965 a letter was received from the Willis School P.T.A. asking for free transportation along hazardous Englishtown Road. Since receipt of this letter, no action has been taken by the White-Rice-BEC Controlled Board,
