# Voters "Cool" School Budget- Heavily Defeated

went to the polls in the annual school board elections and once again soundly let it be known that the operating budget for the coming year was too high. The voters soundly trounced the proposed figures of \$3,767,758 in current expense and \$175,900 for land, buildings and equipment.

The margin of defeat was almost two to one. Also losing was the land acquisition question for new schools amounting to \$138,657 for parcels of property along Route 516 in the Cedar Grove section of Madison. The margin of defeat was similar in this proposal.

The budget will go before the voters for a second time prior to

February . No revision down is expected and if it loses a second time then it goes to the Madison Township Council for review and a cut in funds. How much of a cut is in store once the councilmen apply the knife is unknown at this time.

Individual board members elected were Mrs. Frances White of Central Park, Donald Bates of Sayre Woods South and veteran board member William Kerr of Laurence Harbor. Mrs. White and Bates were backed by the Better Education Committee, an organization which once again made its strength felt. The core of the group is made up of Sayre Woods South residents. Kerr was the only candidate to win who did not have the BEC backing.

The budget and land acquisition questions only passed in the Sayre Woods South areas. This was not enough to buck the rest of the township.

Laurence Harbor and Cliffwood Beach residents voted 591 to 51 against the budget and like amounts against the land acquisition. The budget also lost heavily in the old areas of Old Bridge, Madison Park, Cheesequake, Browntown and elsewhere.

Kerr's third place finish for

the third seat on the board edged out William Staples of Madison Park by a little over 30 votes. Following the victors were Jack Rose and Melvin Roessler of Old Bridge, Philip Maresca of Cen-tral Park and Jerome Goldberg of Pinehaven. Goldberg and Maresca were the only independents in the race.

Many problems face the new board when it reorganizes next Monday. With the influx of apartment dwellers and new house owners in all parts of town, the spectre of split sessions loom in the not too distant future. Staff members, especially principals, now want increases in pay and operating expenses are on the

The present board is now composed of old members, William Rice, Joseph Capelli, Carol Kosobicki, Lindley Higgins, Charles Thompson and Richard Pine.

Thompson handed in his resignation with a stipulation a short time ago. The majority of the board accepted it. Thompson now wishes to withdraw the resignation. He said that he will take his case to the courts if the board decides to go along with its acceptance.

#### Board Should Reduce School Budget

The voters of Our Town handed the members of the Madison Township Board of Education a very strong mandate when they turned out to the polls on Tuesday. The questions on the budget and acquisition of land were soundly defeated by an almost 2-1 vote.

The Board of Education should be able to reduce the budget by approximately \$500,000, we doubt whether they will even reduce the \$5.6 million monster appropriation by even one cent. If past performances of the Board of Education establish any sort of a pattern, then the Board will just resubmit the same budget

Residents of Madison Township are willing to pay for the education of their children, they are however unwilling to be "hood-winked" into buying a "pig in the poke." Perhaps the Madison Township Board of Education should ask the Franklin Township Board of Education to help them with our budget. There are 11 schools in Franklin Township, a Junior High School and High School the system is slightly larger than the Madison Township System and yet the budget which was approved was just over the \$4 million dollar mark. In our Town the school board was asking for over \$5.6 million dollars.

Something must be wrong somewhere. If the Board of Education has the audacity to represent the same budget to the voters of Madison Township, then the voters should again turn out to the polls and really defeat the proposed budget. We feel that the residents of the Township have made their wishes known and the Board of Education should trim the budget by at least \$500,000.

#### Congratulations

Our sincere congratulations to the State Highway Department. We see where they have finally removed the broken down snow fence on Route 9 near the intersection of Ernston Road, and replaced it with a brand new cyclone fence (this was after we pointed out the condition in the Madison American).


#### What Ever Happened To Ernston Road??
