Plumbing Inspector Eugene Hulse of Laurence Harbor was earlier "suspended" from his job. A trio of police led by Police Chief Charles Boice removed the records from the Plumbing Inspectors files and

Hulse was notified in writing by the Acting Manager that he was "suspended" from his duties pending an investigation of his records.

The changeover in some of the personnel is remindful of the G.O.P. gaining control of the Township Council in January, 1963. The 'G.O.P. majority on the council appointed Frank Viafora as Township Tax Assessor, they replaced David Watson of Laurence Harbor and abolished the full time job making the tax collector Thomas English on a part-time basis.

The Republican majority also replaced many of the Building Inspectors and the Plumbing Inspector.

There is presently a mute question as to whether the Acting Manager can legally fire some of the personnel. It is understood as of this writing that at least one of the persons fired by the acting manager will try to get a court decision upsetting the action of the acting manager.

In another aspect of the Democratic Control on the Township Council the Democrats led by Mayor Harry Messenger unseated John Mullane of South Amboy. In December the then

Mullane to fill the position of Township Magistrate replacing Samuel Sladkus. The Democrats then voted that the appointment was believed to be illegal and appointed Samuel Sladkus as the magistrate. Mullane has since taken the problem to the courts to determine whether the appointment he received was legal or not. The courts appointed John Everrit of South Amboy to serve as Acting Magistrate until a legal opinion of the situation is made.

The situation is getting more confusing every day, at the present time the Acting Manager has not relieved any of the clerks in any of the offices from their jobs, many feel that most of the workers in the Municipal Building will keep their present jobs.

Prior to the first of January the G.O.P. controlled council voted along party lines to pass a Personnel Ordinance. One of the first things that the Democratic controlled council moved on was an ordinance abolishing the Personnel Ordinance. There has been no talk in regards to adoption of a similar ordinance on the part of the Democrats.

Board Reorganization Meeting Held

Last Monday was St. Valentine's Day but you would never know it if you attended the annual reorganization meeting of the Madison Township Board of Education, During the hectic session no love was shown for Charles Thompson who was unceremoniously dumped from his seat as a Board of Education member. He was elected two years ago when he successfully ran for the post with his onetime friend, Mrs. Carol Delbasco Kosobucki.

Last December Thompson submitted a letter to the board which was accepted by the body as his resignation. There was a stipulation in the letter which was handed to the board on Dec. 9, stating that he would resign providing that his seat would be filled by the electorate. At that rime the board accepted the resignation with no strings attached and upon the advice of the board's attorney, Alfred Hill, who said that the resignation was not conditional and that it was binding.

Thompson later decided to withdraw the resignation but Hill said that since the resignation was accepted by the board Thompson could not withdraw the resignation.

At Monday night's meeting a letter was read which had been sent by Thompson to the State Department of Education, outlining the original letter of resignation and reviewing the events of the past two months. In the letter Thompson further stated that he was asking the state officials to uphold his "right" to the board seat.

Thompson promised to pursue his "right" to his seat in the courts. It is expected that he will start proceedings very soon.

The reorganization meeting was fraught with tension throughout the evening. Acting Board Secretary Lindley Higgins who conducted the meeting before the seating of the new board silenced Thompson with repeated gavel poundings. Arguments were the order of the evening with Thompson and William Kerr on one side and most of the balance of the board on the otherside. Charges and counter-charges were hurled back and forth.

Kerr was the only member of the board who voted against Thompson's ouster. William Rice made the motion to unseat Thompson and Mrs. Kosobucki moved that Thompson's vote be stricken from the record.

Inducted as new board members were Donald Bates of Sayre Woods South, Mrs. Francis White of Central Park and Kerr from Laurence Harbor.

In addition to Bates, Sayre Woods South now has three members, the other two are Rice and Higgins. Cheesequake is represented by Richard Pine and Mrs. Kosobucki. Joseph Capelli is from Browntown. Thompson's seat will be selected by a board

Following the induction of the three election winners, Rice was elected president and Mrs. Kosobucki, vice president.

Vote No Wednesday

On Wednesday, February 23 the residents of Madison Township will have the opportunity to once again vote on the gigantic School Budget. The local Board of Education made quite a bit of fuss about reducing the budget. This reduction was a slap in the face to the voters of Madison Township who turned out and defeated the budget by an almost two to one vote.

The Board by some fancy figuring came up with some \$46,000 which they suddenly found as surplus money. They removed from the referendum a tractor which was supposed to cost another \$5,000. Then by some slight of hand they reduced the \$5.6 million dollar budget by a little over \$100,000.

Supporters of the budget point out teachers raises as the reason for supporting this gigantic budget. The Madison American has never been against teachers salaries, we are against loading of a budget and then blaming it on increase in teachers accounts. If the money that is listed in this gigantic budget as OTHEREXPENSES was explained, if purchase of buses, the hiring of additional drivers, was explained we don't think that anyone in Madison Township would be against the Budget. However --Township residents don't want to buy a pig in the poke--As the old Chinese proverb goes "Figures don't lie--but liars can figure." We urge that the residents of the Township vote NO on this gigantic school budget -- it can be reduced without harming any child's education. \$1 on sale at door.

Dear Governor Hughes: I would like to request that your office, or an elected or appointed agency that has jurisdiction, investigate a situation in Madison Township, New Jersey that has become increasingly onerous to many of our townspeople interested in maintaining in our community a school system devoid of political control and manipulation.

I believe that two recent newspaper articles speak for themselves. The first is written by a Democratic County Committeeman who objects to the willful violations of state statutes, regarding the conduct of school board elections, by fellow members of his own County Committee! These County Committee people are actively encouraged in this undertaking by the leading members of the Madison Township Democratic organization.

The second article is written by a newly elected school board candidate, a registered Democrat, who shares these views and is also writing you to initiate a state investigation into the flagrant misconduct of a political organization in our school elections.

As a taxpayer who is very interested in seeing that all monies allocated for local education are spent and spent well on only local education, and as a supporter of yours who voted for you in the last election primarily because of your liberal views on the educational needs of our state, I ask you to conduct an exhaustive investigation in Madison Township as to the role of the local Democratic party in our school board elections, and upon finding irregularities or acts of political interference, to order these parties to "cease and desist" under penalty of law. declaration of any and all findings to be made so that all political groups would be made aware of the consequences of improper interference in school board elections should they decide to involve themselves in the future.



AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE PERMITTING UNDER CERTAIN CONDITIONS THE TOWNSHIP OF MADISON BY SANITARY LAND FILL METHODS AND ESTABLISHING STANDARDS FOR THE DESIGN, OPERATION AND MAINTENANCE OF SANITARY LAND FILL SITES."

BE IT ORDAINED by the Township Council of the Township of Madison, County of Middlesex, State of New Jersey that the above-captioned Ordinance be amended to read as follows:

Section 1. Paragraph 2 (c) is hereby amended to read as follows:

The cost for such construction permit shall be in the sum of Five Hundred (\$500,00) Dollars per year and such permit shall be renewed annually, if recommended by the Township Engineer.

Section 2. Paragraph 3 shall be amended to read as follows:

to read as follows:

After obtaining such construction permit as aforesaid, no person, firm or corporation shall operate and maintain a sanitary land fill in Madison Township without having also obtained from the Board of Health of the Township of Madison an operating permit, not being construed.

son an operating permit, the granting of a construction permit not being construct to be a permit for the subsequent operation of a sanitary land fill site.

Such operating permit shall be initially issued for a period of one (1) year and shall be automatically renewed for a subsequent one (1) year period, provided that the land fill operation for which said permit was issued has been operated and maintained in accordance with the provisions of this Ordinance and the State Sanitary Code during the previous one (1) year period.

one (1) year period.

The costs for such operating permit shall be the sum of Five Hundred (\$500.00) Dollars and there shall be an additional annual charge of Two Hundred (\$200.00)

Dollars for each automatic renewal.
Section 3. Paragraph 4 is he amended to read as follows:

The Board of Health and the Township Engineer and any other officials designated by the Board of Health shall exercise close and rigid control of the exercise close and rigid control of the method of operation and maintenance of any sanitary land fill project for which an operating permit has been issued, and the original operating permit or any renewal thereof may be terminated by action of the Madison Township Board of Health, after timely notice and a public hearing with respect to any alleged violations of the requirements of this Ordinance or of the State Sanitary Code or of any other applicable Health Ordinance or of the State Sanitary Code

or of any other applicable Health Ordinances, rules or regulations.

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

This Ordinance shall take effect im-mediately upon publication and according
